UNITED STATES.

A new piece of the value of two shillings, was called a Florida, has been issued from the mint.

There were 534 births at sea, on board ships arriving in the port of New York during the month of May.

A plan for a suspension bridge across the St. Lawrence at Quebec, is before the Commemorative Council of that city.

Young pretenses and claims appeared in the New Orleans market a week ago. Strawberries were also in abundance on the 23rd ult.

A great freshet has occurred at San Antonio, Texas, recently, by which several lives were lost.

From Havana.—Dates from Havana to 15th instant have been received at New York.—The affray represented in the telegraph despatch from New Orleans, to have taken place between English and American sailors, was between them jointly on the one part, and Spanish sailors on the other.

The New Governor General of Cuba had arrived. Much regret was expressed at the removal of General Concha.

Prince Schwartzburg, the Austrian Prime Minister is dead. He died from a stroke of apoplexy.

English Mail of May 1.

(From the Halifax British North America, May 12.)
The British Mail Steamer CANADA arrived here last evening, at about 9 o'clock, in 11 days from Liverpool, with European dates to the 1st inst.

We give below a condensed summary of news, which will be found interesting.
Lord John Russell has opened in Parliament nearly the very same Militia Bill he introduced three months ago. Wilmore and Smith have been set at liberty by the Austrian government, and they will leave the country on the first of May.
The manuscript journals and papers of the late Thomas Moore are in preparation for publication, and will be edited by Lord John Russell.
News from the Cape reported the continued success of the British, who have captured immense droves of cattle and killed thousands of the enemy.
A report was current in Cape Town, that Riebeck, when there in a post with about 40 men, had been attacked by a large body of Caffres, and that the men had taken refuge in the church.
The Dutch bark Jane had been lost, and five passengers drowned off U'Agulhas, on the 24 March.
Intelligence has been received from Adelaide, South Australia, up to the 10th of January. The discovery of gold in the colony had turned out a fabrication.
The Canada arrived at Liverpool on Tuesday, April 27, and the Atlantic on Thursday, 30.
New barracks are to be erected at Plymouth, at a cost of £50,000.
A fine draft of the 30th Regiment were to be embarked on board the Simoon for Canada.
Doing to the effect of bad writing, £11,000 is annually in the London Post Office—contained in "uncalled-for letters."
A Telegraph despatch in anticipation of the Mail from India, has been received from Trieste, where the mail Adria arrived on the 28th April with dates from Bombay to 24 April. The expedition against the Burmah goes on apace. A battle of three hours duration had been fought between twenty-five hundred British troops and a body of native Mountaineers, to the north of Peshawar—Mountaineers defeated, no further details. The import Market at Bombay was firm. Cotton active, and prices rising. Money less abundant. Exchange on London one shilling and seven pence three farthings.
Five days later advices have been received from the Cape of Good Hope. Shirmishes were continually occurring between the troops and the Caffres.
It appears that the Government of Peru have put forward claims to the newly discovered gold islands in the Pacific. The claims of the Live stock Ship-owners' Association has directed the attention of the Foreign Office to the subject, with a view to obtain the benefit of the discovery of these islands for the benefit of the British.
DESTRUCTION OF A BRITISH SHIP BY GUNPOWDER.—By the ship "America," from the coast of Africa, we have received information of the destruction of the "Mary," on the 19th of January. This ship, in the Bonny River, on the 19th of January last, the Mary sailed hence in June last, and had partly discharged her outward cargo and received a portion of her homeward cargo, on the day of the explosion. It was technically known as "the house," built on the ship's deck, had become so dry as tinder, and by some means it caught fire. There was at the time on board between two and three hundred barrels of gunpowder; and the captain and crew, 25 in number, finding themselves unable to quench the flames, threw themselves overboard, and got safely on board of the adjacent vessel. About twenty minutes after the breaking out of the fire, the Mary blew up, with a tremendous report, and soon scarcely a vestige of her was visible. The ship and a great portion of her cargo were completely neutral. She belonged to Messrs. Harrison, of Money Street, Liverpool.

IRELAND.
A party of eight ribbons have been captured in Layford and committed for trial.
Cardinal Wiseman next month visits the College of Maynooth, when all the Roman Catholic bishops of Ireland will meet him.
An old man, named Martin, and his wife, both upwards of 80 years of age, were found dead in bed a few mornings since, at Bridge-end, County Antrim, having resorted to rest in their usual health.
News has reached Dublin, that Thomas Francis Meagher, the Irish political convict, had escaped from Van Diemen's Land. The intelligence has reached his friends from a private source.
The largest copper brewing-pan in the empire is in Dublin, and of Irish manufacture. It is for Alderman Guinness; its weight is twelve tons, and it will contain 1000 barrels.
The man Walsh, convicted at the last Assizes in Kilkenny of a murder committed five years ago, was executed on Thursday week. A few hours before his execution, the wretched man made an attempt at suicide, by forcing a sharp-pointed stick into his ear, hoping to penetrate the brain.
A convict named Abers, under sentence of death at Waterford, for a conspiracy to murder, had his sentence commuted to transportation for life.
REV. FRANK'S HOUSE.—The house of the Rev. Mr. Hoffmann, P. P., at Clonilla, County Tipperary, was maliciously set on fire and burnt to the ground on Saturday night last. The Rev. gentleman himself narrowly escaped from the flames. It was done, it is understood, by a person whose name had been traced to the early part of the same day.
The emigration this summer to the United States, it is thought, will be as large, as at any other period.
It is again stated, that her Majesty will visit Ireland this summer; landing at Waterford, where she will be received by the Duke of Devonshire, with whom she will stop a few days at the Castle, and then proceed to the Lakes of Killarney. She will then proceed to Dublin, hold a levee and drawing-room at the Castle, and passing a day at the new bridge, cross Kingstown to Holyhead, and thence by train to Balmoral.

FRANCE.
Another Review took place on Sunday, on the Place du Carrousel. The troops mustered in greater numbers than on previous occasions.
The Ministers of the Interior and Police are at present occupied with a matter which since great sensation has been made.
A Commissioner of Police is on the point of being arrested on the charge of having trafficked in pardons, and sold for hard cash communications of pardon, or releases from prison. The fact was denounced to the authorities by a prisoner, who had procured his liberty by this corrupt channel, and has since been confirmed by others.
Amongst the 2nd corps, who are to come to Paris for the fetes of the 10th May, are two battalions and a brigade, with their suite of forty pieces.
Prince Jerome Bonaparte opened his saloons at the Luxembourg on Sunday evening, for the first time. A great number of the diplomatic corps were present.
A decree decides, that, in the course of the month of May, the officers of all arms, and the functionaries of the war department are to take the oath of fidelity to the President.
The Minister of Monday, contains a fresh shower of favours to the army. This is a decree ordaining, that the year 1851 shall count as a year of campaign to those troops who were called upon in any part of the French territory to suppress the resistance offered to the usurpation of December 2.
A monster trial is about to come on at the Walgrave Assizes. Fifty-three of a band of some 300 individuals who, in 1848, crossed the Prussian frontier, and plundered a landholder and his family of all his papers, deeds, and jewels, have been indicted.
MEXICO, April 25.—The English embassy at this court is about to undergo a greater change than has taken place here for years.
The Burmah expedition, under General Godwin, had set sail, and was expected to arrive at Madras on the 4th of April. There was already a considerable naval force there,

A second expedition of 2500 men, under Sir C. Campbell, marched against the mountain Caffres to the north of Peshawar, on the 11th of March. On the 20th, they repulsed an attack upon them by the enemy, after a conflict of three hours. Sir Colin had demanded additional forces.
The saps of the Nippon in its various parts, the irregularities of Canada was increasing, and the recall of Lord Falkland was anticipated.
All the secretaries of legation, Messrs. Howard, Lowther, and Hensley, who have been at Berlin for many years, are about to leave their posts, and to occupy the same position at other courts. This sudden recall of persons is generally presumed to be the act of the tory cabinet.
GREEN.—The national fete had been celebrated with the greatest order. There has been a stormy debate in the senate. Several speakers violently attacked the cabinet, and the President was obliged to leave the chair suddenly.

AUSTRALIA.
We notice in Monday's Sun, an extract from a letter received in this City, (Halifax), giving a glowing picture of the Gold Diggings, and bearing date—Oct. 1851. The following is an extract of a letter, written from Sydney, Dec. 18, 1851—TWO MONTHS LATER:—
"The precious metal arrives in daily increasing quantities, and the estimated exports have risen from £1,000,000 to £3,000,000 per annum. There is no end to the gold; and, so far as I have been able to ascertain from personal communication with diggers of various degrees, the labor is in no way so tiresome as it was at first. The harvest is magnificent. Wages are not extravagantly high, and I do not see any prospect of famine for some time to come. I do not venture to prognosticate the probable state of the markets. We are completely in the dark. I have it, however, from good authority, that in the early part of the year the probable heavy shipments of goods on speculation will have the effect of creating a glut; and it would be well if a large degree of caution were exercised in making consignments. The miners brought us the first 'return wave' of the gold news from you; and we are looking with intense curiosity for the first 'return' leader on the subject of our great discovery."

We have received by the Express, Melbourne papers to the 10th instant. The Melbourne Morning Herald, of that date, says—Letters were received in town yesterday from the Police Magistrate at Gipps Land, stating, that the whole driving range between Sydney and Victoria, and known as the Snowy Mountains, for two hundred miles extent, is one vast gold field. There was upwards of a ton and a half of gold in Mr. Commissioner Powell's tent, waiting for the escort, up to Saturday night, and it is expected that to-day's escort from the Mount will not be able to bring down one half the quantity offered. It is intended to increase the military force here to one hundred men.
The Australian Packet Sydney has arrived with gold dust valued at £177,000. Her date is the 9th of January.
NEWFOUNDLAND.
The Packet Steamer Leinster, Captain Hunter, from St. John's, Newfoundland, arrived here yesterday morning—bringing us St. John's papers of the 6th inst. From whence we learn the following particulars:—
The question of the Protection of our Fisheries, says the Newfoundland Express, from foreign aggression, is one which just now most earnestly presses itself upon the consideration of the country; and we are glad to notice the praiseworthy exertions of the several gentlemen of the town, who have obtained a large number of the most influential signatures to a Petition to the Legislature on this vitally important subject. The Petition prays for the appointment of a Cruiser, suitably armed and equipped, on the coast to the Northward and at Labrador; and we trust it will meet with a prompt and earnest attention.
From the same paper we learn, that "about 400 shipwrecked sealers have been brought into Carboneau. These, who were brought here, number in all upwards of 700. It is calculated, that fully as many are still on the coast to the Northward; and the vessels sent out to relieve them, may be long in their return, and with the poor fellows on board. The destination of these sealers is at Labrador; and we hope it will continue to be, as it has hitherto been, readily relieved. The consequent expenditure, with the falling off of the revenue, and the consequent want of ready-forgotten appropriations; but that will not be so much felt, as there is a gratifying knowledge, however, that the fishery, notwithstanding many reverses, has not yet been abandoned; and that, in the present appearance, are equal to the average of former years."
St. George's day was celebrated in St. John's, with much festivity.
The papers are extremely barren—being filled with Legislative proceedings, to the exclusion of every thing else.
An inquest was held on the bodies of George Strong, a fisherman—who went to bed apparently quite well, and was found dead in the morning; and James Sawyer Bowden, who was shot by accident, while hunting, by a young man named Thomson. Verdict in first case, "Died by visitation of God"—and in the second, "Accidental Death."
MISCELLANEOUS.—The Steamer St. George, Captain Husband, sailed from St. John's, Newfoundland, for Cork and this port, on the 19th of January, and has not since been heard of. She was a vessel of 1500 tons, and two engines of fifty-horse power each. It is supposed that she was about twenty persons on board. She was built for the St. George's Steam Packet Company at this port and is now owned by a firm at St. George's, in the County of Cork, Ireland. The St. George was formerly owned in F. E. Island and ran between Charlottetown, and Pictou—E. G. GAZ.

With reference to the case of "Mitchell vs. Harvie," tried at the Supreme Court of Judicature, on Tuesday, May 4th, a report of which appeared in our paper of the 11th inst.—it seems, that one of the three questions raised in the argument was, "Whether the order of the Lieut. Governor justified the Defendant in discharging the Prisoner?" On that issue, the learned Judge states, "It appears to me, therefore, that the Lieut. Governor had no power to discharge the Prisoner, and that the order does not justify the Defendant in having permitted the Prisoner to escape."
The manner in which this case is now reported, leaves the public to infer, that the Lieut. Governor wilfully or ignorantly assumed a power which he does not possess, by issuing an order to allow a person accused of crime, to be liberated before trial. We are authorized and have been desired to state, that His Excellency gave the order in question, fully aware of the powers with which he is invested, and did so entirely on his own responsibility, well knowing, that if he exceeded his powers in this instance, he was amenable and bound to hold himself harmless Mr. Harvie the Jailor, or any other person, from any consequences which might attach to him or them, for acting in obedience to the orders of the Lieut. Governor. The Prisoner White, a Private in the 30th Regiment was, therefore, delivered over to his Commanding Officer, by an order from His Excellency, under the following circumstances.—The man was accused of stealing a Watch, and committed for trial, the Detachment to which he belonged was on the eve of leaving Prince Edward Island, having previously lost ten men by desertion, which quartered in Charlottetown. This circumstance was communicated to the Lieut. Governor, and that White, the Prisoner, (against whom, the depositions were difficult of proof, it being stated,

that the Watch was stolen on a certain day, and at a certain time of day,) was to test his defence on proving an alibi; but that he required several of his comrades to remain in the Colony, to appear as Witnesses on his trial. The Commanding Officer of the Detachment of the 30th, represented to His Excellency, that if these Witnesses remained in the Colony, they would in all probability desert, and that White, if acquitted, would do the same, and trusted, that the Lieut. Governor would, under all the circumstances, take the responsibility on himself, of ordering White to be delivered over to a Military tribunal, which His Excellency agreed to do. But, instead of the Jailor permitting the Prisoner to escape, "he was delivered up and carried to Halifax as a Prisoner, to be tried by a Court Martial. The Lieut. Governor holding himself amenable to the Civil Court for any injury or damage proved to have been sustained by Her Majesty's subjects, in consequence of the order which he gave to Mr. Harvie, the Jailor of Charlottetown Prison.

We can no longer withhold the expression of our firm conviction, that however much wrong, reckless, and indefensible was the conduct of Mr. Whelan in the case of the Election for the second district of King's County, he must be acquitted of the crime of Perjury, happy to say, that he does not seem to have been guilty of the crime of Perjury, but of the crime of fraud, in conveying the property from Dawson to Whelan, that made the qualification taken by him a false one.
