



For the Completion of the Court House and Gaol of the Brock District.

BY-LAW, No. 2,

Determining the Amount of Salaries to be paid District Officers.

[This Act Repealed by By-Laws 7 & 24, except that part which relates to the per centage payable to Collectors.]

WHEREAS by an Act passed in the First Session of the United Parliament of Canada, 4th & 5th Victoria, Chap. 10, Sec. 39, The District Councils to be formed in that part of the Province which formerly constituted the Province of Upper Canada, are authorized, among other things, to determine the amount of salaries to be paid to certain District Officers.

Be it therefore enacted by the authority aforesaid, that the several District Officers hereinafter mentioned, be paid their respective salaries according to the following scale, that is to say:—

The District Surveyor to receive five per cent. on all monies disbursed in the completion and repairs of the Court

House and Gaol, and one pound five shillings per diem, whilst

employed by the District on other works.

The Clerk pro tem. to receive twelve pounds ten shillings for his services, until such time as a Clerk shall be appointed by the Governor-General, taking it for granted that such time shall not exceed two months.

The Clerk to be appointed by the Governor to receive

thirty-five pounds per annum.

The Auditors to receive ten pounds each per annum. The High Constable to receive seven shillings and six

pence per diem, whilst in attendance on the Council.

The Gaoler to receive seven shillings and six pence per diem, whilst in attendance on the Council.

All other Constables to receive five shillings each per

diem, whilst in attendance on the Council.

Township Clerks to receive each, six pounds per annum. Assessors and Collectors to receive per centage, as e pressed in the 16th & 18th Clauses 1st Victoria Chap. 21.

Be it therefore enacted by the authority aforesaid, that whenever any person or number of persons intend applying to the Council for a sum of money for public improvements, notice of such intended application, specifying the particulars, shall be published in the Woodstock Herald, by giving the same two insertions previous to the meeting of the Council, at which application is intended to be made, and that no money be granted for such purposes without proof of the said notice; the party or parties applying, to pay the expense of the said notification.

BY-LAW, No. 4,

For the Construction of Side-Walks, and Planting Trees on the edges of the Roads and Streets, in the Townships and Towns within this District.

Whereas by an Act passed during the first Session of the United Legislature, of the Province of Canada, entitled "An Act to provide for the better internal government of that part of this Province which formerly constituted the Province of Upper Canada, by the establishment of Local or Municipal Authorities therein:" power and authority is, amongst other things, given to the District Councils in the several Districts to make a Bv-Law, "for the making, mending and improv-

ing of any new, or existing road, street, or other convenient communication within the limits of the District, or for the stopping up, altering, or diverting of any road, street, or communication within the limits thereof:" And whereas it is expedient and necessary for the improvement of the public highways in this District, and for the safety and convenience of the inhabitants thereof, that side-roads or walks should be constructed along the roads and streets, in the several Towns and Townships in this District, and that the same should be rendered as convenient as the same can be:-

De it therefore enacted by the District Council of the District of Brock, that from and after the passing of this By-Law, it shall and may be lawful for any of the inhabitants residing in any of the Townships or Towns, in this District, to construct and make a side-walk, or foot-path, for footpassengers, of the width of six feet, extending from the edge of the lot or lots, or part or parts of lots, owned by any of the said inhabitants, into the said road or street; and also shall and may plant any tree or trees, on the outer edge, and adjoining

thereto, of the said side-walk or foot-path.

And be it further enacted by the authority aforesaid, that if any person or persons shall wilfully or maliciously cut, injure or destroy any of the said paths or trees so planted, and made as aforesaid, he, she or they, shall forfeit and pay for every such offence, any sum not exceeding the sum of one pound nor less than five shillings, to be recovered before any of her Majesty's Justices of the Peace, acting in and for the said District, on the complaint of the overseer, of that part of the highway in which the said side-walk or foot-path is situated, or the said tree or trees are growing, or on the complaint of any other person: And that such penalty shall be recovered by distress and sale of the goods and chattels of the party or parties so offending: And that the said penalty shall be naid into the public Treasury, of the said District, to be applied in the improvement of the public highways within the Township in which the said offence is committed, under the authority of the Councillor or Councillors for the time being, elected for the said Townships; And any person or persons riding or driving on the said side-walks shall be subject to a penalty not exceeding five shillings at

WHEREAS by an Act passed during the First Session of the United Legislature of the Province of Canada, "entitled "An Act to provide for the better internal government of that part of this Province which formerly constituted the Province of Upper Canada, by the establishment of Local or Municipal Authorities therein, by the 51st section of the said recited Act, it is among other things enacted, "that all and every the power and authority which by any act or acts in force within that part of this province which formerly constituted the Province of Upper Canada, are now vested in the Justices of the Peace for the several Districts, with regard to high-ways and bridges or work connected therewith," shall, from and after the said first day of January, one thousand eight hundred and forty-two, become and be vested in and may be exercised by, the D rict Council of such districts respectively within the limits thereof:" And whereas it is necessary for the proper execution of the power thereby vested in the said Council, and for the protection and management of the interests of the inhabitants of the District of Brock, that the powers aforesaid exercised by the Justices acting in and for any division of this District, shall from and after the passing of this By-Law, so far as the same is vested in the said District Council, be vested in and exercised by

the several District Councillors within his or their respective

townships or unions of Townships:

Be it therefore enacted by the District Council of the District of Brock that from and after the passing of this By-Law all, and every the power and authority, powers and authorities, which by any act or acts in force within that part of this Province which formerly constituted the Province of Upper Canada, previous to the passing of the before recited act, was or were vested in the Justices of the Peace acting within any division of the said District, so far as the same has been conferred upon the District Council of this District shall be, and the same is hereby directed to be exereised by the Councillors of this District acting within the Township or union of Townships, or of any Town and Township for which they or any of them may have been respectively elected.

Section 2: Be it further enacted, that all, and every person or persons, having any claim against this Council for any damage or damages, sustained by him, her or them, in consequence of any road, or roads established, or to be established by any By-Law of this Council, through or over his, her, or their lands and shall within three months after the passing of any such By-Law, as aforesaid, give notice to the Clerk of this Council in writing, of the amount of damages so sustained by him her, or them, and of his, her, or their intention to claim such damages from this Council. It shall be the duty of this Council to hear evidence in support of such claim during the sitting of the Council next, after the laying out of such road or roads, whose duty it shall be to award the amount of damage or injury sustained.

Section 3: And be it further enacted by the authority aforesaid, that if the party or parties claiming damages shall be dissatisfied with the decision of the Council on such claim or claims, the party or parties, so feeling dissatisfied, shall be at liberty to apply to the next Court of General Quarter Sessions of the Peace, for the said District, and assess the value of such damages sustained before a Jury, having first given at least ten days notice of such, his, her, or their intention to assess such damages to the Clerk of the Council, whose duty

It is enacted that it shall be lawful for any District Council in its discretion by any By-Law to be passed for that purpose, to allow to each member of such Council a sum not exceeding Six Shillings and three pence for each day he shall actually sit in Council, to be paid out of the District funds in such manner, and on such conditions as shall be directed in such By-Law. And whereas it is desirable that the Councillors of this District should be remunerated for their services rendered to the public. WHEREAS on the application of the inhabititants and Trustees of certain School Sections in this District, it has been thought advisable to tax the said Sections for the purpose of paying the salaries of School Teachers in the said School Sections, or to defray the same in part.—Be it therefore enacted by the District Council of the District of Brock, constituted and assembled under and by virtue of the authority of an act of the Parliament of this Province entitled "An Act to provide for the better internal Government of that part of this Province formerly constituting the Province of Upper Canada by the establishment of Local or Municipal authorities therein," and it is hereby enacted by the authority of the same, That the following School sections and union School Sections shall be and the same are hereby taxed in sums following, and for the purposes hereinafter expressed, that is to say: Union School Section No. 6, in the Township of North Oxford, No. 6 West Oxford, and No. 3, East and West Zorra, £40. School Section No. 9, in the said Township of East Zorra £15; School Section No. 1, in the Township of West Oxford £25;-to assist in the payment of the Salaries of the School Teachers in the said respective School Sections for the year 1847.

Section 2. And be it further enacted that the said assessments hereby imposed shall be raised collected and levied in the same manner as taxes and assessments have heretofore been raised, collected and levied by the collectors of the said several Townships, and by them paid over to the Trustees of the said School Sections and union School Section on or before the 30th day of December now next, and that the Clerk of the Peace of this District, do and he is hereby required to issue a Collectors Roll, or Rolls to the Collectors of the aforesaid Townships to enable them to col-

lect the said respective taxes.

BY-LAW, No. 85.

For Lawjing of Taxes for the Erection of School Houses, and other purposes, in the District of Brock.

[Temporary.]

WHEREAS it is necessary and expedient to levy taxes for the erection of school houses and to defray other expenses hereinafter mentioned, connected with the school houses for the several School Sections hereinafter mentioned and set forth: Be it therefore enacted by the Municipal Council of the District of Brock, constituted and assembled under and by virtue of an Act of the Parliament of this Province, entitled "an Act to provide for the better internal Government of that part of this Province which formerly constituted the Province of Upper Canada, by the establishment of Local or Municipal Authorities therein," and it is hereby enacted by the authority of the same, That it shall and may be lawful to assess the following School Sections, and they are hereby assessed in the sums and for the purposes following, that is to say, School Section No. 7, in the Township of Bienheim, the sum of £21, £8 part thereof to defray the costs already incurred in the erection of the school house therein, and £13, the residue thereof, for the purpose of erecting a wood-shed and other necessary out-houses School Section No. 9, in the Township of West Zorra, in the sum of £100; School Section No. 10, in the Township of West Zorra, aforesaid, in the sum of £50; School Section No. 4, East Zorra, £88; School Section No. 9, in the Township of East Oxford, the sum of £30, for erecting school houses in the said Sections; School Section No. 2, in the said Township of East Oxford, the sum of £4 17s. 9d.; School Section No. 3, Township of Blandford, the sum of £4 12s. 6d.; School Section No. 8, in the said Township of Blandford, the sum of £13 15s., for the purpose of providing furniture for the school houses in the said School Sections, over and above all costs and charges and expenses of collecting the same.

Section 2. And be it further enacted by the authority

aforesaid, That the said assessments hereby imposed shall be raised, levied and collected in the same manner as rates and assessments have heretofore been raised, levied and collected by the Collectors of rates and taxes of the said Townships respectively, and be by them paid over to the Trustees of the respective School Sections, at the periods following, that is to say, on or before the 30th day of December now next.

Section 3. And be it further enacted by the authority aforesaid, That it shall be the duty of the Clerk of the Peace of this District, and he is hereby required to issue to the Collectors of the said Townships respectively, Collectors Rolls, to enable them to collect the said sums respectively, for the purposes aforesaid, Provided always, That no Tax shall be levied or collected in School Section No. 4, in the Township of East Zorra, until the District Clerk shall have approved of the title to the school site on which the school house in the said School Section has been erected, and the said school site acquired by the said District Council, or another school site in the said School Section has been acquired and the said school house removed thereto.

Section 4. And it is enacted by the authority aforesaid, That the school house for Section No. 9, in the Township of East Oxford, be duly erected on the site now acquired by the District Council for that purpose, on part of Lot No. 11, in the 8th Concession of East Oxford.
