

## An Act to confirm titles to lands in free and common soccage, and to establish uniformity in the Laws relating to real property in Lower Canada.

WHEREAS the reasons for the introduction into Lower Canada of the Preamble. tenure of lands in free and common soccage no longer exist; and whereas grave doubts are entertained in reference to the Rules of Law to which resort should be had for the determination of controversies 5 relating to lands held under that tenure; And whereas it is expedient to remove such doubts for the future, to confirm existing titles, and to introduce uniformity throughout Lower Canada in the laws relative to real property; Therefore Her Majesty, &c., enacts as follows :

I. All lands hereafter to be granted by Her Majesty, her heirs and Lands to be 10 successors, in Lower Canada, shall be granted in franc-aleu roturier granted in franc-aleu and not otherwise.

III. The Act passed by the Legislature of the late Province of Lower Act of L. All lands in Lower Canada heretofore granted in free and common What laws soccage, or hereafter granted in *franc-aleu roturier*, shall and may here- shall govern after be acquired, held, hypothecated, mortgaged, alienated, and dispos- and common 25 ed of, by Act inter vivos or testamentary provisions; shall descend, soccage or be inherited and divided among those entitled to the same by right franc aleu roof succession, and be liable to community of property, dower, and turier. other rights of married women, under and according to the same rules of law which shall hereafter from time to time govern similar 30 dispositions and incidents of real property throughout the other parts of Lower Canada, and not according to the rules of the law of England.

VI. This Act shall not be construed to repeal or change in any way respecting re- the several Acts of the Legislatures of the late Province of Lower Canada, and of this Province, relative to enregistration of titles, and to the forms of deeds of sale, and of wills relating to immoveable property in Lower Canada (with the exception of the aforesaid Act hereby expressly 5 repealed); But the said statutory provisions shall continue to apply to all the lands described in the first and second sections of this Act
