JANUARY SESSION.

FIRST DAY.

WELLAND, Tuesday, 26th January, 1897.

Pursuant to the Consolidated Municipal Act, 1892, and the Act to reduce the number of County Councillors, the County Councillors elect under the County Councils Act, 1896, made and subscribed the declaration of office and qualification thereto according to Sec. 270, Consolidated Municipal Act, 1892, and met at Council Chamber, Welland, at 3 o'clock p. m., for the purpose of organization, election of Warden, and the transaction of general business.

The Clerk *ad interim* in the chair.

MEMBERS OF COUNCIL.

The following named gentlemen subscribed the declarations of office and qualification as required by law, and took their seats at the Council table, that is to say :

- District No. 1.—J. HARRISON PEW, of the Township of Stamford.
EGERTON MORDEN, of the Township of Stamford.
- District No. 2.—ERNEST CRUIKSHANK, of the Township of Bertie.
ROBERT MOORE, of the Village of Bridgeburg.

District No. 3.—HENRY CRONMILLER, of the Village of Port Colborne.

CHARLES E. STEELE, of the Township of Humberstone.

District No. 4.—EDWARD MORRIS, of the Township of Pelham.

WM. BROWN, of the Township of Wainfleet.

District No. 5.—S. J. SIDEY, of the Town of Welland.

WALTER UPPER, of the Township of Thorold.

The roll having been called, the following Councillors answered to their names :

Messrs. Brown, Cronmiller, Cruikshank, Moore, Morden, Morris, Pew, Sidey, Steele and Upper.—10.

ELECTION OF WARDEN.

The Clerk announced that it would now be in order to proceed with the election of Warden by ballot, and read, for the information of the Council, clause 1 of the Standing Rules, referring to the election of Warden by ballot, after which the following nomination was received :

Moved by Mr. Cruikshank, seconded by Mr. Brown,

That Mr. Morris be Warden for the year 1897.

No further nominations being proposed, the ballot was taken, and resulted in nine for Mr. Morris and one blank.

Mr. Morris was declared by the Clerk duly elected, and came forward and took the declaration of office before Ernest Cruikshank, Esq., Commissioner, as Warden of the County of Welland for the present year, and thanked the Council for the honor conferred. He said the new County Councils Act was now on its trial, and while opinions might differ in some respects all would agree that a reduction of expenditure would be accomplished. He trusted retrenchment would be the order of the day. The expenditure connected with the Industrial Home, especially during 1896, was excessive, and showed extravagance and mismanagement, and he would recommend that the Home accounts for the past two years be brought before Council and examined, with a view to retrenchment in the future.

HOURS OF MEETING.

Moved by Mr. Cruikshank, seconded by Mr. Steele,

That the hours of meeting and adjournment of this Council during the several sessions of the current year be as follows : Meet at 9.30 o'clock, adjourn at 12 noon ; meet at 1 p. m., adjourn at 6 p. m.

Moved in amendment by Mr. Morden, seconded by Mr. Cronmiller,

That the hours of meeting and adjournment during this session be as

follows : Meet at 9 a. m., adjourn at 12 o'clock noon ; meet again at 1.30 p. m., adjourn at 5.30.—Lost on a division.

The original motion was then put and carried.

NOTICES OF MOTIONS.

Mr. Cruikshank gives notice that he will on to-morrow ask leave to introduce a memorial to the Legislative Assembly of this Province, praying for certain amendments to the Game Law.

Mr. Cruikshank gives notice that on to-morrow he will ask leave to introduce a memorial to the House of Commons for Canada, praying for the enactment of an Alien Labor Law similar to that in force in the United States of America.

Mr. Pew gives notice that he will on to-morrow ask leave to introduce a memorial to the Local Legislature *re* Canadian Niagara Falls Power Co.

Mr. Sidey gives notice that he will on to-morrow introduce a bill for the appointment of High School Trustees to fill the various vacancies occurring in the High Schools of the County.

Mr. Morden gives notice that he will on to-morrow ask leave to introduce a by-law to appoint a High School Trustee for the Town of Niagara Falls.

Mr. Morden gives notice that he will on to-morrow ask leave to introduce a memorial to the Ontario Legislature in respect to the extension of the special privileges to the Canadian Niagara Falls Power Co.

Moved by Mr. Cruikshank, seconded by Mr. Sidey,

That this Council do now go into committee of the whole to strike the Standing Committees for the present year.—Carried.

Pursuant to motion, the Council went into committee of the whole, Mr. Morden in the chair.

The committee rose and reported the following resolutions :

Moved by Mr. Sidey, seconded by Mr. Pew,

That the following names constitute the Standing Committees for the year 1897 :

Industrial Home—Messrs. Cruikshank, Steele and Upper.

Jail—Messrs. Sidey, Pew and Cronmiller.

Carried.

Moved by Mr. Pew, seconded by Mr. Cruikshank,
That the whole Council be a Standing Committee on Finance, Education,
Printing and Equalization.—Carried.

The Warden presented report of committee on Standing Committees,
which was read to Council.

Moved by Mr. Morden, seconded by Mr. Upper,
That the report of the committee on Standing Committees be now
adopted.—Carried.

AMENDMENTS TO RAILWAY ACT.

Moved by Mr. Cruikshank, seconded by Mr. Sidey,
That the communication from the County of Lambton, praying for
certain amendments to the Railway Act, be concurred in; and that the
Warden and Clerk be authorized to sign the same and affix the seal of this
County on behalf of this Council.—Carried.

COMMUNICATIONS AND PETITIONS.

The Warden presented the following communications and petitions :
From Thos. D. McBride, *re* resignation as member of the Thorold
High School Board.

From Wm. M. German, M. P., *re* the receipt of copy of memorial
and resolution of the County Council, each of which, he stated, would
receive prompt attention from him on the assembling of the Legislature at
its approaching session.

From Wm. McCleary, M. P., *re* the receipt of copy of petition of the
County Council, which, he stated, would receive his attention at first oppor-
tunity in the House of Commons.

From County of Frontenac, *re* memorializing the Government to take
into consideration the placing on the free list, viz. : Crude oil, coal oil, wire
for fencing, and all raw material.

From County of Wentworth, *re* amendment to Registry Act and General
Road Companies' Act.

From County of Lambton, *re* drainage works through railways.

From Geo. A. Bull, President of L. L. H. S., requesting to fix day for
meeting Council.

From County of Simcoe, *re* the maintenance of the Victoria Industrial
School.

From Prisoners' Aid Association.

From Wm. Pickard, *re* the expenses of the Constabulary Association.

Moved by Mr. Cruikshank, seconded by Mr. Cronmiller,

That the Treasurer be instructed to communicate with the treasurers of the several municipalities in arrears of taxes for the year 1896, requesting immediate payment of the several amounts due from each of them respectively, and that a copy of this resolution be forwarded to each of said treasurers.—Carried.

NOTICES OF MOTION.

Mr. Cruikshank gives notice that on to-morrow he will ask leave to introduce a bill for the appointment of a Board of Criminal Audit for the year 1897.

Mr. Pew gives notice that he will on to-morrow ask leave to introduce a memorial to the local legislature, *re* amending section 241 of Assessment Act of the Municipal Act, respecting arrears of taxes due County from Municipalities.

Mr. Cruikshank gives notice that on to-morrow he will ask leave to

introduce a bill praying for certain amendments in the Act respecting the selection of jurors.

TREASURER'S REPORT.

Moved by Mr. Pew, seconded by Mr. Sidey,

That the Treasurer's report be received and printed in the minutes.—

Carried.

MEMORIAL *re* GAME LAW.

Mr. Cruikshank asked leave to introduce a memorial to the Legislative Assembly for the Province of Ontario, praying for certain amendments in the Game Law for this Province.

Leave granted.

Memorial read to Council.

Moved by Mr. Cruikshank, seconded by Mr. Moore,

That the memorial to the Legislative Assembly of the Province of Ontario, praying for certain amendments in the Game Law of the said Province, be adopted.—Carried.

TREASURER'S BONDS.

Moved by Mr. Cruikshank, seconded by Mr. Steele,

That it shall be the duty of the Finance Committee to report at the present session in accordance with Sec. 249, Chap. 184, R. S. O., which requires that it shall be the duty of every Municipal Council to inquire into the sufficiency of the security furnished by the Treasurer's bonds and report thereon.—Carried.

NOTICE *re* BILL TO APPOINT AUDITORS.

Mr. Pew gives notice that he will on to-morrow ask leave to introduce a bill to appoint Auditors of Treasurer's accounts for the year ending Dec. 31, 1896.

INDUSTRIAL HOME ACCOUNTS, 1895-6.

Moved by Mr. Steele, seconded by Mr. Pew,

That the Warden be requested to "lay on the table" all the accounts and vouchers pertaining to the expense of conducting Industrial Home from January, 1895, to the present date; also all resolutions and instructions of both Council and Home Committee referring to the above.—Carried.

The hour of adjournment having arrived, the Warden left the chair.

AFTERNOON SESSION.

At 1 o'clock p. m. the Council resumed.

NIAGARA FALLS COLLEGIATE INSTITUTE.

Moved by Mr. Cruikshank, seconded by Mr. Morden,

That the deputation from Niagara Falls Collegiate Institute be heard.

Mr. Alexander Logan addressed the Council, giving a statement of the work done by the Institute.

Mr. Quillinan, Secretary of the Board, also addressed the Council, presenting a statement of cost of building and maintenance of the Institute from its inception, and presented report of receipts and expenditures, and also list of pupils attending said Institute.

Moved by Mr. Brown, seconded by Mr. Moore,

That the claim of the Niagara Falls Collegiate Institute be referred to Messrs. Cruikshank, Pew and Morden, as a committee to examine said accounts, and to ascertain the legal liability of this County in respect to certain pupils.—Carried.

PRISONERS IN JAILS.

Moved by Mr. Sidey, seconded by Mr. Cronmiller,

That this Council agrees with the communication from the Prisoners' Aid Association insofar as it approves of the establishing of Industrial Homes throughout the Province ; that, where practicable, prisoners should be divided into classes, and where practicable and at all possible prisoners should be kept employed. At the same time, this Council does not believe that any more money should be expended on making convicts more comfortable, and therefore this Council refuses to grant any money at this time to the fund of the Prisoners' Aid Association.—Carried.

CANADIAN NIAGARA POWER COMPANY.

Moved by Mr. Pew, seconded by Mr. Cruikshank,

That leave be given to introduce a memorial to the Local Legislature, *re* extension of time to the Canadian Niagara Power Company.

Leave granted and bill read a first, second and third time and passed, entitled "A memorial to the Local Legislature, *re* extension of time to the Canadian Power Company."

INDUSTRIAL HOME REPORT.

The Warden presented report of the Chairman of Industrial Home Committee, which was read to Council.

Report stood for further consideration at the request of the Council.

HIGH SCHOOL TRUSTEES.

Moved by Mr. Sidey, seconded by Mr. Steele,
That leave be given to introduce a bill to appoint High School Trustees
for the various High Schools of the County of Welland.

Leave granted.

Moved by Mr. Sidey, seconded by Mr. Steele,
That the bill be read a first time.

Bill read a first time.

Moved by Mr. Sidey, seconded by Mr. Steele,
That the blank in the bill for Trustee for Welland High School be
filled in with the name of David McEwing.—Carried.

Moved by Mr. Pew, seconded by Mr. Morden,
That the blank in the bill for Trustee in the Stamford High School be
filled in with the name of F. A. Hutt.—Carried.

Moved by Mr. Sidey, seconded by Mr. Morden,
That the name of Wm. McGill be filled in the blank as High School
Trustee for the Town of Thorold.

Moved by Mr. Upper, seconded by Mr. Brown,
In amendment, that the blank in the bill for Thorold High School be
filled in with the name of William Williams.

The amendment proposed and carried on a division.

Pursuant to the foregoing resolutions the several blanks were filled up
accordingly.

The bill was read a second and third time and passed, entitled: "A By-law
to appoint High School Trustees for the various High Schools of the County
of Welland."

GRANT TO COUNTY TEACHERS' ASSOCIATION.

Moved by Mr. Steele, seconded by Mr. Sidey,
That this Council make the usual annual grant to the County Teachers'
Association of \$25, being an equivalent to the Government grant.—Carried.

COUNTY AUDITORS.

Moved by Mr. Upper, seconded by Mr. Brown,
That F. W. Casey be appointed an auditor of the treasurer's accounts
for the year 1896.—Carried.

The Warden named on his behalf James P. Pegg as auditor of the

Therefore your Petitioners humbly pray that the Game Laws of this Province may be amended in the said particulars to coincide with that in force in the State of New York.

Your Petitioners therefore pray that the Honorable House of Commons for Canada may be pleased to enact such legislation, as nearly as possible in identical terms with that enacted in the United States, as may be necessary

to remedy the aforesaid grievances, and preserve, as far as can be accomplished by such means, employment in Canada for Canadian citizens.

RE CROSSINGS AND DRAINAGE WORKS THROUGH RAIL-
WAY LANDS.

TO THE HONORABLE THE SENATE AND HOUSE OF COMMONS OF CANADA :

THE PETITION of the County Council of the County of Welland,

HUMBLY SHEWETH :

THAT a great grievance, which vitally affects the well-being of the entire community, exists with reference to the rights of municipalities to construct or repair drainage works through railways. It is a well-known fact that it frequently costs more to construct a drain through or across a railway than it does to construct the whole balance of the drain, and it is also a grievance that municipalities are compelled to appeal to the Railway Committee of the Privy Council in case objection is made by the railway company to permitting the drain to cross the railway track.

Your Petitioners would therefore pray that railway companies, even those declared to be for the benefit of the Dominion, be placed on the same level with other proprietors of lands under the Drainage Act of Ontario, with due provisions to safeguard the interests of companies with reference to the obstruction of traffic, etc.

The public are also inconvenienced to a very great degree by the refusal or delay of railway companies to make crossings for highways and streets over railways, cases having occurred where municipalities after years of correspondence were informed by railway companies that road or street crossings would only be made on condition of the corporation of the municipality paying the entire expense of constructing the crossings and signing bonds becoming responsible for all losses or damage occurring at these crossings for all time to come.

Your Petitioners would therefore pray your honorable bodies to pass such legislation as would compel railway companies to make suitable crossings at their own expense, without undue delay, for all roads and streets crossing their respective railway tracks.

Your Petitioners would also remind your honorable bodies that very great difficulty exists in the way of farmers getting farm crossings. Cases have occurred where farmers whose lands were divided by railways only obtained crossings after years of waiting and on signing bonds of indemnity to the company, and in many cases crossings have been refused altogether.

Your Petitioners would therefore pray your honorable bodies to pass

legislation which will compel railway companies to provide suitable crossings in all cases where farm lands are divided by railways.

And your Petitioners, as in duty bound, will ever pray.

APPENDIX D.

COMMUNICATIONS.

FROM THE PRISONERS' AID ASSOCIATION OF CANADA.

To the Warden of the County:

DEAR SIR,—

On behalf of the Prisoners' Aid Association of Canada, we desire respectfully to call your attention to the following recommendations which we are asking the County Councils of the Province to consider, so far as they are applicable to each County :

1.—The desirability of having a House of Industry, or Industrial Home or Refuge, established in every County or group of adjoining Counties in the Province.

2.—The County Jail so constructed and so managed that first offenders and persons awaiting trial shall be kept altogether apart from old offenders, and if at all possible separate from each other as well.

3.—The jail supplied with suitable books and other reading matter for the use of prisoners.

4.—The prisoners supplied with proper industrial employment every working day, so that there may be no idleness either in the jail or jail yard.

5.—A small sum of money placed at the disposal of the jailer or some society for giving a helping hand to discharged prisoners.

6.—That members of the Jail Committee and the Industrial Home Committee should be appointed for not less than two years.

7.—That an annual grant be made to the Prisoners' Aid Association to promote prison reform and to aid prisoners discharged from the Central Prison and the Reformatory for Women.

These principles have been repeatedly endorsed by both the Provincial and the Dominion W. C. T. U., and by the weekly religious press, as well as by nearly all the churches of Canada.

THE PETITION of the County Council of the County of Lambton,

HUMBLY SHEWETH :

THAT a great grievance, which vitally affects the well-being of the entire community, exists with reference to the rights of municipalities to construct or repair drainage works through railways. It is a well-known fact that it frequently costs more to construct a drain through or across a railway than it does to construct the whole balance of the drain, and it is also a grievance that municipalities are compelled to appeal to the Railway Committee of the Privy Council in case objection is made by the railway company to permitting the drain to cross the railway track.

Your Petitioners would therefore pray that railway companies, even those declared to be for the benefit of the Dominion, be placed on the same level with other proprietors of lands, under the Drainage Act of Ontario,

with due provisions to safeguard the interests of companies with reference to the obstruction of traffic, etc.

The public are also inconvenienced to a very great degree by the refusal or delay of railway companies to make crossings for highways and streets over railways, cases having occurred where municipalities after years of correspondence were informed by railway companies that road or street crossings would only be made on condition of the corporation of the municipality paying the entire expense of constructing the crossings and signing bonds becoming responsible for all losses or damage occurring at these crossings for all time to come.

Your Petitioners would therefore pray your honorable bodies to pass such legislation as would compel railway companies to make suitable crossings at their own expense, without undue delay, for all roads and streets crossing their respective railway tracks.

Your Petitioners would also remind your honorable bodies that very great difficulty exists in the way of farmers getting farm crossings. Cases have occurred where farmers whose lands were divided by railways only obtained crossings after years of waiting and on signing bonds of indemnity to the company, and in many cases crossings have been refused altogether.

Your Petitioners would therefore pray your honorable bodies to pass legislation which will compel railway companies to provide suitable crossings in all cases where farm lands are divided by railways.

TO THE HONORABLE THE LEGISLATIVE ASSEMBLY OF THE
 PROVINCE OF ONTARIO, IN PARLIAMENT ASSEMBLED :
The Petition of the Municipal Council of the Corporation of the County of

HUMBLY SHEWETH :—

1. That the duties to be performed by Municipal Officers before lands can be legally sold for taxes are so numerous, that with the frequent change of officers new to their duties, mistakes almost invariably occur. The courts seem to hold that unless these various duties are performed the tax deed will be set aside. The result is that these lands when sold fetch a very small price in proportion to their value ; that they are purchased in the majority of cases by speculators, who when they get tax deeds sell such lands to farmers and poor men, and give them conveyances without guarantee of title. Subsequently actions are brought against these farmers and poor men, because of the irregularities committed by Municipal Officers, and tax deeds are set aside. In almost every case these tax deeds, when attacked, are set aside and the occupants ejected.

2. Among the acts to be performed and duties to be discharged by Municipal Officers the following may be mentioned :—

(a) By section 7 of the Assessment Act, unoccupied land shall be denominated "Lands of Non-Residents" unless the owner thereof has a legal domicile or place of business in the local municipality where the same is situate or gives notice in writing setting forth his name, place of residence, and post-office address, to the Clerk of the municipality, on or before the 20th day of April in each year that he owns the land, etc.

(b) Now two difficulties present themselves. The notice is not to the Assessor, but to the Clerk. It may simply be a letter and get mislaid. The Clerk prepares both rolls, resident and non-resident rolls, (see secs. 119 and 121), and the Assessor fills them up as he goes his rounds. (Sec. 14.) He finds lands unoccupied, the owner of which may be a resident, but he does not know him. The owner if resident outside the municipality may have notified the Clerk that he owns the land, but the Clerk may not notify the Assessor. The Clerk may notify the Assessor, but verbally, and the Assessor may say he never was notified by the Clerk. One can put the blame on the other.

(c) Then suppose the outside owner does give the Clerk notice under Sec. 3, and the Clerk notifies the Assessor, and the Assessor puts him on the resident roll, but next year the owner gives no notice, and there is a new

Clerk or perhaps a new Assessor, and he finds the lands unoccupied, next year he is put on the non-resident roll, etc., etc.

(d) Again, when the Assessor returns his roll, the Clerk shall examine it and forthwith furnish the County Treasurer with a list of unoccupied lands. But after this list goes, the owner of unoccupied land can apply to the Court of Revision to have his name put on the resident roll (see Secs. 4 and 143.) The Clerk having sent the County Treasurer his list forgets or omits to correct it, and the land goes to sale.

(e) Now as to the Collector (see Sec. 125). In a case such as above, the Collector, in the year that notice was given by the owner, should transmit to him by post a notice and statement of his taxes. He may forget or he may do it and have since left the county, and the owner may say he never got such notice, and to sustain the title the purchaser must prove it.

(f) Then as to next year, no notice being given and the Assessor finding the land unoccupied assesses it as "non-resident," and it goes on the non-resident roll, and the Collector finding the land unoccupied and being unable to make the taxes, is to deliver to the Treasurer of the municipality an account of the taxes remaining due on the roll, etc., and furnish the Clerk of the municipality with a duplicate of such account, and the clerk shall mail a notice to each person appearing on the roll, etc. (See Sec. 135.)

(g) Then again, the Treasurer of every county shall furnish the Clerk of each municipality (except cities and towns) in the county with a list of all the lands in his municipality in respect to which taxes have been in arrears for three years next preceding the First day of January in any year, etc. (See Sec. 140.)

(h) Then such Municipal Clerk is to keep such list on file in his office subject to inspection, etc., and deliver a copy of it to the Assessor when appointed, and the Assessor is to see if any of such lands are occupied, etc., and he is to notify the occupants, and also the owners thereof if known, whether resident within the municipality or not, that the land is liable to be sold for taxes, etc., and such lists shall be signed by the Assessor, and the Clerk shall file them in his office and at once furnish the County Treasurer with a true copy certified under the seal of the corporation, and the Assessor shall attach to such list a certificate signed by him and verified by oath or affirmation, etc. (See Secs. 141 and 142.)

(i) Then the Clerk of the local municipality shall examine the assessment roll when returned by the Assessor to see if any such land is occupied,
