

"ROUGH" BEEF KEPT FOR THE PEOPLE OF THE WEST

SHIPPERS STATE THAT THE CHOICE CATTLE ARE EXPORTED AND THE INFERIOR BEEF RESERVED FOR HOME CONSUMPTION—CONFLICT OF OPINION AS TO WHETHER COMPETITION EXISTS AMONG BUYERS—BETTER PRICES PAID FOR INTERIOR AMERICAN CATTLE.

Special to The Leader. LETHBRIDGE, Alta., June 12.—The provincial beef commission arrived from Medicine Hat and commenced its sessions at Lethbridge this morning. The first witness was T. Freeman Crofts, local manager for the P. Burns and Co., who stated that his beef was obtained locally, while mutton came from all over. He gave a detailed statement of meat prices, and also five weight, stating that a 1,200 pound steer should dress 600 pounds. He paid \$27.50 to \$40 for steers. Local prices for cattle were regulated by competition among buyers, but chiefly by the foreign markets. He claimed he came in contact with competitors locally and from Taber, Pincher Creek and the Crow's Nest. There was no uniform price that he had heard of. Howell Harris, manager of the Circle Ranch, with 2,000 to 3,000 head, said he had sold to P. Burns and Co. for the last ten years because Burns would take both choice and rough, while Gordon, Ironside and Fares or other exporters would only take export cattle, leaving the rough on his hands. Burns sometimes exported the choice, but offered to sell them to Gordon, Ironside and Fares for export. In either case the rough was consumed in this country.

PURCHASE LAND TO OBTAIN WATER

INDIAN HEAD COUNCIL BUY SECTION IN THE SQUIRREL HILLS.

(From Our Own Correspondent.) INDIAN HEAD, June 12.—Twenty men left for the Squirrel Hills on the C. N. R., north of the town, and claim to have today commenced work on the waterworks extension. They are mostly Englishmen who claim that the pay on the C. N. R. is too low in comparison with that paid here. C. F. Seiber, manager of the Union Bank, left this morning for Winnipeg where he will be married this evening to Miss David of Fort Rouge. Work has now begun extending the water and sewerage systems along Water street. The gangs are now at work on three of the principal streets of the town. The town council has settled all disputes with the Brassey & Tate Co. by purchasing a whole section of land about eight miles south of the town. This is the land that holds the much coveted and valuable Squirrel Hills springs from which the town draws its water supply. The price paid was \$25 per acre, which is considered much cheaper when paid for the land than for lawsuits. Mayor Donnelly and councillors Campkin and Boyd were a committee to put the deal through and it is now completed. Several offenders against by-law No. 9, which forbids riding bicycles on the sidewalks of the town come up tomorrow. The council seems determined to put an end to this practice. Miss McCallum, first soloist and choir leader in the Presbyterian church, has resigned her position. The resignation is to take effect in August. Her successor has not yet been appointed. We understand that it is possible the Methodist church may be granted a license for the increasing number of worshippers. The building as it is now is much too small. The Baptists have now taken possession of St. Andrew's church, having held their services there on Sunday. Arrangements are now in preparation for the annual regatta at Lake Kate, north of the town. It will take place early in August.

REGINA MEN DEPRIVED OF THEIR RIGHTS

NEW ASPECT OF ROBLIN GOV. DENIES ACTION IN CASE.

Special to The Leader. REGINA, June 12.—The superintendent of home mission work in the West to have charge of the field in British Columbia. The synod of Alberta asked the Assembly to provide at Carleton Place a school for education of non-Mormon children. Mormonism is making itself so felt that in that place non-Mormon people cannot get a non-Mormon teacher in the schools. Only the church counting to the relief of the situation can help the disadvantage to be overcome, as any government movement would result in separate school squabbles. The request was reported. The presbytery of London overtook the assembly as follows: "In view of the correspondence which has appeared in the public press respecting the Mormon question, more the presbytery of London, respectfully overture the General Assembly as follows: Whereas the presence of the Mormon element in the Northwest is a serious menace to the morals of our land, and whereas the people of the United States have for years suffered very seriously from the same element, this presbytery overtures the General Assembly to take such action as will arouse the whole church to the peril of these parts of the Dominion; and that at the same time approach the other branches of the Christian church in Canada with a view to taking joint action in the matter." The overture was adopted. Dr. Somerville, of Toronto, who has been interim treasurer of the Presbyterian church board of trustees, Western section, since the retirement of A. S. Weir, was selected by the committee of the Assembly (interim) for the post of permanent treasurer. This decision is practically certain to be accepted by the Assembly, in addition to which the committee will recommend the appointment of a field officer to visit the congregations with a view to promoting the schemes of the church. After a long discussion the Assembly approved the establishment of a theological college in British Columbia to open session in the summer of 1908. In response to overtures from the West, it was decided to appoint a special mission superintendent for British Columbia. At present one superintendent has charge of both Alberta and British Columbia.

BANQUET TO W. E. KNOWLES, M. P.

MOOSE LAW CITIZENS GIVE NON-POLITICAL BANQUET IN HONOR OF MEMBER FOR WEST ASSINIBOIA—MR. KNOWLES SPEAKS ON PATRONAGE AND PROGRESSES THAT CANADA WILL REAP FROM THE EMPIRE.

Special to The Leader. REGINA, June 12.—The citizens' banquet to Mr. W. E. Knowles, M. P., tonight was the greatest event in the history of the city and one of the greatest in the most recent history of the province. The banquet was altogether non-political and was attended by over two hundred leading citizens, while the large gallery was thronged with ladies. Mayor Bunnell presided and W. B. Willoughby was vice chairman and the toast list brought forth splendid speeches on the great questions of the day. Mr. Knowles, on rising to respond to "our guest" was cheered to the echo and it was several minutes before he was permitted to proceed. He made a very able speech in which he dealt briefly and conclusively with questions not only of importance to his own constituents but to the country as a whole. The speaker became a national unity in developing the power of assimilation, immigrants who have been placed in the position of above all the problem with which the country has to deal. He believed that it would only be by the aid of the West that the great boon to the West and would greatly relieve congestion. He was in a position to say that a definite contract would be laid before the people within twelve months with regard to this railway. The speaker advocated the development of a Canadian national spirit. The East, he thought, had perhaps more to learn in this regard than the West. Emigrants insist on the preservation of our present tariff which is beneficial to the Eastern industries; to the hindrance of the West. Yet the East does not wish to assist in the building of the Hudson Bay railway, saying that it benefits only the West. There should be a national unity in developing the country. The speaker offered "the humble prophecy" that the time was not far distant when Canada will take a larger status than that of a colony of the Empire. The speaker said that the British will take its place among other nations of the world. Mr. Knowles did not wish to be understood as favoring such a move, but he simply ventured to state what he thought was being said by the speaker.
