# MINUTES.

# SOUTHAMPTON, York County, July 4, 1863.

THE Thirty-first Annual Meeting of the Free Christian Baptist General Conference of New Brunswick assembled at Southampton, York County, this day, at 10 o'clock, A. M. As usual our first meeting was a General Conference meeting, when the Lord's people spake freely to each other of their christian experience, and their hopes of heaven. This meeting was largely attended, and was a season of unusual interest. Many hearts warmed with love for the Saviour, while they heard others rejoice in his mercy.

At 2 o'clock, P. M., met again for the transaction of business. After opening the meeting with singing and prayer, Elder Benja-

min Merritt was unanimously re-elected Chairman.

The Conference being organized, and the names of the members present read by the Clerk, the Corresponding Secretary was called upon to read his Annual Report, which was as follows.

#### ANNUAL REPORT.

BRETHREN, HONOURED AND BELOVED IN CHRIST-

Another year is gone; and by the index of our progression to eternity, we are impressively reminded of the brevity of human life, and the rapidity with which we are passing away. Our lives, with their increasing solemnities and responsibilities, are hastly growing shorter. The time has come when we are again permitted to meet face to face in another Annual Meeting.

Devoutly recognizing the hand of a wise and superintending providence in thus permitting us, so favourably, to meet in this, our Thirst-First General Conference, we sincerely pray that we may be presided over by Him whose law is love; and that while our souls may be refreshed by the renewal of Christian affection, we also be especially blessed, and wisely directed, in all our doings and deliberations; that our coming together may result in increasing the spirituality of our ministry, the purity of our Churches, and the efficiency of our entire denominational interests.

Like many of its predecessors, the last year has been marked by the various vicissitudes of unerring wisdom among the nations of the earth. In some directions peace has prevailed, and liberty and christianity have steadily progressed; in others, national commotions and cruel wars have raged to a fearful extent, and, for the present, seem to have militated against the prosperity of religious enterprizes. But whatever has been the conflicts and changes among the nations, our confidence in the rectitude of the Divine government, remaineth sure; while the exemplified utility and purity of our holy christianity more ardeatly endears it to our hearts. While "clouds and darkness are around about Jehovah, righteousness and judgment are the habitations of His Throne."

protection of a national government, whose sound constitution, and the administration of whose wholesome laws, secure to us the glorious blessings of a civil and religious liberty, which, if not superior to, are fully equal to those enjoyed by any people on the earth. Proportionate to our liberties and opcortunities to do good, are our responsibilities to God, and our obligations to our fellow man, which, we trust, will not be forgotten by us, either in our individual or associated capacity.

By the closing of our ecclesiastical year, I am reminded of my official duties in preparing and presenting to you another Annual Report of the doings and

prosperity of our beloved denomination.

Although we may justly feel humiliated under a consciousness of our great lack of consecration to God, and the feebleness of our efforts to advance the interests of the cause of Christ; yet to His praise be it said, as in former years, we have been made the instrumentality of doing some good. Each year some precious souls, who have been converted by our labours, have passed away to be with Christ, which is far better; and others have become heaven-bound pilgrims. During the last year, a number of our Churches have been blessed with gracious seasons of refreshing from the presence of the Lord; and to quite an encouraging extent, we can say our efforts have been crowned with success. True, not so much as in some former years; but enough to cause us to "thank God, and take courage." There are some things amongst us yet, over which we feel to mourn and lament; but I am happy to be able to say, that one very grievous burden, to which we have had frequently to allude, has become very much lessened, and we hope will, ere we separate, be so annihilated that we shall feel it no more. I refer to our denominational debt. It is to be hoped, that by the providence and Spirit of our God, we shall speedily be purified from every thing that tends to hinder our usefulness and impede our progress as a body of Christians. We need to be kept humble and pure minded, to prove faithful to the important trust committed to us, else our light will grow dim, and our salt lose its savour.

During the year, the mercy of God has been towards us in preserving the lives of all our ministers; and while death has entered many of our households, it has not been permitted to remove from the walls of our Zion any of her watchmen:

Of our First District, which embraces our most northerly Churches, I know but comparatively little. Last year, our interest and influence there were re-ported as steadily increasing, which I hope is still the case. Its Annual Meeting was held with the Church on the Tobique river, last August. Elder McMullin has spent a part of the year with a portion of these Churches. Elder Orser has also laboured with two or three Churches in this district. Elder Curry, who lives in this district, has also laboured some within its limits,

The Second District embraces the Churches on both sides of the St. John river, from the lower end of the first district, down to Woodstock. It held its river, from the lower end of the first district, down to Woodstock. It held its last Annual Meeting in October, with the Church in Upper Brighton. Several of our ministering brethren reside within the limits of this district. Elders Hartt, McMullin, Siprell, Orser, Doucett, White, and Parsons, all live there. Some of them have spent the whole year in labour, with these Churches, while others have travelled more, and visited other districts. A number of the Churches of this district have been blessed with good seasons of revival, and large accessions. The first Church in Wakefield has had the labours of Elder White one half the time. This Church, though reported last year in a low state, has been much revived and blessed. God has made the labours of brother White of great good to them. Last fall they were blessed with a season of revival, when brother Parsons united with brother White, and the Lord working by them, reclaimed many backsilders, and converted many sinners. Twenty-four were baptized by brother Parsons, and added to the

Church. Brother White also laboured with the second Wakefield Church one half his time. The Church in Woodstock has had the pastoral labour of Elder Parsons the whole year, and has had a year of uninterrupted prosperity. At Upper Woodstock, where we have for several years had quite a number of brethren and sisters who have regularly kept up meetings, and have had statel preaching, brother Parsons was blessed to see his efforts crowned with the fayour of God. Several old backsliders were reclaimed, a number converted, twelve baptized, and a Church of thirty-one members organized, known as the second Woodstock Church. A number have been added since.

The revival extended to the first Woodstock Church, where, for several weeks, brother Parsons laboured in special services, and saw much good effected. The Church was much strengthened, and many converted. It was a work of power. Brother Parsons haptized thirty-four, who, with one other,

were added to the Church.

Elder Hartt has laboured with several of these Churches under pastoral engagements, with good results. At Upper Presquile, the Lord gave him to see a blessed work of grace; the Church was strengthened, several reclaimed, and many sinners were converted to God. He baptized twenty-seven, who, with three others, were added to the Church. At Peel, the Church was much encouraged, and three were baptized by brother Hartt. The Church at Williamstown has also been encouraged, and things have been much revived. "At Knowlesville, brother Hartt also saw good interest. He baptized two, and organized a Church of fifteen. Elder McMullin, who has visited and laboured with some of these Churches, also visited Knowlesville, and saw a good interest. He baptized nine. In the Palmer Settlement Church, there was also a good season of refreshing, and a good number were converted. Elder Mullin baptized fourteen there.

The Third District extends down the river, embracing the Churches from Woodstock to Fredericton; within the limits of which, we are assembled today. Several of these Churches have been without pastoral labour during the whole year; and some of them have had but very few ministerial visits.

The Church in Fredericton has had the labour of Elder McLeod, and is in a cod state of efficiency. Elder Gunter has laboured with the Churches at Douglas and Nashwaak. Elder Kinghorn, with the Churches on the Nashwask, in connection with Elder Gunter; also at Kingsclear and the Ferry. Elder Curry, with the Churches at Canterbury and Lower Southampton. In Canterbury, the Lord blessed his labours, and gave him to see some revival. Brother Curry baptized ten. Elder Rattray made an engagement with the Church worshipping in this house; but in consequence of ill health, was unable Church worshipping in this house; but in consequence of ill health, was unable to continue his pastoral labours, and has been unable to preach regularly for several months. Brother Thomas Vanwart has laboured in this district. We trust the Gospel preached by all these brethren, will be like seed in good ground. I do not know of any revivals, or a single beptism in this district during the whole year, except those mentioned by brother Curry. Three Churches which were organized previously to our last General Conference, were received into this district at its Annual Meeting in October last. A number of these Churches must be sustaining loss for the want of public labour; and our ministering brethren, who can will do well to resugnifier this nat of and our ministering brethren, who can, will do well to remember this part of

The Fourth District extends from Fredericton down to Upper Hampstead, including the Churches on the Oromocto. The last Annual Meeting of this district, was held with the Church on the South Branch of Oromocto, in October. These Churches have had but very little labour, except that expended toper. These Univenes have had but very nittle indow, except that expended by Elder Pennington. He has spent the year in the branches of the Oromoto, Geary, Rushhgonish, and thereabouts. In some of these places there has been revival interest, and brother Pennington has baptized eight in the district. Short visits have probably been made to others of these Churches; but I do not know what more I can report. Labour is much needed.

The Fifth District comprises the Churches from Upper Hampstead down to St. John; but does not, since the formation of the Seventh District, include

those of the City. Elders Merritt, French, Conner, and McKenzie live fir this district, and have expended their labours during the year mostly within its limits. I think all these brethren have had engagements with these Churches; and beside their labours, they have been visited by Elders Taylor Taylor spent a few weeks with the Churches in Hampstead, and saw some coming up, and blessing among the people. He baptized eight during his visit. Brother Downey made a visit to Jerusalem, and the Lord gave them to see good effected. This Church had been low and in trial. The difficulties were much removed, wanderers reclaimed, and a number professed faith in Christ. He baptized twenty. Elder Conner has had the pastoral care of this Church, and has laboured to profit amongst the people. Brother McMullin's labours resulted in good. He baptized two at Hampstead, and one on the eastern side of the Long Reach.

The Sixth is our most easterly District, and embraces all the Churches from Middle Land to Taylor Village. Some of these Churches have enjoyed seasons of revival, while others have been in a weakly state. The District Meeting was held with the Church at Coverdale in February last, which was followed by a powerful work of revival. Elder Downey and Deacon Clark laboured several weeks, and the Lord greatly blessed their efforts in reviving the interests of the Church, and in the conversion of sinners. Our denominational terests of the change and an abstract of the district. Brother Downey bap-tized forty-four. This district raised a missionary fund to support missionary labour among its own Churches. Brother E. Garraty was employed by them for a month or two, and laboured to much profit, especially with the Church at Dover. The Lord blessed his labours with revival. Elder Pennington assisted him a few days, and baptized nine. Elder Hartley also spent one week with them, and baptized twenty-four. Elder Dobson has laboured under pastoral engagements with this and a number of other Churches, and has baptized ten in the district.

Elder Wallace has also spent his time within the limits of this district, and has baptized twenty during the year. Elder Knellin has laboured with the Church at Middle Land and Bellisle Creek, with profit. Elder Wayman, who is this district, has been unable to preach nearly all the year, in consequence of ill health. It is a great satisfaction for us to know that this aged minister of the cross has, during his illness, enjoyed continued peace in his soul, and communion with his Saviour. A new meeting house has been finished and opened for the worship of God, and a Church organized at

Trishtowh.

The Seventh is a new District, which was organized in Compobello, in November last, and embraces the Churches from St. John to Grand Manas. This new district was organized with much hope and promising prospects. It was hoped, that by this step, our Churches on the Island, and in that lower part of the Province, would be profited, which there can be no doubt will be the case. The presence of the Lord was especially enjoyed during the entire session. Several important resolutions were passed, and quite a fund raised for missionary purposes; a part of which has been profitably expended in the district. Elder Freeman Babcock, a minister of the Christian Band, and who resides on the Island of Campobello, was received into fellowship with the district, and recommended to this Conference. A good season of revival was enjoyed by the Church; and brother Taylor, who is pastor of the Church, baptized eleven; brother Babcock, six; and Elder Johnston, of the Christian on the upper part of the Island twenty-five baptized by Elders Mallock and Johnston; and a branch Church was organized by Elders Mallock, numbering about forty. In all, fity-two were baptized on the Island.

On Grand Manan, brother Banes has enjoyed a year of continual prosperity. Immediately after our last Conference, brother Banes went to the Island, where he has spent the entire year. God has especially owned and blessed

his labours. Our interests have been very much extended through the whole Island. A branch Church has been organized; three new meeting houses have been commenced, and brother Barnes has baptized eighty-nline; with two others, by brother Babcock, and one by brother Taylor—making in all, ninety-two. The interest continues good, and the prospects are very encouraging. Our brother has laboured very hard during the year, and has seen an abundant harvest. To God be all the praise.

The Church in St. John has enjoyed the labours of Elder Downey. Elder Hartley laboured in Carleton, and saw some revival last winter. He baptized eleven. Elder Perry, who lives in St. John, has made a few visits to Churches in the country. The Church at Beaver Harbour has been blessed with some revival interest. Five have been baptized by Elder Johnston, and a meeting

house has been commenced.

I have thus, dear brethren, endeavoured to give you some account of the labours of our brethren, and their more immediate results during the year. Much, no doubt, might have been named, that I have no knowledge of. We know that much seed has been sown—the fruits of which, we have not yet harvested; but which, we hope, will bring forth abundantly. The cause of temperance is prosperous in some districts; while in others, its interests are too lightly regarded. Sabbath schools exist in all the districts, many of which are in a very efficient state; but as committees will be appointed to report on both these causes, I will leave that work to them.

The whole number haptized and added to our Churches, is four hundred and fifty-five. The state of many of our Churches loudly call upon us to make fresh efforts to supply them with more ministerial labour. I think resolutions respecting finances, and other matters of importance, were passed in several of our District, Meetings, to be recommended to this Conference, which, I trust, will enable us to do something in the care of our Churches that will be per-

manent and saving.

In conclusion, allow me to say, that as Churches, we owe important duties to the communities in which we are located, and to our country in general. Churches should be separate and model societies; and just in proportion as they have the Spirit of Christ, they are such. They are the light shining in this morally dark world; the leaven in the meal; the salt in the earth—sustaining and advancing whatever things are true, honest, just, pure, holy, virtuous, praiseworthy, and of good report. And we say, God forbid that we should ever be satisfied with any thing short of worshipping Him in spirit and in truth ourselves, and declaring to our fellow-men the true character of God our Saviour, and seeking the highest earthly and heavenly good of our neighbours.

With a sincere prayer that He who has planted us, and hitherto been our guide, will still be with us, making us useful and happy in life, and ultimately bring us off more than conquerors, when in joy and bliss we shall sing the praises of the Lamb for ever and ever, I submit to you my Annual Report.

### REPORTS.

The following is the Report of the Committee appointed on SABBATH SCHOOLS.

We, the Committee on Sabbath Schools, beg leave to Report-That we find the system of reporting to the District Meetings, and from those again to the Conference, to be so imperfectly carried out as not to convey all the information which is really desirable on so important a subject. For this reason we can only state as an approximation that the whole number of Sabbath Schools in connection with our denomination in the Province is about 37-two of which are in the first District, seven in the second, four in the third, five in the fourth, eight in the fifth, five in the sixth, and six in the seventh. Some of these appear to be in a very flourishing state, while others, once prosperous, are now evidently lacking some of those essential elements of interest and progress upon which the advancement of the institution depends. We are fearful that some of our Elders, and other public and influential brethren, do not take as deep and active an interest as they ought in this good cause; and that this is one of the reasons why so many places are deprived of the advantages which Sabbath Schools are so well calculated to supply. We believe that this denomination should be more deeply engaged in sowing the seeds of instruction through this divinely appointed instrumentality; and that the fruit of the seed thus sown will be gathered in well filled sheaves into the garner of the Lord. We therefore recommend—1st, That this Conference enter more diligently into this heaven-approved work, by adopting such measures as will best secure the organization and efficient working of Sabbath Schools in connection with all of our Churches; and, 2nd, That in addition to the Statistical Report of the Churches, the Sabbath Schools be statistically and fully reported by a delegation from the Churches to the District Meetings.

### TEMPERANCE.

The Committee on Temperance reported as follows:-

Your Committee believe Temperance to be a very prominent principle of the religion of Jesus Christ, a very precious fruit of the Holy Spirit of God in man, a principle that Jehovah has distinctly taught and written in the Bible, and therefore consider that it cannot but triumph at last over the lusts and passions of the flesh.

We, therefore, in accordance with these views, believe it to be the imperative duty of every denomination claiming purity of heart and life, to see to it that its membership maintain well the principles of Total Abstinence from all intoxicating drinks.

In the second place, we believe it to be our duty as a Christian denomination to enforce pure Gospel discipline in every instance where this Christian grace is violated and set at naught by the use of inebriating beverages; and, further, that we cannot help doubting the genuineness of that man's religion which does not restrain him from running into

As it regards the traffic in intoxicating or alcoholic drinks, your Committee deem it their duty to utter their united testimonies of disapprobation against it, believing that it is productive of nothing good, neither indeed can be; a business which we cannot possibly tolerate in our Churches by retaining as members those who may be engaged in it (if any there be), but most earnestly demand their immediate expulsion after proper Gospel labor.

We condemn it not only because of its sad and fatal consequences to those victims who partake, but also upon the premises that the glass of liquor is not an equivalent for what is received, and therefore must be discontinued by Christians as a dishonest and disreputable occupation.

#### MINISTERIAL LABOR.

The following is the Report of the Committee on Ministerial Labor and Missions:

Your Committee on Ministerial Labor and Missions beg to submit the following Report.

We may be permitted to say that we have found it difficult to arrive at anything very definite that we think would be practicable at the present time. We are of the opinion that the circuit system would be the best plan that could be adopted; but after consideration have deci-

ded not to recommend it this year.

Many of our Churches are suffering from the want of pastoral labor, and we do earnestly recommend that all our Churches raise a fund in some systematic way, and where a number of Churches are located near each other, they unite and secure the labors of some minister as a pastor. We also recommend that this Conference send out one or two Missionaries to labor with those Churches who are not able to secure pastoral labor. To assist in raising means for their support, the Missionaries should do all they can where they labor, and be especially careful in collecting the twenty-five cents from each member of the Churches as required by Conference; also, that the pastors of Churches be particular in collecting the same Conference fund-twenty-five cents

A proposition was then made by those on the 3rd tier, that the members of the Committee be twelve; but subsequently they were willing to reduce the number to six. This was objected to by the 2nd tier. Another proposition was made by those on the 2nd tier, in which they were unanimous that the whole matter of dispute be referred to the Surveyor General, and that his decision be final. The 3rd tier, after

considering the proposition one week, declined accepting it.

Your Committee deem it proper to state here that a difference of opinion exists between the 2nd and 3rd tier, as well as between those on the 3rd tier and your Committee, as to whether it was the intention of the General Conference, in the resolution governing this matter, to refer the entire matters of difficulty both of Church and estate, or only the question of dispute in land. Those upon the 2nd tier, as well as your Committee, were of the opinion that it only embraced the question of dispute in land, especially as non-professors of religion were eligible to sit on the Committee. Your Committee were strengthened in their opinion by the impropriety of referring matters of Church discipline to such a Committee. Consequently the question was narrowed down to the difficulty between the parties about land, and to those persons only who were directly interested therein.

Your Committee being unsuccessful in reconciling the parties in difficulties, in consequence of the disagreement and misunderstanding referred to, beg to refer the matter back to this General Conference, to be deals.
