

To grant further powers to The Montreal Fire, Life and Inland Navigation Assurance Company, and to change the name of the said Corporation.

An Act to grant further powers to The Montreal Fire, Life and Inland Navigation Assurance Company, and to change the name of the said Corporation,

WHEREAS The Montreal Fire, Life and Inland Preamble. Navigation Assurance Company have petitioned that certain further powers hereinafter mentioned be granted to them, and that the name of the said Corpora-5 tion be changed as hereinaster set forth, and it is expedient to grant the prayer of the said Petition: Be it therefore enacted. &c.

And it is hereby enacted by the authority of the same, Name of the That the Corporation established by the Ordinance of the Company 10 Governor and Special Council of the late Province of Lower Canada, passed in the Session held in the Third

and Fourth years of Her Majesty's Reign, and intituled, "An Ordinance to incorporate certain persons therein men-Ord., 3 and 4 tioned under the name of The Montreal Fire Assurance Vict., c. 37.

15 "Company," and to which Corporation further powers were granted by the Act of the Parliament of this Province, passed in the sixth year of Her Majesty's Reign, and intituled, "An Act to grant further 6 Vict., c. 22. "powers to the Montreal Fire Assurance Company, and to

20 "change the name of the said Corporation," by which last mentioned Act the name of the said Corporation was changed to The Montreal Fire, Life and Inland Navigation Assurance Company, shall, from and after the passing of this Act, be known and designated as The Montreal New name.

25 Assurance Company, but its powers, rights, obligations and liabilities, shall not be altered or affected by such change of name, except as expressly declared by this Act, nor shall any action, suit or proceeding by or against it, be thereby abated, discontinued or interrupted.

And be it enacted, That it shall be lawful for the Powers of the said Corporation to make contracts and grant Policies of Company extended to Assurance against all losses or damages to ships, vessels, Marine Insursteamboats, barges and other craft or floats of what kind ance. soever, navigating within or without this Province, and in

35 making voyages from any port or place in this Province, to any port or place without this Province, whether within the dominions of Her Majesty or otherwise, and vice versâ, and in making voyages from any British or foreign port or place, to any port or place within this Province or else-

where, and against all losses or damages of or to the cargoes or property conveyed in or upon such ships, vessels, steamboats, barges, craft or floats, and the freight due or to grow due in respect thereof, or to timber or other property of any description conveyed in any manner, and generally to do all matters and things relating to or connected with Marine Insurance.
