A report from the Altar Guild was unfortunately omitted from a previous number of the Monthly Notes. Six new members have been added to the list of workers. The receipts for year were \$53.50 and expenditure \$40.25. Receipts for November \$3, December \$4.70.

Mr. E. O. White, an old friend of the Cathedral, has most generously presented to every officer, teacher and Scholar in the Sunday School, about 300 altogether, an exceptionally good large photograph of the late Archbishop, bearing his crozier as Metropolitan.

The Gas standards in the Chancel were a gift which was intended to be recorded by a suitable inscription. This however has been delayed by the death of one donor and absence from Canada of the others, but the intention was always borne in mind, and the inscriptions were recently engraved on the standards. One is inscribed "The gift of Alexander James Burrowes Close and Isabella Burrowes Close his wife," with a shield of the arms of Close impaling Benson; the other, "The gift of William Patrick Burrowes Close and Clara Harvey Burrowes Close his wife," with a shield of the arms of Close impaling Lough.

The desk in the Library, made many years ago by the late Archbishop with his own hands has been given to the Cathedral by Mrs. Sweatman and her family, who have also desired that the late Archbishop's official seal shall be kept in the Library with that of Bishop Bethune which has been preserved there.

A meeting of the Cathedral Chapter was held on 1st March to make arrangements in connection with the Consecration of the Bishop-elect on the 25th inst. The Consecration is to take place at St. James', in the forenoon, and the Installation and Enthronement at St. Alban's later in the day, probably in the evening. With regard to the latter ceremony we are obliged again to ask the forbearance of our people, for these being official ceremonies provision must necessarily be made for persons and representatives who will attend officially, leaving but little space available for members of the ordinary congregation. Let us hope that the day is not far distant when our ability to accommodate numbers will be materially increased.

At this meeting the following resolution was passed by a standing vote

Resolved—That the Chapter do tender to the Venerable Archdeacon Sweeny their most sincere congratulations on his election to the Episcopate of this Diocese, observing with satisfaction that such election was by practically unanimous vote; and that they pledge themselves to aid him with loyal support in carrying on the administration of the Diocese, and with their prayers that both at this time and at all times hereafter he may have such Divine blessing and guidance that his Episcopal acts may in all things be for the prosperity and advancement of the Church and the glory of God. And they hope also that he may be so guided and furthered in the extension and establishment of this Cathedral building that as the parts of it now erected stand as a monument to the memory of our late Diocesan, so may the episcopate of the now Bishop-elect be rendered memorable by its extension.

Reports of the Annual Meetings and Election of Officers of the W.A. branches were received too late for the present issue and are held over till April.
