## Rules of the Association.

1. That the Association be called the DOMINION OF CANADA ARTILLERY ASSOCIATION, and have for its object the development of Gunnery skill, and the dissemination of Artillery knowledge throughout the Dominion of Canada.
2. That the annual subscription for individual members be *two dollars*, which will give the right of voting at any regularly organized meeting, other than a meeting of Council. The donor of *twenty dollars*, in cash, at any one time, or a prize of not less value than *forty dollars*, to be competed for at a general prize meeting, may be elected a life member.
3. That any Canadian Artillery or Engineer Corps, the Royal Military College Cadets, and the Artillery detachment of the Northwest Mounted Police Force, subscribing not less than *ten dollars*, per Field, and *six dollars* per Garrison Battery, per annum, may become affiliated to this Association, and shall be entitled to a number of memberships in the proportion of one for each two dollars thus subscribed, the officers of each subscribing Battery to select from amongst themselves the person to hold such memberships and return their names and addresses, when selected, to the Secretary, to be registered by him previous to the Annual General Meeting.
4. The affairs of the Association to be managed by a Council to consist of *ex-officio* members and such officers on the Active or Retired lists as may be elected annually at a General Meeting. The Hon. the Minister of Militia and Defence; the Deputy Minister of Militia and Defence; the Major-General Commanding; the Adjutant-General; the Inspector and Assistant Inspectors of Artillery; the Deputy Adjutants-General of Districts, and Brigade Majors; All Officers Commanding, and Regimental Field Officers of Artillery Brigades; Officers Commanding Affiliated Batteries and Engineer Corps; the Director of Stores; the Commandant and Professors (being officers), Royal Military College; Military Secretary to the Governor-General, and President Dominion Rifle Association, shall, if members of the Dominion Artillery Association, be *ex-officio* members of Council. The Secretary and Treasurer shall likewise be *ex-officio* a member of the Council.
5. The Governor-General of the Dominion and the Lieutenant-Governors of the Provinces shall be respectfully requested to become Patron

and Vice-Patrons, respectively, of the Association; and at any General Meeting of the Association other names may be added to the list of Vice-Patrons.

6. A General Meeting of the Association shall be held annually, on the third Thursday after the meeting of Parliament, to receive the Annual Report of the Secretary and Treasurer, and to transact general business. No alteration of the Rules of the Association shall be made, excepting at such meeting. Twenty-one days' notice of any motion involving such alteration shall be given in writing by the member intending to propose it at the General Meeting to the Secretary, who shall forward it immediately to every member of the Association; and the notice shall be also published in two issues of the *Canadian Militia Gazette* prior to the Annual Meeting of this Association by the Secretary or other person authorized to act on his behalf—so long as such paper is published.

7. The office bearers shall consist of a President and four Vice-Presidents of the Association, to be elected annually at the Annual General Meeting of the Association, and a President and four Vice-Presidents of Council and a Secretary-Treasurer to be elected annually at the first meeting of the Council next after the Annual General Meeting. The Council shall have power to fill up vacancies occurring subsequently. There shall be also an Executive Committee to consist of the Inspector and Assistant Inspectors of Artillery, with two officers to be elected by the Council from among its members at the Meeting of Council after the Annual General Meeting, of which the Inspector of Artillery shall be chairman, to the charge of which Committee shall be entrusted all technical artillery matters and carrying out of annual competitions, appointment of umpires and the arrangement of details in connection therewith, three to form a quorum. The members of the Executive Committee to be eligible to any office and to report to the Council.

8. At all General Meetings of the Association the chair shall be taken by the President, in his absence by the senior Vice-President present, and in the absence of all the Vice-Presidents by the President of Council, and so on.

9. At all Meetings of Council five shall form a quorum, all questions shall be decided by the vote of the majority, and the chairman shall have a casting vote when the members are equal.

10. Ordinary meetings of Council shall be held on the day previous to, and immediately after the Annual General Meeting.

11. Extraordinary Meetings of Council shall be summoned by the Secretary when required by the President of Council, at such places as the President may direct, either at his own discretion, or upon the request, in writing, of six members of Council, of at least three different corps, duly qualified to vote at such meeting, one of whom shall be a Vice-President, notification being sent to each member of the Council at least fourteen days previous to such meeting, and the requisition for the meeting and the notices to the members must state the object, or objects, of such meetings. Members of Council shall be permitted to send a written vote to the Secretary upon subjects to be discussed at such meetings.

12. All subscriptions, other than through affiliation, to the Association shall become due on or before the 1st May for the current Association year, and the treasurer shall be required to deposit all sums of money paid over to him on behalf of the Association, in a Savings' Bank.

13. Two Auditors shall be appointed annually to examine the Treasurer's Accounts previous to the Annual Meetings.

14. The payment of money for current expenses must be authorized by the President of Council or in his absence by one of the Vice-Presidents, other payments to be made only on authority of Council.

15. The Council have the power of establishing such competitions as they may deem advisable. All technical details to be referred to the Executive Committee.

16. An annual report from the Secretary and Treasurer to be submitted to the Council before publication. The Council shall also make a report of the proceedings of the year to the General Association Meeting.

17. All competitions to be closed by the 31st December of each year, and all returns thereof, with list of men entitled to badges, must be sent to the Secretary by the 15th January ensuing the year for which the claim is made.

18. That members of Council, not being life members, must pay the annual subscription to remain as such.


19. That any Commanding Officer of a corps, being a member of Council, unable to attend any meeting of the same, may nominate, in writing, an officer of his own command to attend in his stead, and upon such officer delivering to the Secretary such nomination, he shall be entitled to speak and vote at such Meeting of Council, but any motion made or

seconded by him shall be made by him in the name of the member of Council for whom he acts.

20. Whenever an Artillery Association is formed for any of the Provinces of the Dominion, the Secretary shall be required to furnish such information from the records in his charge as may be required for the issue of Provincial prizes.

21. Officers who compete for prizes must be life or annual members of the Association.

22. All subscriptions for affiliation must be forwarded so as to reach the Secretary on or before the 1st of July in each year.

# CIRCULARS 1893.

## Annual Gun Practice—Field Batteries.

### GENERAL REGULATIONS.

1. In accordance with G. O. (26), 14 Ap. '93, and G. O. (13), 13-5-'92, the following instructions are issued for the Annual Gun Practice of the Field Batteries in the Dominion :

2. Batteries which perform their drill in camp, in the vicinity of which a land or water range can be obtained, will carry out the following instructional practice.

#### Range Finding by Batteries.

3. The entire Battery will parade in drill order, march to the practice ground, and be halted in a suitable position, under cover if possible, in rear of the position to be selected for action.

(a.) The command "*Prepare for Action*" will be given, when limber boxes will be opened, one common shell per gun fuze with R. L. Fuze, tube pockets strapped on, sponge buckets filled, etc.

(b.) The C. O., Nos. 1 and Range-takers (if any) will advance, and dismounting under cover, select the positions for the guns. The target will be pointed out and its range taken or estimated. If necessary for the better observation of the results of fire, the C. O. will remain mounted during the practice.

(c.) Upon signal from the C. O. the Battery, under the command of the next senior officer, will advance as rapidly as the nature of the ground will allow, and each gun will come into action at the place marked by its own No. 1.

(d.) The C. O. will then give the command "with shell load," naming the target and range. Each gun will be laid at the named elevation, and the required deflection will be ordered by the Sectional Officer. The officer commanding is not limited to the employment of Nos. 1 as layers, the two best marksmen in each sub-division should be generally selected for this purpose, and should fall in as Nos. 7 and 8.

(e.) The C. O. will then order *slow fire* from the right or left, and will order the elevation for the next and succeeding rounds, care should be

taken that each gun is laid at the elevation last ordered by the C. O. When the short bracket has been found, three rounds should be fired with the lesser of the two elevations found, vide pg. 132, Vol. II. When the range is found, common shell fire will be changed to shrapnel, the length of fuze being ordered for each gun by the C. O. and one round being fired by each.

(f.) The second target will now be used, and the range found by the above method, a second layer being selected, and one round of shrapnel fired as above.

Under ordinary circumstances, with careful observation, the range ought to be found with from 8 to 10 rounds. Should, however, the range not be found in 12 rounds, practice will be continued at the same target until it is so.

(g.) The Sectional Officers will be required to keep an accurate record of the elevation and deflection at which each of their guns is fired, noting the result as + or -. The C. O. and Captain, if available, will keep a record of the elevation of each round fired and will note the result as + or -, adding the estimated number of yards in each case.

(h.) The range party will keep a record of the observed result of each round, noting the estimated number of yards over or under of the burst, or first graze if blind. This record will be read out to the whole Battery after the practice is over, and the general results commented upon by the C. O. and Inspecting Officer.

4. Two targets, consisting of a float with cask and banrol, if a water range, will be placed at distances from 1200 to 1800 yds. range. They should be at a lateral interval of about 100 yds., and from 200 to 300 yds. apart. The Officer Commanding Artillery in Camp will make the necessary arrangements for providing targets and for range duties.

5. Officers Commanding Batteries will forward without delay, requisitions for the ammunition required for 24 rounds common and 8 rounds shrapnel shell. The supply for camp should, if possible, be drawn from their Battery reserve and taken into camp in the limbers—filled shell to be fitted with wads or primers and securely plugged.

It is most important to bear in mind that the instructional value of the above practice depends in a great measure upon its being carried out with every precaution supposed to be necessary in actual service, in consequence the greatest exactitude and celerity are indispensable in every movement.

No competition whatever will be sanctioned.

#### Annual Gun Practice.

6. Camps for Field Artillery Practice have been authorized to be held at Quebec and in Ontario during the month of September. The former

will be attended by detachments of four officers and eight N. C. O. or men from Field Batteries in Nova Scotia, New Brunswick and Quebec; and the latter by similar detachments from Field Batteries in Ontario.

The usual arrangements will be made for transport and allowances.

Revised Rules for Practice will be published.

The number of rounds to be expended and the general Rules and conditions will be the same as in 1892.

Officers commanding Batteries are requested to communicate directly with the Assistant Inspectors of Artillery at Quebec and Kingston with reference to requisitions for ammunition, dates of practice, etc., etc. These officers will act as Camp Commandants at these camps.

The Winnipeg and Sydney Field Batteries will practice at local headquarters.

### Field Artillery.

GUN PRACTICE.—General Rules and conditions the same as in 1892, with the following exceptions, alterations, etc.:—

1. Winnipeg and Sydney Batteries practice at Local Headquarters and also the Woodstock Battery, unless satisfactory arrangements can be made for transport to Quebec.

Unless a suitable range can be found at Kingston, the Shefford Battery will practice at Quebec, and the Ontario Batteries at Port Hope.

2. If found practicable, the range will be altered for each battery competition, between defined limits, not exceeding 100 yds.—1700 to 1800. One trial shot will be fired at the commencement of each battery competition, the gun will be laid by the Umpire, who will inform the officer in charge as to the elevation and deflection given, and the result as signalled by the range party.

The officer in charge of the detachment will direct the elevation, deflection and length of fuze to be given.

OFFICERS' FIRING AND OBSERVING COMPETITIONS.—As last year. The latter to include the shrapnel shell, which *will not* be signalled. Distance of burst, or of graze, if blind, to be observed.

DRILL AND DRIVING COMPETITION.—Same as last year.

GENERAL EFFICIENCY COMPETITION.—Same conditions as previously published.

A subsistence allowance of *seventy-five cents per diem* will be made to each officer and man for such days as they are necessarily absent from

### Garrison Artillery Competitions.

In accordance with authority received, the Annual Competition for gun practice and shifting ordnance will be held at Halifax, N.S., commencing on Tuesday, the 8th August.

Arrangements for transport, etc., to Halifax will be the same as last year, except that three officers are authorized to accompany each Company detachment. In the case of the Halifax Battalion, each company, if of a total strength of 84 N. C. O. and men, will count as two units for all competition. An entrance fee of six dollars must be paid for each unit entered.

#### REGULATIONS.

1. The following firing, drill and shifting ordnance competitions will be held, viz.:—

FIRING COMPETITION.—64-pr. R. M. L. gun.

Three Layers, selected from each detachment of seven N. C. officers or gunners, to fire each—

Common shell, plugged . . . . . 4

Shrapnel shell, time fuze . . . . . 1

The shrapnel shell to be fired after all the common shells have been fired. Fuze to be bored by No. 1 (gun captain). Elevation, deflection and length of fuze will be ordered by officer in charge of detachment.

One trial shot will be fired at the commencement of each Company competition. The gun to be laid by the Umpire, who will inform the officer in charge of the elevation and deflection given, and the result as signalled by the Range party.

There will be *no* individual prizes, except marksman's badges, in this competition.

2. OFFICERS' FIRING COMPETITION.—64-pr. R. M. L.

As last year. Officers to act as layers. To fire immediately before detachment.

3. DRILL INSTRUCTION AND COMPETITION.—Each detachment, with its officers, will be required to go through a course of instruction, from 4 to 5 hours, at drill with 9 inch or 10 inch R. M. L. guns, in Casemate or open batteries, under instructors from the Royal Artillery. During the last half hour's drill an examination in the drill previously practiced will be held, and prizes given for the best drilled detachments.

4. OFFICERS' OBSERVING COMPETITION.—As last year, to include shrapnel, which are not to be signalled.

5. SHIFTING ORDNANCE COMPETITION.—Rules same as last year. The following will be the details for the

6. GENERAL EFFICIENCY COMPETITION.—The change in the establishment of the Halifax and British Columbia Batteries of Garrison Artillery, from 7 and 5 Batteries to 4 and 5 Companies respectively, will necessitate a change in the conditions regulating the General Efficiency Competition.

The present conditions are based upon a Battery unit of 3 officers, 6 N. C. officers and 35 gunners. Each of the Companies of the new establishment of the above Battalions, if not less than a total strength of 84 N. C. officers and men, will be considered as representing two units. As, however, there are only 5 officers per Company, in one of the half Companies the answers to officers' questions will be 12 instead of 8 each, thus giving the same total value to this subject. The N. C. officers' questions to remain the same, but to be answered by 6 N. C. O.'s, 2 Sergeants, 2 Corporals and 2 Bombardiers in each half Company.

The number of gun squads not to exceed four per half Company.

A subsistence allowance of *seventy-five* cents per diem will be made to each officer and man for such days as they are *necessarily* absent from Company Headquarters—leaving after 6 p.m. and arriving before 6 a.m. will not be counted as days necessarily absent. Subsistence allowance for men of detachment *while in Camp* will be paid to the *Camp Caterer*.

All affiliation fees must be paid on or before 30th June, inst.

## Rules for Practice.

1893.

1. One trial shot, Common Shell with percussion fuze, or solid shot, will be allowed at the commencement of each Battery Competition or *when target has been moved to a different locality during a competition.*— Trial shots to be laid by the Umpire on the target, without any deflection and the results as signalled communicated by him to the officer in charge of the Detachment.
2. Before commencing, guns to be in action, time fuzes not bored, percussion fuzes may be screwed in, detachment in post at the guns or under cover.
3. Each competitor to prepare and fix his own time fuzes, and to lay his gun without verbal assistance except from the officer in command of his detachment, who will instruct the competitor as to length of fuze, elevation, deflection, etc., but who must not look over, or correct the laying of the gun. After the gun is laid, and the tangent scale lowered, the officer in charge of the detachment may, without interfering with the sights, ascertain if the gun is laid for the correct target, if not, the competitor will be required to re-lay the gun, losing the time necessarily so occupied, in addition to a penalty of two points.
4. Lots to be drawn for the order of competitive firing, and not divulged until the competitor is called out by the umpire.
5. The Range Officer is alone responsible for points given for elevation. No appeal.
6. The danger flag will be *hoisted*, and cease firing sounded by the Range Officer when it is necessary to visit the target. When these signals are *repeated* from the Battery and the firing flag lowered, he can visit the target, lowering the danger flag and sounding "commence firing" when he has returned to a place of safety.
7. The Officer in charge of the marking at the Battery is alone responsible for points given for direction. No appeal.
8. On all other matters the decision of the Officer superintending the practice is final. No appeal.
9. Each competitor may be told the points given for direction. The observation of the effect of each shot will be made by the officer in charge

of the detachment, who will communicate it to the competitors, at the same time giving necessary directions as to changes in elevation, deflection, or length of fuze. Except when sanctioned by the umpire, the observing officer is not to take any position in front of, or more than 20 yards from the gun.

10. On Land Ranges, when the circumstances of the case will permit, or when two or more Batteries are practising together, telephones may be used for signalling purposes.


11. When the signalling is by flags, and if considered necessary by the umpire, a *white* flag may be hoisted at the Battery when shrapnel shell are to be used.

12. At all competitive gun practice, with Field or Garrison Guns, the result of the trial shots only, will be signalled at once by the range party.

13. When two or more detachments are firing over the same Range, the position of the target will be altered before the commencement of each practice. This alteration of range will not exceed 50 yards either over or under, and will be carried out by the Range party by direction of the umpire, who will be careful to see that no information is given as to the new position of the target.



General Rules.

1. If a competitor breaks the bit in the fuze, he will be required to bore the Fuze with another bit, at the next graduation over, or under, as the Officer superintending the Practice may decide.
2. No points to be given for shrapnel shell bursting beyond the target, whether before or after a graze.

3. Shells grazing outside limits, over or under, to have no points for elevation or fuze.

4. Shells grazing and bursting within shrapnel limit to receive points according to position of burst.

5. The Umpire will have full discretionary powers to disqualify any detachment, or to inflict a penalty of from two to five points for each irregularity or mistake at drill noticed by him.

Ties to be decided by—

1. Points for direction.
2. Common shell score.
3. Time.

Nine-pounder gun and limber, four horses. Four detachments, each to consist of 1 N. C. Officer (mounted,) 6 Gunners, 2 Drivers. Field day order,—forage caps may be worn.

Harness bits with curb chain or straps are to be used—in very exceptional cases, and with the sanction of the umpire, a bridoon bit may also be used.

Detachments are to be in order of march. No. 1 and drivers stand to their horses.

1. Gunners and drivers prepare to mount. Mount. Half left.—March—Half right—Right wheel—Forward—Right wheel—Forward—Half right—Half left—Halt.

The gun to be taken through two gates, represented by pickets, not less than 3 feet 6 inches high, and 6 feet 10 inches apart, and back to the original ground.

2. Action—Front—With drill cartridge, load—Fire one round (friction tube to be used).

3. Cease firing—Rear limber up—Prepare to mount—Mount—Advance—March.

Gun to be taken through a gate, as described above, 30 yards distant—when 15 yards clear, then:

4. Halt—Action rear—With drill cartridge, load—Fire one round (friction tube to be used).

5. Cease firing—Front limber up—Form the order of march.

The pace throughout not to exceed a trot.

The side gates will be 30 yards from the starting point and from each other.

No. 1's horse may be held by No. 7 when the gun is in action. No. 1 will lead through the gates.

Drill cartridges to be taken separately from the limber box by No. 6. Ammunition not to be carried.

For striking any of the pickets, 5 seconds to be added to the total time.


For any faults or mistakes in drill as judged by Umpire, not more than 5 seconds to be added for each.

## Drill Competition—Garrison Artillery.

*From Capt. F. M. Lowe, R. A.,  
To the Officer Commanding Royal Artillery,  
British North America.*

Halifax, Nova Scotia,  
17th August, 1893.

SIR.—I have the honor to report, for the information of the Dominion Inspector of Artillery, that I have examined the detachments from various Companies of Dominion Artillery, in 9 in. R. M. L. gun drill and forward a list of the same herewith. I beg to append the following remarks:

1. The greater part of the detachments had the disadvantage of being instructed and examined in very hot weather. The detachments examined on the 14th inst. suffered under the greater disadvantage of heavy rain.

2. The hours of instruction were very limited, and for various reasons the actual hours on the programme attached were rarely, if ever, worked.

3. The zeal and interest displayed by all the detachments left nothing to be desired. If no great part of the keenness evinced is to be ascribed to a sense of novelty and the spirit of competition, the men could be made in a few days very valuable gunners.

4. Probably it is the result of different conditions of life, that the men of the Canadian Artillery are more handy and adaptable than men of the same class at home.

5. I regret exceedingly to be obliged to disqualify the Digby detachment on account of one of its members being under the influence of drink.

6. Allotting marks has been difficult owing to the fact that all are so nearly equal. With a very short time for instruction, that Instructor who can most quickly impart his knowledge is not unlikely to make the better detachment. Each detachment was examined in precisely the same manner. Minor details of, and time taken in drill were disregarded. Marks were taken off for mistakes, that in actual firing might cause

1. Loss of life or accident to limb.
2. Damage to the gun and stores.
3. Inaccurate shooting.
4. Undue loss of time.

The greater portion of discredits came under 3 and 4 of above.

7. The New Brunswick and P. E. Island Battalions brought to Halifax five detachments under the necessary strength for 9 inch R.M.L. gun drill. The N. B. Battalion therefore made up four full detachments of their men, but the P. E. I. Battalion made up the number in No. 3 with three men who had formed part of No. 5 on the previous day. No. 1 was made up similarly. It is therefore strongly recommended, with due regard to fairness, that No. 3 P. E. I. should be debarred from receiving a prize.

8. I would recommend that on future occasions the gun Captains should be N. C. Officers. It will be seen that at this meeting they varied from Major to Gunner. The gun layer might be any N.C. Officer or man with an aptitude for laying.

If the Officers wish to compete it appears desirable that they should do so as such, or in detachments entirely composed of officers.

9. It is further recommended that each company should be provided with both volumes of Garrison Artillery Drill 1892, and also with the corrections and alterations that are made therein from time to time. If 64-pr. drill as therein laid down is known, that of any other garrison muzzle loading gun can soon be acquired.

10. Some of the men were a great deal too light for Garrison Artillery work.

## Report of Council.

1. The reports of the Executive Committee and of the Secretary-Treasurer with accounts duly audited are submitted herewith.

From the former it is satisfactory to learn that the meetings for competitive practice of both branches were largely attended and very successful, and that the instructional practice has been productive of all the results expected from it. Its importance cannot be too strongly insisted upon.

It is a matter of congratulation that the report of the Secretary shows that the affairs of the Association continue to be in a fairly satisfactory condition.

2. The usefulness of the duck suits issued to the Artillery has now been so thoroughly demonstrated, that the Council hope that the Department will allow a full issue, at least to each Field Battery. If it be impossible to give full suits, overalls at least should be issued. If the Department could also issue serge tunics to batteries going to camp it would be a great comfort to the men and would save the more expensive cloth tunics which would be worn only at inspections, church parades, reviews, etc., and consequently would have to be renewed only at longer intervals.

3. The Council once more urgently recommend that an increased number of days drill be allowed annually to the Artillery. As has been already stated, the necessity of more time for learning the numerous duties and acquiring the technical knowledge required of an artilleryman is obvious to everyone who will seriously consider the matter.

Although the reports of the Inspectors of Artillery show that the Force has more than maintained its efficiency, still the Council are of opinion that it is difficult to effect any further improvement unless more time is allowed so as to admit of preliminary drill.

4. An Extraordinary Meeting of Council was held at Ottawa on 5th December, 1893, to consider a letter from the Inspector of Artillery respecting the Cobourg detachment having with it a person not a *bona fide* member of the battery. (See minutes of proceedings, also the recommendation of the Executive Committee as to the necessity for more definite rules as to the eligibility of competitors.)

5. It seems evident that the range at the Island of Orleans has advantages which that at Halifax does not possess, and the Council recommend that practice be carried on there in future instead of at Halifax, especially as there is now a 9 in. gun in the citadel at Quebec at which detachments can be exercised.

Some buildings might be put up on the grounds which, without being expensive, would greatly contribute to the comfort of the competitors. If it is decided to continue the competitive practice, some outlay should also be made at Port Hope, which is reported by the Executive Committee to be the best range as yet found available for the practice of the Ontario Field Batteries, although it is not considered suitable for a permanent range.

6. The Council desire to express the obligations of the Association to the General Officer Commanding the Imperial Forces, and the Officer Commanding the Royal Artillery in Halifax, for their kindness in allowing the detachments to obtain instruction in the method of drilling with and working the 9 in. gun, also to the Park Commissioners of Halifax, and John Helm, Esq., Port Hope, for allowing the use of their grounds.

7. The Association has received the greatest assistance from the Inspector and Assistant Inspectors of Artillery, who by the considerable amount of work they have done in connection with the carrying out of the practice, have greatly contributed to its success.

8. The Officers of the Regiment of Royal Canadian Artillery, who were selected for the purpose, ably performed the duties imposed on them in carrying out the details of the practice.

9. The following suggestions have been made by Members of Council and are referred for the consideration of the Annual Meeting :

By Lt.-Colonel Macdonald, Comdg. 1st Bde., Field Artillery—

“ That the present development of Field Artillery work requires the provision, if the marksmen of the Batteries are to be concentrated, of a range extensive enough to enable them to do the work of practical gunnery, such, so far as may be, as that which is done at Oakhampton by the Royal Artillery ;

“ That, if such a range cannot be provided, at least the officers and marksmen should be concentrated for a number of days together to take a short course in theoretical and practical gunnery ;

“ That, if neither of these schemes can be carried out, it would be better to devote the time and money now spent in concentrating the marksmen, in a more extensive general instruction of the whole Battery in gunnery and range-finding practice.”

By Major Coutlée, Comdg. Winnipeg Field Battery—

“ That soft felt caps such as worn by N. W. M. Police be issued for fatigues and drills—this is a necessity for the Winnipeg Field Battery,

" as men are constantly laid off by the Surgeon suffering from swelling of the skin of the forehead and affections of the eyes directly resulting from sun-burn and heat."

" That a couple of spare gun horses be allowed per battery. A horse should also be allowed for the Farrier, as he is necessary on the field and when route marching."

" Provision ought to be made to allow of a squad from Winnipeg Field Battery competing with the Ontario batteries "

#### Dominion Artillery Competition at Halifax.

GENERAL REGULATIONS—9th June, 1892—PARA. 5. "The N. C. officers and gunners of each detachment must have attended at least one annual drill and be *bona fide* members of the Brigade or Battery they represent, and be accompanied by at least one officer thereof."

The latter is not a member of the Battery, but wore the uniform and acted as a gunner during the Firing and Drill Competitions—and received the allowance of 75 cts. per diem. It is referred for consideration as to whether this detachment, having infringed the rules governing such competition, should be disqualified from participation in the Prize List.

SIR,—I have the honor to acknowledge the receipt of your letter of 22nd inst., and in reply beg to state that I did send Captain Hamilton, 40th Batt., with the detachment of Cobourg Garrison Artillery in the capacity of a gunner to the competition at Halifax. I found great difficulty in making a detachment on account of my men being engaged in work,

mainly in the car works. They were unable to leave for the time necessary to go to Halifax and return. After some trouble I succeeded in getting a detachment, but on the day before leaving for Halifax, one of the men found it impossible to go. The disappointment was very great, as I was very anxious that the Battery should be represented at the competition. Not being able, on short notice, to get another man of the Battery to fill the vacancy, I requested Captain Hamilton (who was at Cobourg taking his holidays) to go, as he had been for some years a member of the Battery, and holds a certificate from the School of Gunnery. I had not noticed the conditions of the rule referred to by you. I do not offer this as an excuse, as I should have made myself acquainted with the rules.

I requested Hamilton to go, as I stated above, not with the slightest idea of taking any advantage of the Dominion Artillery Association, or of any individual member, but simply that a detachment might be sent to represent Cobourg.

I exceedingly regret that I made so grave an error, which at the time of action I did not consider in the same light as I do now on more deliberate consideration, and would ask that you would place the full responsibility upon me, who alone am to blame in the matter.

## Report of the Executive Committee.

1893.

### FIELD ARTILLERY PRACTICE.

1. Range finding was carried out on the same general system as during the previous year, with the additional advantage gained by the employment of a second target at a different range. The London and Sydney Batteries joined in this practice for the first time. The former at Port Stanley after a march from London, and the latter at Camp grounds Sydney, where however they were unable to find a range suitable for competitive practice.

2. Competitive gun practice was carried out by the Winnipeg Battery at local headquarters, by the Quebec and New Brunswick Batteries at the Island of Orleans and by the Ontario Batteries at Port Hope. The latter appears to be the most suitable and centrally situated range as yet found to be available in the Province, and with a moderate expenditure for the use of additional camping grounds, construction of markers' butts, &c., is capable of considerable improvement. It is not, however, by any means suitable as a permanent Field Artillery range, being too limited in its extent to enable the guns to take up different positions, or to afford any opportunity of varying the nature and position of the targets. It appears to be worthy of consideration as to whether the amount now expended on this competitive practice, could not be more profitably spent on a more extended system of Range finding and Fire discipline at Camp or local headquarters.

### RULES FOR PRACTICE.

3. The revised Rules seem to have worked well in practice, and the increase of the Prizes awarded for aggregate scores and corresponding decrease of individual prizes is a step in the right direction, which it is suggested may be still further extended. The individual capabilities of the officer in charge of the detachment, both as an instructor and observer are of much greater importance than appears to be generally recognized, and, as on actual service, the gun layers should be trained to receive their instructions from him, and to carry them out to the best of their ability, without reference to the effect of each round, which only can be observed by them under exceptionally favorable conditions, not likely to occur on service.

#### DRILL AND DRIVING COMPETITION.

4. This was entered for by 12 Batteries as compared with 13 in the previous year. The scores made show a very marked improvement, the best average time being nearly 15 seconds better, and no less than six Batteries having beaten the record for 1892.

This competition is an excellent test of smartness in drill and driving, and should be more generally encouraged. It is proposed to slightly alter the conditions by loading with dummy shell and cartridge, and by giving No. 1 two adjustments of the tangent scale.

#### GARRISON ARTILLERY PRACTICE.

5. This competitive gun practice was held this year at Halifax, and was participated in by detachments from all the Companies authorized for drill except those of the B. C. Battalion. The actual gun practice was limited to firing the usual number of rounds from 64-pr. R.M.L. guns, under the revised Rules for Practice, and with the new system of drill.

The practice was generally very satisfactory, with the exception of a few cases in which the gun layers were not sufficiently trained, or suffered from defective vision. It was also noticed that in some cases the officer in charge of the detachment was not competent to give instruction as to elevation, deflection or length of fuze.

The practice was at times delayed for long periods by fog and passing vessels and the difficulty of observing the effect of fire, owing to the low site of the Battery, detracts very considerably from the instructional value of this Range.

6. Arrangements were made, with the sanction and cordial assistance of the General Commanding the Imperial Forces, and the Colonel Commanding the Royal Artillery, by which each detachment received about 4 hours instruction in the method of drilling and working with the 9-in R. M.L. guns mounted at Cambridge. The detachments were all examined by Captain Lowe, gunnery instructor, Royal Artillery, and prizes were awarded according to their relative proficiency. The Companies of the Halifax Battalion, being provided with a 9 in. gun in their Drill Shed, did not take part in this instruction and competition, but were subsequently examined in a similar drill competition at their annual inspection.

7. The arrangements for camping and messing were entirely satisfactory, and the thanks of the Association are due to the Park Commissioners who very kindly gave every assistance in their power, as regards the use of the grounds, and the occupation of a Band cupola thereon.

A comparative statement of the expenses involved by the adoption of Halifax as the site for this Annual competition will be found in the Treasurer's report.

#### SHIFTING ORDNANCE COMPETITION.

8. The A, or previously named shift was competed for by four detachments from the Halifax Batt., one from the Montreal Batt. and one from the P. E. I. Batt., and was won by the latter after a close competition. In this operation only a time limit was fixed, the relative merits of the competitors being decided by points for careful and accurate drill.

In the B, or "go as you please" competition time was the only factor in determining the result. It was entered for by four detachments from the Halifax Batt. and one from the P. E. I. Batt., and was won by No. 1 Co'y. of the former. It is suggested for consideration that this shifting ordnance competition should be considerably modified, if not indeed replaced by some other form of efficiency competition.

#### EFFICIENCY COMPETITION.

9. The result of these competitions has been published in general orders, and continues to shew the close competition which is the direct result of the desire to win, or to shew a good record in the competition for, these honorable trophies.

The Field Batteries have all succeeded in obtaining more than 50% of the possible credits, but there are still eight garrison companies, not including the B. C. Battalion, not yet fully organized, which have failed to reach this minimum of efficiency.

#### PRIZE LIST.

10. The Turnbull Challenge Shield, previously held by the Battery making the highest aggregate score with F. M. L. and R. B. L. guns at practice, was, owing to the withdrawal of R. B. L. guns from practice, awarded to the Company making the highest aggregate score for efficiency and gun practice combined.

#### COMPETITORS' ENTRIES.

11. There seems to be a necessity for more definite and stringent rules as to the eligibility of competitors forming part of detachments for Gun Practice, Shifting Ordnance, &c., and it is suggested that the nominal roll of entries should be accompanied by a certificate from the officer commanding, that each man is a *bona fide* member of, and has attended the last annual training of his Battery, Company or Battalion.

## Secretary's Report.

The Secretary presents herewith the Seventeenth Annual Report of the Association, containing details of the several competitions entered into during the year.

The affiliations were :—

- Royal Military College.
- 2 Royal Schools of Artillery.
- 15 Field Batteries.
- 31 Garrison Companies.

Each company of the Halifax Battalion on account of increased strength, being considered as equivalent to two units, affiliated as such. See page 8.

Exclusive of the British Columbia Battalion, there were only two Field Batteries, Kingston and Sydney, and two Garrison Companies—No. 1, Quebec and the Mahone Bay—in the Dominion which did not affiliate.

The life membership is two less than last year. Numerically the list of annual subscribers shows an increase of two.

There is only one special donation to record for the year, viz. *one hundred* dollars from the Hamilton Powder Company, through the President Dr. T. C. Brainerd. The Cups usually presented by His Excellency the Governor General for *General Efficiency* were presented this year by the Association. Those donated by the Earl of Derby for 1892 have not yet been received by the winning batteries.

In accordance with resolution of Council, an engrossed and illuminated address was forwarded to the Earl of Derby (late His Excellency the Governor General) expressing the regret of the Association at his departure and thanking him for the many favors received at his hands during his residence in Canada.

His Excellency the Earl of Aberdeen, Governor General, has signified his acceptance of the office of Patron of the Association.

The receipts during the year amounted to \$3478.30, from the following sources :—

The disbursements for the year will be found in statement of accounts.

The expenditure on account of the Garrison Artillery Competition at Halifax, amounted to \$1438.72, being a decrease of \$253.57 as compared with 1892. This shows an excess of \$228.13 only over the last year at Quebec. The transport expenses for detachments to Halifax are about \$1000 less than to Quebec.
