An Act to vest in certain inhabitants of the Township of Moore, a Road Allowance therein, and to establish a new Road in lieu thereof.

WHEREAS the original Allowance for Road in the First or Preamble.
Front Concession of the Township of Moore, in the County
of Kent, from lot number thirty-seven to lot number sixty-eight, in-
clusive, has never been opened or travelled upon, by reason of its
5 ~~unfitness for a Road~~; and whereas the owners of the said lots have
dedicated and set apart another and more convenient Road through
the same lots, in lieu of the said original Allowance, and it is pro-
per to vest the said original Allowance in the owners of the said
several lots through which it passes, and to confirm their said new
10 Road, according to the prayer of their petition to the Provincial
Legislature to that effect, Be it therefore enacted, &c.,

That the said original Allowance for Road, laid out in the first or Original Al-
front Concession of the said Township of Moore, from lot number lowance for
thirty-seven to lot number sixty-eight, inclusive, is hereby vested Road vested in
15 in the several owners of the lots through which the same passes, owners of
their heirs and assigns for ever. lands through
which it pas-
ses.

II. And be it enacted, That the Road as now laid out and New Road es-
travelled, through the said lots, is hereby established and declared tablished.
to be a Public Highway through the same, and shall be of the
20 width of one chain.

III. And be it enacted, That this Act shall be a Public Act. Public Act.
