

SIFTH SESSION OF THE SIXTH GENERAL ASSEMBLY.

#### TUESDAY, FEBRUARY 2, 1796.

HE House having met agreeable to his Excellency the Lieutenant Governor's Proclamation.

Peter Macgowan, Esq. and Mr. John Webster, who were returned as Members to serve in this present Assembly for King's County, appeared, and having taken the usual Oaths, were admitted to their Seats. And Mr. Ralph Brecken, Merchant, who was returned as a Member to serve in this present Assembly, for Charlotte Town, also appeared, and having taken the usual Oaths, was admitted to his Seat.

His Excellency the Lieutenant Governor sent a Message to the House by the

Deputy Secretary, requiring their Attendance in the Council Chamber.

Accordingly Mr. Speaker with the House attended—and being returned, Mr. Speaker reported, that his Excellency was pleased to deliver the following Speech to both Houses:

Mr. President, and Gentlemen of bis Majesty's Council, Mr. Speaker, and Gentlemen of the House of Assembly;

T is with great Satisfaction, at all Times, that I convene the Legislature of this Government for the Dispatch of Public Business; but it is with additional Pleasure that I now meet you in General Assembly, when, by the late Election of several new Members to supply the vacant Seats in the House of Assembly, the Representation of the People is rendered compleat, and an Opportunity thereby afforded me of receiving the most full and certain Information of the Interest and Wishes of his Majesty's dutiful and loyal Subjects in this Island, to which I am ever disposed, both from Duty and Inclination, to pay the utmost Attention and Regard.

Not having received any late official Information respecting the Operations of the War, or had any Thing in immediate Command from his Majesty's Ministers to lay before you at this Time, I am left to felicitate you on that condescending Notice and encouraging Attention which has been paid by his Royal Highness Prince Edward, his Majesty's Commander in Chief, to the better Defence of this Town, and on the Enjoyment of that local I ranquility and Security, which, under Divine Providence, has during the War been afforded to this Island, by the extensive Protection and operating Influence of his Majesty's Arms.—And to recom-

mend to you a wise and discreet Use and Improvement of those fortunate Circumstances by a closer Attention to the enacting of such salutary Laws, and concerting such judicious Measures, as may be thought most conducive to the mutual Interest of his Majesty's Service, and the Prosperity of this Island—the flourishing State of which, it must be acknowledged, is most conspicuously evident, from the greatly improved Aspect and Appearance of the Face of the Country in Point of Cultivation and Agriculture, but more unequivocally certain from the vast annual Increase of our Exports of various Kinds of Produce, and most distinguishingly so in the valuable Articles of Wheat and black Cattle.

The erecting of a Church in this Town since the last Session of the General Assembly, for the more decent and devout Public Worship of Almighty God. begun and so far carried on by private Subscription, I persuade myself cannot be either unobserved by you, or regarded with Indifference-And while contemplating the Means of affording some Assistance towards the completing an Edifice for religious Worship, suffer me, Gentlemen, once more to recal to your Recollection the great Duty which we owe to the present rising and succeeding Generations, of making some Provision and Endowments for the permanent Establishment of a Public School, or Academy, for the better Education and Instruction of the Youth of this Island.—The transcendant Benefits and Advantages of a polished and liberal Education have too often been made the well chosen Theme of both ancient and modern Declamation to receive any additional Elucidation, or Encomium, from any Thing that I am able to say upon the Subject. I, however, do not hesitate to believe, that Religion and Learning are, at this enlightened Period and Age of the World, universally acknowledged to be not only the highest Ornament and Glory. but the principal Source and Basis of substantial Happiness in every Government, and of every People. And under such Impressions it is, that I now submit the Consideration of those truly important and lastingly interesting Subjects, to the liberal Result of your deliberate and united Consultations.

Gentlemen of the House of Assembly,

I SHALL give Directions to the proper Officers to lay before you the Public Accounts of this Government; whereby you will be enabled to discover how far the Public Revenue of this Island has fallen short of discharging the Public Debts, and defraying the current unavoidable Expenditures of the Year, and consequently you will perceive the Propriety of devising some Ways and Means of paying or otherwise doing Justice to the Demands of Public Creditors.

Gentlemen of bis Majesty's Council, and Gentlemen of the House of Assembly,

REPOSING an entire Confidence in your Loyalty and Affection to our Most Gracious Sovereign and his Royal and illustrious Family, and of your Zeal for his Majesty's Interests, and Attachment to his Government, I will only add, that I shall at all Times most cheerfully and cordially concur with you in every proper Measure and Effort which may tend to a Manifestation of such laudable Principles, or that can in any Manner or Degree promote the Prosperity and Happiness of his Majesty's faithful Subjects in this Island.

Mr. Macgowan moved for Leave to bring in a Bill intituled "An Act to render valid Conveyances of real Estates of married Women, by them made, or to be made, during their Coverture."

Leave being given accordingly, the same was read a first and second Time, and

ordered to be committed for To-morrow.

On Motion of Mr. Macgowan, Leave was given to bring in a Bill intituled "An Act for the better Regulation of Elections"—which was read a first Time.

Ordered to be read a second Time on Tuesday next.

Moved by Mr. Macgowan, that a Committee be appointed to examine the Laws that are near expiring, and report the same to the House.

Mr. Macgowan, Mr. Brecken, and Mr. Hodgson, were accordingly appointed

for that Purpose.

On Motion of Mr. Hodgson, Leave was given to bring in a Bill intituled An Act for repealing two several Acts, that is to say, an Act made and passed in the twenty-first Year of his present Majesty's Reign, intituled An Act for the Preservation of High-Ways; also an Act made and passed in the twenty-fifth Year of his present Majesty's Reign, intituled An Act to explain and amend an Act made and passed in the twenty-first Year of his present Majesty's Reign, intituled, An Act for the Preservation of High-Ways. Read a first and second Times, and committed for To-morrow.

Adjourned till Eleven o'Clock To-morrow.

#### THURSDAY, FEBRUARY 4, 1796.

THE House met according to Adjournment.

On Motion, the same was read a first and second Times.

Ordered, That Mr. Macgowan and Mr. Brecken do carry up to his Majesty's Council, the Bill intituled "An Act to prevent the Robbing of Gardens and Orchards, Potatoe and Turnip Fields, and the throwing down of Fences, and for amending an Act made and passed in the twentieth Year of his present Majesty's Reign, intituled "An Act for preventing Trespasses by unruly Horses, Cattle, and Sheep, and for preventing the running of Hogs at large through the Town of Charlotte Town."

A Message from his Majesty's Council with a Bill intituled "An Act for ap-

A Member of his Majesty's Council came down and acquainted the House that they requested a Conference with this House on the Subject Matter of two Bills, viz

A Bill intituled "An Act to render valid Conveyances of real Estates of married Women by them made, or to be made, during their Coverture," and also a Bill intituled "An Act to prevent the Robbing of Gardens and Orchards, Potatoe and Turnip Fields, and the throwing down of Fences, and for amending an Act made and passed in the twentieth Year of his present Majesty's Reign, intituled "An Act for preventing Trespasses by unruly Horses, Cattle, and Sheep, and for preventing the running of Hogs at large through the Town of Charlotte Town." And then withdrew.

On Motion, Mr. John Webster was ordered to go up to the Council, and acquaint them that this House agreed to a Conference on the Subject abovementioned, and were ready to proceed therein immediately. He withdrew accordingly.

Having returned, the House immediately proceeded to the Council Chamber,

where a Conference was held.

The House having returned, the Speaker read the Alterations proposed to be made by his Majesty's Council in the two Bills last mentioned, and having put the Question thereon severally, the same were agreed to.

#### THURSDAY, FEBRUARY 11, 1796.

IT is with peculiar Satisfaction that I am enabled, at this early Period, by your Unanimity and unprecedented Dispatch of Public Business, to put an End to the

Session, by dismissing you from any further Attendance at this Time.

I have so often, Gentlemen, expressed my entire Approbation of your Conduct when assembled in your legislative Capacities, and so repeatedly declared my Opinion of the just Claim which you have to the Confidence and Gratitude of your Constituents, that I cannot conceive how I can possibly more satisfactorily close the Business of the present Session, or more fully illustrate the Estimation of your public Merit and Services, than by communicating to you a Paragraph in a Public Dispatch which I lately had the Honor of receiving from his Grace the Duke of Portland, one of his Majesty's Principal Secretaries of State, dated at Whitehall, the 5th of last August, wherein the Duke, after acknowledging the Receipt of my Letters, transmitting to his Grace the Speech, Addresses, Journals, and Acts, of the last Session, and informing me of his having laid my Letters before his Majesty, adds his official Approbation on the Occasion in the following condescending and flattering Terms, that "It is with great Satisfaction that he observed a zealous Attention on my Part, seconded by the united Concurrence of the Council and Assembly of Saint John's, in support of his Majesty's In-

terests and those of the Island, which are inseparable."
