

An Act to amend the Act to incorporate certain persons under the name of the "Quebec Friendly Society."

THEREAS the President, Vice-President, Secretary, and Prenuble. Treasurer of the Friendly Society of Quebec, pray for certain amendments to the Act of incorporation of the said Society, and it is expedient for the general advantage thereof to make the 5 same; Be it therefore enacted, &c.,

That that part of the fourth Section of the said Act by which it is Part of Sect. enacted that "such Treasurer or Treasurers, Trustee or Trustees, 4, of Act of L.C., 57 Geo. "and all and every other officer or officers or other persons what- III, c. 39, re-"ever, who shall be appointed to any office in anywise touching peoled.

10 " or concerning the receipt, management or expenditure of any "sum or sums of money collected for the purpose of the said "Society, shall execute the duties of such office without any fee, "reward or compensation whatever," be and it is hereby repealed, and that all and every the said words be and they are hereby struck 15 out of the said Section; and that it is and may be lawful for the said Society to allow to the said Treasurer or Treasurers, Trustee or Treasurers Trustees, and to any other officer or officers or other persons and other whatsoever, who are or shall be appointed to any office in anybe paid. wise touching or concerning the receipt, management or expen-20 diture of any sum or sums of money collected for the purpose of the said Society, all such fees, reward or compensation as they shall think fit, and conducive to the interest and advantage of the said Society.

II. And be it enacted, That the said Friendly Society shall How the 25 and may invest and dispose of all such sum or sums of money as funds of the shall have been collected or paid for the purpose and objects of immediately the said Society, the immediate expenditure or application of required may be invested. which is not required, in the purchase of Provincial Debentures or of the Bonds of any corporate bodies in this Province, as the 30 said Society shall think fit and profitable, all provisions and restrictions, and the provisions made under the said Act for the loaning, investment and disposal of the said money by the said Society, to the contrary notwithstanding; and that the said Society shall and may loan, invest and dispose of such sums of money, 35 being at their disposal, either in the manner provided by the said Act, or in the purchase of Provincial Debentures or of the Bonds of any corporate bodies in this Province, as aforesaid.

III. And be it enacted, That the Interpretation Act shall apply Interpretation. to this Act and to the Act hereby amended.
