

BY-LAWS.

I. The Society shall consist of such persons of English or Welsh birth, or descent, in the male line, as shall be elected members thereof according to the regulations hereinafter made.

II. The objects of the Society are to unite Englishmen and Welshmen, and their descendants, in a social compact, for the promotion of mutual and friendly intercourse, and for affording to persons of English or Welsh birth or descent who may be in distress, their advice and counsel, and, if necessary, such pecuniary assistance as the funds of the Society will admit of.

III. In addition to the Officers named in the Act of Incorporation, six Stewards shall be elected, who shall co-operate with the Committee in all celebrations to be held by the Society; also a Marshal and Standard Bearers shall be appointed by the President.

IV. The Officers of the Society shall be elected as follows: Any member may nominate a Candidate for each office, in succession; and in the event of more than one nomination for any one office, the decision shall be by ballot.

V. The President and Vice-Presidents shall not be eligible for re-election to the offices respectively filled by them for the next succeeding year.

VI. The Annual General Meeting of the Society shall be holden on the third Friday in January in each year. In each year there shall be holden four Quarterly General Meetings, viz.: 1st. The Annual General Meeting, and one each on the first Friday of the months of April, July, and October. Monthly Ordinary Meetings shall be held on the first Friday of

each month throughout the year, excepting in January, April, July, and October, as otherwise provided.

VII. Any gentleman desirous of joining the Society shall, at a General or Ordinary Meeting, be proposed and seconded by members, and may be elected by a majority of such meeting, on payment of the first year's subscription.

Dollars. The subscription year shall be from 1st January to 31st December. Any new Member elected between the 1st of January and 30th of September shall pay the full subscription for the current year; any elected on or after 1st October, may be admitted on paying for the current quarter only.

IX. A subscription of \$10 shall be a life-subscription, and the same, together with all donations of \$10 and upwards, unless such donations are made for a specific purpose, shall be invested by the Managing Committee, and form a portion of the permanent fund, the unterest on which shall be applied to the charitable purposes and ordinary expenditure of the Society. No ordinary member shall be eligible to life membership until he has paid all arrears of subscription as such ordinary member.

X. The Annual Meeting shall order the investment of such proportion of the surplus funds as may appear desirable, and in such manner as may be then determined, and the annual subscriptions, with the interest of investments, shall constitute the ordinary funds applicable to the charitable purposes and ordinary expenses of the Society.

XI. The Treasurer shall be authorized to advance to a distressed individual'a sum not exceeding Two Dollars, upon the written recommendation of the President or either of the Vices Presidents, or of any member of the Managing Committee by them appointed to grant such relief: provided always, that such recommendation does not involve the payment of more

than Two Dollars to any one person or family. In cases demanding more than the ordinary relief thus afforded, the same shall be referred for further enquiry and action to the Managing Committee as hereinafter set forth.

XII. The Managing Committee shall meet weekly, and any five members thereof shall form a quorum. It shall be their business to direct the affairs of the Society generally, under this Constitution; to determine all matters referred to them by the Society, and to prepare for each Annual Meeting a Report of the proceedings of the Society for the year, to be submitted previous to the election of Officers.

XIII. The Managing Committee may make loans (not exceeding Twenty Dollars to one person or family,) from the ordinary funds of the Society, to persons in temporary distress or trouble, upon receiving such reasonable security as they may deem expedient, provided the period of such loans do not exceed six months. It shall have power to grant extended relief in particular cases at discretion, the orders upon the Treasurer being in all such cases signed by two or more of the Members of the Committee.

XIV. The Committee, assisted by the Stewards, shall arrange for the Annual Celebration of St. George's Day, and report such arrangements at the Monthly Meeting in March. No expense of any celebration or social entertainment whatever, shall be charged against the funds of the Society.

XV. The President (or in his absence, the Senior Vice-President,) shall direct the Secretary to convene a Special General Meeting of the Society, upon requisition (stating the purpose thereof) from any five members, and the Secretary shall call a Special Meeting of the Managing Committee, either by direction of the President, (or in his absence, the Senior Vice-President,) or upon the requisition of any two members of the Committee.

XVI. The Chair shall be taken thirty minutes precisely after

the hour appointed for meeting, and if there be not then a a quorum of at least ten members present, the meeting shall be forthwith adjourned.

XVII. Any member in arrears of subscription for two years may be considered as having withdrawn from the Society, and his name shall be erased from the list of members, after due notice being given him.

No member shall be entitled to vote at the Annual Election of Officers, or at any subsequent meeting, neither shall be be eligible for election to any office of the Society, if he shall not have paid his previous year's subscription.

XVIII. The annual subscription shall be considered due and payable in advance, on or before the 23rd day of April in every year.

XIX. The duty of the President shall be to preside and preserve order at all the meetings of the Society, and to protect and further its interests to the best of his ability. It his absence, the senior Vice-President present shall exercise the authority and duty of the President. In case of the absence of the first four officers from any meeting, the members present shall be empowered to elect a Chairman out of their number.

XX. The Secretary shall have charge of the Seal, Banners, and other Insignia of the Society. He shall keep a fair register of all proceedings, orders, rules, and regulations, and manage the correspondence. He shall, when applied to, and on payment of such fees as may be determined on by the Committee, issue certificates of admission to each member (on his having signed the Constitution,) to which he shall affix the Seal of the Society. He shall, when necessary, summon the Society to its various meetings, and shall sign such Cards of Invitation to all Celebrations as may be required of him by the Committee and Stewards. He shall also, at all meetings of the Society, and of the Managing Committee, enter into the respective minute books the names of the members present at such meetings.

The Treasurer shall have the custody of the funds. He shall countersign such certificates of admission as may be issued by the Secretary. His accounts shall be fairly kept and exhibited to the President and the Managing Committee, whenever called for, and shall also be laid before the Society at its January Meeting. It shall be the duty of the Treasurer to open an account with such one of the Chartered Banks in the City as may be approved of by the President and Managing Committee of the Society, and there deposit the securities of the Society in the joint names of the President and of himself; and when directed by the Committee, all funds belonging to the Society, and paid to the Treasurer, shall be deposited in such Bank.

XXII. All vacancies in the offices of the Society, happening in the interim between two succeeding Annual Meetings, may be filled by election in the usual way at the Quarterly Meeting next after the same shall have occurred.

XXIII. To preserve order, and to expedite the business of the Society, any member who may have proposals to make, or observations to offer upon any proposition, shall rise and address the President; and no person shall interrupt another when speaking, if the speaker be in order.

XXIV. The introduction of political or religious subjects, or their discussion, shall never be allowed at any meeting of the Society.

XXV. The members of this Society shall faithfully observe and conform to all the rules and regulations that shall be made by the Society, and entered in the books thereof, on pain of being dismissed from it, and having their names erased from the list of members.

XXVI. If the majority of all the members present at any general Meeting shall vote for the expulsion of a member, his name shall be erased, and he shall never afterwards be admitted

to any meeting of the Society, unless again elected by ballot, as in the first instance: provided always, that no proposition for the expulsion of a member shall be in order, unless one month's notice has been given of an intention to submit it at the then next ensuing Quarterly Meeting.

XXVII. The Banners and Flags of the Society shall not be used except on occasions when the Society, as a body, takes part in the proceedings, or where the Society is represented by its officers.

XXVIII. At any Quarterly or Annual Meeting the members present may, on one month's notice previously given, elect any one of its members an honorary life member, in consideration of services rendered the Society, and also may elect any distinguished person eligible to become a member, in like manner for services rendered either to the Society or the country, and such honorary member shall be entitled to all the privileges of an ordinary member.

XXIX. An Obituary Record shall be kept by the Secretary of any member of this Society who may hereafter die, stating his birth and parentage, if known, date of admission as a member, his position, general character, and such other facts in regard to him as may be interesting to chronicle. Such record to be published with the Annual Reports.



REPORT

OF THE

Managing Committee for the Mear 1868.

Your Committee, in presenting their Annual Report for the year which has just passed, are pleased to be able to congratulate the members upon the continued prosperity and usefulness of the Society, which since its incorporation in the year 1858 has, notwithstanding the existence of serious drawbacks, gradually increased in importance, and may now take rank as one of the permanent institutions of Toronto.

The total amount of the receipts of the Society during the year ending the 31st December, 1868, inclusive of the balance of \$140.63 in hand at the date of the last report, is \$2104.88, of which the sum of \$200 consists of the subscriptions of life members, and has accordingly been invested, and forms part of the permanent funds of the Society.

The total disbursements amount to \$1821.69, leaving a balance in the Treasurer's hands of \$283.19.

The investments of the Society consist of Canada Permanent Building Society stock \$1000, dividends 10 per cent. per annum; Provincial Permanent Building Society, stock accumulating 100; Do. capitalized, \$300, dividends 8 per cent. per annum; City of Toronto debenture \$125, interest 6 per cent. per annum; Village of Yorkville debenture \$100 interest at 6 per cent. per annum; Government debenture, "Phipps Fund," \$1000 interest at 5 per cent. per annum. Total investments, \$2,625.

During the year 800 applications for relief or employment have been entertained and disposed of by the Committee, and the sum of \$727.13 has been disbursed in pecuniary relief. It is not, however, to be supposed that the above number represents distinct persons, inasmuch as many individuals were relieved on repeated occasions. Nevertheless the number of new applicants was largely in excess of, in fact was nearly double, that of any previous year.

The further sum of \$140 has been expended in passes granted on the different railways and steamboats, and the sum of \$5 has been applied towards burial expenses.

Since the commencement of the year, 16 life and 54 ordinary members have been added to the Society, which now numbers 9 honorary, 77 life, and 347 ordinary members,—in all 433 members.

The number of defaulters among the latter class again imperatively calls for a revision of the roll.

The Society has lost by death, during the year, one member,

Robert Wells, Esq., of Davenport Hill.

With regard to the obituary record, which by the 29th rule of the Society is required to be kept, your Committee must observe, that without assistance from the other members it is quite impossible to keep it with any degree of accuracy, or to obtain those particulars which alone constitute the value of such a record.

The available funds of the Society having been considerably diminished early in the year by the unusually large number of applications for relief, it became necessary to consider the best means for recruiting them. It was deemed inadvisable to give the Annual Ball in the Spring, as the experience of previous years shewed that large pecuniary results were not to be expected from it.

granted, the Conversazione was held on the evening of Thursday, the 26th of March. It was largely attended by the members of the Society and the general body of the citizens of Toronto. Several distinguished amateurs kindly consented to sing on the occasion. The sum of \$230.09 was realized by this entertainment for the charitable fund.

In accordance with the suggestion of the Committee of the previous year, your Committee determined that the annual religious service should be celebrated on the evening of the Sunday next preceding St. George's Day. The change was fully justified by the result. The service was held (by permission of the Dean) in the Cathedral Church of St. James. Prayers were read by the Rev. Provost Whitaker, one of the Chaplains of the Society, and the Rev. Dr. Neville, of Hamilton, preached an impressive and eloquent sermon to a large and appreciative congregation. A collection was taken up after the sermon, which, after payment of the usual expenses, added the sum of \$87.40 to the charitable fund.

For some years past the laudable custom of the members dining together on St. George's-day had been discontinued, and in this respect our Society has been singular. It is a custom which is regularly observed by the sister Societies, and one which, in spite of all that can be said of it as a national weakness, is well adapted to encourage and extend that feeling of kindness and good will which should always prevail among Englishmen.

Actuated by these considerations, Your Committee made arrangements for a dinner at the Rossin House, on the evening of St. George's Day. It was well attended both by members of the Society and others, and the greatest harmony and good feeling prevailed.

Although an entertainment of this nature is not usually

undertaken with the view or expectation of adding anything to the funds of the Society, your Committee have pleasure in reporting that, after payment of expenses, the sum of \$44.93 was transferred to the charitable fund.

The Annual Pic-nic was held on Dominion day, at the Mimico Grove. Notwithstanding the numerous excursions, and other attractions and amusements offered to holiday seekers, the picnic was one of the most successful in point of attendance and profit which has yet been given by the Society. The day was all that could be wished, and every thing passed off pleasantly.

Your Committee, however, regret to state that the flags of the Society were on this occasion stolen by some evil-disposed person, and although energetic measures were immediately taken for their recovery, they have not yet been successful. After payment of all expenses, the proceeds of the picnic amounted to \$143.98.

The Society's ball was held in the Music Hall in the Mechanics' Institute, on the evening of the 30th October. The tickets sold have realized, after payment of expenses, the sum of \$51.50.

The distribution of Christmas cheer took place on Thursday, the 24th December, at the Carriage Factory of Mr. R. Coghill, King Street West, a little above the Revere House, the free use of which was kindly given by him for the purpose.

The recipients of the Society's bounty on this occasion were 350 families, numbering about 750 persons. The provisions distributed consisted of the following, viz.:—Beef, 4000 lbs.; Mutton, 1000 lbs.; besides liberal contributions of meat from various friends of the Society; Tea, 120 lbs.; Bread, 642 loaves; and a quantity of coffee and other sundries.

tribution was \$122.40, which has been carried over to the charitable fund. A statement of the contributions received, with the names of the donors, will be found appended to the report.

The tent has continued to be a source of income to the Society, the amount received for the use of the same being \$90, less expenses of storage, repairs, &c., \$27.38, leaving a balance of \$62.62 carried to the charitable fund.

Your Committee have therefore the gratification of reporting, that all the charitable entertainments and celebrations usually undertaken on behalf of the Society, have proved upon the whole in no small degree profitable, and have enabled them to transfer to their successors the balance of \$283.19, which appears upon the Treasurer's statement. The whole of which, they may add, is available for relief, and does not, as in the case of the balance of last year, include any life-members' subscriptions.

Your Committee regret that they were deprived of the services of two valuable officers during the year. The 1st Vice-President, Mr. J. E. Day, felt himself compelled to tender his resignation, which was accepted at the quarterly meeting, held on the 3rd of July.

At this meeting, 2nd Vice-President Gordon, and 3rd Vice-President Wood, were respectively appointed 1st and 2rd Vice-Presidents; and Mr. F. Biscoe was appointed 3rd Vice-President. The vacancy in the Committee occasioned by the last appointment was filled up by Mr. J. F. Lash.

Mr. Biscoe, having commenced to practise his profession in Guelph, sent in his resignation as 3rd Vice-President after the quarterly meeting in October, and up to this time the office has necessarily been vacant.

Another member of the Committee also resigned during the year, whose place was filled by the appointment of Mr. W. J. Bird.

The Physicians of the Society have on all occasions been attentive to the wants of the poor recommended to them by the Committee.

Your Committee having thus given a general view of the Society's operations, would call your attention to the large and increasing demand upon its resources, as exemplified by the number of cases considered during the year. owing in a very great measure to the continued and extensive emigration from the mother country. A marked difference has been observed in the character and class of those seeking relief and assistance, many of them being persons who have seen better days, and who have emigrated to Canada with the vague undefined hope of improving their position in some wayhow they cannot tell-but who are quite unsuited for laborious occupations, or from previous education or apprenticeship to some trade or calling peculiar to England, are without the ability to engage in the most ordinary kinds of work; while if they do obtain employment as farm hands or city laborers. their remuneration is so small as to be often quite inadequate for the support of their families. Spindle turners, rope mat makers, vermin trap makers, cloggers, and other artisans and mechanics are sent to Upper Canada, where their trades are unknown, and where they must, to obtain a livelihood, unlearn all their previous experience, in acquiring, under the greatest disadvantages, a knowledge of some new trade, or must waste those abilities which in other parts of the Dominion might be turned to good account, in the disheartening pursuit of mere manual labour. The Emigration Department is in a great measure responsible for this state of things. A little care and attention on their part in classifying new arrivals as far as possible, and in giving them information and advice as to where their labor and skill is most in demand, would incalculably diminish the distress which too often overwhelms the unknown and friendless emigrant.

Your Committee feel that the Society labors under a disadvantage in having no systematic means of procuring employment for those in search of it. In many cases pecuniary relief would be needless if the Committee could but refer "the right man to the right place." As far as possible they endeavour to do so, and situations have been found for many. Adifficulty however often arises in doing this, from the fact that a number of those persons who profess to be competent to take the situation of clerk or bookkeeper, or other confidential position, have neglected to furnish themselves before leaving England with certificates of good character and competency.

Your Committee are glad to observe that a "Discharged Soldiers' Aid Association" has recently been established in the City, which will doubtless in some degree relieve the Society from attending to the necessities of this class.

With regard to members' subscriptions, your Committee cannot but feel it to be a standing reproach to the Society that so many members allow their subscriptions to remain in arrear. The state of the Society's finances—its ability to fulfil the end of its existence,—ought not to depend upon the variable success of the pic-nic or ball, or other entertainments, but upon the subscriptions. To get in these it ought not to be necessary to employ a collector at all, and it is a matter of deep regret to be obliged to admit, that among members perfectly able to pay, some habitually disregard their obligations, while others compound them in a depreciated currency.

Your Committee would recommend the adoption of a by-law to the effect that every one proposing a member shall pay his first subscription, as it has been found that many persons proposed as members of the Society neglect to pay upon being notified of their election.

Your Committee further recommend that greater efforts be put forth to induce Englishmen to become life-members.

In conclusion, your Committee would bespeak from the members a greater interest in the affairs of the Society, and urge them to manifest such interest by the spontaneous payment of subscriptions, and a more numerous attendance at the monthly and quarterly meetings. Arduous as are the duties of your Committee, it would often lighten them to find members taking an active personal interest in the working of the Society. The records of thirty-two years can now be appealed to as proofs of its usefulness and vitality. Let not lukewarmness impair its efforts in the future. As Englishmen, let us all foster that warmhearted feeling of nationality which binds together in distant countries those, however unequal their condition, who can claim the same descent, and can regard as a joint heritage those glorious memories of a Fatherland which centuries have bequeathed to them-the feeling which finds in the poorest a brother-which forbids change of mind with the change of sky, and which-in their country and their God-is bound up with all that is holiest and best in the nature of mankind.
