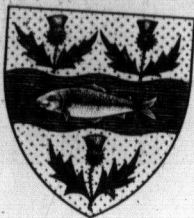

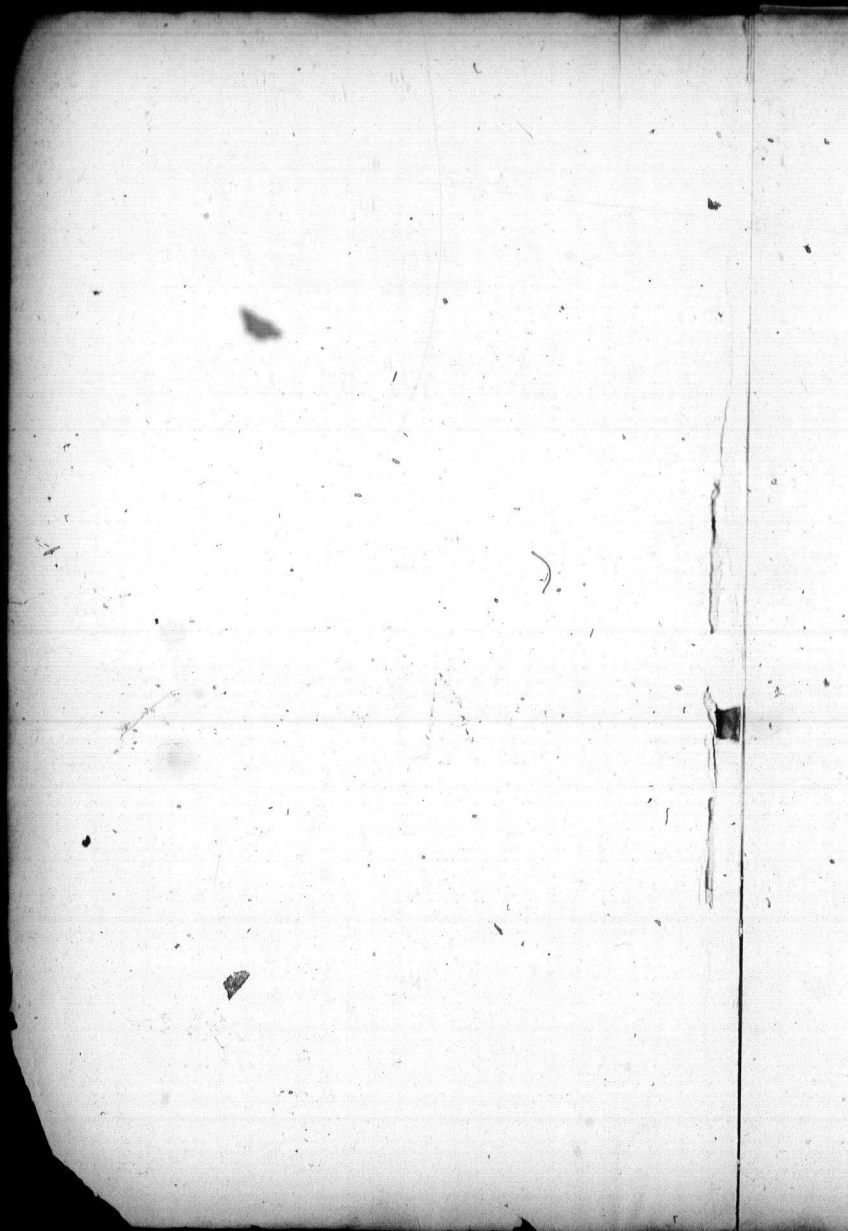

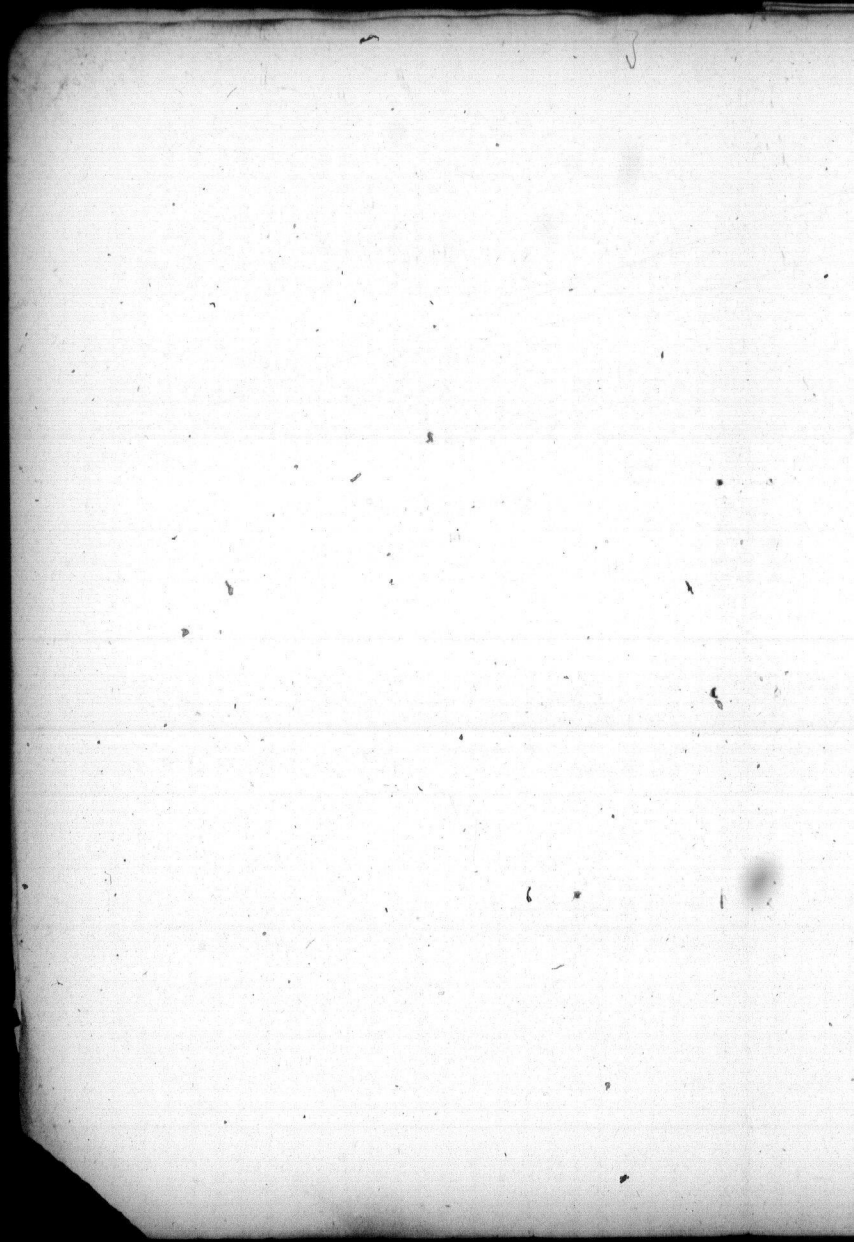

STANDING RULES
FOR THE
CONSTITUTION AND GOVERNMENT
OF THE
NEWFOUNDLAND CHURCH SOCIETY.

NAME.

1.—The Name of this Society shall be "THE NEWFOUNDLAND CHURCH SOCIETY."

OBJECTS.

2.—The objects of this Society shall be, (1) to contribute towards the maintenance of the Clergy and Licensed Lay-Readers; (2) to assist in the erection, enlargement or repairs of Churches, Parsonages, or School-rooms, and in the purchase of land for Glebe or other Church purposes; (3) to provide for sale a supply of Bibles, Prayer Books, School Books, and other Religious Books and Tracts; (4) to assist in creating and sustaining a Special Fund for the endowment and support of the Theological College in St. John's; and (5) to create and maintain a separate Fund for assisting the Widows and Children of deceased Clergymen of this Diocese.

MEMBERS.

3.—The members of this Society shall be, (1) all persons who shall have paid to their Clergyman or the Treasurer the two preceding years the annual sum of ten shillings for the objects of the Society; and (2) all Clergymen who shall have officiated in

Newfoundland or Labrador the two preceding years with the Bishop's license.

4.—All members shall have power to vote at the annual and other general meetings.

OFFICERS.

5.—The Officers of this Society shall be, (1) the Lord Bishop of the Diocese, President; (2) the Venerable the Archdeacon and the Rural Deans, Vice-Presidents; (3) a Treasurer; and (4) a Secretary; the last two to be chosen by the members of the Society at the annual general meeting; but in case of resignation of office, or removal of either Secretary or Treasurer, during the interval between two annual meetings, the Committee shall appoint a person to act in either case, until the next annual meeting.

MANAGERS.

6.—The Committee of Management shall consist of the officers of the Society, and certain lay-members, elected as representatives in each of the Deaneries—viz., four elected by members of the Society resident in the Deanery of Avalon; three by members resident in the Deanery of Conception Bay; two by members resident in the Deanery of Trinity Bay; two by members resident in the Deanery of Bonavista Bay; three by members resident in the Deanery of Notre-Dame Bay; two by members resident in the Deanery of Placentia Bay; and two by members resident in the Deanery of Fortune Bay.

7.—The election of representatives shall be as follows:—On some day in Easter Week, in the year 1859, and in every succeeding fourth year, a meeting of the members resident in each mission, shall be convened by the Clergyman in charge at some convenient hour and place, of which notice shall be given (with the Bishop's consent) in each Church in the mission on some Sunday in the previous month; at which meeting the Clergyman, or, in his absence, some other person then to be chosen by

the members, shall preside, and the members present shall vote *seriatim* for the prescribed number of representatives.

8.—When the voting, which may be continued, if necessary, six hours, but not longer, is completed, the Presiding Officer in each Mission shall report the result to the Rural Dean, and the persons who have obtained a majority of votes in the Deanery, shall be elected representatives; provided that every person to be a member of the Committee must be a Communicant of the Church of England.

9.—The Rural Dean shall report the result of the election in his Deanery to the Secretary in St. John's, the first convenient opportunity.

10.—The new representatives shall be convened by the Secretary at the Michaelmas quarterly meeting; until which time the former representatives shall continue in office.

11.—As often as it shall become necessary, from the death, absence from the Colony, resignation, disqualification, or refusal to serve, of any of the representatives, to appoint another or others in their place, a special meeting of the members, in the Deanery where the vacancy has arisen, shall (as soon as the Rural Dean, or, in his absence, the Clergyman next senior in standing in the Diocese, may in his discretion appoint) be convened in like manner as the Easter meeting, when the required representative or representatives shall in like manner be elected.

12.—The President or a Vice-President, and six other members of the Committee, shall be competent to manage the business at every meeting duly convened.

13.—All Clergymen of the Diocese holding the Bishop's license, shall be *ex officio* honorary members of the Committee, with the right of speaking, but not, with the exception of the officers, of voting at its meetings.

TRUSTEE.

14.—The Lord Bishop of the Diocese shall be the Trustee of this Society, and shall have power to let or to take houses or lands, and to receive all rents and interests of monies as the same shall fall due, and shall pay the same to the Treasurer for the time being, taking his receipt, and handing it over to the Committee.

GENERAL MEETINGS.

15.—An Annual General Meeting of the members and friends of the Society shall be holden in St. John's on the second Thursday after Trinity Sunday, or as soon after as the Bishop may appoint. The Secretary shall give notice to each of the Clergymen in St. John's, who shall publish it [with the Bishop's consent] in his Church on the previous Sunday.

16.—At the Annual General Meeting a report on the state of the Society, with the Treasurer's accounts, duly audited, shall be submitted by the Committee, to be printed, or otherwise, as shall be then and there determined by the members.

17.—A special general meeting may be convened at any time, [1] by the President; [2] by a Vice-President and six members of the Committee, or [3] by any twelve members of the Society whose payments are not in arrear; provided notice of such meeting be duly given as in the case of annual general meetings.

18.—The Chairman shall not vote at any general meeting, except in the case of an equality of votes.

COLLECTIONS.

19.—It is expected that a collection for the various objects of the Society will be made every year by every Clergyman in the Diocese, from every head of a family and every adult member of the Church in his Mission, assisted if need be by his Churchwardens and other respectable members of his congregation.

20.—Every Clergyman shall transmit to the Secretary a list of the contributors to the objects of the Society in his Mission,

with the amount of their several payments, and to the Treasurer one-fourth at least of his whole collections, on or before the last day in every year, or as soon after as practicable.

N. B.—This Rule does not apply to the Clergy of St. John's, who shall send in the whole of their collections to the Treasurer.

21.—All Clergymen who have collected as far as possible from every head of a family, and from every adult Member of the Church in their Missions, towards the objects of the Society, for the two years immediately preceding, and who have remitted to the Treasurer one-fourth of the whole collections, shall be entitled to assistance from the funds of the Society towards any of its objects in their own Mission; provided that no Clergyman shall make a collection for his own maintenance separate from or independent of the general collections; and that pew-rents and assessments be not considered as part of the said collection or collections.

GRANTS.

22.—It shall be the duty of the Committee to determine from time to time on the appropriation of the Funds, by making grants towards the objects of the Society under the recommendation and sanction of the President.

23.—No Clergyman declining or neglecting to collect for the Society, or to transmit a list of the contributors, and their payments, and a fourth part of his collection (as directed in Rule 20) shall be entitled to receive any grants from the Society for himself, or for any of the objects of the Society, in his Mission; provided that where a collection has been duly made, and the list, with the fourth part of the collections, transmitted for the two previous years by his predecessor, any Clergyman newly in charge may, before sending his annual collections, ask and receive for any of the objects of the Society, excepting only his own maintenance.

24.—It shall be competent to the Committee to make grants in the usual manner to any Mission in connection with the Society, which supports its own Clergyman; and any such Mission shall be held to be in connection with the Society whose Clergyman subscribes ten shillings, and makes a collection in his Mission, annually, towards the general funds of the Society.

25.—If a Clergyman leave his Mission before the time for sending in his annual collection, the Committee shall have power, on the recommendation of the President, to grant him a sum which shall appear equitable.

DUTIES OF OFFICERS.

26.—In the absence of the President, the Archdeacon, or in his absence the senior Vice-President, shall take the chair at all meetings of the Committee or members, and shall have a casting vote.

27.—The Treasurer shall receive all monies forwarded to him for the objects of the Society, and shall pay or disburse the same as determined by the Committee, and shall furnish to the President and Committee a statement of accounts up to the day appointed for auditing the same.

28.—No money shall be paid or disbursed by the Treasurer except on a written order, specifying the amount to be paid, and its object, which order must be signed by the Chairman of the Committee at which the grant was made, or in his absence, by the senior Officer of the Society in St. John's.

29.—The Committee shall meet for the despatch of business in St. John's, on the first Thursday after every quarter day, at 2 o'clock, P. M.

30.—A special meeting of the Committee may be convened at any time, either (1) by the President, or (2) by two Vice-Presidents, or (3) by any five members of the Committee; provided due notice of such meeting, with its objects, be given the day before to all the other members of the Committee in St. John's.

31.—At a special meeting to be holden seven days before the annual meeting, the Committee shall appoint two of their number to examine the Treasurer's accounts up to that season, which accounts examined, approved and signed by the Auditors as correct, shall be submitted to the Committee, to be by them incorporated in, or appended to the next yearly Report, and so presented to the members at the next annual general meeting.

32.—The Committee shall fix the salary of the Secretary, and shall provide for all the contingent expenses of the Committee and the Society.

DUTIES OF THE SECRETARY.

33.—The Secretary shall summon and attend all meetings of the Committee and Members, and shall arrange the business, and record minutes of the same to be signed by the Chairman. He shall prepare the annual report, and superintend the printing of the same; shall conduct the correspondence with the Clergy and others on behalf of the Committee; and shall be responsible for the safe custody of all books, receipts and papers belonging to the Society.

PRAYERS.

34.—All meetings of the Society, or of the Committee, shall be opened and closed with the prayers used at the meetings of the Society for the Propagation of the Gospel, or others provided for the purpose by the Bishop of the Diocese.

ALTERATION OF RULES.

35.—These rules may be altered, repealed or added to by the members assembled at any general meeting: provided the proposed alteration has been stated in writing by any person intending to propose it, to the Secretary, at least a month before, for the information of the President and Committee, and that assent has been given to it by the President and a majority of the whole Committee convened for its consideration: and provided also, that it shall be competent to the President to propose

any alteration to a general meeting, notwithstanding such alteration may not have received the assent of the Committee.

NEW DEANERIES.

86.—New Deaneries created by the Lord Bishop of the Diocese shall be allowed to elect Representatives : provided that in every Deanery there shall be at least two resident Clergymen, and ten Churches and Congregations.

SECURITIES.

87.—At each Annual Meeting there shall be appointed three members of this Society, who shall be requested to examine all securities belonging to the general funds of the Society, or belonging or appertaining to the Clergy Widows and Orphans' Fund, or to any other Fund over which the Society has or shall have control, and to report, in writing, to the President, or, in his absence, to the Senior Vice-President, in St. John's, their opinion upon the sufficiency or insufficiency of the same ; and if necessary a special meeting of the Committee shall be convened to consider such report, and to take such action upon it as shall be deemed requisite.

88.—All title deeds, mortgages and other securities belonging to the Society, or over which it has control, shall be deposited and preserved in a suitable muniment box to be provided by the President for the time being, at the expense of the Society, and to be always kept in his charge for the use of the Society.

NOTE.—While it is expected that every Clergyman in the Colony will make a yearly collection for the promotion of the objects of the Church Society, and impress upon every individual under his Pastoral charge the obligations by which he is bound to contribute thereto, year by year,—the system of the Church Society does not require any Clergyman to withhold the ordinances of the Church in any case of refusal or neglect to pay towards his support.

BYE-LAWS
OF THE
COMMITTEE
OF THE
NEWFOUNDLAND CHURCH SOCIETY
RESPECTING GRANTS.

— 0 —

NEW BUILDINGS.

1.—No grant shall be made towards the erection of any Church, School, or Parsonage, or towards the purchase of any Land in any Mission or Settlement, until the Land has been secured in trust for ever for the Members of the Church of England resident in the said settlement.

2.—No grant shall be made towards the erection of any Church, School, or Parsonage, until a plan with an estimate of the cost, and the means of meeting the cost, have been submitted to the Committee.

3.—No grant to any Church shall exceed one-third, and no grant to any School or Parsonage shall exceed one-fourth of the estimated and probable cost; except under special circumstances, approved by the Committee.

4.—The first moiety of any grant towards the erection of any Church, School, or Parsonage, shall not be payable until the building is at least boarded all round and covered in; and the second moiety shall not be payable until the building is finished and ready for occupation and use.

N. B.—All the above rules shall apply in respect of the enlargement of any Church, School, or Parsonage House.

REPAIRS.

5.—No grant shall be made towards the repair of any Church, School, or Parsonage House, until an estimate of the cost, and the means of meeting the cost have been submitted to the Committee.

6.—No grant shall be made until after an interval of seven years from the last grant for a like purpose ; and no grant towards the repair, including painting of any Church, shall exceed one-half, or of any School or Parsonage, one-third of the probable and estimated cost, except under special circumstances, approved by the Committee.

7.—No grant towards the repair of any Church, School, or Parsonage House shall be payable until the work is fully completed, and the cost ascertained, and the whole amount, with the Society's grant, provided for.

8.—All votes passed by the Committee shall lapse to the general purposes of the Church Society, if not expended and applied for within three years from the time the vote was made.

CLERGY WIDOWS AND ORPHANS' FUND.

Clergymen unable to make their yearly collection in their mission for the Clergy Widows and Orphans' Fund, as required by the Seventh Standing Rule, through absence with the Bishop's leave, shall be required in every case to pay in lieu thereof a sum not less than one pound (£1) currency, or more at the discretion of the Committee.

PROCEEDINGS

At the Thirty-third Anniversary of the NEWFOUNDLAND CHURCH SOCIETY, holden at St. John's, in the Cathedral Sunday-School Building, on Tuesday, Sept. 8, 1874.

The Chair was taken at 8 o'clock, P. M., by His Excellency the Governor, assisted by the Rev. T. M. Wood, Vice-President.

After prayer, the business of the evening commenced with reading the Report, and submitting the Treasurer's accounts, after which the following Resolutions were proposed, seconded, and carried unanimously:—

Moved by Rev. G. HUTCHINSON, seconded by C. T. RYLAND, Esq.,—

That the Report now read be received, adopted, and printed with the Treasurer's accounts.

Moved by the Rev. W. PILOT, seconded by Hon. J. S. CLIFT,—
That devout thanks be humbly offered to Almighty God for all the signal blessings vouchsafed to the Church Society during the past year.

Moved by the Hon. W. V. WHITEWAY, Solicitor-General, seconded by the Rev. A. C. WOOD, and supported by Hon. F. B. T. CARTER, Attorney-General, H. LEMESSURIER, Esq., and Revds. R. TEMPLE and G. M. JOHNSON,—

That this meeting cordially accepts the proposal contained in the Report for the establishment of Missions in the Diocese, to be supported by the Church Society; and respectfully invites the sanction of the Bishop of the Diocese to its initiation, under such circumstances as shall seem to His Lordship most fitting and desirable.

Moved by the Hon. the SPEAKER, seconded by Rev. J. F. PHELPS,—

That the thanks of this meeting be very heartily given to the Bishop, as President, and to the Officers and Committee of this Society, for their management of its affairs since the last annual meeting;—that W. H. MARE, Esq.,

be appointed Treasurer, and Rev. G. M. JOHNSON, Secretary, for the ensuing year; and that E. L. JARVIS, THOMAS CLIFT, and HENRY LEMESSURIER, Esquires, be appointed to discharge the duties required by the Thirty-seventh Standing Rule.

Moved by the Hon. A. W. HARVEY, seconded by Rev. J. LOCKWARD,—

That the hearty thanks of this meeting be respectfully tendered to His Excellency the Governor for his kindness in presiding.

The meeting was closed by singing the Doxology and the Benediction.

REPORT—1874.

Your Committee commence their Annual Report with an explanation of the cause of the unusual lateness of the present meeting. It was the wish of the Bishop of the Diocese that it should take place in the early of part June, before the Coadjutor Bishop left on his intended Visitation voyage. This desire was communicated to the Secretary at the end of May, who in reply was obliged to inform the Bishop, that not only were all the St. John's collections then incomplete, but that no less than 12 of the Out-harbor Clergy had not sent on their lists and remittances, and to urge the probability that part of the year's income might be lost if the accounts were closed and the meeting held before the usual time. In justification of the opinion given by the Secretary, your Committee further state that an examination of the Treasurer's accounts has shewn that out of the whole year's receipts, amounting to £1,216 11s. 1d., no less a proportion than £528 0s. 11d. was received during the month of June, and again that of this latter sum, £390 12s. 7d. was paid after the date of the Coadjutor Bishop's departure in the *Lavrock*. Your Committee would remark on the great inconvenience made apparent by the foregoing statement, and desire pointedly to draw the attention of the Clergy to the following memorandum, printed, with a view to calling attention to this subject, in the two last annual reports. "It is particularly requested that all subscription lists and remittances to the Church Society may be made up and sent in, as far as practicable, not later than some time in the month of March, in each year."

Six Clergy, and their Missions, have been added to those who contribute to the Church Society; three of them, viz., Portugal

o

Cove, Channel, and Ferryland, being of the number remarked upon, as being absent from the list at the last annual meeting. The additional Missions are those of Brigus, Belloram, and the South Side of Harbor Grace, the last of these being a newly separated charge, spoken of last year as having been committed to the care of the Rev. John Godden, whose name, your Committee are glad to observe, has lately been placed on the list of the Missionaries of the Society for the Propagation of the Gospel, and the permanence of the Mission, it is hoped, thus fully guaranteed.

The payments from the Funds of the Church Society, have been of a larger amount than usual, so far as ordinary votes have been concerned, having this year reached the total sum of £949 14s. 2d., against £894 18s. 6d. expended in the previous year. An extraordinary vote of £500 to the Bishopric Endowment Fund, was agreed to by your Committee on the recommendation of the Coadjutor Bishop at their meeting in March, subject to the approval of the Bishop of the Diocese. This vote has since been fully sanctioned, and the first moiety of the same transferred to the Fund to which it has been appropriated. The balance remaining in the hands of the Treasurer, stands at the sum of £655 19s. 7d., the liabilities from undrawn votes, except the balance of £250 set apart to the Bishopric Endowment Fund, being much the same as usual. Your Committee would here remind the Clergy that the following new Rule was last year added to the Committee Bye-Laws respecting grants, and printed for the first time in the last Annual Report. "All votes passed by the Committee shall lapse to the general purposes of the Church Society, if not expended and applied for within three years from the time the vote was made." The sealers' contributions for the year 1873, which had not been received when the last meeting of this Society was held, are credited in the Treasurer's accounts, as are also those received for the present year. These last, it will not surprise the Meeting to learn, are of a much smaller amount than usual.

Your Committee remark with pleasure on the satisfactory condition of the general Funds of the Church Society, and in drawing attention to the increase of the balance in the Treasurer's hands, an increase which is the result of steady progress, would suggest that it is desirable, instead of allowing these Funds to accumulate from year to year, rather to apply them to the extension of Missionary work in the Diocese. Doubtless the appropriation of the vote, which has been spoken of, to the Bishopric Endowment Fund, may fairly be considered as a Missionary vote of the most unquestionable character, since the Bishop

must always be the chief Missionary of the Diocese, but your Committee feel it almost a reproach that after so many years no Mission exists to which they can point as originated, under the Bishop's guidance, by the Church Society.

The time has surely come when this Society may feel itself warranted in undertaking the responsibility of such a Mission on the same terms as the older Missions are assisted by the Society for the Propagation of the Gospel, and in guaranteeing a stipend similar to those paid by that Society to any Clergyman whose services the Bishop may be able to procure for any new Mission his Lordship may think fit to establish in any part of his Diocese. Your Committee are fully prepared on the experience of the past to make such a venture on faith of the future, assured that this proposal will be received with the fullest approval by the present meeting, and by the Bishop, and that a blessing from Almighty God, in the way of larger increase of Funds to carry out necessary works of usefulness, will be vouchsafed in response according to the real needs of His Church in all coming time. It is the full belief of your Committee that each year's income will be found sufficient on the average for each year's pressing needs as they arise; that the accumulation of an excessive balance, is both unnecessary and inexpedient, and that money raised for the purposes of a Society, such as that before the present meeting, is always put to its best use, when well spent and got rid of. Your Committee take up this position with the greater confidence as being able to point to the fact that after meeting all the demands of the past year, ordinary and extraordinary alike, the balance with which their accounts are closed is still larger than that with which the year began.

CLERGY WIDOWS AND ORPHANS' FUND.

So far as the subscriptions of the Clergy, and the comparative progress of this Fund is concerned, its condition is much the same as at the time of last reporting thereon. Remarks were then made as to the not altogether satisfactory condition of the collections

which the Clergy who subscribe for its benefits are required to make for this Fund. It is true they have somewhat increased since that time, but this has been not so much by the efforts of separate Clergymen as by the fact that more Clergy have been added to the list of those enjoying a prospective beneficiary interest, and have thus come under the duty of collecting. Apart from the collections in the Churches in St. John's, which amounted to £46 2s., those of 83 Outharbors have only reached a sum of £75 12s. 11d., of which total more than one-third has been contributed by Twillingate, Fogo, Bay-de-Verds, Harbor Briton, and Hermitage Cove; while on the other hand, seven of the most populous Missions in the Island have sent forward a sum amounting to an average from each of no more than £1 0s. 5d. Your Committee draw the attention of the Clergy to the above facts with all possible emphasis, and add further the warning, than which nothing can be more forcible, that the capital of the Fund, which was last year £4,031 0s. 1d., has to this time advanced to a no greater sum than £4,079 2s. 4d., in other words that it shews only £48 2s. 3d. increase. Upon the Clergy in general, your Committee would again urge the very great importance of using their utmost endeavors to enlarge their annual collections so as to secure the permanence of this Fund, in which they are themselves so deeply interested. The number and amount of pensions with which the Fund is chargeable remains the same, and has reached a no less sum than £300 cy., with a prospect of being added to rather than diminished.

BOOK DEPOSITORY.

The sales for the past year have again increased and reached the unprecedented sum of £666 6s. 5d. This fact sufficiently bespeaks the appreciation by the Clergy and Laity of the advantages of such an institution, or rather of its absolute necessity. By the last Annual Report of the Society for Promoting Christian Knowledge, it appears that in one only of the Colonial Depositories, did the sales exceed those of Newfoundland, and that they were surpassed by not more than ten in all the Cities and

Towns of the United Kingdom. It may be expected that another year, when the sales now spoken of are reported, which have been larger than those of last year by upwards of £200, a much higher place will be taken by the Dépôt in St. John's.

BISHOPRIC ENDOWMENT FUND.

In the absence of the Bishop and of the Secretary to the Committee of Management of this Fund, much information that might otherwise have been given cannot now be obtained. In the last report of the Church Society, it was noticed that the Fund then stood at the amount of £3,130. Since that time your Committee have learned that by sums from England and elsewhere, the sum to the credit of the Fund, has been increased to £7,865 6s. 10d. without the first moiety of the Church Society's vote already mentioned. That the Fund is not progressing, so far as the contributions of members of the Church generally throughout the Colony are concerned, your Committee regret to say they were made aware by the Coadjutor Bishop in recommending it to the aid of this Society. The same fact is also made evident by the last printed report published in March. Your Committee deem its statements so important, that they embody them in this Report as calculated more than any words of theirs to stimulate the Clergy and Laity to more combined and energetic efforts to complete what is necessary for this all-important Fund, in order to make due provision for the sufficient and becoming temporal maintenance of those who may hereafter be called to discharge the functions of the episcopate among Churchmen of this Colony. The report referred to is as follows :—

“ The Committee of the BISHOPRIC ENDOWMENT FUND, in presenting their Second Annual Report, beg to call the attention of the Clergy, and members of the Church generally, to the following analysis of the Subscription List, proving, as it does, how very slight have been the efforts made throughout the Diocese to obtain support for this Fund, though it is admitted by all to be necessary to the continued existence of the Diocese, in its integrity, in future years.

- 1.—Thirty-four Missions have sent Returns.
- 2.—Ten have contributed nothing.
- 3.—Thirteen have paid less than £5 in three years.
- 4.—Twenty-one have paid less than £10 in three years.
- 5.—Of two Missions, in no way exceptionally circumstanced, one, *Pogo*, has sent £109 5s., and another, *Harbor Buffett*, £56 15s. 5d.,—proving what may be done where the Clergy are active and zealous in bringing the claims of the Fund before their people.
- 6.—In St. John's, out of 242 names on the Cathedral List of the Church Society, there are only 25 Subscribers to the Fund.
- 7.—Out of 73 names on the St. Thomas's List there are only 17 Subscribers.
- 8.—Out of 51 names on the St. Mary's List there are only 25 Subscribers.

The Committee hope that these facts will weigh with the Clergy especially, in inducing them to make some more earnest efforts during the next two years to obtain more general support to the Fund. Most kind and liberal assistance has been given from England, often by persons who can afford it less than many in Newfoundland who have as yet contributed nothing; and this assistance has been given on the faith of the assurance that every effort was being made, and would continue to be made throughout the Diocese for the completion of the Fund.

While thankfully acknowledging the large subscriptions of some wealthy and generous members of the Church in St. John's, the Committee beg that it may not be forgotten that the due support of all Church funds cannot depend upon the offerings of a few, however large, but must rest upon the contributions of all the members of the Church (individually, it may be, small, but large in the aggregate), given regularly and in proportion to the means which God has given them."

All present at this meeting are well aware of the circumstance of the Coadjutor Bishop's return in ill health from Labrador in the earlier part of last July. He had visited and confirmed in the Mission of Bay-de-Verds, and had been to Bay of Islands and Bonne Bay, and was on the Quebec portion of the Labrador shore, which he had undertaken to visit for the Bishop of that Diocese, when he was taken seriously ill from exposure during a stormy night on a dangerous part of the coast, and very reluctantly compelled to return at once to St. John's. It is also within the knowledge of all present, that, having been advised to seek entire rest and change, he has gone to Nova Scotia, where, it may be added that there is good hope that his health, although remaining far from all that could be wished, is being by degrees restored. The visitation work of the summer, which was intended by the Coadjutor Bishop to have embraced the whole of the Missions on the Southern and Western Shores, in addition to a portion of the Diocese of Quebec along the shores of the Gulf of St. Lawrence, has been taken up by the Bishop of the Diocese, who hurried from England for the purpose, as soon as he heard of the Coadjutor Bishop's illness. This work will be carried out by his Lordship as far as possible. Your Committee regret that the immediate cause of the Bishop's return prevents its being a subject of unmixed congratulation. They desire to offer their sympathies to the Coadjutor Bishop under what they know to be a trial and disappointment to him, and no less to the Bishop, in having suddenly to hasten to undertake one voyage only immediately to enter on another, and in being compelled, after having as was supposed transferred to the Coadjutor Bishop this portion of his work, to enter upon duties involving such extended travel, at a later period of the year than he ever had selected of his own free choice. Your Committee hope to have the pleasure of welcoming the Coadjutor Bishop in renewed health to resume his work in the Diocese, and trust that the Bishop will be permitted in the good Providence of God to complete his visitation voyage in health and safety.

Three Ordinations have taken place since the last Annual Meeting of this Society. In September the Bishop had the pleasure, at Catalina, on the same day on which his new Church there had first been consecrated, as the fitting crown of the new work, and of Mr. Netten's long and faithful and laborious diaconate, of ordaining the Rev. William Netten to the priesthood. The day of these events was a great day for Catalina and its Clergyman, and their appreciation of both events was evinced in the warmest manner by his congregation and his brother Clergy, all of whom within reach were present, nor may we be sure was the pleasure greater to his Bishop, nor the tidings less heartily welcomed by the Clergy generally of the Diocese, whose love and respect for Mr. Netten has been always very great. The other ordinations were those of Mr. Curling, to whose Missionary work and to himself a very peculiar interest must ever be attached, who was ordained Deacon on All Saints Day, and Mr. S. M. Wren, on Trinity Sunday. The former has been placed at Bay of Islands, and the latter at Bonne Bay, both of which Bays were formerly under the sole care of the Rev. Ulric Rule. Three Students were brought from England last month, by the Bishop, once more filling up the vacancies in the College, caused by the sad occurrence of last winter, with the melancholy nature of which all present are acquainted.

Your Committee feel that this report cannot properly be brought to a close without noticing the provision that was made during the last Session of the Legislature for sub-dividing the Education Grant, and thus extending to members of the Church of England the privileges and advantages so long enjoyed solely by Roman Catholics. This measure will come into operation on July 1, 1875, but requires before that time to be perfected in its details, specially those belonging to the arrangement of Church of England Education Districts and the jurisdiction of their Boards. Your Committee take this opportunity of remind-

ing the Clergy and others of this circumstance, that they may make their wishes known in the proper quarter.

Your Committee close their report, as is most meet and due, with the expression of humble gratitude to Almighty God for His many blessings in the past year, and with devout petitions for His favor in the year before them. May He be pleased to bless our Church Society in all its work for the sake of JESUS CHRIST OUR LORD.

It is requested that subscriptions and collections may be remitted together as ordered by the latter clause of rule 7.

Subscriptions paid after Jan. 31, in each year, will come under a fine of 10 per cent. See rule 5.

Clergymen unable to make their annual collections for the CLERGY WIDOWS' AND ORPHANS' FUND, through absence with the Bishop's leave, shall pay in lieu thereof a sum of not less than £1 currency, or more, at the discretion of the Committee.

It is particularly requested that all subscription lists and remittances to the Church Society may be made up and sent in, as far as practicable, not later than some time in the month of March in each year.

STANDING RULES
OF THE
CLERGY WIDOWS' and ORPHANS' FUND.

— 0 —

1.—The NEWFOUNDLAND CHURCH SOCIETY'S Special Fund, for assisting the Widows and Orphans of deceased Clergymen of the Diocese of Newfoundland, shall consist of all monies paid to the Treasurer of the Society for that object.

2.—The Committee of the Church Society shall have the management of the Fund.

3.—Every Hundred Pounds of available surplus shall be invested by the Committee as opportunities occur. Smaller sums shall be deposited every quarter in the Savings' Bank.

4.—All Clergymen in the Diocese holding the Bishop's license may secure the benefit of this Fund by contributing, within six months from the time of obtaining their License from the Bishop, as follows :—(1) Unmarried Clergymen and Widowers, without a child, one pound (£1) per annum ; (2) Married Clergymen (and such as shall afterwards become married,) and Widowers with a child, two pounds (£2) per annum.

5.—Annual Subscriptions shall be payable in advance on the 1st day of January in each year : provided that Clergymen on entry shall for that year pay only a rateable proportion of the annual subscription up to the 1st day of January following. Thirty days' grace shall be allowed, but every Clergyman ne-

glecting to make payment within that time, shall forfeit his claim upon the Fund, to be recovered only upon payment of arrears, with ten per cent. thereon, before the following 1st day of January.

6.—Any Clergyman neglecting to subscribe according to Rule 4, or to pay his annual subscription within the time limited by Rule 5, may, if the Committee see fit to admit or re-admit him, secure the benefit of the Fund by the payment of two pounds ten shillings (£2 10s.), if married or a widower with a child; and one pound ten shillings (£1 10s.) if unmarried or a widower without a child, from the day on which the last annual subscription to be paid was due, or from the date of his being licensed by the Bishop, and from the date of such admission or re-admission, he shall come under the operation of Rule 4.

7.—Every Clergyman securing the benefit of this Fund will be required to make a yearly collection for the same in his Mission, and to forward the amount, with his own annual subscription, to the Treasurer.

8.—The Widow of every Clergyman who shall have paid his annual subscription, and forwarded an annual collection, till his death, or till incapacitated by mental or bodily infirmity, shall be entitled to receive a yearly pension of thirty pounds (£30) currency, during widowhood.

9.—If the Fund should at any time permit, the Committee may increase the amount of pension to any sum not exceeding £50; such an addition, however, being subject to be withdrawn wholly or in part, should the state of the Fund not warrant its continuance.

10.—If the Widow die or marry again, the pension shall be paid to Trustees for the benefit of such children of the deceased husband as may be, if boys, under sixteen, if girls, under eighteen years of age.

11.—The Trustees named by a deceased Clergyman, in the event of the death or marriage of his Widow, shall be recognized by the Committee in paying the pension for the benefit of the child or children; but if the Trustees so named are unwilling or unable to act, the Bishop of the Diocese shall act as Trustee in the application of the pension.

12.—If the wife die before her husband, his child or children shall receive the pension, so long as there is a claimant under Rule 10.

13.—The pensions shall be paid half-yearly by the Bishop's order on the Treasurer, on the first of January and first of July. The first payment to be calculated for the interval from the husband's death to the day of payment.

14.—If a Clergyman having joined the Fund after the 24th June, 1863, removes from the Diocese after having served less than fourteen years, his connection with the Fund shall cease, and he shall be entitled to receive back half the amount of the annual subscriptions he has paid. If he removes after having served fourteen years and less than twenty-one years, he shall be allowed to remain in connection with the Fund by paying an annual subscription of six pounds, or nine pounds if residing within the tropics; or he may receive back half his annual subscriptions, upon which his connection with the Fund shall cease. If he removes, after having served twenty-one years, he shall be allowed to remain in connection with the Fund by paying an annual subscription of five pounds, or seven pounds ten shillings if residing within the tropics; or he may receive back three-fourths of his annual subscriptions, upon which his connection with the Fund shall cease. All Clergymen in connection with the Fund previous to the 24th June, 1863, to be governed by the original Rule 14 thereof.

15.—A yearly statement of the Treasurer's accounts with this Fund shall be published, with the Society's Report.

16.—None of the above Rules shall be altered or repealed, except at a General Meeting of the Church Society, and after a full year's notice to the members of the proposed change.

The following is the original Rule 14, governing Clergymen in connection with the Fund before June 24, 1868 :—

“14.—If a Clergyman removes, with the Bishop's consent, from the Diocese, after officiating in it not less than seven years, he shall be allowed his claim upon the Fund, on the payment of an annual subscription of three pounds (£3) ; or, if he desire it, may receive back half the amount he has paid, which repayment shall release the Fund from all his claims upon it.”
