Hunt, Chan-cellor of the Exchequer, stated in House of Commons that the expenses of the Bri-tiah expedition in Abyssinia, up to date, were less than four millions sterling. Dublin, March 16-Rooney, Lawless, Kelly, and Hurley, are the names of the four Fenians of *Jacmel* packet party, who have just been released by British Gov-ernment, on condition of returning to America. It is reported that all their companions, including Gen. Nagle, who were arrested at Dungarvon, will also be liberated on the same terms.






