THE PONTON CASE

Detectives Greer and Wilkes Were on the Stand.

BUT NO STARTLING EVIDENCE WAS GIVEN. One Pinkerton Thinks the Accused Was Not Treated Fairly.

It Would Have Been Fair Play, Wilkes Says, to Have Shown Ponton the Slip Found in the Bureau Drawer and Have Asked Him for an Explanation...

Napanee, Oct. 14.—(Special.)—The evidence of the detectives is now all in, and there are no more serious developments in the Ponton case.

BADS SHOW THE C.P.R.

Cannon Ball Express From Toronto Collided with a Freight

FIFTEEN MILES THIS SIDE OF OTTAWA. Four Men Were Killed and a Like Number More or Less Hurt.

The Express Was Running at the Rate of Forty Miles an Hour, and the Trains Met at Full Speed in a Hollow—The Engines Topped Over Into the Ditch and the Wreck Was a Fearful Sight—Deputy Minister of Interior Smart Was a Passenger, and He Describes the Wreck Graphically—Wreckers Had the Track Cleared as Speedily as Possible—Express Should Have Stopped at Stittsville.

Ottawa, Oct. 14.—There was a frightful fatality on the C.P.R., near Stittsville, this morning at 5 o'clock, and as a result four people are dead. Two trains met in a dense fog and going at full speed. The killed are: Robert Peden, mail clerk, Ottawa; Samuel Hasty, brakeman, Carleton Place; Frank Larondeau, engineer, Ottawa; R. Kearney, driver, Cantley, Que.

The wounded are: Harry Kavanagh, fireman, James Fleming, Cantley, Que., driver on freight, head and body cut, but not serious; Alex McCuaig, engineer on express, leg broken, and T. Brienall, mail clerk.

Both engines are piled up in a shapeless mass and the debris and wreck is strewn about the place for some distance. At this point of the road a short valley occurs with grades both ways, and both trains were on the level when they met, going at a terrible rate of speed. One of the trains was the Cannon Ball express, carrying a large number of passengers, and the other a special train, carrying mail and express.

The wreck was so close to them when first sighted that nothing could be done to avoid the smash. Larondeau, when Annable yelled in the ditch, but he went rolling up people are dead. A handsome gold watch and chain hung from the man's neck, and a pocket watch which was found in his trousers pocket.

The deceased had been a mail clerk on the Grand Trunk for 25 years. He was a well-known resident of Ottawa, and his name was known to many in the city.
