Editorial Notes

The majority for prohibition is officially placed at 12,218.

There were twenty-eight failures in Canada last week against thirty in the corresponding week last year.

Mrs. Townsley, president of the Ontario W. C. T. U., has shown that nearly one-half of the population of Quebec cannot write. This is a dreadful degree of illiteracy and it is time that the most vigorous steps were being taken to remedy it, for it is a disgrace to the educational system of the Dominion. Until this province becomes enlightened Canada will be held in the power of progress and reform.

Campbell is to have an electric light system installed. Messrs. Duncan & McLellan of this city have secured the contract and everything is to be in running order by Christmas. The plant, which is to be purchased from the Royal Electric Co., of Montreal, is to cost in the vicinity of \$13,000. This is a move in the right direction as Campbell's streets, or rather Main street, are very poorly lighted by oil lamps placed at various distances as to be little benefit. The city is coming "out of darkness into light."

At the banquet in honor of General Klondike at the Hotel Chatham last night, the Hon. J. J. Tweedie, Minister of the Interior, announced the decision of the French Government to evacuate Fashoda. In his remarks he said:

"This afternoon I received from the French Ambassador the information that the French Government have come to the conclusion that the occupation of Fashoda is of no sort of value—prolonged laughter and cheer—and that they have thought in the circumstances, that to persist in an occupation which would only cost them money and do harm, merely because some advisers thought it might be disagreeable to an unwise neighbor, would not show the wisdom with which, as I think, the French Republic has been uniformly guided."

They have done what I believe every Government would have done in the same position—resolved that the occupation must cease. (Cheers.) I must not be understood as saying that all causes of controversy are removed. That is not so. Doubtless there will be many discussions between us; but a somewhat acute and somewhat dangerous cause of differences has been removed."

While other towns are progressing rapidly, what is Newcastle doing to boom its many resources? Simply nothing. We move along in the same old rut from year to year. It is true that during the past two years a number of fine stores and dwelling houses have been erected which add very much to the winter appearance of the town, but there is nothing to give employment to labor in the long winter months except the lumbering industry, therefore during that period trade is almost at a standstill. We need of other towns, some as large as Newcastle, offering thousands of dollars as a bonus to induce companies to build their factories or mills within their limits. Cannot we offer such an inducement? If we had a pulp mill at the Millers, a better place could hardly be found where there would be a place of employment for a large number of men all the year and a market for the small spruce that grows on our farmer's lands. We would like to know what our readers think on this subject and would be pleased to ventilate their views through our columns.

Man Killed at Chatham.
A man named Peter Murray of Carleton Place, who had a schooner at Ritchie's wharf, Chatham, was found dead on the ledge at the side of the wharf about 10.30 o'clock last Saturday night. It is thought that he was murdered as there was a deep cut across the forehead and several bruises about the head. There are so many conflicting stories in circulation that it is impossible to obtain a correct statement of affairs.

The following are the facts as nearly as can be obtained them.
Murray came to Chatham a few days ago with his schooner with a quantity of fish for sale, had completed his business and was to sail for home at the turn of the tide. Murray not showing up at the time desired, the men on the schooner proceeded to look him up, as they thought he was on board some of the other craft and had forgotten the time of sailing. After a lengthy search the body was found as stated above. The body has been taken in charge by Coroner M. S. Benson and the following jury empanelled: E. A. Strong (foreman), Michael Hickey, T. M. Harrington, R. A. Murdoch, Angus Buckley, W. R. Gould and John Johnston.

The inquest is being held at Chatham to-day and a large number of witnesses are being examined.

Start for Canada.
LONDON, Nov. 3.—The Earl and Countess of Minto left London today to embark at Liverpool on board the Scotia, bound for Montreal.

Asbury on the Flats.
The coal barge Grandeur took the ground at the Horseshoe a few days ago, and was got off. Then an attempt was made to tow her up in the night, though she was drawing 20 ft., and she ran hard and fast against Gordon's flats. Schooners are relieving her of part of her cargo.—World.

The ceremony was performed by the Rev. Canon Forsyth at 5.30 p.m. As the bride entered the church leaning on the arm of her brother Mr. Angus Willock, the choir sang "The voice that breathed the Eden." She was attended by Misses Marion Keith and Annie Bowser, and Mr. Wm. Vorton of Campbellton supported the groom, while Mr. A. Willock gave the bride away. The bride looked charming in a cream cashmere gown, prettily trimmed with lace and chiffon, a bridal veil and orange blossoms, and carried a magnificent bouquet of white chrysanthemums.

The bridesmaid's gown was of white organdie with chiffon and ribbon trimmings, and carried bouquets of white and pink chrysanthemums. A number of the ceremony the hymn "O Perfect Love" was sung. As the newly made bride and groom retired from the church, Mrs. T. Fleet, who presided at the organ, played the Bridal March from Lohengrin. The wedding party, consisting of all of near relatives and friends of the bride and groom proceeded to the home of the bride's mother, where supper was served. Rev. Canon Forsyth proposed the health of the bride, to which the happy groom replied. The bride and groom left by the evening express for their future home in Campbellton, followed by the best wishes of their numerous friends. The bride's travelling suit was a pale blue Amazon cloth, with velvet hat to match. The bride's presents were numerous and valuable, including a handsome cashmere or writing desk from members of St. Mary's choir, of which she was a member. The church, which was profusely decorated with chrysanthemums and greenery, presented a very pretty appearance. A number of their New castle friends were at the station to see them as they passed through and they were the recipients there of another shower of rice.

New Brunswick's Success

CALGARY, N. W. T., Nov. 4.—R. B. Bennett, who came from Chatham, N.B., in February, 1897, was today elected to the legislative assembly for West Canada, having in five polling divisions alone polled the largest vote ever given to a candidate in the constituency. The fight was the bitterest in the territories. Bennett was opposed by two old timers, Muir, Q. of the city, and Stuart, a rancher, but let in both the city and country. This vote was within fifteen of their together.

Mr. Bennett's many friends in Northumberland will be pleased to learn of his recent success. Mr. Bennett is a native of Albert county, and is a graduate of Dalhousie. After his admission to the bar, he entered into partnership with Hon. L. J. Tweedie, and went west, as above stated, in 1897, as law partner of Hon. Senator Longhead.

Death of a Former Newcastle Man

Mrs. G. F. McWilliam of Montreal received a telegram on Monday last, informing her of the death of her brother, William F. Maltby in Marquette, Wis.

The particulars were brief, but it seems that on Saturday (Oct. 29th) while unloading logs in the lumber woods in Floodwood, Mich., the chains broke. The result was the log rolled on the unfortunate young man, severely crushing him. He was immediately taken to the hospital in Marquette, where he lingered till Monday at 11 a.m., when death relieved him of his sufferings. His brothers, Edith and Frank were with him at the time of his death. Deceased left Newcastle fifteen years ago, and since that time has worked in the lumber woods in the western States. He had many friends in Marquette, who will regret to hear of his early death.

Provincial Girls in Boston

Correspondence from Boston, in a late number of the Halifax Mail, has the following:

As of late there has been a large influx of young girls from Nova Scotia and P. E. Island. The Mail correspondent had an interview with D. J. Lamond, proprietor of the Lamond Employment Bureau, at 46 Gray St., in reference to their chances of securing employment. He said that the number of girls coming from the Provinces every year, was increasing, but that wages were decreasing accordingly. What they call "girls' girls," can be had now for as low as a dollar, or a dollar and a half a week. This pay is advanced after a time of course, but, nevertheless the average Provincial girl is working for a great deal less than she was five years ago.
