WHEREAS certain of the inhabitants of the Townships of Luther, Preamble-Arthur and Minto, in the County of Wellington, Proton, Egremont and Normanby, in the County of Grey, Carrick in the County of Bruce and Howick in the County of Huron, have petitioned for the 5 ercction of the tsaid Townships into a separate county, under the name and style of the County of Palmerston: Therefore Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:—
