An Act to amend Chapter ninety-two of the Consolidated Statutes of Canada.

In amendment of chapter ninety-two of the Consolidated Statutes of Preamble. Canada, entitled, "An Act respecting offences against person and property," Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:

- 5 **1.** The twenty-second section of the said Act is hereby amended, by inserting after the word "steals" where it occurs the first time in the said section, the words "or for any fraudulent purpose destroys, cancels or obliterates the whole or any part of,"—and the same words after the word "steals" where it occurs the second time in the said section; 10 and the said words so inserted shall be read and construed as forming part of the said section.
- Section 22 of
the said Act
amended.
2. The twenty-sixth section of the said Act is hereby amended by inserting after the words, "authentic Act" in the said section, the words "or any authentic copy of any original document,"—and the 15 said words so inserted shall be read and construed as forming part of the said section.
