An Act to amend "An Act in relation to Fire Insurance Companies not incorporated within the limits of this Province."

[THEREAS, it is expedient to amend the Act of the Legislature of this Preamble. Province, passed in the twenty-third year of Her Majesty's reign, intituled "An Act in relation to Fire Insurance Companies, nct incorporated within the limits of this Province."

- Therefore, Her Majesty, &c., enacts as follows:
 - 1. The first section of the said Act shall be held to include any Fire Act 23, Vic.
