

To the Officers and Representatives of the Grand Division of the Sons of Temperance of Canada West:

Brothers—Let us be truly thankful to the "Giver of all good" for the privilege of meeting together at the Semi-Annual Session of the Grand Division of the Sons of Temperance, Canada West, in this the eleventh year of its existence.

The increase of membership since you last met, and the present prosperity and harmony generally manifested throughout your jurisdiction, are unmistakeable evidences that your efforts to extend the heaven-born principles of Temperance and Brotherly-love have not been unavailing.

Your Grand Scribe's Report will furnish a detailed account of the condition and progress of the Subordinate Divisions under your jurisdiction, and the Report of the Grand Treasurer will exhibit the favorable state of your finances.

The difficulty with Frontenac Division No. 2, pending at your last Session, has terminated—unfavorably to the claims of the Grand Division so far as the law-suit was concerned, but satisfactorily with regard to the appeal to the National Division. In deciding the case against the Grand Division, Chief Justice Robinson said: "The Statute 14th and 15th Vic., chap. 159, sec. 4, confers upon a Subordinate Division, when incorporated, the same privileges given to the larger corporation called the Grand Division. Among these is the important privilege of holding real estate and personal property. The condition that Subordinate Divivisons, to be incorporated, shall be in full standing in the Order, is not prospective in its nature; it makes the being in full standing in the Order a condition, in the first instance, but not a condition of the existence of the Charter. I cannot say that the nonexistence of such full standing, after the Subordinate Division has become incorporated, works ipso facto a dissolution of the Corporation."

From the foregoing extract it will be observed that the effect of incorporating a Subordinate Division, under the Act of the Legislature referred to, is to render the same independent of the Grand Division: that is, under Statute law, the only question which came under the consideration of the Court.

With reference to the desirable and intimate connection existing between the Grand Divisions and the Subordinates under their respective jurisdictions, there is a higher law than the 14th & 15th Victoria. I mean the law of love, one of the cardinal principles of our Order. We are bound together by the strongest of human ties—" our honor as men"—and the violation of this law, and the severance of this tie on the part of Frontenac Division, were the questions taken into consideration by the National Division. The case being one of very great importance as affecting the intimate relations existing between the Grand and Subordinate Divisions, I annex the Report of the National Division Committee entire, which was adopted unanimously by the National Division.

APPEAL No. I.

Frontenac Division No. 2, Grand Division, Canada West.

Several appeals and protests are involved in this case, growing out of the same state of facts; and a decision in one case necessarily settles all; hence the Committee have considered them as one.

The case was before this Body at its last Session, and was referred back to the Grand Division of Canada West for amendment of record.

The document before the Committee would make a respectable octave volume, and there are involved many nice questions of fact as well as law—not only the law of the Order, but of Her Majesty's Province. With the first only are we concerned, as the Courts have been invoked to settle the latter.

After a laborious research, demanding great patience and critical examination, we find the following to be the facts material to the issue:—

First—Two members of Frontenac Division—George and Linton—who were also members of the Grand Division, were charged in their Subordinate Division with violating their obligations as Sons of Temperance, by publishing and circulating reports derogatory to the character of the Grand Division, and calculated materially to impair the usefulness of the Order.

Second—Charges were preferred against these Brothers in the Grand Division to the same effect. These Brothers, if guilty of quietly uttering these slanderous and scandalous reports and imputations upon the Grand Division, were certainly unworthy a place in any branch of our Order.

Third—A Committee, composed of some of the best men in the jurisdiction, were appointed to investigate the charges preferred against Brothers George and Linton before the Grand Division. After a careful and protracted investigation of the case, the Committee reported a resolution declaring them guilty, and recommending their expulsion from the Grand Division. This Report was adopted, and the recusant members expelled by a vote of about 70 to 2.

Fourth—The charge preferred in Frontenac Division was referred to a Committee, and two reports were made, one declaring them guilty, the other acquitting them. The Division refused to find them guilty. An appeal was taken to the Grand Division, and there the action of the Subordinate Division was reversed, and Frontenac Division was directed to expel them.

Fifth—Charges were preferred against Frontenac Division in the Grand Division for insubordination and rebellion, it appearing that some of its members were engaged in defaming the National and Grand Divisions, and exerting their united influence to break down the Order. The Division (George being W.P., and Linton R.S.) were maliciously co-operating in every assault made upon the integrity and reputation of the Order. These charges against the Division, after full investigation, were sustained in the Grand Division, and the following Resolution was passed:—

"Resolved—That the Grand Worthy Patriarch be delegated from this Grand Division to visit Frontenac Division, to counsel the members thereof, and that he have power to suspend said Division No. 2, or otherwise deal with it as he may deem expedient and necessary."

In accordance with that Resolution, the Grand Worthy Patriarch did visit the Division, and, as appears of record, met them in the most fraternal spirit, and counselled them in love to yield to the authority of the Grand Division. After this interview and admonition, the Division, by a vote of 35 to 9, deliberately resolved to resist the authority of the Grand Division, by refusing to conform to its decisions. Thereupon the Grand Worthy Patriarch demanded the Charter, Books, Property, &c., in accordance with the By-laws of the Grand Division, and declared the Division suspended until the next meeting of the Grand Division; and in the face of these remonstrances took possession of the Charter.

The action of the Grand Worthy Patriarch was fully sustained by the Grand Division.

Sixth—Subsequently, instead of appealing to this body, as good and loyal Sons of Temperance should have done, the members declared themselves independent, and proceeded to organize and set up for themselves, and on their own account.

In pursuance of their design they have instituted vexatious law-suits, not yet decided, to recover property, &c.

In reviewing all the proceedings of this complicated and unpleasant case, imperfectly sketched in this Report, your Committee have concluded as follows:—

First—That the accused brothers, George and Linton, exhibited, from the first to the last, a malicious and contumacious spirit, and that their connection with the Order was unfortunately formed and most judiciously terminated.

Second—We have rarely, if ever, seen a more malignant spirit manifested against our Order and its teachings, even by its most open and vicious opponents.

Third—The consideration and forbearance on the part of the Grand Division, and the patient and persevering efforts of its officers, to induce Frontenac Division to yield its rebellion and conform to the laws of the Order, command our admiration, and deserve the praise of all good Sons of Temperance.

Fourth—We are satisfied, from all the facts in the case, that Frontenac Division was most righteously and lawfully abolished, and that upon every principle of our organic law, and the requirements of the Blue-book, the Charter, Books, &c., are the property of the Grand Division of Canada West.

We submit the following resolution:-

Resolved—That the action of the Grand Division in expelling Brothers George and Linton, and in suspending Frontenac Division No. 2, is hereby affirmed by the National Division, and that all appeals and protests against the said action of the Grand Division be dismissed.

Respecting this unpleasant case, I have only to add that your Executive, relying upon the good sense of the Subordinate Divisions, and their firm attachment to the Grand Division, thought it unadvisable to incur the expense of publishing circulars to the Subordinate Divisions, last winter, contradicting the misstatements put in circulation as to the case.

One other case of Appeal settled by the National Division claims your attention.

It is that of Newmarket Division No. 108, against the Grand Division. This case being one of importance also, I append the Report of the Committee thereon, which was unanimously adopted by the National Division:—

REPORT OF COMMITTEE ON APPEALS.

NEWMARKET DIVISION No. 108, vs. THE GRAND DIVISION OF CANADA WEST.

The facts in the case are as follows:—

First—On the 16th day of June, 1857, Brother T. Nixon signified his wish, verbally, to withdraw from the Division. On the 23rd June, next meeting, a motion was adopted that Brother Nixon's resignation be accepted.

Second—On the 21st October, 1857, more than four months after, a motion was adopted that the vote granting Brother Nixon's resignation be rescinded. A motion was then made that a Card of Withdrawal be granted Brother Nixon, upon the payment of his dues, &c., up to this date. This motion was adopted.

On the 17th November, 1857, the Division voted that the whole matter in reference to granting Brother Nixon a card of withdrawal be expunged.

An Appeal was taken to the Grand Division, which decided that Brother Nixon was not entitled to a Withdrawal Card, and affirmed the action of the Subordinate Division in expunging all matters relating to the granting of a Card. What, now, is Brother Nixon's position? The vote granting his resignation is rescinded, and the vote granting him a Card is expunged.

As the matter now stands, Brother Nixon is still a member of the Division; and if we even affirm the action of the Grand Division, he can claim a membership. Did Brother Nixon ask to withdraw? The minutes say he did; and this is strengthened by the fact that an application to resign must be made in writing, while an application to withdraw need not be made in writing. It is further shown that Brother Nixon persisted in his wish to get a Card.

The Subordinate Division, recognizing a mistake, correct their record by granting him a Card, and, having granted a Card, they have no right subsequently to expunge their record.

The Committee, therefore, offer the following resolution :-

Resolved—That the decision of the Grand Division be reversed; that Brother Nixon is entitled to a Card, and that the case be remanded to the Grand Division of Canada West for correction.

Your Delegates to the National Division were instructed by resolution of the Grand Division, in December last, to make application to the National Division to have the words, "Touch not, taste not, handle not," added to the Pledge.

Your Grand Worthy Patriarch had the honor of moving a resolution in the National Division, in accordance with the above instructions, which was referred to the Committee on Constitution, who reported adversely to the change required, which Report was adopted by the National Division.

Your Grand Worthy Patriarch was instructed by the joint Committee appointed by the Good Templars and the Grand Division, to prepare a draft of a Prohibitory Liquor Law, to be submitted to the Legislature for adoption. The labor was accomplished, not as perfectly as could be wished, but the general principles of the Bill are supposed to be in harmony with the views of this Grand Division, and those whom they represent. A copy of the Bill is herewith submitted for such action as may be deemed advisable.

The Bill proved too stringent a measure to meet the views of the Committee of the House of Assembly upon Temperance and Prohibition. The members of this Committee were Mr Simpson, Niagara, Chairman: Hon. Mr Cameron, Mr W. Powell, Mr A. P. McDonald, Mr Roblin, Mr Cook,

It appears from the reports of the Committee that a good deal of attention was paid to the subject in hand. The inquiries instituted resulted in the collection of a large amount of valuable statistical information connected with the traffic, and elicited the opinions of many persons connected with the adminsitration of the law, and otherwise, respecting the kind of legislation required to lessen the evils resulting from the liquor traffic, deplored by all.

Having been appointed at the December Session of the Grand Division to watch the proceedings of the Legislature upon this question, I was present at several meetings of the Committee, and had an opportunity of speaking to most of the members thereof upon other occasions, and found that those of them really desirous of passing a Prohibitory Law, began to fear early in the Session that, although a fair majority of Upper Canada members could be counted in favor of such a measure, yet, the House, as a whole, were adverse.

I found, also, that some of our friends in the House, as well as out of it, were desirous of trying a Sunday Prohibitory Law for a time, before pressing the general measure; hence the chances for passing such a Prohibitory Law, during the Session, as would be satisfactory to the Sons of Temperance were considerably lessened. Nevertheless, the Committee determined to press the question upon the attention of the House in such a manner as to raise a discussion upon the principle and propriety of Prohibition.

Several members of the Committee, including the Chairman, assured me, time and again, that a discussion upon the question should be induced in the House. It will be recollected that the Session of the Legislature terminated rather abruptly, and this may have prevented the Committee from raising the contemplated discussion; but many of our friends think the Chairman of the Committee, who holds a good deal of power in such matters, manifested an unnecessary reluctance to press the question upon the attention of the House.

Certainly the Committee had as strong grounds to stand upon in asking the Legislature to take some decided action upon the Liquor Traffic of the country as they could possibly desire. The statistics which they gathered, the evidence accumulated, and the opinions elicited, not only strongly showed the absolute necessity of speedy action, but, also, that all classes in the community demand such action.

True, some difference of opinion exists as to what the legislation should be; but all thinking men agree that something more stringent is necessary to stay the tide of intemperance which is sweeping over and desolating our fair country. Before that Committee, Physicians, Justices of the Peace, Coroners, Gaolers Recorders, Mayors, Sheriffs and Ministers of the Gospel, bore testimony to the terribly scathing effects of the traffic upon our fellow-men; and Brewers and Distillers stood up and cheerfully witnessed to the vast quantities of God's good grain which they were consuming in the business; and this, too, while the heart-rending wail of famine from several of our recently-settled Counties was appalling the stoutest hearts in the Legislature, and sending a thrill of horror throughout the entire country. Add to this the united voices of 150,000 petitioners, imploring the Legislature to take decided action respecting the liquor traffic; and then tell me if the Committee had not strong reasons for pushing the question.

Since our last meeting, the principles which you labor to disseminate have received such an impetus as to force upon the public a consideration of the

question of Prohibition. A Prohibitory Law applying to the time intervening between 7 o'clock, P.M., on Saturday, and 8 o'clock, A.M., on Monday, passed the Legislature, and is now in force. Why this infringement upon the vested rights of the citizen? Why deprive a high-minded, independent man from paying his own money, during those hours, for a glass-a harmless glass of liquor? Why break in upon the established rules of sociality, and prevent the enjoyment of friends around the wine-cup? Why interfere with the right of the Publican to sell his liquor which he does not want, at any time, for money which he requires? It is answered—the law was passed in order that the Lord's Day should be kept sacred. But if that were all intended by the Legislature, why include a part of the week, during which men may labor, within the operations of the law? The truth is, the principle of Prohibition is fully conceded; and if there be danger to the community in selling liquor at six o'clock on Monday morning, there is danger also in selling at six o'clock on Monday evening, or at any time on any day of the week. Brothers-be it your mission to show this to our countrymen, and to convince them that if it be well to prevent the sale of spirits during thirty-seven hours in the week, 'tis better to extend the restriction to the entire week.

In continuing your labors in the field of Temperance and Prohibition, be not forgetful to avail yourselves of all the instrumentalities within your reach.

Organize Sections of Cadets wherever practicable, and cherish those young volunteers, for they are to supply our places in the Division-room. If we cannot sober off the present generation, let us be instrumental in training up those into whose hands the weighty affairs of our progressive country will soon fall, to habits of sobriety.

Support the Temperance Press, that silent power which sways the world.

Call to your aid the enchantment of the human voice; send forth honest, ardent men, whose truthful, burning words shall melt the heart, and swell your ranks with zealous converts.

And fail not to secure the potent aid of Woman. Make your Division-rooms attractive to your wives, sisters and daughters, and the triumph of your principles is certain.

Brothers! Our work is not yet done. The country—this beloved country of our birth or adoption—is sinning still and suffering still; and while she blindly continues to do so, your task is unfinished.

Brothers! Work on—with firm faith and stout hearts, work on—and when men shall come to be governed by good sense and sound reason, as most assuredly they will; when the power of truth shall prevail, as ultimately it will, then shall be witnessed the grand triumph of the principles of moral suasion, and the telling efficiency of Legal Prohibition.

The Grand Scribe presented the following Report:

Office of the Grand Scribe, Kingston, 20th June, 1859.

To the Grand Worthy Patriarch and Representatives of the Grand Division of Canada West:

Officers and Representatives—The period having arrived for the Semi-annual Session of this Grand Body, I herewith submit to you a Report of the principal transactions of the last six months; and I feel that it is incumbent to acknowledge with gratitude that the Beneficent Creator has permitted so many to assemble again for the purpose of deliberating upon the best means to be employed to promote the interests of our beloved Association, and to strengthen each other with the power of fraternal combination in suppressing one of the most alarming evils that ever afflicted suffering humanity.

The special business of this office, by the direction of the Grand Division at its last Session, has been active and incessant in arousing every agency to promote the Heaven-born cause of Temperance. An immense quantity of blank Petitions with Circulars has been scattered freely over Canada West, and the members of the Order have nobly performed their part in canvassing for signatures to Petitions, which have in a great degree resulted in many huge Petitions being presented to the Legislative Assembly for a Prohibitory Liquor Law. Very many localities forwarded Petitions signed by ninetenths of persons solicited, and many canvassers scarcely met with a refusal; still, it was evident that in many places very feeble effort was made to circulate petitions at all, from the fact that some stern Temperance men had no faith in the Representative Assembly as at present constituted.

Our esteemed Grand Worthy Patriarch, who drafted an excellent Prohibitory Liquor Law, and assiduously watched over, and attended during the whole Session to, the interests of Prohibitory legislation, will, no doubt, give you an ample and interesting report.

An Act to restrain the sale of Intoxicating Liquors from Saturday night till Monday morning has received the Royal assent, and is now the law of Upper Canada. This "Sunday Act" has been freely granted by the Legislature, without any solicitation emanating from this Grand Division or the Order, and it is generally accepted as an instalment of entire Prohibition. A copy of the Act has been forwarded to each Deputy Grand Worthy Patriarch.

In accordance with instructions, a Memorial was prepared and forwarded to each County, Township, City, Town and Village Municipal Corporation in Canada West, requesting each Corporation to petition the Legislature to pass a Prohibitory Liquor Law. (A copy of Memorial is herewith presented.)

I am happy to report that a few Municipalities concurred in sending Petitions, whilst with others the important question of Prohibition gave an occasion for discussion and ventilation of the subject.

I herewith present a copy of a Circular issued during the recess by direction of the Grand Division, defining the privileges of Lady Visitors, as generally understood by the Order.

The draft of Memorial to the various Ecclesiastical Bodies in the Province, prepared with great care by Brothers Reverends R. D. Wadsworth, W. Rowe and J. A. Williams, was received, and copies were forthwith engrossed and forwarded to the several Synods and Conferences about to be convened; and I am gratified to report that most of the Reverend Religious Bodies received the Memorial courteously, and responded with prompt and



decisive action to the christian appeal for help. It would not be invidious to mention, because lately constituted, the courteous manner with which our Memorial was received and acknowledged by the Very Reverend the Synod of the Diocese of Toronto of the Church of England and Ireland. It is, indeed, gratifying to contemplate the sublime spectacle that the Church of Christ in this Province is earnestly striving for the good of fallen man, not only religiously but morally, and trying to uphold your hands whilst engaged in the conflict with an evil the greatest obstacle to the spread of the Gospel. When the hands of Moses were upheld Israel prevailed.

I am happy to report that the Rituals, &c., for the Cadets have been completed by the Committee appointed by the Grand Division. Due praise and thanks should be awarded to Brothers C. H. Vannorman, P.G.W.A., and Rev. R. D. Wadsworth, P.W.P., for the care and attention bestowed in the preparation, revision and completion of the Cadet Work. When the Work was ready, your Grand Scribe issued a Circular, with information necessary to parties making application for Charters. About seven hundred of said

notices were forwarded to the Order in Canada West.

Sufficient time has not elapsed to receive many, but already sixteen applications for Charters have been received. The greatest satisfaction has been expressed at the adaptation, neatness and cheapness of the Cadet Work. The Grand Division will please make an appropriation for the payment of Cadet Books, &c.

I trust that the Grand Division will, at this Session, recommend that every Division embrace the earliest opportunity to organize Sections of Cadets, from whose ranks we shall assuredly draw the best recruits to

strengthen our beloved Order.

A subject of vast importance requires attention, and that is, the employment of and maintaining one or more Lecturers. There is plenty of native talent in the Order that could be secured if a plan could be devised to raise a fund which would afford a fair compensation to a Lecturer. In this connection I would respectfully bring under your immediate notice and favorable consideration the eminent services rendered to the Order and the Cause by our talented Brother, Alfred Hagerty, D.G.W.P., as lecturer.

Your Grand Scribe is satisfied, from reliable information, that the collections and contributions have been insufficient to cover expenses, and would strongly appeal to the Order--the old pioneers in the great philanthropic movement-to render pecuniary aid to valuable and reliable advocates properly accredited.

There are other valuable advocates deserving notice; and amongst them might be mentioned Reverend Brother John McKellican, D.G.W.P., who is willing to render more valuable services than heretofore to our "Branch of the Tree;" and would cheerfully labor for a time in extreme Western Canada, and extend the principles of our Order. I would respectfully submit that this Grand Division should not lose sight of a matter of such paramount importance. Whilst other organizations are making use of this agency, the Order of the Sons of Temperance have of late years neglected to present "the claims of our Order" and its sublime teachings to the masses.

In presenting the Statistical Report, I regret that we cannot refer to anything new or striking. The Order within your jurisdiction is about in statu quo. Are we to rest satisfied with merely occupying the present vantage-ground? We must advance or recede. We are aware that the past year has been one of great financial depression; and had not our principles entered de been in su

Some of the Divisions are in a most flourishing condition. Franklin Division No. 82, organized since the last Session, numbers upwards of 130 members. Although some Divisions may have unhappily fallen, yet others have arisen to supply their places.

As requested, I beg to lay before you a Circular from the Grand Division of Eastern New York, soliciting aid for a Sons of Temperance Monument to the memory of Past Most Worthy Patriarch, D. H. Sands, deceased. Said Circular, having been approved by our esteemed Grand Worthy Patriarch, has been issued to each Subordinate Division of the Order in Canada West, for their voluntary contributions.

I am glad to find that there is not a single case of Appeal to be presented at this Session; and the Order throughout this jurisdiction is characterized by its accustomed peace and harmony.

Minor differences of opinion continually occur respecting the meaning of the Constitution, and its supposed infringements. The decision of our Grand Worthy Patriarch in such cases is invariably treated with due respect, as are the opinions given by the Grand Scribe.

PETITIONS PRESENTED.

The Petition of Berwick and Pine Grove Division No. 339, for a new Charter, theirs having been stolen.

The Petition of Meaford Division No. 314, for a new Charter and Books, theirs having been destroyed by fire.

The late agreeable Session of the National Division of Sons of Temperance of North America, just closed, was more numerously attended than on any previous occasion. All of the British Provinces were well represented; and I am rejoiced to learn that our Order is rising.

I may be permitted to quote from the Report of the Most Worthy Patriarch a few lines of that able document, which clearly explains our wants:—

"The Order wants no legislation at present; all it wants is a universal moving spirit, and Divisional and individual effort. Divisional in the missionary work of forming new Divisions, and individual work in gaining new members."

The Most Worthy Scribe has communicated to this office that the National Division has sustained the Grand Division of Canada West in the matter of Appeal of Linton and others relative to the late Frontenac Division No. 2.

The vote on the Report of the Committee dismissing the Appeal as stated was unanimous.

In the case of Newmarket Division, the Appeal was referred back to the Grand Division for amendment—a Withdrawal Card to be granted to Brother Nixon.

I am happy to state that the Representatives of this Grand Division to the National Division were found at the place of duty.

Upwards of ten years have elapsed, and we find that the Order has accomplished more than its most sanguine friends ever anticipated. And this is not surprising; for we find that the life-inspiring principle of our Order is a generous love of man. The sacrifice of self for the good of others is its natural expression.

In the beautiful Town in which we are now permitted by a kind Providence to assemble, the Order of the Sons of Temperance first had birth in Canada. This day is the Anniversary of good old Brockville Division No. 1; and on this favored spot the Grand Division of Canada West was organized. These hallowed associations should kindle anew our zeal, and excite us to still greater exertions to aid the cause of Temperance and humanity.

Trusting that this Session may not be devoid of beneficial results, but that interchange of sentiment will animate all present with renewed hope and ardor to work for the cause of all mankind.

The Committee on the Grand Worthy Patriarch's Report submitted the following Report:—

Committee Room, Brockville, June 23d, 1859.

To the Grand Worthy Patriarch, Officers and Brethren of the Grand Division of S. of T. Canada West:

Your Committee to whom was referred the Report of the Grand Worthy Patriarch, beg to report that they have given the document their best consideration.

To them, as it must be to every well-wisher of the Temperance movement, the healthy and harmonious state of the Order, at the present time, is a mat-

ter of sincere gratification. While they humbly acknowledge their dependence and indebtedness to a gracious Providence for the measure of success which has attended our beloved Order, they feel that much of that success is attributable to the persevering and efficient efforts of the members of the Order generally, but more especially to those of our respected and esteemed Brother who fills the Chair of this Grand Division. To his untiring exertions has our Order in Western Canada been greatly indebted; and your Committee feel that a sense of duty to his fellow-men, more than any earthly personal consideration, has been his incentive in laboring so earnestly as he has done for the furtherance of the good Cause. The thanks of all good

men, and the prayers of benefited humanity, will be his reward.

Your Committee have much satisfaction in learning that the appeal made to the National Division by some of the late members of the late Frontenac Division, respecting the action of this Grand Division, has not been entertained, and that the proceedings had in relation thereto by this Grand Division have not only been fully sustained, but cordially approved of by that body; and the tribute of praise paid by the National Division to the patient and careful consideration of the whole subject, and the forbearance and brotherly feeling manifested by the late officers and members of this Grand Division, is most satisfactory and gratifying. At the same time, it is a matter of sincere regret and concern to your Committee to find that the interpretation of the law Courts of our country respecting the Statute incorporating our Organization, conflicts with the decision of the highest branch of our Order. The subject is so well known that it need not be explained here. The difficulty is one of more than ordinary import to the best interests and well-working of our Order. After the most attentive consideration which your Committee could bestow upon the subject in all its bearings, they have come to the conclusion that it is desirable that the Act of Incorporation should be so amended as to make the letter coincide with the spirit of the enactment, as was intended by its originators, and by the Members of our Order generally. With this view they would recommend that the Executive officers of this Grand Division be instructed to take such steps as may be necessary to have the desired change effected.

And further, respecting this matter of difficulty with the recusant members of the late Frontenac Division, your Committee have to recommend, in view of the many and persistent efforts put forth, and the manifold misstatements published by interested parties, to the detriment of the fair fame and honorable dealing of the members of this Grand Division as a body, that a number of copies of the Report of the National Division respecting this matter be published and circulated as widely as possible; your Committee conceiving it to be a full refutation of the many foul imputations

thrown out against this Grand Division.

Respecting the appeal to the National Division from the decision of this Grand Division, relative to the trouble which has arisen between Brother Nixon and the majority of the members of Newmarket Division No. 108, your Committee regret to find that the action taken by this Grand Division has not been sustained by that august body. They, nevertheless, feel bound to suggest that this Grand Division humbly bow to the ruling of their superior body, and recommend that the previous action had by this Grand Division be reversed, and that the Newmarket Division No. 108 be directed to grant to Brother Nixon a card of withdrawal, in accordance with the decision of the National Division.

added to the Pledge the words "touch not, taste not, handle not," was not favorably entertained by that body. This, your Committee conceive, should operate as a caution against all such attempts at extreme and impractical legislation by this Grand Division in future.

Your Committee, in common with the great majority of the friends of total abstinence throughout the country, regret that the efforts put forth during the late Session of the Provincial Parliament to secure the enactment of a Prohibitory Liquor Law were not successful. Still, your Committee have every reason to believe that they were not unprofitable. In the investigation of the subject by a Committee of the House of Assembly, a mass of facts and a vast amount of reliable information has been elicited, which your Committee regard as being of very great importance—facts and information which may be used with advantage and benefit to every advocate of our Cause-which may go far to bring home conviction to the minds of many men when other instrumentalities had failed—and the publication of which plain truths cannot fail to be beneficial in every sense. In that respect, at least, good service has been done by last winter's agitation. But in another point of view the agitation has not been unproductive. Through its instrumentality mainly has a partial prohibitory enactment been secured, viz.: the law to restrain the sale of intoxicating liquors between the hours of seven o'clock on Saturday evening and eight o'clock on Monday morning, to certain parties. This enactment your Committee regard as being one of marked importance. They view it as one step in the right direction—a certain indication of the end to be attained. Your Committee confidently rely that the satisfactory results of the working of this measure, if fairly administered, will lead to the adoption of a wholesome Prohibitory Law-such a law as the necessities and the exigencies of the times call for. Your Committee strongly conceive that the best efforts of this Grand Division, by every instrumentality at its command, should be earnestly put forth to the attainment of this most desirable and necessary reform.

Your Committee have had under consideration the draft of a law for the suppression of the manufacture and sale of intoxicating liquor, which was submitted to the Committee of the House of Assembly, but which the majority of that Committee deemed too stringent. Your Committee fully approve of the Bill, and would gladly see it adopted. To the Grand Worthy Patriarch is due the credit of drafting this document, and it in no way detracts from his well-earned reputation as a clear-headed and practical legislator.

Your Committee feel that they cannot more properly close their Report than by directing the attention of this Grand Division to the closing observations, so eloquently expressed, of the Grand Worthy Patriarch, respecting the organization of Sections of Cadets, the support of the Temperance Press, the encouragement of the advocates of our Cause, and the potent influence of woman. These are matters of first importance, demanding the most serious and careful consideration.

Grand Division Committee Room, Brockville, June 23d, 1859.

TO THE GRAND WORTHY PATRIARCH, OFFICERS AND REPRESENTATIVES OF THE GRAND DIVISION, SONS OF TEMPERANCE, CANADA WEST, ASSEMBLED:

Your Committee, to whom was referred the very excellent Report of the Grand Scribe, found great pleasure in carefully perusing the same, displaying, as it does, thought and diligence, with a very happy recognition of the Divine goodness and favor shown to this Order since its first establishment, and a willingness to acknowledge the services of each and every Brother.

We are pleased to find that, on the whole, the Order must be considered in a state somewhat better than statu quo, inasmuch as we have not only held our own, but our peace and harmony are in the highest state of perfection. It is worthy of notice that there are no appeals. We have peace in all our borders; and while we are thus strong ourselves, we can and do rejoice at the growing prosperity of kindred organizations. We conceive we have gained much; first, by the zealous and very general agitation connected with the circulation of the Petition for a Prohibitory Liquor Law; second, by the actual enactment of a law similar to the Forbes Mackenzie Act of Scotland, by which the principle of prohibition is not only recognized but enforced, and that, too, during a period of the week (the holy Sabbath) when there is not only more public drunkenness, but also the many other evils therewith associated; third, the readiness with which some of the Municipal bodies, and all Ecclesiastical bodies, have received and entertained the Memorials presented by this Grand Division, going beyond, in their deliverance thereon, all former action; fourth, we have again commenced instituting Sections of Cadets, and strongly urge Subordinate Divisions to encourage their formation within their respective localities; and we recommend the payment of the expense incurred by printing Ritual and Constitution, &c.

Your Committee are of opinion that Lecturers, of good talent and high moral character, ought to be encouraged by the members of this Order; especially self-denying men, who are willing to visit destitute parts, and there instruct our rapidly increasing population in the heaven-born principles of our noble Order. We regret that the present state of our finances will not warrant the payment of a stipulated salary to such worthy laborers; but would respectfully suggest the appointment of a Special Committee to report to the Annual Session some feasible plan by which a well-organized system of lecturing can be maintained throughout the whole Province the year round.

We lament the frightful amount of delinquency amongst our members by the violation of Article II.; and we see no other remedy but to recommend to each Subordinate Division the appointment of a Special Committee, whose duty it shall be to visit every suspended or expelled member personally, and endeavor to persuade all to return to the Order, with the assurance that they will be received with open hands and warm hearts.

We are glad to find the action of this Grand Division in Appeal No. 1 sustained by the National Division, and in reference to which we fully concur in its decision. It is pleasing to know that we were fully and ably represented in that august body; and the success of our far-extending and

To the Grand Worthy Patriarch, Officers and Representatives of the Grand Division of Canada West:

Your Committee, appointed to report on certain alterations proposed to be made in the Constitution of Cadets of Temperance, beg leave to Report—

I. That they recommend Article IV. of the Constitution to be amended by adding a Sixth Section, as follows:—"That a Withdrawal-card shall be granted to members desiring to remove to another part of the country, provided the Brother applying shall be clear on the books of his Section, twelve and a-half cents to be paid therefor, which shall continue good for one year. Brothers leaving the Order shall not be entitled to such Card. The Grand Division to furnish said Cards."

II. Finding that exception is taken to some parts of the Constitution, especially the power of electing the chief Officers, and the requirement that they shall be Sons of Temperance; also, the non-allowance of members over eighteen years of age to remain members of the Sections; we would respectfully recommend the Grand Division to appoint the present Committee as a Special Committee, to report at the next Annual Session all amendments and alterations thought necessary, and in the mean time let suggestions on the matter be addressed to its Chairman. Said Committee to meet the day before the meeting of the Annual Session at Newmarket.
