ANNUAL RETURNS.

I regret that I am again obliged to report the want of punctuality in County Masters, in not making their Annual Returns at the proper time. Unless these returns are made as provided by the Constitution, your Grand Secretary cannot complete his work for the Grand Lodge meeting.

REPORTS, RITUALS, &c.

During the past year I have forwarded to each County Master, in this Jurisdiction for all Lodges two copies each of the Reports of the M. W. G. L. B. A., and of this R. W. G. L., together with Rituals and Constitutions, when required.

Grand Lodge Reports have been forwarded to each Grand Officer, to the Secretaries of the Sister Grand Lodges, and also to distinguished Brothers in Great Britain and Ireland.

On April 25th 1871, I mailed to each County Master, for all Lodges within his County, printed circulars, calling on the Brethren of this Province for subscriptions to aid in erecting a monument to the memory of our late Brother Scott, who was murdered at Fort Garry. I regret to report that the response has not been up to the anticipations of this Grand Lodge, only five Lodges have as yet been heard from.

A statement of the receipts on that account will be laid before this Grand Lodge.

On December 5th, 1871, I mailed to each County Master a full supply of blank forms for Returns, and on February 8th, 1872, I also forwarded to each Grand Officer and County Master the usual notice of the Annual Meeting of this Grand Lodge, together with a full supply of Blank Railway Certificates for single fare on the Grand Trunk, Canada Central, Brockville and Ottawa and Midland Railways.

In accordance with a resolution of the M. W. G. L. of B. A., I have prepared a list of the names, so far as ascertained, of the Officers and voters, with their rank in the association, and number of Lodge, also a statement of the Lodges in arrears, for the use of the Committee on Credentials.

In closing my report I must tender to the Grand Officers and Brethren my best thanks for the kindness and courtesy displayed by them in all their correspondence with your Grand Secretary.

Trusting that your deliberations may be characterized with that spirit of Brotherly love and harmony which should always exist among members of our Order.

That in view of these facts, (while spurning the sympathy of any that would traffic in the ashes or memory of our beloved Brother in order to make political capital), we pledge ourselves with all the Sister Grand Lodges of the Dominion or even Western Ontario Grand Orange Lodge, to unite in procuring from the Past Grand Master, the Hon. J. Hillyard Cameron, Q. C., and Provincial Grand Master D'Alton McCarthy, Esq., Barrister at law, and Herbert S. McDonald, Esq., M. P. P., their legal opinions in writing as to what Empire, Dominion, Province, or Tribunal had or now has the right and power to cause the arrest and prosecution of the alleged murderers of the said Bro. 3rd. Your Committee concurs in the replies given by your Grand Secretary with the exception of those given to Nos. 72 and 29. The former being from Bro. Wm. Elliot, County Master of Carleton, in which he asks if he will remit the money in his hands, which had been subscribed for the Scott Testimonial, or retain it until wanted.

Your Grand Secretary should have instructed him to forward the money to him (the Grand Secretary) at once, instead of replying to do as he thought proper; and the latter from Bro. George Evans, Secretary of L. O. L. No. 194, aring if a Brother, not having a vote in the District Lodge, was eligible to be elected to office.

Your Committee are of opinion that the Constitution did not warrant

CONSTITUTIONAL QUESTIONS

ASKED OF THE R. W. GRAND MASTER AND HIS ANSWERS THERETO:

1. Have Private Lodges a right to pass By-laws reducing the Initiation Fees of the Several Degrees below the amount stated in the Constitution?

Answer.—They have no such power.

2. Have Private Lodges a right, either directly or indirectly, to refund any part of the Initiation Fees, either before or after the Initiation?

Answer.—They have a right to make such disposition of their funds as they may deem proper.

3. Brother Tipson asks the Grand Master what is to be done with those members who were expelled and suspended in the year 1870, and not reported to this Grand Lodge last year in consequence of the Annual Reports for the County of Frontenac not being forthcoming at this G. L?

Answer.—The cases of those members will be attended to when the reports are sent in, and their names will be published when action has been taken in reference to them by this Grand Lodge.

4. By A. R. Anderson, County Deputy Master of Peterboro: Would like to have opinion of Grand Master, whether a Deputy County Master can sit and vote in the absence of the County Master, without the regular form of Proxy?

Answer.—He can in the M. W. G. Lodge, but not in this R. W. G. L.

5. Also, whether it is the duty of District Master to collect the Warrants, and other property of Dormant Lodges, and hand them into County Master's possession, or the County Master's duty to collect them himself?

Answer.—In my opinion the County Master himself is responsible for the collection of Warrants, &c.
