



SECOND ANNUAL SESSION.

NEW WESTMINSTER, B. C., 18TH OCTOBER, 1887.

The G. C. Templar appointed Bros. Mable, Mashiter and Sister Bertram, Distribution Committee.

The question of deferring the presentation of the reports of the various officers until the arrival of the G. C. Templar, Bro. Rev. J. A. Wood, was submitted to the Lodge, and on motion it was decided to have the G. Secretary's, G. Treasurer's, and G. S. J. Temples' reports read as our next business.

The Grand Secretary then presented the following report :---

To the Grand Lodge of British Columbia, I. O. G. T.:

Dear Brothers and Sisters.—With the end of another year it becomes my duty to lay before you a review of our work in this jurisdiction.

Herewith are submitted the various statements as to membership, lodges, property and finance—our membership has been considerably increased, and as far as reported the value of Lodge property has been materially enhanced; the members of Onward Lodge, No. 2, are to be congratulated on their acquiring, during the past pear, a commodious Hall, centrally located on the main thoroughfare of the city and on which there does not exist a dollar of debt.

The finances of the Grand Lodge are in a healthy condition, and I believe the time has now come when the services of a good lecturer should be secured. If the right man is secured, new lodges will be added to our roll, and our older lodges will be strengthened; earnest, faithful work on these lines will tell; time, trouble or expense should not be spared in laying the foundations of Good Templary, broad and deep, and we shall in due time reap if we faint not.

In the sad calamity which befell the City of Nanaimo on the 3rd of May last, Samuel H. Myers, our late Grand Counsellor was called to his eternal reward. A page in our journal should be set apart to the memory of one who loved our Order so well. In the same disaster Onward Lodge lost five other brothers. Our late brother, Wm. Raybould, M. P. P., deserves more (than passing notice. He was a faithful, active member of Onward Lodge, No. 2, from the day of its organization in March, 1870, to the time of his unfortunate death on 3rd December, 1886. He was one of the few men in politics whose position on the Temperance question was clearly defined. I mention these names particularly, as by every day knowledge of them *V* knew their worth and devotion to our order.

Our death roll is large. Ten members have been borne to their last resting place. Their names are: William Raybould, Samuel H. Myers, John A. Stevens, F. Coyne, J. G. Stewurt, Arthur R. Meakin, Robert Buffington, John Malcolm, Hudson Lee and H. A. Fulton. The lamentable death of our de oted leader Hon. John B. Finch will be

The lamentable death of our defoted leader Hon. John B. Finch will be deeply deplored throughout our Order. Our loss is severe and his place will be hard to full. We humbly trust and pray that his mantle of usefulness may fall on some brother who will lead the united host of Good Templars on to the victory which awaits all earnest consecrated endeavor for the raising of fallen humanity. Some badge of mourning should be adopted in memory of our fallen chief.

In conclusion I have to thank you, brothers and sisters, for the uniform kindness that has been extended to me in my intercourse with you through the past year, and humbly pray that the blessing of God may rest upon your labors during this session; and that the happy day may be bastened when the scourge of intemperance shall be driven from our land.

On motion the G. Treasurer's report was received and referred to the Committee on Finance.

The G. Supt. Juvenile Temples submitted the following report :-

To the Officers and Members of Grand Lodge of British Columbia, I.O.G.T.: In presenting to you this, my first annual report of success although small,

it, I trust, is permanent, and that our success of the past year may be only the harbinger of a brighter dawn for the Juvenile Templars of this jurisdiction.

While meeting with various forms of opposition from outside parties our temples need and ought to have encouragement from every lodge of our noble order. I have called the attent on of nearly every lodge in our jurisdiction to the noble work of raising the children, but in nearly every instance meet with some excuse or other. I am informed that in Victoria there is a Band of Hope working under the auspices of the W. C. T. U., with a membership of 40 children, and that in that city the school report shows 965 children attending the public schools. There are about 200 more attending pri-

vate or no school. We ought to have a great and grand temple in that place. and if some one of our sisters or brothers would try to assist we would have a temple there

I organized "Jubilee Temple, No. 1" at New Westminster on the 27th of June last. We now have a membership of 75 in good standing, with a very faithful Superintendent ably assisted by the Rev. Thomas Haddon, we have bright prospects for the future. 1 also commissioned Bro. Moffat of Wellington, to organize a temple there, who, assisted by Bro. Bickle, organized "Good Hope of Wellington, No 2," with a membership of 37, making a total membership of 112 Juvenile Templars.

I succeeded in having two sets of supplies douated by the R. W. G. Secretary, and have also received supplies from Bro. Gough, our G. Secretary.

I would recommend that 5 per cent. of the Per Capita Tax be devoted to Juvenile Templar work. I have received a commission for two years from the R. W. G. S. of J. T., unless revoked by her, therefore I act in the capacity of D. R. W. G. S. of J. Temples. The following stock is on hand, viz :--One set of supplies, three Charters, three Superintendent's Commissions, a few Catechisms and two pledge cards.

ms and two preuge contacts of C, S. F. HOLL, Submitted in F. H. and C, Superintendent, Juvenile Temples. The report of the G.S. of J. Temples was received and referred to the Committee on Distribution.

Bro. Holt personally invited the Grand Lodge to visit "Jubilee Temple, No. 1," at their regular meeting to-morrow, and on motion of Bro. Dowler it was Resolved, that this Grand Lodge accept with thanks the kind invitation of Bro. Holt, to visit the Juvenile Order of Good Templars to-morrow (Wednesday) afternoon at half-past three o'clock.

Bro. Halliday gave notice that at the Evening Session he would introduce a resolution to reduce the Per Capita Tax.

The Grand Lodge then adjourned until 7 o'clock p. m.

EVENING SESSION.

The Grand Lodge was called to order at 7:15 p. m. by P. G. C. Templar, Bro. R. B. Hemlaw.

The Minutes of the afternoon session were read and approved.

The Committee on Credentials presented the following supplementary report :- Your Committee have examined the credentials and find that Bros. O. D. Sweet and Alex. Kilgour have been duly elected representatives from Richmond Lodge, No. 12, and Bros Rev. T. W. Hall, D. McGillvary and Geo. Chadsey from Peerless Lodge, No. 11, are all entitled to seats in this Grand Lodge, also Bro. G. H. Grant, Chief Templar and Sister Lillie Kard, Vice Templar, of Dominion Lodge entitled to the Grand Lodge Degree.

Bro. Gough raised the point that the resolution was out of order, in that it dealt with matters not contained in the notice of motion.

The G. Chief Templar ruled that the point was well taken, and Bro. Halliday was permitted to amend his motion so that it may conform with the notice given.

The question was very generally discussed, and on the question being called the motion was put and declared lost.

ed hhe motion was put and declared lost. The acting G. C. Templar called Bro. W. J. Mable to the chair and addressed the Grand Lodge on the matter of a set of Regalia, it having been referred to him at our last session. In the course of his remarks he stated that while East he had visited Toronto, and having had the privilege of visiting their District Lodge he had endeavored to induce them to present this young Grand Lodge with a good set of Recalia, and that he had good reasons to expect that before our next meeting we would have them.

A vote of thanks was tendered Bro. Hemlaw for his services in trying to procure a set of Regalia.

Motion moved by Bro. Losee, seconded by Bro. Mable, that in the event of the District Lodge of Toronto sending us a set of Regalia, that a hearty vote of thanks be forwarded to them by the Executive Committee. Carried.

Motion moved by Bro. Halliday seconded by Bro. McAllister that the regulation passed at the last session, by which members of the order runder 16 years of age are deprived of the privilege of voting, be amended so that it be optional with Lodges whether minors vote or not. A discussion ensued and a motion moved by Bro. Losee, seconded by Bro. Crundle, to lay the matter on the table was put and carried.

Bro. Walter infroduced the following resolution which was seconded by Bro. Wilson.

Resolved, that immediate action be taken to influence the various members of the Local Legislature, by means of petitions, to get the obnoxious clauses of the Municipality Amendment Act of last Session repealed, which places the power of granting licenses in the hands of a majority of the Railway Directors in conjunction with two Justices of the Peace, and is a direct infringement of the liberties of the people. Also that means be taken to have the bar where liquors are sold, kept apart from any store, and not as it now often is, the two businesses carried on in the same room.

The foregoing resolution was referred to the Committee on Political Action. The Grand Lodge then on motion adjourned till 9 o'clock to-morrow morning.

MORNING SESSION.

WEDNESDAY, 19TH OCTOBER, 1887.

The Grand Lodge was called to order by P. G. C. Templar, R. B. Hemlaw, and opened with prayer.

On the roll being called the following representatives and officers were found present, viz: Sisters Cummings, Grant, Bell, Bertram and Bros. Losee, Mable, Wilson, Gough, Holt, Hamilton, Moffat, Halliday, Dowler, Walter, Bell, McAllister, Mashiter, Hall, McGillvary, Chadsey, Sweet, Kilgour, Rowling and Hemlaw.

The Minutes of the session of last evening were read and approved.

The Finance Committee were permitted to retire to complete their report. A communication from Sister Brookbank, R. W. G. Superintendent of Juvenile Temples, to Bro. Holt, pressing the claims of the Juvenile Templars was read and referred to the Committee on State of the Order.

Motion moved by Bro. Holt, seconded by Bro. Sweet, that a committee on Juvenile Temples be appointed by the chair. Carried.

Finch for the gift of one hundred copies for one year of "The Good Templar," which has been sent to the Lodge Deputies for distribution, and suggest that each Lodge endeavor to become a large and permanent subscriber to this valuable monthly. We are also grateful to Bro. F. S. Spence, of the Canada Citizen for copies of the TEMPERANCE HERALD. The Canada Citizen ought to have a large circulation in this Province. During the year we did all that could be done to get a first class lecturer to visit this province, and it is only within the past few weeks that we have received notice that the Hon. A great number of questions came to me during the year but there is only one which I will submit for your review. This question came from both Dominion and Vancouver Lodges.

Question.-Can a hotel waiter, who serves guests with liquor be admitted to our Order?

Answer.-No. Our pledge excludes them as no one who furnishes liquor or causes it to be furnished can be a Good Templar.

I would desire to impress upon all Good Templars the importance of recommending suitable persons as Lodge Deputies. The most efficient and most punctual person should be the deputy. If a deputy fails to do his duty the Lodge should recommend another, and more suitable person with reasons for the change.

From only a few of our Lodge Deputies have I received quarterly reports, and from some I have not heard during the year. I would urge lodges throughout the Province, but especially in the cities, to hold more open meetings. Our object is not only to benefit members of our Order, but all within reach, open meetings properly conducted have a wonderful power of awakening and interesting those who have never taken any active part in temperance work or realized the benefits to be derived from membership among us.

OBITUARY. A

While assembling here we cannot but be painfully conscious of the loss we have sustained in the death of our highly esteemed Grand Counsellor, who with other brethren, was so suddenly called away from among us by the dire calamity which befel Nanaimo in the coal mine explosion. Your representative had an unconditional promise from R. W. G. T. on behalf of executive, that this jurisdiction should be "missioned" by Right Worthy Grand Lodge Lecturers, and one of these (D. V.) was to have been Bro. Finch bimself-the latter, now alas, can never be. The R. W. G. L. can however lay its hands on grand men, and such a selection will be made when one is sent to the Pacific coast.

There was a disposition on the part of all to aid in every way weak jurisdictions, and many kind and encouraging remarks were made as to the positions taken by the Grand Lodge of B. C. You will see by the R. W. G. L. report that the R. W. G. Templar in his report speaks in the highest terms of our Grand Lodge. In fact in the management of its affairs it excites "his highest admiration."

Your committee on Political Action beg to submit the following report :--Whereas, we are pleased to learn of the progress made by other Provinces of the Dominion of Canada on the national question of Prohibition of the sale and manufacture of alcoholic liquors, as was expressed by the new parlia-ment at its first session this year which is very encouraging indeed, but we regret that the representatives from British Columbia were unanimous (with one exception) with the anti's. Therefore be it

Resolved—1st. That in view of the neglect of proper organized effort of all the temperance organizations in the past, we recommend the formation of temperance electoral unions upon such basis as may be deemed expedient and further recommend that we call upon temperance electors everywhere to withhold all pledges of political support to party candidates until an official declaration has been made upon the temperance question by the respective party caucusses or conventions, and we further strongly advise temperance electors to take steps to secure the nomination and election of known and avowed prohibitionists as representatives to the Commons, Provincial Legislature or Municipal Councils.

That the Executive of this Grand Lodge prepare petitions to be ad-2nd. dressed to the Local Legislature at its next session, to be distributed to the various subordinate Lodges within the jurisdiction requesting them to circulate the same with a view of obtaining signatures, requesting the Legislature to repeal the obnoxious clause in the Municipal Amendment Act, 1887, which empowers any two Justices having jurisdiction within any municipality through which a railroad passes, in conjunction with the managing directors of such railroad to grant Liquor Licenses, as we consider the provisions of that Act, a violation of the rights of the people secured to them under the provisions of Responsible Government; also that the general license laws of the Province should be revised so as to prevent "bars" from being kept in grocery stores, and that a Wholesale License and Restaurant beer license should be obtained in the same way and manner as a retail liquor license, and that all saloons and bars be closed from 10 o'clock p. m., on Saturdays to 6 o'clock a. m., on Mondays, and that the penal clause should be made explicit respecting what constitutes a sale.

3rd. And we further recommend the friends of temperance throughout the Province the absolute necessity of making special efforts at the next session of the Provincial Legislature by petitioning it, asking for progressive legislation on the Temperance question.

The G. C. Templar stated that as the vote on the place of holding the next session of the Grand Lodge had been re-considered it was necessary to take action on the matter at once.

The city of Vancouver was placed in nomination and being the only place named the Grand Secretary was directed to cast the vote of the Grand Lodge in favor of Vancouver, and the G. C. Templar declared the City of Vancouver as the unanimous choice of the Lodge for holding the next session.

Motion moved by Bro. Wilson seconded by Bro. Mable that a letter of condolence be sent to the wife of our late Right Worthy Grand Chief Templar, Hon. J. B. Finch. Carried.

Bro. Hamilton was excused from further attendance on this Grand Lodge session.

A motion to adjourn was carried and the meeting was closed with the benediction by the G. Chaplain.

MORNING SESSION.

THURSDAY, 20TH OCTOBER, 1887.

The Grand Lodge was called to order at 9:20 a. m. by G. C. Templar, Bro. Hemlaw, and opened with prayer by the Grand Chaplain.

The minutes of the afternoon and evening sessions of yesterday were read and approved.

The Committee on State of the Order submitted the following report:-To the Grand Lodge, I. O. G. T., of British Columbia:

Your Committee on State of the Order beg to report,-

1. That upon the application of Mount Benson Lodge, No. 5, respecting the appointment of District Deputies, we would recommend that the Lodge Deputies of each District be requested by the G. C. Templar to nominate a suitable person to act as District Deputy.

2. We recommend that all subordinate Lodges be requested to drape their charters in mourning out of respect to the memory of the Hon. J. B. Finch, R. W. G. C. Templar, and also that one page of our Journal in each case be devoted to the memory of the late G. Counselor, Bro. S. H. Myers and Bro. W. Raybould, M. P. P., another earnest worker.

3. We notice with pleasure that our membership has largely increased, and that our finances are in a flourishing condition, and trust that the renewed exertions may be made during the present year to still further the cause of Total Abstainence. We earnestly recommend the necessity of political organization, and would impress upon all temperance people the benefit to the cause of uniting in using the franchise and supporting only those candidates pledged to Temperance Reform.

4. We recommend that the other matters in the report of the Grand Chief Templar be accepted and placed on file.

5. We also recommend that the report of the G. Secretary be adopted and placed on file, and the thanks of the Grand Lodge accorded him.

The following official circular from the office of our late R. W. G. C. Templar was read and ordered to be spread upon the minutes:-

RIGHT WORTHY GRAND LODGE, I. O. G. T.

TEMPLAR'S OFFICE, EVANSTON, ILL., SEPT. 13TH, 1887.

To the Worthy Grand and Grand Secretaries:

Dear Brothers and Sisters.—The Constitution of the R. W. G. Lodge provides as follows:

SECTION 9. The fourth week in November of each year shall be known throughout the Order as "Missionary Week," and the entire Order, at the Subordinate Lodge meetings held during the week, shall be requested to raise at least ten cents, or its equivalent, from each member of the Order, to be sent to the Missionary Fund of the R. W. G. Lodge, to be used by that body in the circulation of temperance literature. The funds raised shall be sent by the Secretaries of the Subordinate Lodges to the G. S. of the Grand Lodge, and by him to the R. W. G. Secretary. The R. W. G. Secretary shall acknowledge the receipt of, and forward the same to the R. W. G. Treasurer. The R. W. G. Secretary shall show, in his annual report, the amount of this fund, and by which Grand or Subordinate Lodge contributed; *provided*, that the funds raised in W. G. Lodges shall be sent to the W. G. Secretary, and by him to the W. G. Treasurer, to be used by the W. G. Lodge.

At the Saratoga Session of the R. W. G. Lodge, the following recommendation of the Committee on Petitions was adopted :

"And we would earnestly recommend that inasmuch as the Constitution of the R. W. G. Lodge has set apart the fourth week in November of each year as "Missionary Week," that it will also be designated and observed as a special season of prayer, and that the R. W. G. Templar by proclamation invoke the Order all over the world to unite at that time in praise, prayer and generous giving for the welfare and prosperity of our Order."

In accordance with the law and instruction of the R. W. G. Lodge, I' proclaim the fourth week in November, 1887, a week of prayer throughout the Order. At the regular Lodge meeting held during that week let the entire membership join in prayer and thanksgiving to Almighty God for the wonderful blessings vouchsafed to us as an Order during the past year. The greatest blessing during the year has been union of the divided Order, and I want to urge the whole united Order in every part of the world by a contribution of at least ten cents by each member to place in the hands of the R. W. G. Lodge Executive the funds to liquidate certain debts which prevent full and perfect union of the Order. To accomplish this the collection must be general, and Worthy Grand Lodges must donate the collections in their jurisdiction to the R. W. G. Lodge for such purpose. The need is great, and I plead with every Grand and Worthy Grand Lodge to do all in its power to make the collection a general offering of the Order for the blessing of union.

ary of the Grand Secretary for the forthcoming year be \$75. Carried. Motion moved by Bro. Keith, seconded by Bro. Rowling, that the Grand Secretary procure on the most reasonable terms, the printing of not less than 250 copies of the proceedings of this session to be distributed as follows :-One copy to each representative and officer of this Grand Lodge; one copy to each Lodge and each Lodge Deputy; one copy to each Grand Lodge in the Dominion of Canada and the United States; one copy each to the R. W. G. Templar and R. W. G. Secretary, and not less than 25 copies to be preserved for future binding. Carried.

On motion it was ordered that the thanks of this Grand Lodge be presented to the Pastor of the Baptist Church for the use of their church for our meetings.

Motion moved by Bro. McGillvary, seconded by Bro. Hall, that the Executive Officers be requested to take steps towards securing reduction of fares from Steamboat and Railway Companies to all representatives and members attending the next meeting of the Grand Lodge and that each and all Subordinate Lodges be instructed at least one week before the meeting of the Grand Lodge. Carried.

Motion moved by Bro. McAllister, seconded by Bro. Moffat, that each representative report to his Lodge the necessity of recommending persons for the position of Lodge Deputy at once. Carried.

A deputation from the W. C. T. U. of New Westminster, consisting of Mrs. N. A. Cunningham, Mrs. A. A. Cochrane and Mrs. E. E. Pearson, was introduced by the Grand Marshal and the following address was read by Mrs. Cochrane :-

NEW WESTMINSTER, OCT. 20TH, 1887.

Grand Chief Templar and Members of the Independent Order of Good Templars of British Columbia :

We have the honor of presenting to you the fraternal greeting of the New Westminster Woman's Christian Temperance Union.

In conveying to you the kindly feelings of our organization we would claim kinship with you in the great work of Temperance Reform, which has brought so many of you together at this time.

Our methods may not be identical but our object is one and you will find us ready, gladly to co-operate with you whenever such co-operation may tend to the more speedy overthrow of that giant evil, the licensed liquor traific.

Bros. Mable and McGillvary were nominated. A ballot was taken, and Bro. McGillvary was declared recommended.







Grand Lodge of British Columbia By-Laws,

ANNUAL SESSION.

ARTICLE 1. This Grand Lodge shall hold a regular session not later than the third week in the month of October, and shall continue to meet from day to day (Sundays excepted) until the close of the session.

PLACE OF MEETING.

ARTICLE 2. The Grand Lodge shall, during its session determine the place of the next Annual Session, and the majority of all votes cast shall be necessarv to a choice.

REPRESENTATIVES.

ARTICLE 3. The basis of representation in the Grand Lodge shall be one for the Charter and one for every fifty members or fraction thereof.

ALTERNATE REPRESENTATIVES.

ARTICLE 4. Every Lodge shall have the right to elect for the same term as a regular representative, any member in good standing in the Lodge as alternate to act only in the absence of the regular representative.

ELECTION OF OFFICERS.

ARTICLE 5. The election of Grand Officers shall take place on the second day of the session. Any member of the Grand Lodge shall be eligible, and a majority of the votes given shall be necessary for a choice; but no member shall hold more than one office. In case no candidate shall have received a majority on the first ballot, the representatives shall proceed immediately to ballot again, dropping the candidate receiving the lowest number of votes on each ballot, and in case of a tie the last named in the order of nomination, until some candidate shall receive a majority offield the votes cast.

LODGE DEPUTIES.

ARTICLE 6. At the first meeting in August in each year each Subordinate Lodge shall nominate a member for the position of Deputy Grand Chief Templar, whose name shall be transmitted to the Grand Secretary, with the quarterly returns. In case of a vacancy occurring in the office, the Lodge shall make and forward recommendations as at the beginning of the term.

DISTRICT DEPUTY GRAND CHIEF TEMPLAR.

ARTICLE 7. District Deputies shall have the power anywhere in their respective districts to institute new Lodges, in accordance with the law, to install the officers of any lodge when requested to do so by the Deputy of such Lodge, or in the absence of such Deputy, by the Lodge; and to grant dispensations and perform the other duties of their office in any Lodge in said district, in the absence of the Lodge Deputy, or in case of a vacancy in such office. They shall forthwith report to the Grand Chief Templar all cases of violation on the part of subordinates of the Constitution and By-Laws of the Grand Lodge, or of disobedience of its lawful commands.

TRIAL OF OFFICERS.

ARTICLE 8. No officer shall officiate in the Grand Lodge during the time occupied in his trial. Whenever the Grand Chief Templar or officer acting as such, shall be on urial, or whenever the resolution for the removal of the Grand Chief Templar or officer acting as such, shall be submitted, the Grand Lodge may direct any Chief Templar or Past Chief Templar then present to occupy the chair.

ARTICLE 9. Any representative may be expelled from his seat, as such, for misconduct upon the vote of two-thirds of all the representatives present at any meeting after a copy of the resolution of expulsion shall have been served upon him.

EXECUTIVE COMMITTEE.

ARTICLE 10. Of the Executive Committee the Grand Chief Templar shall be the Chairman, and he shall call meetings thereof as often as occasion requires, and at such points within the jurisdiction of the Grand Lodge as shall seem for the best interest of the Order, at which time the Grand Lodge degree may be conferred on those entitled to receive the same, under Article I., of the Constitution, and none but the members in possession of that degree shall be admitted to the deliberations of the committee.

APPEALS.

ARTICLE 11. All appeals on questions connected with the Constitution, or with the Ritual, Laws and usages of the Order, shall be from the Chief Templar to the Lodge, from the Lodge to the District Deputy, then to the Grand Lodge, if that body be in session; if not, to the Grand Chier Templar, and from him to the Grand Lodge at its next session. On questions of construction of By-Laws, Rules of Order, etc., of particular Lodges or of parliamentary law, appeals shall lie to the Subordinate Lodge, the decision of which shall be final; *provided*, that if any member deem himself or any other member personally wronged or aggrieved, he may appeal from such decision of the Subordinate Lodge to the Grand Lodge, if that body be in session, otherwise to the Grand Chief Templar, and from him to the Grand Lodge.

VOTING.

ARTICLE 12. The vote on any question shall be taken by ayes and navs whenever required by five representatives. In such case the roll of Lodges represented shall be called, with the number of votes to which each is entited, and the result shall be recorded in the journal of the Grand Lodge. When a vote is taken by ayes and nays the representatives present shall be entitled to cast the full vote of their respective Lodges, *provided*, that on the question of the expulsion of a representative, each representative shall be entitled to only one vote.

REVENUE.

ARTICLE 13. SEC. 1. The Revenue of this Grand Lodge shall be raised for the purpose of defraying the necessary expenses thereof.

SEC.2. At each annual session the Finance Committee shall ascertain, as nearly as possible, what amount of money will be necessary, in addition to what may be received for Charter fees, etc., to meet the necessary expenses of the Grand Lodge for the current year, and the amount so estimated shall be assessed upon each Subordinate Lodge in proportion to the number of its members returned at the quarterly report thereof. Such assessments shall be paid by the Lodges quarterly, on the first of February, May, August and November of each year, and shall be forwarded by the Deputy of each Lodge to the Grand Secretary, and shall be sent in registered letters, or in the shape of money orders, otherwise the Grand Lodge will not be responsible for moneys claimed to be sent but not received.

CHARTERS.

ARTICLE 14. When a Charter is granted for the organization of a new Lodge, such Lodge shall receive its instructions from the Grand Chief Templar or Deputy Grand Chief Templar, and if a special Deputy be appointed, he shall be a Chief Templar or a Past Chief Templar. An application for a Charter shall be presented to the Deputy Grand Chief Templar of the District in which such Lodge is to be located; and if approved by him the application and charter fee, which shall be Twelve dollars and a certificate of approval shall be forwarded to the Grand Secretary, when a charter may be issued in accordance with the Constitution. If the Deputy shall disapprove of the application he shall nevertheless transmit the same, and the Charter fee to the Grand Secretary, accompanying them with a statement of his reasons for disapproval, for the consideration of the Grand Chief Templar or Grand Secretary. The supplies to accompany a charter shall include, in addition to those necessary for the organization of a Lodge, a copy of Robarts' Direst.

TRIAL OF SUBORDINATE LODGES.

ARTICLE 15. Before any Lodge can be put on trial, charges duly specifying the offense shall be preferred to the Grand Lodge by the proper Deputy Grand Chief Templar of another Lodge, or by any member of the Grand Lodge, a copy of which shall be served on the said Lodge; and its answer, together with the charges, shall be handed to the Deputy Grand Chief Templar, and by him sent to the Grand Secretary, when the Executive Committee shall take such action as to them shall seem expedient.

SUSPENSION OF SUBORDINATE LODGES.

ARTICLE 16. Any Subordinate Lodge failing to hold meetings for six months, or to make its returns as required by the Constitution, for one year, shall be deemed an extinct Lodge, and its charter shall be forfeited.

CERTIFICATES TO MEMBERS OF EXTINCT LODGES.

ARTICLE 17. Before granting certificates of membership to members of extinct Lodges, the Grand Secretary shall require a recommendation from the Deputy of such extinct Lodge, or some other Deputy in the district, or other satisfactory evidence.

RESTORATION OF CHARTERS.

ARTICLE 18. Applications for restoration of charters of extinct Lodges must be accompanied with satisfactory evidence that a fair opportunity has been given to all who were members in good standing at the time the same became extinct to petition therefor.

DUTIES OF FINANCIAL SECRETARIES.

ARTICLE 19. Financial Secretaries of Lodges are required to present the accounts of members in arrears for collection, regularly each quarter, before another quarter's dues shall have accrued.

SESSIONS.

ARTICLE 20. This Grand Lodge shall not hold open sessions at any time while transacting Grand Lodge business, but may set apart a specified hour during the continuance of the session for instruction in the Subordinate Lodge work, should there be a demand for it, and the business of the Grand Lodge permitting, admitting all who were at the time entitled to a seat in the Subordinate Lodge.

STANDING COMMITTEES.

ARTICLE 21. The Grand Chief Templar shall at the opening of each session, appoint the following standing committees, to consist of five each :-Credentials and Returns, State of the Order and Constitutions, and after the installation of officers at each session the Grand Chief Templar shall appoint standing committees on Appeals. Finance and State of the Order.

Bills from Mr. P. Peebles of \$3 25 for framing Grand Lodge Charter; Rev. J. A. Wood, \$6 for stationery and postage were read and ordered to be paid.

An account of \$2 for gas and wood was ordered to be paid and on motion \$5 was voted to the care-taker of the church for special services rendered the Grand Lodge.

An official circular from B. F. Parker, Esq., R. W. G. Secretary, announcing the death of the R. W. G. Templar, Hon. J. B. Finch, was received and read, and on motion the G. C. Templar was requested to have the circular reprinted and issued to all the Subordinate Lodges.

Motion moved by Bro. McAllister, seconded by Bro. Wood that the Grand Secretary be authorized to procure a box, in which to keep the Grand Lodge Charter. Carried.

Motion moved by Bro. Holt, seconded by Bro. Moffat. that the organizer of any Subordinate Lodge east of Yale be allowed \$12, provided that sum be collected.
