

TELEGRAPHIC

London, Aug. 22. Gold in Bank of England has increased forty one thousand pounds during the week.

Paris, 22nd. It is said that one of the results of the Conference, which has been held at Salzburg between the Emperors Napoleon and Francis Joseph, is to insist that the South German States shall unite in a Confederation, of which Austria is to be the head.

London, Aug. 23. It is rumored today that the formal treaty concluded at the conference recently held at Salzburg between the Emperors Napoleon and Francis Joseph for the formation of a South German Confederation has proved a failure.

The Fenian convention holds its session with closed doors and the members are under a stringent oath of secrecy, as to the proceedings. So far Mr. Collins of Boston has presided. Delegates are present from St. Louis, Cincinnati, Boston, Portland, Philadelphia, Baltimore, and other places to the number of about two hundred.

Athens, Aug. 21. The Greek steamer "Arcadia" which has been successful in running the blockade around the Island of Crete was pursued by a Turkish man-of-war, and the crew of the "Arcadia" finding that they were in danger of falling into the hands of the Turks, scuttled and set fire to the steamer and took to their boats.

Berlin, Aug. 25. The semi-official journals of this city attack severely the policy of France, and denounce the action of the Emperor Napoleon in the Salzburg Conference. They assert that in spite of the details which have been published, definite arrangements for a southern Germany.

London, 26. Despatches from the East report that a rising had taken place in Montenegro but that it was speedily suppressed, and at last account the country was quiet.

Paris, 25. Reports have reached here from Spain that an insurrection had broken out in the Province of Aragon, and that for the moment the rebels were carrying everything before them.

St. Louis, 25th. A despatch from Fort Hayes, Kansas, dated the 23rd says a courier has just arrived from Capt. Ames had a severe battle with 800 Indians, under Santate, on the Republican river. The village was two miles long. Capt Ames charged twice through their wigwags. The savages fought desperately. Three of our men were killed and 25 wounded and 30 horses lost. The Indians lost severely, but finally repulsed our troops.

New York, Aug. 27. Gold 111. Wants of the New Dominion.

Notwithstanding the complete and successful accomplishment of confederation, the New Dominion has still two great wants. She wants more capital and more labor. We have so often in these columns pointed out how magnificently a fish Canada presents for the employment of capital and labor that it is but the old story we have to tell over again in case referring to the fact; but each small, more apt, brings us additional evidence of the truth of our oft-repeated assertion, that in no country under the sun has the capital, the skilled workman, or the emigrant, a finer field for the employment of his money, his handicraft, or his unskilled labor than in British America.

The now created Dominion, as regards its resources, is yet but imperfectly known. We can count the shore line of its lakes and rivers by thousands of miles—its mineral and its fisheries are inexhaustible—its agricultural produce shows per head of population a proportionate result that the United States themselves and this magnificent country is in want of more capital and more laborers.

The population of London in the middle of the present year is estimated by the Registrar General at 3,082,372; of Edinburgh (city), 176,081; of Dublin (city) and some suburbs, 319,210; of the borough of Liverpool, 492,489; of the City of Manchester, 362,823, and of the borough of Salford, 115,942; of the City of Glasgow, 410,076; of the borough of Birmingham, 344,648; of the borough of Leeds, 232,428; of the borough of Sheffield, 325,190; of the City of Bristol, 165,572; of the borough of Newcastle-on-Tyne, 125,960; of the borough of Hull, 102,740.

THE FIRST UNION VICTORY.

The Unionists have made a good beginning in Ontario. The two districts in which the conflict was commenced are respectively West Northumberland and Lincoln. The Union force believed well in both, as the following from the Toronto Leader, received on Saturday night, plainly proves:—

"In West Northumberland Hon. James Cockburn was elected without opposition, to the House of Commons, and Mr. Alexander Fraser, who is a Reformer, holding anti-coalition views, but will offer no factions opposition to the Government, for the Legislature of Ontario.

In Lincoln, Hon. J. R. Beeson and Mr. J. C. Rykert, friends of the Administration, were elected respectively, by acclamation, to the House of Commons and the local Legislature."

The Toronto Globe talks very quiet over the result in the two cases cited.—[News.

OUR FISHERIES.—We notice that very little attention is paid to the protection of the fisheries. It appears that the Americans fish just where and when they please. For the last week they have been in the Bay of Passamaquoddy fishing within a mile of the Town without license and to the detriment of our own fishermen. Where is the Warden and why does he not perform his duty?

This leads us to an examination of our Fishery Law. At present an English and American vessel of 100 tons each may both catch 400 barrels of mackerel, which is admitted to be but a small take. The U. S. vessel pays \$50 license for fishing in British waters.

They both go to a United States port for a market; the Dominion vessel has to pay a duty of \$2 per barrel, while the U. S. vessel has no duty to pay, thereby giving her the advantage of \$750 in gold over the British vessel. Is this to be made a Dominion policy? Or is it a bid for fishermen to become annexationists, as some of them are inclined to be under the unequal exactions of the present law.

The policy need not be prohibitory with reference to the fisheries, but the Americans should be obliged to pay a tax for fishing equal in amount to that exacted by our own fishermen; then our fishermen would be placed on a fair footing with them, and the Dominion exchequer would be a gainer. We trust the hon. Mr. Mitchell will give the subject his attention, and that our contemporaries will assist in calling attention to the subject, which we have so briefly and imperfectly adverted to.

The Elections. We notice from our exchanges that the contest has fairly commenced in all the Provinces. The election at Ottawa was to some off first, during the present week—the great struggle has consequently taken place between Mr. Gibbs the Government candidate, and Mr. George Brown his opponent who spared no efforts to defeat the Government. The result was looked forward to with great interest by both parties; if Mr. Brown were elected the "Anti's" in the lower Provinces—defeated, as well informed Canadian journals assert he would be, then as far as the Government is concerned it will have a majority, which will be augmented by the Provinces of New Brunswick and Nova Scotia. The elections in this Province and Nova Scotia for the Commons are to take place next month. The electoral district of Carleton leads the way—nomination 2d, September, voting on the 7th. Our own County on the 7th and 12th. St. John on the 9th, 13th for the County, 14th for the city. The elections for the Assembly will take place immediately after. We notice that our contemporary, Mr. Stevens of the "Eastern Advocate" has published his card as a Candidate from Albert, for the House of Commons.

The Annual Pic Nic of the employees on the N. B. & C. Railway, took place on Thursday last. Six cars loaded with the men and invited guests, left the Depot at 10 o'clock for Dumbarton Station, where they arrived in good time. The day being very fine, the large party enjoyed themselves in various ways, until the dinner hour, when they were invited to partake of a substantial repast provided for them by the manager, Mr. Osburn in a large building near the station. After dinner many enjoyed themselves by tripping the light fantastic, while others rambled through the beautiful woods. As the shades of evening drew nigh, the whistle sounded the "retreat," and in a few minutes, "all aboard," the train moved forward on its return, and arrived at the Depot at 8 o'clock, p.m., the excursionists expressing themselves much pleased with the day's enjoyment.

We notice that several of our contemporaries including the Montreal Trade Review, confound the "Western" with the "Frontier" route. The Western line, as recently defined, is Frontier from River-du-Loop to Grand Falls, then diverges to the interior by a route explored by Mr. Buck in 1861, following this across the Tanguay river to the N. W. Branch of the Miramichi river, and along same to the Central line by Mr. Fleming's route along this to the Keswick summit, and then by the Keswick valley to the main river, and thence across the river somewhere most practicable, and never yet mentioned by anyone, and thence along the Fredericton Branch and Western Extension to St. John. This is said to be the shortest line to St. John, but it nevertheless entails a work of great magnitude and cost, viz: the bridging of the river at Fredericton; but then the St. Lawrence has been spanned at a cost of Ten millions of Dollars, and why not the St. John, at one half the scale, to favor the Fredericton branch.

Telegraphed advices from Canada state, that the Government supporters up to 27th, were all elected, most by acclamation. Only one Opposition. Brown was low down on the poll. The Premier was far beyond his opponents. It is now sure there will be large majorities to support the local governments of Ontario and Quebec.

Dr. Thomson's Card will be seen in another column. He declares himself in favor of the frontier route for the Intercolonial Railway to connect with the St. Andrews & Quebec Line, ending as it does, at an open winter harbor. The election as we stated some few weeks ago will be a contested one.

The contract for conveying the Mail between St. George and St. Andrews, has been awarded to Michael Kerney, of this town.

Large schools of Mackerel have been in the Bay for the past week, and afforded great sport to many of our citizens, who have been making large hauls of fat No. 1's.
