



#### ELEVENTH ANNUAL COMMUNICATION.

The Most Worshipful Grand Lodge of Ancient, Free, and Accepted Masons of British Columbia, commenced its Eleventh Annual Communication at the Masonic Temple, corner of Douglas and Fisguard streets, in the City of Victoria, B. C., on Saturday, the 17th day of June, A. D. 1882, A. L. 5882, at 2 P.M. Upon calling the roll there were found to be present the following:—

The Grand Lodge was then opened in AMPLE FORM by the M. W. Grand Master of Masons in British Columbia, Coote M. Chambers, Esq., and Solemn prayer by V. W. Bro. Rev'd. Richard Hall Smith, Grand Chaplain of the Order.

The Grand Master next announced the following:— COMMITTEE ON CREDENTIALS.

The Grand Lodge was thereupon called from labor to refreshment for half an hour to allow the above named Committee time to examine Proxies and make their report. The Grand Lodge being called to labor again, V. W. Bro. Edgar Crow Baker, from the Committee on Credentials submitted the following:—

REPORT OF COMMITTEE ON CREDENTIALS.

TO THE M. . W. . GRAND LODGE OF BRITISH COLUMBIA:

Your Committee on Credentials beg leave to report that:-

VICTORIA COLUMBIA LODGE, No. 1. is represented by the Worshipful Master and Senior Warden.

VANCOUVER QUADRA LODGE, No. 2, is fully represented.

ASHLAB LODGE, No. 3, is not yet represented.

CARIBOO LODGE, No. 4, is not yet represented.

Mount Hermon Lodge, No. 7, is not yet represented,

Union Lodge, No. 9, is represented by the Worshipful Master in person, and as proxy for J. W. . ., and by P. . M. . Kelly, as proxy for Senior Warden.

Inasmuch as information has been received to the effect that the W. . M. . and officers of Ashlar Lodge, No. 3, will be down to represent their Lodge in person, and as the proxies from Mount Hermon, No. 7, are expected by the steamer from New Westminster, and further representation is anticipated from other quarters, your Committee respectfully ask leave for further time in order to complete their report on arrival.

#### ANNUAL ADDRESS OF GRAND MASTER.

To our Brethern of the Grand Lorde:—This, the Eleventh Annual Communication opens up as I foreshadowed in my last year's Annual address as Deputy Grand Master with every reasonable prospect of having our long cherished hopes of prospects, surely you will agree with me that it is so, when we consider the stupendous public works that are nowgoing on in this our adopted Province of railway construction and other important works, which must open up our country and cause increased population, out of which I trust fitting material in abundance will be found to swell our numbers and make the benign influence of Free-masonry felt throughout the length and breadth of this Western Province. officers of the Grand Lodge, are permitted to meet to-day just as we left our beautiful Temple this time last year, shielded from the hand of death, and thankful that only Three of the members of the Subordinate Lodges have been summoned to appear before our Creator. For this our songs of thankfulness should be raised, when we look amongst our Sister Grand Lodges who have not been blessed with the same Providential immunity Many eminent and distinguished Masons in other parts of the world have responded to the call of death and entered upon a new and higher life, where in a second Temple and a purer Lodge the Mason will find eternal truth The death sleep of the heathen was a sleep from which there was no awaking, but masonry deriving its system of symbolic teachings from a more enlightened source presents death as the gate or entrance to a better and brighter existence. One of our good Brothers, who, since our last meeting has gone to realize the glorious truth of his own cherished convictions, once said, "The Masonic idea "of death is accompanied with no gloom, because it is represented only as a "sleep from whence we awaken into another life."

Among those who have taken their last degree and passed on to the enjoyment of membership in the Supreme Grand Lodge may be mentioned the names of Bro. Albert, G. Mackey, P. G., Secretary of Grand Lodge of South Carolina, and author of many valuable works relating to the welfare and general history of the Craft. There can be no doubt that the higher elevation of the order can be traced to the judicious publications that have from time to time appeared on the subject of Masonry. To the untiring efforts of Brethren who devoted their attention to Masonic Literature, we are greatly indebted for the position now held by the Craft in the ranks of science. amongst these, Bro. Mackey was one of the leading spirits. During the past year it has been our painful duty to chronicle one of the most dastardly acts. and which for down right wickedness and revenge is unparalleled in the history of the world, the assassination of our deceased Bro. James A. Garfield, late president of the U.S.A., the very thought of which chilled the blood in our veins and created an indignant shudder in the minds of all civilized people. Our Brothers of the neighboring republic have our warmest sympathy in this behalf, and although we cannot foresee the future effect to the nation, our prayer goes out in harmony with the million upon millions that have been offered up, that under the protecting hand of a kind Providence the nation will continue to prosper.

I have also to mention the deaths of Bro. Thomas Douglas Harrington, P. G. Master of G. L. of Canada; Bro. Tracey P. Cheever, R. W. G. Secretary of Massachusetts. This eminent Brotherafter the last closing of his Grand Lodge said, "My record is finished: it will be read a hundred years hence." Half an hour after he was taken ill, and a portion of his words verified within a few hours. Also, Bro. James M. Austen, R. W. G. Secretary of New York; Bro. John P. Glossbrenner of Indiana; Bro. I beg to thank M. W. Past Grand Master, Eli Harrison, also R. W. Past Senior Grand Warden Wm. Dalby, and W. Bro. George Frye for calling my attention to the demise of some of the foregoing Brethren. It is apparent they are attentive to their duties as Grand Representatives. Upon receipt of the sad news of each of these deaths, I ordered all the Lodges in this jurisdiction to be draped in mourning for the period of thirty days.

#### GRAND LODGE QUEBEC AND GRAND LODGE OF SCOTLAND.

A most interesting communication has been received from the Grand Lodge of Quebec, stating that the Grand Lodge of Scotland has recalled and cancelled the patent of the District Grand Master of Montreal, of the three Lodges late Scottish Registry in that city, namely:—The Elgin, late No. 348, S. R.; The Argyle, late No. 625, S. R., and the King Solomon, late No.

These three Lodges are now duly enrolled on the Registry of the Grand Lodge of Quebec, and by request the three original warrants have been returned to these subordinate Lodges to be preserved in their archives. I am pleased to say this settles the difficulty between these Grand Bodies.

It is gratifying to inform you that the resolutions which were passed stating that Masonic relations had ceased between the Grand Lodges of Missouri and Mexico are now rescinded, and that the two Grand Bodies are in fraternal intercourse one with another

Invitations from the Grand Lodge of Pennsylvania to some members of this Grand Lodge have been received, commemorative of their Sesqui Centennial Anniversary, held on St. John's Day, but regret that we could not avail ourselves of the opportunity of attending owing to the great distance, but feel confident that the ceremonies were most interesting as well as instructive.

#### FOREIGN RELATIONS.

Our fraternal relations with other Grand Bodies remain the same, utmost peace and harmony existing amongst us, and I am pleased to state that we have Grand Representatives in nearly all Sister Grand Lodges.

#### DISPENSATIONS GRANTED

To bury with Masonic honors our late Brother A. Rocke Robertson of Victoria Columbia Lodge, No. 1, Judge of the Supreme Court, though scarcely in the prime of life when he was called away. Also to perform the same sad rites for our late Brothers James K. Lockhart of Mount Hermon Lodge, No. 7, and Hugh McKay of Victoria Columbia Lodge, No. 1. I granted a dispensation to appear in public with regalia on St. John's Day at our "Masonic Re-union" when hundreds of Brethren with their wives and families, met for interchange of thoughts, music, &c. This, to me, was one of the most delightful Masonic gatherings I ever witnessed, and trust as each year rolls on that St. John's Day will be similarly kept.

#### BY-LAWS

I have sanctioned several amendments to the By-lawsof Vancouver Quadra Lodge No. 2, on some desirable points and in strict accordance with the constitution.

Mount Hermon Lodge forwarded their By-laws for total revision, but which are not as yet confirmed. I regret to mention that some of the members of Cariboo Lodge have not been acting in a true Masonic spirit, one with another; the trouble arose from the election of officers last fall, and which at one time seemed of a very serious nature, but has been settled by my ordering a new election of Master, and sincerely hope that the Brethren of this Lodge will try and pass smoothly over the faults of others, and that those who have been elevated to the highest offices, will use every endeavor to assist those who are not so fortunate as themselves and give the necessary instructions to enable them to fill the stations with ability.

#### VISITATIONS.

The Grand Lodge Officers accompanied me on Oct. 24, 1881, to visit Victoria Columbia Lodge No. 1, when their work in the second degree was exemplified in a hearty efficient manner. On Dec. 27, 1881, I had the pleasure of visiting Vancouver Quadra Lodge No. 2 and installing the Brethern, ably assisted by the R. W. Deputy Grand Master, and in January, 1882, performed the same offices with similar assistance for Victoria Columbia Lodge No. 1.

It was your intention to accompany me last fall to instal the officers of Cascade Lodge No. 10, at Yale, but unfortunately when everything was about being put in order a raging fire burst forth and destroyed half the town, sweeping away in its course the proposed Lodge room; it was also the intention on the way up to visit Ashlar Union and Mount Hermon Lodges, and which accounts for these Lodges not having been visited.

It is pleasing to know that their jewels and other properties were all preserved.

#### DECISIONS.

I have been called upon to decide some few questions, and as to my mind decisions of all kinds should appear for future reference. I will now give them in full.

1st. Has a Lodge the right to admit to membership any one who has not resided 12 months in this or any other jurisdiction under the Grand Lodge of British Columbia, but who has been an itinerant resident of the Province for several years?

"'Provided any Candidate has resided 12 months in the Province, and his "residence transient, any Lodge and make him by adopting the usual course.

2nd. Are there any means by which a Lodge can confer the honor of Past Master upon a Brother without passing through the chair?

"To confer the honor of Past Master on any Brother who has not been duly elected as Master of his Lodge, would be at variance with the Ancient "landmarks."

3rd. Is a man that stammers eligible for the degrees of Masonry?

"If the defect of speech pr duced by stammering would not disable the "apalicant from imparting to others instruction, or the secrets of the craft-"said applicant is eligible."

#### COMMISSIONS.

I have caused Commissions to be issued to W. Bro. J. C. Hughes in conjunction with W. Bro. J. A. Cottrell, of Mount Hermon Lodge No. 7, W. Bro. R. B. Kelly of Union Lodge No. 9, and W. Bro. Wm. Stewart in conjunction with Brother Past Master Bate of Ashlar Lodge No. 3, to inspect the books, and report on the efficiency of their respective Lodges.

In conclusion, W. Brethern, I would beg to thank the members of the Board of General Purposes, as well as the officers of the Grand Lodge, for their courtesy, kindness and invaluable advice during my term of office; the assistance has been duly appreciated, and enabled me to carry out my duties with greater confidence, and in returning you the great honor you have conferred upon me. I trust that my actions may meet with your approval, and that in selecting another to fill my place you will chose one of more marked ability than myself, and may the Grand Architect of the Universe guide and direct you all in your deliberations for the well being of our Order.

REPORT OF THE R. W. DEPUTY GRAND MASTER.

MOST WORSHIPFUL GRAND MASTER AND BRETHREN OF THE GRAND LODGE.

In presenting this my first report, permit me to express the pleasure it affords me to be again assembled with you on this the Eleventh Annual Communication of our Grand Lodge, and to hope that we may all be long spared to meet and enjoy the benefit and pleasure of communion with each other.

During the past year I have attended the Most Worshipful Grand Master on all his Official Visitations, and have experienced much pleasure and satisfaction in the cordial and fraternal reception accorded to us by the Brethren

On the 27th of December, I assisted the Most Worshipful Grand Master in the installation of the Worshipful Master and officers of Vancouver Quadra Lodge, No. 2, and have also been present on many subsequent occasions in that Lodge, and can assure the Grand Lodge that their work is carried on with regularity and propriety and all business conducted in a truly harmonious and Masonic spirit.

On the 5th of January I had the pleasure of assisting the Most Worshipful Grand Master in the installation of the Worshipful Master and officers of Victoria Lodge No. 1, and have also attended nearly all the regular and emergency meetings of that Lodge, which I am happy to say is in a very prosperous and healthy condition, having during the past year added ten to their number, viz., eight by initiation and two by affiliation, and I am satisfied that the material used is of the right kind to assist us in building up our order.

On the 10th of January it was my duty as, chairman of committee, to preside at a very pleasant and enjoyable Masonic reunion under the auspices of the Lodges in this city, and as most of you, Brethren, are aware, we spent a very happy and social evening, accompanied by our wives and friends. I think these social gatherings do us a great deal of good, and should be glad to see them repeated on all convenient occasions.

It is with deep regret that I notice the death of several eminent Masons outside of our own jurisdiction, some of whom were representatives of this Grand Lodge, viz:

Bro. J. T. Blackie, near the Grand Lodge of Tennessee.

Bro. J. P. Glossbrenner, near the Grand Lodge of Indiana.

Bro. W. E. Webster, near the Grand Lodge of Iowa, and in our own jurisdiction.

Bro. J. T. Thompson, near the Grand Lodge of Quebec.

As this subject will doubtless receive full attention at the hands of our Very Worshipful Grand Secretary, I shall merely suggest that a page in our next printed proceedings be devoted to the memory of the above named Brethren.

As the representative of the Grand Lodge of Wyoming, near this Grand Lodge, I have much pleasure in stating that I am now in possession of my credentials, dated Sept. 1881, and signed by Bro. H. M. Foote, Grand Master, and Bro. R. T. Hilliard, Grand Secretary.

Wyoming, though only a young Grand Lodge, numbering but seven annual communications and with only five Lodges, had in Sept. 1880, being the last proceedings in our possession, 342 members on their roll, which number by this time is doubtless considerably augmented.

I have also much pleasure in stating that on Aug. 27th, I received my credentials from the Grand Lodge of South Carolina, signed by Bro. Jas. F. Islar, Grand Maser, and by Bro. Charles Inglesby, Grand Secretary.

This is a very important Grand Lodge, numbering over 200 Lodges, with a membership of more than 6000. Not being in possession of their proceedings for 1881, I am unable to give you further information regarding this Grand Lodge.

As Deputy Grand Master, if the Brethren not residing in Victoria feel I have neglected part of my duty in not having visited them in their own Lodges during the past year, I must here apologise and ask their kind indulgence, and for excuse plead the pressing emergencies of my own private avocations; at the same time I must say that if it had been found convenient for the Grand Lodge to have made an official round of visitation, I should have striven to have been one of the number.

In conclusion, Brethren, I must add that as a member of the board of general purposes I have done my best to forward the interests of Freemasonry in this province during the past year, and beg to assure you that if my humble efforts have been only of the slightest service to the Craft, I shall be fully compensated by having had the important duties of Deputy Grand Master intrusted to me.

#### ANNUAL REPORT OF GRAND SECRETARY,

TO THE MOST WORSHIPFUL THE GRAND LODGE OF A. F. & A. M. of BRITISH COLUMBIA:

M .. W .. SIR AND BRETHREN:

Another year has rapidly passed away since I had the honor of addressing you on the state of the Craft in this Western corner of the "Masonic Banner," and contributed my humble mite of Masonic information (as required by Constitution) for the benefit of the Brethren of the jurisdiction of British Columbia.

I shall not attempt to expatiate upon the annual work and efficiency of the Subordinate Lodges for two very good reasons, viz:—that from a peculiar combination of circumstances I have not been able to visit but one of the Lodges on the Mainland, and (secondly) these matters coming more within the province of the M. . W. . Grand Master, and R. . W. . Deputy Grand Master, will doubtless be dwelt upon at much length by those eminent Brethren in their addresses.

The Committee on Foreign Correspondence, I am credibly informed have prepared for the first time during my term of office, a somewhat lengthy report which will be presented to you during this session, and thus I am relieved of the onerous task of reviewing all the proceedings from Sister Grand Lodges. I shall, however, if time permit, make a short reference to the transactions of those Grand Bodies who have honored me with their representation in this Grand Lodge, viz.: Arkansas, Georgia, and New South Wales, (Australia). Without further preamble, therefore, I shall at once proceed with those matters which come more clearly under my individual care.

My thanks are due to many Brethren in different parts of the world for occasional copies of pamphlets and periodicals of a Masonic nature, notably the "Masonic Chronicle," from M. C. Lilley, of Columbus, Ohio; "Masonic Token," from Stephen Berry, of Portland; 'Orient," from Grand Lodge of Hungary; "Hajual," from the Grand Lodge of Budapest; "Masonic Chronicle and Official Bulletin," from J. G. Barker, of New York; and the "Free-mason," from the Grand Lodge of New South Wales.

We are also regularly in receipt of those useful and interesting publications the "Voice of Masonry," Chicago; "Freemason's Monthly," from Kalamazoo; and the "Canadian Craftsman," edited by Bro. J. B. Trayes, of Port Hope, Ontario.

This year, as in the past, I have received numerous applications not only from other Grand Lodges but also from many eminent brethren of our Order for copies of our Proceedings, and I am pleased to say that their demands have been promptly responded to as far as applicable to 'the years 1877. 1878, 1879, 1880 and 1881, of which Annual Sessions I have still a fair supply on hand (as also of 1873) but I much regret to say that those of 1874 and 1876, as also those of the "First Session," and "Provincial Grand Lodge" have been absolutely expended to a single copy.

I must again express my fervent desire the usy soon be financially in a position to supply these pressing demands by a "re-print" of our Proceedings from the commencement in 1871 up to and including the present session. Not only will they be useful and interesting to the steadily increasing number of Masons in this Province, but they will be the means of enabling us to comply with the request of those Brethren abroad who pay us the compliment of asking for them, and thus evince the interest they take in our existence and welfare, and show that we are ever green in their memories.

I would suggest, therefore, that after a mature consideration of the report from Bro. Grand Treasurer we vote such sum from Grand Lodge funds as can be conveniently spared for the purpose, and that the Printing Committee be empowered by resolution of Grand Lodge to carry out this suggestion and to embody in said work all "decisions of Grand Masters"—"resolutions and edicts of Grand Lodge," and the "Constitution" as revised at this session—this latter might with greater wisdom be printed in a separate book. It may not incur such a very great amount of expense, and even allowing that Grand Lodge cannot stand the whole outlay there are many Brethren who will willingly contribute sufficient to make up the difference, and I shall cheerfully place my services at the disposal of the Printing Committee in the compilation of the work, and thus supply a want long felt and now rendered an absolute necessity.

#### ARKANSAS.

This Grand Lodge held its Forty-second Annual Communication at Little Rock, commencing 22nd November, 1881. J. H. Van Hoose, Most Worshipful Grand Master, presiding.

The Grand Master's address is able, eloquent and exhaustive, and your Committee would like to pay extended attention to the same, but our space is limited. We give, however, the closing sentences.

"But my zeal for our time honored institution shall in no wise be abated when I take my place in the ranks again as a private soldier. I love Masonry and all true Masons.

And when too old and feeble to make the long journey to this city, I will still love you, and in SPIRIT be with you. Already my steps are teuding towards the West, and in a few more years I will be regarded as one of the old Masons

of the past.

But should I live to be as old as my gray-haired sire, who has reached his four-score and nine, or my grand-father who at the extreme oldage of one hundred and eleven (111) years yet totters across the floor upon his two canes, and should retain my memory of by-gone days as well as they yet do, I shall never forget the pleasant reunions of loved friends and brothers, and when the chilly winds of November are again moaning through the forest-trees and the dried leaves of Autumn are rattling against my window panes, the old man in the chimney corner who sits with bowed head dreaming of happy days gone for ever, will think of the returning season of your gatherings here and will long to be with you once more. And it would be to him an assurance most dear to know that at your happy re-unions in the midst of your joyous festivities "some loved one were saying I wish he were here."

The Grand Master says there should be a Masonic periodical published in the State.

The decisions are numerous, we select a few:

- 1. A Lodge may investigate a charge against a Brother by a woman, if not frivolous.
- 3. Where a Lodge under dispensation has no suitable hall to meet in, they may thankfully accept temporarily the use of a good hall tendered them by the Knights of Pythias, though when they have procured a suitable hall, and it has been dedicated they cannot reciprocate the courtesy.
- 5. Master Masons are obliged to sit up with a sick Fellow Craft when summoned for that purpose.
  - . 28. A Mason cannot affiliate on a diploma; he must have a demit.

The condition of the Craft in this jurisdiction is reported prosperous.

# CALIFORNIA.

The Thirty-second Annual Communication was held at San Francisco on the 11th day of October, 1881. M.: W.:, Samuel Crawford Denson occupying the Grand East.

The M. '. W.'. Grand Master in his address notified the removal of the edict of non-intercourse between the Grand Lodges of New York and Connecticut, also that the funds of the Grand Lodge failed to meet expenditure, dispite economy. "Why don't you raise your fees to make ends meet."

#### DAKOTA.

The Seventh Annual Communication occurred at Sioux Falls, June 14th, 1881, The Grand Master being absent, the R. W. Deputy Grand Master presided.

The address of the Grand Master is brief, but abounding in good sense and comprehensive.

He congratulates the Craft, that the Lodges in this jurisdiction with perhaps two or three exceptions are in a thriving and prosperous condition.

"They are free from debt and are gradually increasing in numbers and influence."

Bro. Hand submits a few decisions, but none that require particular notice. Concluding he says:

'Four years ago the Grand Lodge of Dakota was composed of six chartered Lodges; now sixteen chartered Lodges are in obedience to it with five under dispensation. Then it was engaged in an unfortunate controversy with a Sister Grand Lodge which disputed its authority and refused it recognition. To-day it is at peace with the world and its jurisdiction is unquestioned \* \* "''

The Committee on Foreign Correspondence presented a resolution which was unanimously adopted, extending fraternal recognition to the United Grand Lodge of A. F. & A. M. of Colon and the Island of Cuba

The Grand Master's address occupies nine pages, and specially refers to the bereavement of the Craft by the death of Bro. James A. Garfield, and giving a history of his Masonic life.

Both of the M.'. W.'. Grand Master and R.'. W.'. Grand Secretary were re-elected.

Number of Lodges on Roll, 27; Total membership, 2,752.

#### IDAHO.

A Special Communication assembled at Boise City, January 11th, 1881, over which M. ·. W. ·. H. E. Prickett, Grand Master, presided.

The Fourteenth Annual Communication was held at Boise City, Sept. 14th, 1881. M.'. W.'. H. E. Prickett, Grand Master, again presiding.

The Grand Master speaks very encouragingly of the healthy condition of Masonry in his jurisdiction. We extract the following:—

"It is a noticeable and gratifying fact that in Idaho, as men gradually lose the habits and propensities which pertained to their earlier condition and settle down into the more regular vocations and industrial employments of cultivated life, a higher tone of morals has succeeded, which is making a marked impression upon our fraternity."

He also gives some wholesome advice and reminders of our duties as Craftsmen

"It is not the unworthy that generally drop out and forsake us. Once within the Lodge they are pretty sure to remain and it is the upright man and desirable Mason that withdraws when he is no longer willing to remain and associate with the unworthy. 

" " We are first citizens, then Masons. Our primary duty is to our country."

The Grand Master announces the death of Past Junior Grand Warden, Bro. W. W. Glidden Johom. They mourn the loss of a good and true man.

The Grand Master refers to the claim of recognition of the so-called Grand Lodge of Ontario, and very justly takes the stand that as the Grand Lodge of Canada already occupies that Province, the attempt is revolutionary and must be put down.

The resignation of Bro. John F. Burrell as Grand Secretary, and the appointment of Bro. Frank Hudson as Grand Secretary pro, tem. is communicated.

#### IOWA.

The annual address of the Grand Master is largely devoted to home matters. He had granted 17 dispensations for new Lodges. Among the Brethren who have joined the majority is Past Grand Treasurer, J. A. Thompson; Past Junior Grand Warden, James Shepherd; Past Deputy Grand Master, Geo Acheson, and Bro. James Vokes Mackey, Grand Representative near the Grand Lodge of Ireland, are more particularly eulogized.

Eleven charters were granted and six dispensations continued.

The Grand Lodges of New South Wales and New Mexico were recognized.

Bro. Geo. B. Van Saun, of Cedar Falls, is Grand Master, and T. S. Parvin re-elected Grand Secretary.

### NEBRASKA.

The Twenty-fourth Annual Communication was held at Lincoln, June 21st, 1881. M.: W.: James A. Tulleys, presiding. Sixty-seven out of 'seventy-four chartered Lodges being represented.

The Grand Master speaks very encouragingly of the affairs in this jurisdiction.

He recommends that the Grand Lodge furnish all Lodges to be hereafter chartered, with the books and blanks necessary for proper lodge work.

The following amendment to the by-laws of the Grand Lodge was laid over until the next Annual Communication.

At the end of Section XIII add the following words: "But no Subordinate Lodge shall charge any fee for affiliation to a Master Mason."

The following was adopted:

"No Mason, member of a Lodge under the jurisdiction of this Grand Lodge, shall be demitted, except for the purpose of joining another Lodge or to assist in forming a new Lodge, agreeable to the ancient land-marks and regulations."

An eloquent oration was given by the Grand Orator W... Bro. Samuel P. Davidson from which we take the following good extract:--

"Then my Brethren, let none of you conclude that Masonry is waning, or that it has outlived its usefulness; because as long as there is human want, either mental or physical, as long as there are injustice, impurity and oppression to oppose, as long as human nature remains, there will be a vast and ever-opening field in which Masonry is called to effective and ceaseless labor.

#### KANSAS.

The Grand Master's address fills nearly ten pages of printed matter, and refers mostly to internal affairs; also like most other Grand Lodges the reference in feeling terms is made to the several distinguished Masons who have joined the majority, among them he specially mentions our laste illustrious Bro. Albert G. Mackey, the Masonic author, and M. Austin, Grand Secretary of New York.

No less than nineteen dispensations for formation of new Lodges were issued.

The proceedings of this Grand Lodge are noticed at length in the correspondence.

The motion made by Brother Stewart in regard to the eligibility of officers as to their proficiency in the degrees is much commended, and the remark is made: "Let such rules be adopted, then strictly and impartially enforced and inefficient officers would soon disappear from the halls of the Craft.

There are 185 Lodges on the roll with 19,108 members. The income during the year was \$5,252.28, and the expenditure \$4,347.61.

The Grand Master favors a tribunal of arbitration of all the Lodges on this continent, to which any disputes may be referred for adjustment, a most excellent idea.

The Grand Master decides: "Where a Lodge convicts a Brother of a Masonic offence, but refuses to inflict a penalty, the Brother so convicted is in good standing"; also, "A trial is not necessary to authorize a suspension for non-payment of dues"; also, "A Brother is not required to give his reasons for asking for a demit, as a condition preceding to granting it"; also, "An elective officer can be suspended from his office by the Grand Master only

The Grand Master finds that the income of Grand Lodge is insufficient to meet the expenses, which he thinks cannot be reduced without impairing efficiency, hence records desired as increase of income.

TO THE M. . . W. . GRAND LODGE OF A. F. & A. M. OF BRITISH COLUMBIA:-

The Board of Geneval Purposes beg to submit their Annual Report, 1881-82, as follows:—

- 1. There have been nine sessions of the Board during the past year, viz: on the 8th July, 1881, 11th October, 1881, 26th October, 1881, 13th January, 1882, 10th February, 1882, 14th April, 1882, 28th April, 1882, 2nd June, 1882, 15th June, 1882.
- 2. At the first meeting of the Board, on the 8th July, 1881, W.:. Bro. Thomas Trounce was unanimously re-elected Vice-President of the Board.
  - 3. The following Committees were then appointed:-

Finance and Returns.

With  $V_{\cdot}$  W. Bro. Edgar Crow Baker, as Grand Secretary and Secretary of the Board to act with said Committees as had been customary since the formation of Grand Lodge.

- 4. There have been no appeals from a Subordinate Lodge as to the expulsion or suspension of members during the past, nor have there been any other appeals save and accept matters in regard to Cariboo Lodge mentioned hereinafter.
- 5 The subject of recognition of this Grand Lodge by the Grand Lodge of Scotland has not yet been officially extended, although we are in receipt of a letter intimating the probable intention in the near future.
- 6. In the matter of the reduction of dues to Grand Lodge, during session of 1880, and the subsequent carrying of the same into effect, your Board deemed it advisable to promulgate for the information of Subordinate Lodges its decision as to the method of computation re membership, viz:—"Subordinate Lodges shall pay \$1.25 per annum for each member on their respective Rolls on the 28th February of each year, i. e., at the date of making up "the Annual Returns to Grand Lodge and irrespective of additions or sub-"tractions for portions of the year."
- 7. Report of the Trustees of the Building will appear at the proper time, and it is pleasing to note, that, notwithstanding the fact that the stores have only been used in a desultory manner for storage purposes, the dividend to the shareholders will probably be 5 per cent. The surplus funds in the hands of Trustees of G. L. Benevolent Fund have been devoted to purchasing more shares in the building from Brethren desirous of selling, and the same has received the sanction of the Board of General Purposes.
- 8. The Notices of Motion referred by Grand Lodge to the Board, (and emanating from Bro. P.: M.: Stewart), were maturely considered and the proposed amendment to the Constitution rejected, as in "the opinion of the "Board it would be unwise to restrict the rights of selecting officers by Sub-"ordinate Lodges or to affect or impair the privileges of their members to the "extent proposed by Bro. P.: M.: Stewart." All Subordinate Lodges have been notified of this decision of your Board, to whom the matter was referred for such action as the Board saw fit. The subsequent correspondence on this subject will be laid before you.
- v. Your Board regrets to announce the death of several prominent Brethren of our Order in other jurisdictions, notably the following:—Dr. George Stodart Blackie, A.M., M.D., Ph. D., the Representative of this Grand Lodge near the G. L. of Tennessee, and of many other Grand Bodies; President James A. Garfield, President of the United States; Albert G. Mackey, an eminent Masonic writer. Letters of condolence have been sent in keeping with custom and fraternal feeling, and we recommend that memorial

pages to these at least (and others also) be inserted in this year's proceedings expressive of the appreciation in which our deceased Brethren were held.

- 9a. James M. Austin, Grand Secretary of New York, and Past Grand Master Thomas Douglas Harington, of Canada, to the relatives of these departed Brethren letters of sympathy have also been sent.
- 10. Still further correspondence has taken place between the Board and various persons in regard to the affairs of the late J. Spencer Thompson, and the indigent circumstances of his widow, but more particularly between the Board of Relief in San Francisco, and to whom we are indebted for much information and temporary assistance to the widow. Every effort has been made to obtain for the widow the travelling and sessional allowance from Canada, and we have reason to believe that the Ottawa Government have consented to pay her the sessional allowance.
- 11. Up to the present moment no acknowledgement has been received from the Brethren having the conduct of the "Anatolia Famine Relief Committee," of the \$25 sent by this Grand Lodge through the Bank of B. C., towards alleviating the sufferings of those in Asiatic Turkey. The draft was paid at the Imperial Ottoman Bank, and the lesson to be learnt by such apathy and indifference is, to look well and see if, in the future, we cannot find sufficient requirement for our funds in our own land.
- 12. An application from Mount Hermon Lodge, No. 7, for \$50 out of the Fund of Benevolence, was allowed by the Board on the 14th April, upon the terms of their application dated 31st January; but inasmuch as the circumstances were a little peculiar and exceptional when rigidly compared with the By-Laws of said Fund your Board asks the approval of said donation.
- 13. The Board has received intimation from Galatz, Roumania, to the effect that a spurious Grand Lodge has sprung up in Toultscha which it is well the Brethren should know, although we are not likely to receive many visits from there. It is also a matter of much satisfaction that the differences heretofore existing between the Grand Lodges of New Mexico and Missouri have been settled, and a Circular letter issued rescinding the previous interdiction.
- 14. No change has occurred on the Board since its formation at last session of Grand Lodge from any of the many causes which might have made a breach in it, and we sincerely trust that the same reign of peace and harmony is in store for our successors, and the total absence of "unfinished business" will be sufficient in itself to testify of its usefulness and advocate its necessity.
- 15. The Board is much pained to still further announce that the resper Death has taken from us two more of our Representatives near other jurisdictions, and both of them much esteemed by their Brethren, viz:—Bro. Gloss Crenner, of Indiana, and W. E. Webster, of Iowa, as also the much esteemed Grand Secretary of Massachusetts, R. W. Bro. Tracey P. Cheever, of Boston, Mass.
- 16. Pursuant to resolution of Grand Lodge at its last session a dispensation was issued to Bro. Alex. Lindsay, (as W.: M.:.), Bro. Isaac Oppenhei-

W. .), and certain Brethren mentioned in the Petition, on the 22nd June. 1881, to hold a Lodge at the town of Yale in this jurisdiction to be called "Cascade Lodge, No. 10." On the 5th July a more extended and formal dispensation was granted to said Lodge, and on the 29th October the Charter was issued to them. Your Board regrets exceedingly to be compelled to announce to Grand Lodge that this infant Lodge has been forced by dint of circumstances over which the Lodge had no control to surrender its Charter, and which the Board, ad interim, has accepted, but owing to the causes which prompted the Brethren to pursue this course, viz: (recent fires at Yale and changes incident to Railway construction, etc.,) they have been informed that at some future time, during the ensuing twelve months, said Charter may be re-issued to a sufficient number of the original members free of charge, and further that the dues up to the date hereof be remitted, all of which is hereby recommended by your Board for favorable consideration.

17. Communication has been received from Mount Hermon Lodge, dated 8th June, stating inability to open Lodge at Regular Meeting and expressing regret at non-representation at approaching session of Grand Lodge. Grand Master suspended Clause 2, page 67 of Constitution, and instructed Grand Secretary to telegraph to Worshipful Master of said Lodge to that effect, and authorized him to appoint Proxies to be forwarded by steamer of Saturday, 17th inst., without fail, in order that every possible opportunity may be afforded to Lodges in the country to complete their representation in Grand Lodge; and which action your Board heartily endorses, and recommends the ratification of same by Grand Lodge.

18. Much correspondence has taken place between your Board and Cariboo Lodge, No. 4, in reference to their Annual Election of Officers, in which matter they appear to have experienced considerable difficulty, and the Grand Master, with the advice of the Board, ordered a new election for Worshipful Master, and confirmed the election of all other elective Officers as per minutes of their meeting of December. The matter of the legitimacy of their Proxies under the existing circumstances has been left in the hands of the Committee on Credentials, as also all the correspondence upon the subject.

19. In conclusion your Board would recommend that Grand Lodge attend Divine Service, in regalia, at 11 o'clock, a.m., at the Pandora Street Church, which has kindly been placed at the disposal of the V. '. W.'. Grand Chaplain by the Elders of that Church.

TO THE M . W. GRAND LODGE OF BRITISH COLUMBIA:

The undersigned, the Grand Representative of the M. . W . Grand Lodge of Utah near this Grand Lodge, has been requested to make you acquainted with the position the Masonic Fraternity of Utah has adopted towards those professing the Mormon tenets of Polygamy. From the Circular which has been sent me, as I was well aware prior thereto, the three Lodges who held charters in the Territory prior to the establishment c: the Grand Lodge ten years ago, did not admit any person who professed Mormonism to become a Mason. Since then the same rule has been followed by the Grand Lodge of Utah without, however, distinctly so expressing it, which, however, they now do; their reasons they state are, that whilst the Fraternity in Utah believes and upholds the universality of the Masonic institutions, and recognizes the right of every Craftsman to join any Church and embrace any creed he chooses, and demands of him only that he shall admit the theological belief taught on the threshold of our sacred Temple, and further 'that he must be loyal to the Government under which he lives, and yield a willing obedience to all its laws,' The Masons in Utah contend that the latter impertant pre-requisite is wanting in the Mormons, because the chief tenet of the church is polygamy, which a United States statute has declared to be a crime, and which all civilized nations consider a relic of barbarism.

The Grand Lodge of Utah is desirous that its Sister Grand Lodges shall be made acquainted with the position it has taken in this vexed question, and they are auxious that every Sister Grand Lodge shall be assured that the Craft of Utah, as a link of the Masonic chain, will in the future as in the past, perform its sacred duty to the satisfaction of every Sister Grand Lodge.

All which is fraternally submitted.
