

An Act to establish a Circuit Court in and for the County of Argenteuil.

HEREAS from the great cistance at which that part of the Two Preamble. Mountains Circuit, which now constitutes the County of Argenteuil for purposes of representation, is situate from the place where the sittings of Circuit Court for the said Two Mountains Circuit are held, the inhabi-5 tants of the said place are subjected to serious inconvenience and expense: And whereas it is expedient to detach the said County of Argenteuil from the said Two Mountains Circuit and to form a new Circuit to include and consist of the present County of Argenteuil, and to divide the time now occupied by the sittings of the Court in the Two Mountains Circuit Court, 10 equally between the said Court and the new Circuit hereby established; Therefore Her Majesty, &c., enacts as follows:

I. " nada," as enacts that the Two Mountains Circuit shall include the County of Two Mountains as then constituted, (the said County then comprehending the present County of Argenteuil,) and so much of the said Act as relates to the time when the sittings of the Court in and for the said Two Moun-20 tains Circuit shall be held, shall be and the same is hereby repealed; and from and after the said day the County of Argenteuil now included in the said Two Mountains Circuit shall be separated from the said Circuit and shall from and after the said day form and constitute a Circuit to be called Name. the "Argenteuil Circuit."

All cases pending in the Circuit Court for the Two Mountains Pending cases 35 Circuit at the time when the said Argenteuil Circuit shall be constituted not affected. under this Act, shall be proceeded with and be prosecuted to final judgment, and all proceedings after judgment shall be had therein in the said Circuit Court for the Two Mountains Circuit, as if this Act had not been passed.
