

### BILL.

An Act to incorporate the Jewish Congregation Anshc-Sholem of Hamilton.

WHEREAS the Members of the Hebrew Benevolent Society Anshe-Preamble. Skolem, of Hamilton, hereinafter named, have by their petition set forth that they have in contemplation the erection of a Synagogue and have prayed to be incorporated, and it is expedient to grant their 5 prayer;

Therefore, Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows :
