





AN ACT TO INCORPORATE THE QUEBEC BOARD OF TRADE.

18th September, 1841.-Presented for Her Majesty's Assent and reserved " for the signification of Her Majesty's pleasure thereon."

19th March, 1842 .- The Royal Assent signified by the Proclamation of His Excellency SIR CHARLES BAGOT, Governor General.

THEREAS the Honorable William Preamble. Walker, the Honorable George Pemberton, James Dean, Henry W. Welch and others, hereinafter named, Merchants, resident and carrying on trade in the City of Quebec, have by their petition to the Legislature represented, that they have associated themselves together for some time past for the purpose of promoting such measures as they might upon due consideration deem calculated to advance and render prosperous the lawful trade and commerce of this Province, and of the said

City of Quebec more especially, and have further represented that having already experienced the good effects of their said association, and being convinced that the advantages arising from it would be greatly extended and increased if they and their associates and successors were incorporated, and if certain powers were conferred on them, they pray the Legislature so to incorporate them and grant them such powers: and whereas it is expedient to grant the prayer of their said petition ;---Be it therefore enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and of the Legislative Assembly of the Province of Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of the United Kingdom of Great Britain and Ireland, and intituled An Act to Reunite the Provinces of Upper and Lower Cabers of the nada, and for the Government of Canada, and it is hereby enacted by the authority of the same, that the said Honorable William Walker, Honorable George Pemberton, James Dean, Henry W. XXV. And be it enacted, that this Act shall be a Public Act, and shall be judicially noticed as such by all Judges, Justices and other persons whomsoever without being specially pleaded.

An Act to render permanent two certain Acts therein mentioned incorporating the Boards of Trade of

Preamble.

[29th March, 1845.]

THEREAS it is expedient to render permanent the respective Boards of Trade established in the Cities of Montreal and Quebec, and now incorporated by Law: Be it therefore enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and of the Legislative Assembly of the Province of Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of the United Kingdom of Great Britain and Ireland, and intituled : An Act to Re-unite the Provinces of Upper and Lower Canada, and for the Government of Canada, and it is hereby enacted by the authority of the same, That the twenty-Acts temporal sixth clause of an Act of the Parliament of this Province, passed in the fourth and fifth years of Her Majesty's Reign, intituled, An Act to incorporate the Montreal Board of Trade, and the twenty-third clause of a certain Act of the said Parliament, passed in the same year, intituled, An Act to incorporate the Quebec Board of Trade, be, and the same are hereby repealed.

BY-LAWS OF THE QUEBEC BOARD OF TRADE.

CHAPTER 1ST .- OF MEMBERS.

SECTION 1st.—The Members of this Corporation shall pay an annual contribution of one pound five shillings, to be paid in advance, the first Monday in April in each year.

2nd.—That any Member who shall have failed to pay his subscription, and be in arrear more than twelve months, shall not be entitled to vote on any question that may be before the Corporation.

3rd.—Any Member who shall refuse or neglect to comply with the By-laws and Regulations, may be expelled by the vote of three-fourths of the members present at an extraordinary meeting to be held for that purpose.

4th.—Every Member who shall be absent from the province more than a year, shall pay only the sum of one pound per annum for every year he may have been so absent, to be paid within three months of his return; his neglect to pay the same shall be considered as his withdrawal from Membership on the day of his departure from the province.

5th.—Every Member who may wish to withdraw from the Corporation, shall give notice thereof in writing, but his wish shall not be acceded to until he shall have paid up his subscription to the expiration of the year in which the application to withdraw shall have been made.

CHAPTER 2ND. -OF OFFICERS.

SECTION 1st.—It shall be the duty of the presiding clicer then in the chair at any meeting to regulate the other thereof, to inform the Board of the proceedites, nee last meeting, to cause the reports of the Council and other communications to be read and if needful acknowledged to receive and put motions, and to announce to the meeting what he may think concerns the Mercantile interest, he shall keep order, but an appeal may be had from the decision of the chair to the Members present.

2nd.—The Treasurer shall have the charge of all the monies belonging to the Corporation, and shall see that the officers appointed by the Council of the Board to make collections, does his duty as such collector, and all such monies received by such collector or otherwise for account of the Corporation, shall be paid over to the Treasurer who shall receive the same, and out of such receipts he shall pay all accounts approved of by the Council, and keep a regular account of the income and expenditure of the Corporation, which shall be laid on the Table at the Annual Meeting of the Corporation held on the first Monday in April, or at any other time that he may be required by the Corporation so to do.

CHAPTER 3RD .- OF THE COUNCIL.

SECTION 1st.—The Council of this Corporation as constituted by the Act of Incorporation, shall have the sole management of all and every the real and immoveable property which may now or hereafter be acquired by the Corporation, and shall have power to authorize the President, and in his absence the Vice President, to grant a lease of all or any of the houses, buildings or premises of or belonging to the e presiding to regulate e proceedorts of the read and if t motions, may think Il keep orecision of

2nd.—The Council shall conduct all the business of the Corporation reporting its proceedings at each ordinary meeting for approval.

3rd.—The Council can appoint a Secretary or officers and regulate his or their Salary or Salaries.

4th.—The Council can draw up petitions and either forward them at once or if they may think fit refer the same to the Corporation at either a General or Special Meeting; they shall if required by the Corporation draw up and forward such petitions as the Corporation may agree upon, at any regular meeting, all petitions to be signed by the President, or Vice President, coanter-signed by the Secretary, if there be one, with the Seal of the Corporation attached.

5th.—The Council shall have full power to appoint Committees who shall report proceedings to the Council.

CHAPTER 4TH. OF COUNCIL MEETINGS.

SECTION 1st.—The Council shall meet every Wednesday at quarter to Eleven o'clock in the forenoon,

and if there shall not be a quorum before Eleven o'clock, such members as shall be present shall adjourn.

2nd.—The Council shall conduct its meetings as follows, viz. :--

1st.—The chair shall be taken at Eleven o'clock in the forenoon, at the weekly meetings.

2ud.—The minutes of the last meeting shall be read and confirmed.

3rd.—All reports of Committees or other communications shall be read, and orders taken thereon, nuless sufficiently important to be the subject of a motion to which may then be made.

4th.—All drafts of letters, petitions, or by-laws prepared shall be read.

5th.—A motion for adjournment shall be always in order.

CHAPTER JTH. OF THE BOARD OF ARBITRATION.

SECTION 1st.—Upon communication being received by the Council through the Secretary or otherwise of matters requiring to be adjusted by the Board of Arbitration, the Council shall summon a meeting of such Board of Arbitration.

2nd.—Such Board of Arbitration shall choose from among their members, whether present or not, three persons to act as Arbitrators, taking care to select if possible such as may be best acquainted with the matter to be decided on; in case of difficulty arising from the Board not agreeing as to the persons so to be appointed, a Ballot for three members shall be taken, who unless prevented by absence from Quebee, or siekness, shall serve on such Board under a penalty of Two pounds currency, unless he shall give in an excuse to the satisfaction of the Council. re Eleven shall ad-

3rd.—Such Arbitrators so appointed shall meet together to arbitrate on the matter in dispute, and shall report to the Council their decision within fifteen days, unless the Council shall see fit to grant delay.

4th.—The Secretary of the Conncil to attend all meetings of the Board of Arbitration, and of the Arbitrators, whether he shall have been appointed one of them or not, to take minutes of the proceedings.

5th.—In all cases submitted for Arbitration such fees shall be exacted as the Arbitrators shall see fit, one half of which to go to the Arbitrators and Secretary, who sit on any such cases, and the other to the funds of the Council, who shall also decide which party shall pay the same.

6th.—The Council upon receiving the award of the Arbitrators, shall notify the parties who may have a matter under consideration the amount of the fees, and that upon receipt of the same the award will be communicated to them.

7th.—The Treasurer shall open an account with one of the Banks in this City, and a Balance of the Books made once a month, and the Cash Book to be exhibited at the monthly meetings of the Council.

Amendment at Special General Meeting, 6th December, 1873.

That the By-Laws be so changed as to allow the Council to change the meetings of said Council to any hour they may deem most convenient.
