Saturday Morning, June 24th, 1871.

The Central Baptist Association convened this day with the 5th Cornwallis Church, at Pereaux, at 10 o'clock, A. M.

In the absence of the Moderator of last year, the Association was called to order by Rev. D. Freeman, A. M., pastor of the church.

Resolved, That the following brethren be our delegates to the Convention; Hon. Judge McCully, A. A. Pineo, Francis Webber, Edward Parker, and T. H. Rand. Passed.

Resolved, that 1000 copies of the Minutes of this Association be printed as last year, by Bro. Selden, and that 50 copies be reserved for the Association, and paid for at the same rate. Passed.

The Rev. Dr. Cramp, in accordance with a notice given last year, that the first article of the Constitution of this Association be amended by inserting the words, "not exceeding five from any one Association," immediately after the words "together with delegates from Corresponding Associations." Passed.

Hon. Judge McCully, Chairman of Committee appointed to apply to the Legislature for an Act to enable Baptist Churches to perpetuate Trustees; presented a verbal report, whereupon it was moved that said Committee be continued in office. Passed.

The *Christian Messenger* has heretofore and hitherto proved itself an invaluable auxilliary for the promotion of evangelical objects in connection with our denomination. While its readers have at the same time been supplied with a large amount of useful secular information, and the current news of the day. Your Committee therefore recommend it to the warmest sympathies of Baptist families and Baptist Churches. No higher or better guarantee for its future management, while under the control of its present Editor, is, in the opinion of your Committee, required, than a reference to its past history.

Under these circumstances it would scarcely seem to be necessary at each succeeding Association to appoint a Committee with a view of recording an expression of opinion upon the subject of its merits or its management.

Voted, That the Association do now adjourn to allow the Home Missionary Society to hold its Annual Meeting.

The Annual Session of the N. S. Home Missionary Society was held, and the Officers and Board of Managers for the ensuing year elected. Good speeches were made in setting forth the claims of Home Missions on the churches.

The business of the Association again resumed.

The Committee on Questions in Letters presented their Report.

Voted, That the Report be taken up clause by clause. After considerable discussion on the first clause, it was unanimously adopted. Second clause passed unanimously.

That the letters received from the African Baptist Churches at Halifax and Hammond's Plains, asking for admission into this Association, not containing sufficient information as to the reason why they seceded from the organization known as the African Baptist Association. We therefore recommend that a Committee be appointed to enquire into the merits of the case and report at the first session of the next Association.

They also recommend that our next Association be held with the 2nd Cornwallis Church, at Berwick.

Voted, That the Burton Church be also retained at the request of Brethren S. Selden, and F. Webber, they also agreeing to make enquiry concerning it and report next year.

Voted, That Brethren S. Selden, A. Clarke, Revs. O. E. Read and A. A. Pineo be a Committee to make arrangements with the proper authorities, for the usual reduction in Railway fares to those in attendance at the Central Association, at Berwick next year.

Voted, That the Ministers be requested to read from their pulpits the Circular Letter from this body to the churches.

Hon. Judge McCully delivered an eloquent address in favor of Female Education, Ministerial Culture, and Benevolence.

After prayer by Rev. J. L. Read, the Association adjourned to meet to-morrow morning, at 10 o'clock.

Whereas, The erection of buildings for a Male and Female Seminary, and also for our College Library and Museum in connection with our Institutions at Horton is an immediate necessity, the entire cost of which would probably be about \$25,000 :

Therefore Resolved, That it be recommended to the Board of Governors of Acadia College to divide the same in shares of \$250. each, and the benevolent of the denomination be solicited to take one or more of these shares till the whole are taken up.

Voted, That the Revs. E. M. Saunders, J. E. Goucher, and Bro. S. Selden be requested to prepare an Abstract of the Letters from the churches for publication in the *Christian Messenger*.

Voted, That the thanks of this Association be presented to the brethren, sisters, and friends, of the fifth Cornwallis Church, and vicinity, for their kindness and hospitality during the present Session.

Voted, That we adjourn to meet with the Second Cornwallis Church, Berwick, on the first Saturday after the 20th of June, 1872, at 10 o'clock, A. M.

THE CIRCULAR LETTER FROM THE NOVA SCOTIA CENTRAL BAPTIST ASSOCIATION TO THE CHURCHES OF WHICH IT IS COMPOSED.

Dear Brethren,—

We propose on this occasion to present before you some thoughts in relation to the Lord's Supper, an ordinance of the Church of God of no mean importance.

There are four passages in the New Testament which give an account of the origin of this rite. Mat. xxvi. 26-29. Mark xiv. 22-25. Luke xxii. 19-20. 1 Cor. xi. 23-26. By examining these, which agree substantially, we shall get all the information (save from incidental allusions) that is contained in the Word of God. From these we may learn. I. What the ordinance is not. II. What it is. III. What class of persons is entitled to participate therein. IV. The duties enjoined upon those who partake.

I. This ordinance, is *not* a sacrifice for sin. Christ was *once* offered and requires not that sacrifices of himself should again and again be made. We need scarcely advert to the absurd and unscriptural notions, by which the Church of Rome, and other Churches, so called, under pretence of exalting the mystery, pervert and destroy the original idea of the institution. The words "This is my body" so plainly figurative, being alleged in support of the theory, that the bread and wine are changed into the actual body and blood of Christ. No one can pretend to misunderstand our Lord, when he says "I am the doer," "I am the way," "I am the vine."

The Communion is not a way or method of salvation.—Those who are anxious about their souls, are frequently encouraged to come to the Lord's table. It is hoped that the vivid representation there made, of the sufferings of Christ, and the solemnity and deep feeling,—developed by the whole ceremony, will have a tendency to draw such persons to Christ, and give them peace in believing. However plausible such a view may seem, it has no authority, either by precept or example, from the Word of God. The custom arises from a mistaken view of the ordinance, and it may be also, from an erroneous idea of the condition of mind of those, who profess to be seeking salvation.

We might advert to other theories, which have been held, and put forth on this subject, but time would fail us. We pass on to consider

II. What this rite is.

1. It is an ordinance of Divine appointment. *This do.* It was instituted by Him to whom all power is given, in heaven and on earth. It was instituted in a marked, impressive and binding manner. Thus it bears all the sanction and weight of a Divine command. With everything adapted to give force to the command, touching pathos and solemnity to the occasion, we should keep the feast, not forsaking the assembling of ourselves together, as the manner of some is, and so much the more as we see the day approaching.

2. Again, This is a Commemorative Rite. It commemorates to the world a great transaction. Leslie, in his "Short method with a Deist," makes use of this fact, as a powerful evidence of christianity. Here is a succession. No observance of the church is more distinctly and more clearly traced to the very words of Jesus, than this. Positive ordinances may have some disadvantages, in that they may be misinterpreted or perverted, but they have this benefit, that they are a standing memorial from generation to generation, that certain events took place.

Men die. Faiths change. But just so long as ordinances are observed, we have a clue by which to trace their original design.

Almost every sect which professes to be christian, celebrates this observance. The Roman Catholics it is true, have mutilated it by depriving the laity of the cup, have perverted it by exalting it in the place of Christ. The Friends or Quakers have abolished it altogether; but all others concur in commemorating to the world, the great events it is intended to betoken.

It commemorates to the church her great Head. "Do this in remembrance of me." "Ye do shew forth the Lord's death." It commemorates to the individual who receives it, a wonderful transaction in which he himself has participated. It brings before his mind, certain truths adapted both to humble, and to make him joyful. His own christian experience is involved in the celebration. He remembers the time when he came first to Jesus; when the words of love and mercy entered his heart, filling his soul with gladness and joy. The ordinance becomes indeed to him a eucharist, a glowing offering of thanksgiving and praise. "What shall I render unto the Lord for his benefits toward me? I will take the cup of salvation, and call upon the name of the Lord." I will pay my vows, which my lips have uttered when I was in trouble.

3. And this brings us to consider, thirdly that the Supper is a symbolic rite. Under the former dispensation, the method of teaching by symbols was very freely used. Thus

the Mercy Seat, the Holy of Holies, the Sacrifices, were emblems. They were very fitting in what may be termed the childhood of the human race. The picture or form of a thing, is well adapted to aid the memory and judgement of a child. But when the mind has become matured, these to a great extent can be dispensed with. When I became a man I put away child-like things. Thus in the epistle to the Galatians, the Apostle speaks of the law, as poor, weak and rudimentary, but still adapted to the time and purpose, for which it was designed.

In the kingdom of Christ this teaching is almost entirely put aside. The law was our schoolmaster to bring us unto Christ, but having accepted Christ we are no longer under a schoolmaster.

In the two positive ordinances of the christian church however, and only in these it appears to have been beneficially retained.

The one, that of Baptism, symbolises the death, burial and resurrection of our Lord, and the believer's spiritual resurrection with Him. Rom vi. 4; the washing away of sin, see the same passage, also Acts ii. 38, and xxii. 16.

The other teaches—

1. The sufferings of Christ on the cross. This is my body which is broken for you, thus recalling to mind the passage in Isaiah liii. 5. So the wine poured out indicates the blood shed on the cross for us, and points to the truth, that without shedding of blood, there can be no remission of sin. Thus viewed it bears a close analogy to the Passover. That was instituted in memory of a great event in Jewish history, a great deliverance accomplished. As often as the children of Israel partook thereof, they were reminded of the destroying angel, of the blood-sprinkled door posts, of the wailing cry in Egypt, of the paschal lamb slain, roasted and eaten in hot haste, their loins girded, shoes on their feet, staves in their hands. These were facts, emblematic of God's mighty power, of their own helplessness, and of the wondrous deliverance effected.

The Lord's Supper teaches us, of our guilt and danger, our helplessness and ruin; of God's infinite love; of Christ's divine compassion; of His awful sufferings, and of our deliverance from the thralldom of death and hell.

Not only so, there is also a subjective meaning attached to the observance of this rite. Take the 6th chapter of John's Gospel, and read ten verses from the 48th to the 58th. This was the hard saying which some of his disciples could not bear, and walked no more with him.

Food may be so prepared as to gratify the eye, but merely to gaze upon it, will do us no physical good. It must be taken into the mouth, eaten up and digested. If it be whole-

some, it makes blood, and is distributed throughout the body, performing its functions, and quickening the whole man into active vigorous life. So the doctrines of the gospel, may be looked at as statements, and even pondered, but they do no good, unless they are taken into the understanding, the conscience, and the heart. Then they produce spiritual life.— Except ye eat the flesh of the Son of man, and drink His blood ye have no life in you. The Redeemer nourishes our spiritual life as food nourishes the natural life, and we realize the force of the expression, “We are members of his body, of his flesh and of his bones.” Conversion involves a personal reception of Christ for ourselves, into our hearts.

III. Let us consider in the third place, the class of persons entitled to partake of this rite.

1. It is very evident that the careless, the worldly, and the profane, have no claim to be admitted to the privilege.

2. Neither, as we have already shewn, are we authorized to invite those who are seeking salvation, who have never wholly given themselves to Christ, and have no sense of pardon or acceptance.

3. Those who first partook were disciples of the Lord. “Drink ye all of it.” Whom is he here addressing? Evidently those who professed to believe. Though there was a Judas among them, he avowed as much attachment to Christ, as the others. To whom did the Apostle, in the Epistle to the Corinthians, give directions about its due observance? “Unto the Church of God, which is at Corinth, to them that are sanctified in Christ Jesus, called to be saints.”

4. It is evident from this that they were not only regenerate but baptized. The Apostle says again. When ye are come together in *the Church*. 1 Cor. xi. 18. See also John iv. 1, Acts ii. 41, 42. The Supper is then an ordinance of the church, to be held *in* the church and nowhere else. The church also, has authority to decide, who may and who may not partake, and the church alone.

In these views, we agree substantially with our Presbyterian and Congregational brethren, though we differ from our Episcopalian and Wesleyan brethren on some points.

This statement will perhaps surprise some persons. We have been taunted so frequently with the exclusiveness of our close communion sentiments, as they are termed, that persons are very apt to suppose us bigotted in the extreme, when the reverse is the case. We set up no barriers which others do not set up. We are in fact less exclusive than some others. Were we disposed to retort, we might truly say, that they effectually exclude a large and ever increas-

ing number of their brethren and sisters, from the Lord's table. They making that baptism which is nowhere commanded, and thus place the matter in such a light, as to make it impossible for us, without a manifest violation of our principles, to commune with them. Although there are open Communion Baptists, many in England, and a few on this continent, their position is anomalous, and the mode of argument, by which they attempt to justify that position, is such, that, if carried to its logical results, it would nullify the ordinance of baptism altogether.

IV. Finally. The question arises, What are the duties enjoined upon those who partake?

1. Self examination. But let a man examine himself, 1 Cor. xi. 28. There is danger, even of the Christian eating and drinking unworthily. Many temporal judgements seem to have come upon the Church at Corinth, on this account. Many were weak and sickly among them, and many slept. Test your motives. Try your hearts. See whether you be sincere in your profession, steadfast in your attachment to Christ. If the result of such examination be unfavorable, let that drive you, not away from the table, but to confession and to prayer. If we confess our sins, God is faithful and just to forgive us our sins, and to cleanse us from all unrighteousness.

2. Again. If thou bringest thy gift to the altar, and there rememberest that thy brother hath aught against thee, go be reconciled to thy brother. Confess your faults against one another, one to another.

3. Remember Christ, especially in His own ordinances. Cultivate a spirit receptive of His teaching. Endeavour to apprehend that for which you also are apprehended of Christ.

Let your heart go out in love toward the body of Christ, and more especially to that church with which you are individually connected. Let your consecration of yourself, to your Saviour, be renewed as often as you meet Him at His table. Remember that you are not your own. As often as the emblems of His broken body, and shed blood, are received by you, let the language of the poet be yours :

" Were the whole realm of nature mine—
That were a present far too small ;
Love so amazing, so divine,
Demands my life, my soul, my all."

If with these feelings, we, from time to time endeavour to meet our Lord, the formality otherwise inseparable from a stately recurring observance, will disappear. It will be a source of never-failing delight. We ourselves quickened and renewed, will advance in the life of God, our usefulness will be increased, our sympathies drawn out. This largely experienced will make the church to be wonderously admired and multitudes will join themselves to us.

ON MISSIONS.

Your Committee beg to report that in their opinion no subject which invites the attention, sympathies and united efforts of this body, presents greater claims than that of Missions. Viewed, either in its relation to the fulfilment of the glorious prediction which declares that the “kingdoms of this world shall become the kingdom of our Lord and of his Christ,” or in connection with its practical bearing upon the prosperity of those engaged in the work, it reaches a sublimity unsurpassed by any other subject.

While the proclamation of the gospel and the emancipation of men from the corruptions of idolatry and the thralldom of sin in all its forms are the exalted aims of all true missionary enterprise, it is a well attested fact that the work itself where vigorously pursued in the spirit of the Master has a tendency to quicken the pulse of spiritual life, and

becomes an element of vitality and power, as well as a source of unmingled enjoyment.

The Home and Foreign Missions, in the judgment of your committee, are so intimately connected and of such vital importance that it becomes difficult to decide which presents the stronger claims. It is evident from our Lord's teaching together with the great Commission that the "field is the world," and every believer in Christ is called upon to be a labourer in this great field. When the great missionary enterprise was launched forth upon the world, Jerusalem was its centre of operations its theater of action was limited only by the boundaries of the entire world.

Your Committee are conscious that the efforts of our denomination in this department are not at all in proportion to our means, and the necessity of the demands of a sin-suffering world, yet it is gratifying to learn that something is being done.

In the Foreign Department although the Baptists of these provinces have not what is termed an Independent mission, yet there are abundant channels through which their benevolence may flow and accomplish the end so ardently desired, the salvation of the heathen. Intelligence from time to time of the marked success of Native preachers, supported by our churches, sabbath schools, and by individuals is truly encouraging, and evidently show that our efforts are stamped with the seal of Divine approval. The departure of our beloved sister, Miss Norris, during the past year, and her safe arrival on the field of her future labors awaken feelings of devout gratitude to God, and the fact that there are young men among us whose hearts are burning with an unquenchable desire to tell the story of the cross to the benighted, and are diligently preparing for that work, encourage the belief that at no distant day the Baptists of these provinces will have a strong and efficient force, successfully prosecuting this glorious work.

The praiseworthy efforts of our sisters in forming Woman's Aid Societies to supply means for carrying on the work, cannot be too highly commended, and your Committee strongly recommend the formation of similar societies in all our churches, with the hope that our brethren will be stimulated by their noble example to greater exertions in the work of Missions.

In the Home department great good has been accomplished. Weak churches have been confirmed, and souls have been converted as the report of the Home Mission Society testifies; and although the machinery by which the work is carried on is by no means perfect, or as efficient as it ought to be, yet in view of past success and present prospects we have reason to thank God and take courage.

ON EDUCATION.

The Committee rejoice that they live in a country where education is valued and amply provided for, and where the poorest may obtain knowledge. The School-law of this Province, judiciously and vigorously administered, cannot but prove a blessing of priceless worth.

In the higher branches of education facilities are now fully furnished. Our Denomination, has largely shared in the honour of making provision for the thorough training of the young men of the Province, and has been rewarded with encouraging success. There are many persons, occupying positions of trust, responsibility, and usefulness, and whose powers were developed and disciplined in our Institutions. Horton Academy and Acadia College have been for many years great blessings, not only to the Baptists, but also to Nova Scotia at large. Our co-religionists acknowledge the truth of this statement, while we ourselves freely admit the merits of other Institutions, which have deserved well of their country.

The College, we are happy to report, continues to pursue a prosperous career, under the presidency of Dr. Sawyer. Twelve students graduated at the last Anniversary, and it is expected that a large Class will matriculate at the commencement of the next Collegiate year.

Arrangements are now made by which ministerial students, spending a fifth year in College, that is, remaining another year after graduation, wholly occupied in Theological pursuits, will be far better prepared for the work to which

they have devoted themselves than if they were to be transferred at once from literary engagements to pulpit and pastoral labours. These arrangements, however, will ere long require to be supplemented by an increase of the professorial staff. There will then be no necessity for our candidates for the ministry to go out of the country in order to pursue their professional studies, thus exposing themselves to the temptation to settle for life on a foreign soil, and depriving their native land of the benefits that might accrue from the employment of their talents there. It may surely be expected that Baptist Licentiates will be prompt to avail themselves of the advantages now offered them. The progress of society renders it imperative on those who propose to become religious instructors to "seek and intermeddle with all wisdom."

The Committee are assured that the Governors are desirous of the further improvement of the College in all respects. They would willingly furnish more ample accommodation to the students, on the College premises. The library greatly needs an enlarged supply of books in the various branches of literature, as well as in Theology and Ecclesiastical History, and a new building is urgently required for the use of the Library and Museum. A considerable sum of money ought to be expended in putting the college buildings into a state of respectable repair. But the want of means stands in the way of the accomplishment of these purposes. Wealthy Baptists might render immense service to Denominational interests by devoting a few thousands to their advancement.

The Committee desire to commend the Academy to the especial regard of the denomination. It is in successful operation, and the number of students is increasing. It is the only Institution which acts as a feeder to the College by supplying the necessary preparation for College studies, under the supervision and control of the Governors. Young men who propose to take a College course should be earnestly recommended to enter the Academy, and to remain there a sufficiently long time to secure adequate fitness for the higher exercises in which they are to be engaged..

A superficial preparation is much to be deprecated. It is far better for the student to spend two or more years in the Academy than to hasten his entry into the College before the proper time.

It is much to be lamented that in addition to the objects referred to above there is as yet but little prospect of the erection of a Female Seminary, or of a building for the joint use of males and females, for educational purposes. But why cannot this most desirable object be effected? What hinders the Baptists of Nova Scotia from raising a fund of twenty thousand dollars, and making immediate provision for the

ON OBITUARIES.

Your Committee find that one brother in the ministry and a number of esteemed brethren in the churches have been removed by death during the past year :

REV. NELSON BAKER departed this life, July 11th, 1870, after a few days of intense suffering which he bore with submission to the divine will. This brother had for a few years been residing in the neighborhood of Halifax where he had been enabled to provide for the wants of a large family. After he had made his family comfortable, he engaged anew in the work of the ministry. A revival attended his labours in Tancook, and it was on his return to this place for the purpose of preaching the gospel, that he was seized with his last sickness. Our brother was an earnest preacher, and a strong advocate of ministerial education. He availed himself of every opportunity to qualify himself in this respect for the great work in which he was engaged. Our brother leaves a widow and a large family of children to mourn their loss. May the rich blessing of the God of the widow and fatherless be abundantly bestowed upon the mourners.

JAMES WALTON NUTTING, D. C. L. deacon of Granville Street Church, fell asleep in Jesus on the 7th of July 1870, in the 84th year of his age. Our departed brother was a member of the first class that graduated at King's College, Windsor. He subsequently studied law, and was admitted to the Nova Scotia Bar in 1810; and after entering upon active life in the legal profession he was appointed Prothonotary of the Supreme Court and Clerk of the Crown in Halifax, which offices he held till the close of life. He was a learned man,—and a good man. He lived in the highest esteem of all who knew him, and his memory is cherished in the warmest affection by all his brethren in Christ! He helped to found our Institutions of learning and never withdrew his sympathies from them. He rendered valuable service to the cause of Christ, and the Baptist denomination, by assisting to start the *Christian Messenger*—the first weekly religious newspaper in these provinces,—and con-

tinued to contribute, more or less, to its pages up to within a few weeks of his death.

He had the rare power of making all men his friends, and among all who knew him at his death not an enemy could be found.

God has also taken from among us Deacons Theodorus Kinsman, (of the 3rd Cornwallis Church); J. P. Graves, (of the Upper Aylesford Church); Wm. Skinner, (of the 2nd Cornwallis Church); and brethren Wm. Shaw of Falmouth, and Mahew Beckwith of Canard.

We cannot make extended notice of all these excellent brethren separately, but of all we feel glad to say, that they were good men, and full of faith. Each has left to the world, a pleasing tribute to the power and beauty of the gospel of Christ.

BRO. MAHEW BECKWITH, was for many years a member of the 1st Cornwallis Church and to the very last manifested much interest in all the enterprises of the denomination. His attendance upon the public services of the Church was very punctual, and his death has made a painful blank in the congregation among whom he worshipped. He was at the time of his death a member of the Board of Governors of Acadia College, and in sympathy and fellowship with all his brethren.

BRO. WILLIAM SHAW of Falmouth, was well and long known by all the ministers of our Association and esteemed by them for his amiability, and generous hospitality. His house had been a home for good men for many years, and he himself a lover of such. He professed faith in Christ quite late in life, but for years had possessed the adornment of a meek and quiet spirit.

The death of **BRO. J. P. GRAVES** was sudden and unexpected. He seemed cut down in the midst of usefulness and promise. The master had need of him, and he was ready to depart.

BRO. KINSMAN died an old man, full of days, amiable, discreet and eminently pious.

DEACON WM. SKINNER was one of the first members of the 2nd Cornwallis Church. He was known among his brethren for the clearness and firmness with which he held the doctrines of the gospel. He was faithful unto death.

ON BENEVOLENT OBJECTS.

Your Committee beg leave to report:—

That they are apprehensive that the systematic and continued efforts recommended last year by the Committee on Benevolent Objects have not been made by the churches of this Association. Had it been so, the increase in the funds would have been greater than appears from the letters of the Churches. Your Committee would endorse the sentiments of the report of last year, and urge them upon the attention of the Association. In addition to systematic and sustained efforts, indispensable to success in raising funds for denominational objects, there are, in the opinion of your Committee, two or three considerations which merit the attention of this Association. In the earlier days of our denominational history, not a tithe of the wealth, possessed by the Baptists now, was then in their hands. A high standard of benevolence was impossible at the beginning. This measure of liberality has been too generally retained in the memories of the older and too generally adopted by the younger members of our denomination. Had we not increased in numbers our increase of wealth would be of no service. The increase in our contributions is not in proportion to our increase in both wealth and numbers, but numbers alone. Scholarships of four hundred dollars ought now to be four thousand dollars. The few shillings to missions by individuals ought now to be as many pounds. The old standards are a delusion and a snare. It is a time for taking down these old ones, and erecting new and higher ones. The giving should not be according to the measure in the past, but according to the means of the present. Advantage also ought to be taken of the special interest shown by individuals in particular objects. Let those enthusiastic for education be encouraged to put down their hundreds and thousands to the Endowment Fund of the College to the building of a new Academy and Seminary for young ladies, or for a fund to support young men studying for the ministry, as the case may be. A special sympathy will thus be engendered for particular objects and larger helping and fostering care extended to them. The evidence of this appears in the contributions which are coming almost spontaneously from all parts of the province for the support of native preachers in the East. This tendency should not be repressed. When all our denominational objects are presented every one in whose heart there is a benevolent impulse, and every one capable of such a feeling will be drawn toward some object. In this way the strongest sympathies will be cultivated, and the greatest amount of means raised.

CONSTITUTION

OF THE

Central Baptist Association of N. S.

ARTICLE 1st.—This Association shall consist of Delegates representing the Churches of which it is composed, each of whom shall be a member of one of those Churches, together with Delegates from Corresponding Associations, not exceeding five from any one Association, and such other brethren present as the Association may see fit to invite to sit in Council.

ART. 2nd.—The Association shall meet at such time and place as may be agreed upon by the body.

ART. 3rd.—Each Church shall have the privilege of sending one Delegate or more, but no Church shall be entitled to send more than five in addition to their Pastor.

ART. 4th.—At each meeting of the Association the Moderator of the preceding year shall preside till his successor is chosen. The choice of Moderator shall take place by ballot, as soon as a list of Delegates has been prepared, as hereinafter provided. No brother shall be chosen Moderator two years in succession. It shall be the duty of the Moderator to preside in all the transactions, maintain due order, and nominate Committees, unless otherwise ordered by the Association. A Secretary shall be chosen, whose duty it shall be to record the transactions of the Association, and to furnish a correct copy of the same for the press; he is also to remain in office till his successor is chosen.

ART. 5th.—It shall be the duty of each Church to send by his messengers a letter to the Association giving an account of its state, particularly of the additions and diminutions within the last year, and generally of whatsoever relates to its peace and prosperity.

ART. 6th.—At each Annual Meeting the letters from the Churches shall be first handed in, from which the Secretary shall immediately make out a list of Delegates. The election of Moderator and Secretary shall then take place, after which the letters shall be read. Committees nominated by the Moderator shall not consist of more than five brethren, of whom three shall constitute a quorum. When large Committees are judged desirable they shall be appointed by the Association, and two-thirds of the members appointed shall be competent to act.

ART. 7th.—When any Church shall desire admittance into this body, application must be made by letter, and satisfactory evidence furnished of its faith and order; this being done, and a vote of acceptance taken, the Moderator shall, in the behalf of the Association, give to one of its messengers present the right-hand of fellowship.

ART. 8th.—When any Church shall neglect to make communication for three years successively it shall be considered as having withdrawn from us, and shall be dropped from the Minutes, unless two or more members shall request its continuance and shall engage to enquire into its standing, and report at the next meeting of the Association.

FOURTEENTH ANNUAL REPORT.

The Board of Managers in presenting their report beg to state that fourteen Missionaries have been sent out under their direction during the year. *Five* of these have been laboring on the Island of Cape Breton, *two* in the Counties of Guysborough and Antigonishe, *one* in Colchester, *two* in Cumberland, *Two* in Hants, *one* in Kings, and *two* in Lunenburg.

Revs. Wm. McPhee and E. C. Spinney, have been in the service of the Board on the Islands of Cape Breton during the entire year.

Revs. E. B. Corey in Cumberland, and R. R. Philip in Hants, have each an appointment for twelve months, partially fulfilled. The other appointments made ranging from *five to ten* weeks each.

The whole number of weeks services is 225½ equivalent to *one* Missionary for about 4½ years; Sermons preached 754 Prayer and Conference Meetings held 486; Family Visits 2110; Baptisms 73; Pages of Tracts distributed 10965; miles travelled 8469. £850,54½ has been collected by the Missionaries.

The Treasurer has received \$250 more than was paid in last year. Thus in nearly every particular an improvement upon the preceeding year is manifest.

The success which has attended this department of Christian work during the year now closed, should be an incentive to increased activity, and zealous labour, in a cause which has been so evidently marked with Divine approval.

The work of Missions, or making known the truth as it is in Jesus, is an important part of the responsibility of the Churches of Christ.

The Redeemer when on earth bade his disciples "go into all the world and preach the Gospel to every creature" yet particularly required that they should "begin at Jerusalem" by which we may justly infer that the field embraced within the bounds of our Associations has a strong claim upon our attention, labor and sacrifice.

If we loved Christ with an affection corresponding to his love for us, we should feel that no sacrifice was too great for his honor, or if we cherished in our hearts anything like that love for perishing sinners, that brought him from heaven to earth, to seek and save that which was lost—how earnest how devoted, how ready should we be to lay our all at the

CAPE BRETON.

Rev. Wm. McPhee has continued to labor in the service of the Board during the year.

Preached 196 sermons attended 83 Prayer and Conference meetings, made 532 Family Visits, Baptized 8, collected £82.27½.

Extracts from letters received.

June 7th.—“This certainly is a time to strike for Cape Breton, a time to go forward and possess the land. May the Lord grant his people an aggressive, a missionary spirit. From Arichat to Cape North, the field is wide open for Baptist Missionaries. Baptist sympathy and sentiments are growing, for the people begin to read God's Word.

September 13th.—“Lord's day before last I baptized an

aged person at St. Anns. It was a special season, the Lord by His Spirit was indeed present. There were, probably, one thousand people sitting on the banks of the River, many of whom came to mock, but throughout the whole assemblage, solemn attention was paid, while I preached from the commission as recorded in the gospel by Matthew. The Lord grant to hasten the day of general awakening among the people.

April 4th, 1871.—Since writing to you last, I baptized one at Baddeck River. He was an aged man and his conversion was very remarkable. He could not read and consequently was dependant upon the few passages of God's word, which he had committed to memory.

Every passage he said seemed to him a volume. He truly felt the power of God's word.

This whole Island calls loudly for evangelical labor, but the mines the loudest. This is also the most important. Individuals here brought under the influence of the gospel, return to their homes throughout the Island, and carry with them an influence for *truth*.

I am persuaded more and more that any effort made by the church of Christ on behalf of this Island will not be regretted.

Whoever makes the greatest *sacrifice* now, will be the most *honoured* in time to come. God calls upon us to proceed and possess the land.

Rev. Joseph F. Kempton: spent 8 weeks at Margaree and Mabou. Preached 16 sermons, attended 11 Prayer and Conference Meetings, visited 49 families, Baptized 4, Restored 1 to church fellowship, travelled 308 miles. Collected \$58.07½.

Bro. Kempton labored under the direction of the Board for some years, first at Cow Bay, afterwards at the above mentioned places, and with much success.

Believing that God had called him to another field of labor, where the cause was self supporting, the Board reluctantly relinquished his services, and Bro. K. is now laboring successfully with the church at Lakeville, Kings Co.

Rev. E. C. Spinney is still engaged in Home Mission work at Cow Bay Mines and vicinity. Reports for 42½ weeks have been received. Preached 123 sermons, attended 170 Prayer and Conference Meetings, made 277 family visits, Baptized 11, distributed 2000 pages of tracts, travelled 1500 miles. Collected \$229.45.

Extracts from letters.

June 21st, 1870.—“The cause is steadily increasing amidst all opposition. The words of Chillingworth ‘The Bible the Bible only is the religion of Protestants’ are being more needed now than formerly. We have been endeavouring to show what constitutes Christian baptism,

and trust in some measure we have succeeded. Many who were previously blind as to the Scriptural teaching on this point now see. Error is rapidly being supplanted by the glorious truth of the Word of God.

Our meetings are interesting and well attended. The Sabbath Schools are engaging the attention of almost all, both old and young.

February 20th, 1871.—Since my last our church edifice at Cow Bay Mines has been completed, and opened for divine worship. So far as numbers are concerned; our most sanguine expectations have already been realized. On different occasions the House has been comfortably filled. There seems to be a great door opened for us which we hope will prove effectual.

March 29th.—The Lord is doing great things for us whereof we are glad. Christians have been and still are being revived. Some who had wandered very far from the fold, have come back with weeping. Sinners are awakening to a sense of their state before God. A few are awaiting baptism.

The *Christian Messenger* of 19th April published the following from Bro. Spinney. "Yesterday was a great day at Homeville, eight happy converts were buried with Christ in baptism and received into the fellowship of the Church. Others are anxious. Pray for us.

Rev. Jno. Shaw labored nine weeks and two days in the following places, Strait of Canso, West Bay, North Shore, Grand Ance, Kempt Road, Little Bras d'Or, North Sydney, South side North West Arm, the Bar, South Sydney, South Bar, Homeville, Cow Bay Mines, Glass Bay and Boularderie Island.

Preached 33 sermons, visited families, read the scriptures, remarked on the portions read, and prayed with them as often as I possible and conveniently could. Collected in aid of the Mission \$81,64.

Congregations in general large and attentive, and in some instances broken down under the Word. Cape Breton is a great field already white to harvest. Among the Gaelic population in particular the Lord is working mightily, not through preaching exclusively, yet preaching (sermonizing) not excepted. The people meet themselves in private houses, read the Scriptures, exhort and pray together.

From Grand Mira to Sydney Mines, shore and backland settlement the work is going on. There may be some chaff and it is likely there is, but without a doubt the Lord of the harvest is gathering his wheat into the garner, and that through such means as he pleases, whether reading the Scriptures, exhortation, Ministerial or lay preaching (as people call it,) "The word of the Lord is not bound."

Rev. Alfred Chipman received an appointment of 13 weeks in destitute places adjacent to Sydney Town. The mission has only been partially fulfilled and therefore the statistics are not given in the report.

May 29th, Brother Chipman writes as follows: "At Victoria Coal Mines my principal station, no decided religious influence or activity, I regret to state, prevails. A few professors of religion connected with different churches reside there. All new coal mining centres are hard places for christiann labor. Yet I shall watch anxiously for the opportunity to establish some other religious services than preaching, and I do hope the Lord will convert some souls there before your appointment closes. The attendance and attention at my present fort-nightly services are on the whole encouraging. At some other places where I have recently visited, the Spirit of the Lord was evidently working in some hearts. More than the foregoing statements I am not now in a position truthfully to make. "My word shall not return unto me void."

GUYSBOROUGH COUNTY.

Bro. Isaac Skinner, Licentiate, report of 8 weeks mission.

"I first went to Guysborough town; found the Church there without a pastor and much needing a shepherd to keep the flock together and impart to them the word of life.

Before visiting the Strait I went to New harbour on the Southern Shore and spent *eight* days. I was gladly received. Congregations were good and attentive, and a greater earnestness in the Cause of Christ was generally manifested.

On my arrival at the Strait I found that the little church at Sand Point had been for some time without the ministration of God's word and as is generally the case, the results were visible, in the cold state of the professed followers of Christ. I laboured praying that God would manifest himself in the hearts of those who had become indifferent, and produce a desire to return, as did the prodigal to the Father's house, and to influence those outside the fold of Christ to flee for refuge. I am pleased to state that in a small degree God did visit us by his grace and holy influence, by collecting together the little band of disciples, and giving them a desire to work together in harmony and love. Two young friends who had been awakened by the labors of Bro W. F. Armstrong last summer, came out in the full enjoyment of the religion of Jesus, and desired to follow their Redeemer in all his appointed ways.

Preached 20 sermons attended 18 Prayer and Conference Meetings, visited 60 families, travelled 443 miles, collected \$9.05.

COLCHESTER COUNTY.

Bro. G. O. Gates, Licentiate, having been assigned a mission of 8 weeks in New Annan, and the Head of Tatamagouche Bay, reported as follows :

"In both places I found regularly organized churches, but very small, and the love of many grown cold, "sheep without a Shepherd". The state of religion indeed appeared low, the lamp almost extinguished. Still a feeble few I found praying and hoping that yet a brighter day will dawn; trusting that though "sorrow may endure for the night, joy will come in the morning.

I was gladly received by the brethren, and was treated with uniform courtesy by all denominations. The field is a very inviting one. I left there many anxious souls, especially among the young.

In one of our social meetings a young man arose and requested prayer on his behalf. He informed me that he was tired of the ways of sin, found no pleasure in them and wanted to find Jesus as the Saviour of his soul. My prayer is that he may find that dear Redeemer. Two or three are waiting to join the Church at the earliest opportunity. "The waters are indeed being troubled."

In new Annan there are two quite prosperous Sabbath Schools. I visited them often and tried to encourage them. I trust the seed has been sown here, and that an abundant harvest will yet be gathered in. The work is the Lord's. He is able and also willing to bless. The people were very thankful to the Home Mission Board for remembering them and did cheerfully what they could in the way of remuneration.

I travelled 409 miles, preached 29 sermons, attended 13 Prayer and Conference Meetings, visited 106 families, some of them frequently, generally reading the Scriptures and offering prayer. Distributed 1230 pages of tracts; these were gladly received by all, and more than once have I been cheered by being informed of the comfort and encouragement derived from their perusal. "Cast thy bread upon the waters, and it shall be seen after many days." Collected in aid of the Mission \$51.97.

CUMBERLAND COUNTY.

Rev. E. B. Corey has labored 13 weeks in the service of the Board.

Preached 60 sermons, attended 18 Prayer and Conference meetings, made 379 family visits, Baptized 10 persons distributed 2000 pages of tracts, travelled 500 miles, collected \$40.89.

Extracts from letter of May 5th, "During my mission I have endeavoured to preach the gospel in the following

places, viz. Leicester, Mount Pleasant, Centreville, Port Philip, Torry Bay, Goose River, Pugwash and Pugwash River, Rail Road line Sec. No. 7.

In the month of March I labored at Torry Bay and Goose River. The church was revived and strengthened, eight happy converts were baptized upon a profession of their faith in the Lord Jesus. Three were restored to the fellowship of the Church.

In April I held special services at Pugwash River, some mercy drops have fallen.

Two rejoicing converts were baptized in the presence of many witnesses. A number more are expected. Our congregations are large and attentive, truly the Lord is displaying his power in the salvation of sinners."

HANTS COUNTY.

Bro. Rufus Sanford, Licentiate, spent *seven* weeks at Maitland and vicinity.

The following extract is a taken from a letter dated July 30th, 1870.

"I am pained to know that the little Baptist Church here has been so destitute of ministerial labor for years past. Revs. Geo. Wethers, and T. H. Porter, I think are the only two who have expended labor here to any extent. The interest as you may well suppose is very weak.

I am much encouraged in the work. The people seem inclined to do all in their power to support the gospel in their midst.

This field is one of deep interest and ought to receive your special attention. If a missionary could be supported in this place for one year, through the co-operation of the Board with the people, and the blessing of God attending his labors, I think that the cause would be self sustaining afterwards. There are many persons whom I found favourable to Baptist sentiments. These need to meet the encouragement arising from regular preaching services, a working organization.

My labors extended from Dimock Settlement to Noel, inclusive, a distance of twenty miles. Within this space I labored from house to house, reading the Scriptures, with prayer, conversation and distribution of tracts. We held two conference meetings, at the last of which, two persons were received into the fellowship of the church by letter. Also various matters neglected, respecting the Church records, were arraigned; Bro. David McCurdy was chosen Clerk, and a movement made in reference to finishing the meeting house. May the Lord prosper his work among those dear people."

meetings, made 120 family visits, distributed 683 pages of religious tracts, travelled 316 miles, 2 persons received into the church by letter, collected \$41.92.

LUNENBURG COUNTY.

Mahone Bay, Lunenburg, North West. Rev. Augustus Shields labored in the service of the Board 8 weeks, preached 43 sermons, attended 7 Prayer and Conference meetings visited 120 families, distributed 420 pages of tracts, travelled 240 miles, collected \$9.59.

On the 10th Feb. Bro. Shields wrote as follows: "I entered on the duties assigned me in Lunenburg County on the 20th Nov. Our brethren were happy to co-operate with me wherever I went. On week days I visited many places that otherwise would have been neglected. My heart was made glad in seeing many enquiring for "the way of life." I found it difficult to get a place in town; but in the Garden Lots, I preached to attentive, weeping hearers. I visited Heckman's Island several times.

We have a few believers there, they were glad of the privilege of hearing the precious gospel of Christ, and mourn that they are as Sheep without a fold, as there is no House of God in that place. I preached also at the Black Rocks."

The *Christian Messenger* of the 15th March contains a letter from Bro. Shields from which a few extracts have been gleaned.

"An unusual interest has been felt by the people in Mahone Bay and North West, for some weeks past. Last Sabbath I baptized *two* rejoicing souls, and expect to administer the sacred rite next Sabbath, as quite a number have obtained hope, and some received for membership.

The enemies of evangelical religion are mustering their forces to arrest the work. But how vain the attempt, since the work is evidently of the Lord! His conquering word has gone forth, and the impenitent are bowing before its power and majesty. May it everywhere go forth as brightness, and His salvation as a lamp that burneth, until all our churches are enlightened, refreshed, and greatly strengthened.

Bro. Joseph Robbins, Licentiate spent *five* weeks at New Ross and made the following report dated 2nd Sept.

"I preached 20 sermons, held 7 Prayer and Conference meetings, made 60 family visits, distributed 1200 pages of tracts, travelled 240 miles, and collected \$20 58½.

I found the little Church at New Ross feeble and somewhat cold, prayer and Conference meetings having been neglected during the winter, but I trust both will be sustained for the future.

The attention was very remarkable, and the congregations

constantly increased, on the last sabbath numbering *Eighty-five*. Baptist families in this settlement are few and widely scattered. There are many young people in this place in whose spiritual welfare I feel especially interested.

They are for the most part, thoughtful and some are enquiring the way to Zion. I found many families neglectful of family worship, and made it a particular part of my mission, strongly to urge parents to the performance of this important duty. There are two Sabbath Schools in connection with the Church, in both of which the young seem much interested.

May the Holy Spirit bless with power the word spoken in weakness, that saints may be revived, sinners converted, and God's name thereby glorified.

KING'S COUNTY.

Bro. Chas. Norwood, Lic., received an appointment of six weeks on Sherbrooke Road and Vicinity, and reports as follows :

"After a long time I have been enabled to fulfil the mission given me by the Board. The Lord has revived his cause wonderfully in that place—to Him be all the praise; the work is still going on. I intend to labor there during the coming winter, I have been preaching about *five* years with considerable trials of mind, whether I could be the means under God of doing any good, but I now feel that the Lord has done great things for me whereof I am glad.

Oh for a faith that will not shrink, though pressed by every foe.

Rev. Jas. Parker wrote to the *Christian Messenger*, Nov. 30th, 1870, as follows :

"Bro. Chas. Norwood has been laboring for a few weeks on Beech Hill, a section of the third Horton Church assisted somewhat by Bro. C. Burguss of Windsor.

God has greatly blessed their labours. It was my privilege last Sabbath to baptize twelve young persons as the result of their labors, and the converting influence of the Spirit."

Preached 32 sermons, attended 19 prayer and Conference meetings, made 57 family visits, baptized 29, distributed 972 pages of tracts, travelled 220 miles, collected \$13.98.

The following is from Rev. R. R. Philp :

CONSTITUTION

OF THE

N. S. BAPTIST HOME MISSIONARY SOCIETY.

I. This Society shall be called "The Nova Scotia Baptist Home Missionary Society."

II. The object of this Society shall be the preaching of the Gospel throughout Nova Scotia, and Newfoundland, the assistance of feeble Churches, and the planting of new ones.

III. Any person may become a member of this Society by contributing five shillings and upwards annually, to its funds. Any person contributing five pounds at one time shall be a Life Member. Any person contributing twenty pounds at one time, or whose contributions shall amount to that sum, shall be a Life Director. Every Association or Auxiliary, which contributes annually to this Society shall be entitled to be represented by one Delegate for every five pounds so contributed; and every Baptist Church contributing annually to the funds of the Society, shall have the privilege of sending a delegate. Should the funds so contributed exceed five pounds, such church shall be entitled to send one delegate for every five pounds contributed,—*Provided*: That no Association, Auxiliary or Church, shall be entitled to send more than five Delegates at one time.

IV. The officers of this Society shall be a President, Vice-Presidents, Secretary, Treasurer, and Auditor, who shall be annually appointed by the Society from among its members.

V. The Society shall annually appoint a Board of Management, consisting of twenty-four members, members of Baptist Churches, seven of whom shall reside in the place designated, from year to year, as the location of the Board, or in its neighborhood, and five shall constitute a quorum. The officers above named shall be *ex-officio* members of the Board. The following shall be the duties of the Board, viz.:—To meet from time to time for the despatch of business, due notice of such meeting being given; to appoint missionaries, and assign their respective spheres of labor; to expend the funds for the objects of the Society, provided that all amounts contributed for any specific purpose shall be faithfully applied as far as possible in accordance with the wishes of the donors; to employ agents for the collection of funds, and for the general advancement of the interests of the Society; and to furnish a report of the proceedings of the past year at the Annual meeting.

VI. Every Auxiliary Society which shall agree to commit all its funds to the direction of this Society, shall be entitled to receive Missionary labor in such field as it may designate, to an amount at least equal to its contributions; provided that such designation be intimated at the time of payment.

VII. The members of Auxiliary Societies shall be members of this Society. Life Directors shall be entitled to attend and vote at meetings of the Board.

VIII. The Annual meeting of the Society shall be held at such time and place as shall be determined upon at a previous Annual meeting. At that meeting, the officers of the Society for the ensuing year shall be appointed, and such other business transacted as the members then present deem expedient.

IX. No alteration of this Constitution shall be made without an affirmative vote of two-thirds of the members present at an annual meeting.

BYE LAWS

OF THE

N. S. BAPTIST HOME MISSIONARY BOARD.

ARTICLE 1.—This Board shall meet for the dispatch of business at 4 o'clock, P. M., on the 1st Wednesday of each month,—Also at such other times as duly called by the Chairman, or Secretary, or two other members of the Board.

ARTICLE 2.—Each meeting of the Board shall be opened and closed with prayer, and the minutes of preceding meetings read and approved.

ARTICLE 3.—None but Licentiates from regular Baptist Churches and ordained Ministers, recognized as such by a regular Baptist Association, shall be employed as Missionaries for the Society.

ARTICLE 4.—No Missionary shall be at liberty to change his field of labor or to extend the time of his service beyond appointment without consent of the Board.

ARTICLE 5.—The compensation allowed, generally, for married, and ordained Missionaries shall be eight dollars per week, for married licentiates and unmarried ordained Missionaries seven dollars, for unmarried licentiates six dollars, in each case exclusive of travelling expenses.

ARTICLE 6.—All Missionaries or pastors serving under the Board are empowered and expected to make all reasonable effort during the time, and in the localities of such service, to collect funds in aid of the Treasury, to be transmitted forthwith to the same, or reported to the Board, credited towards labor performed.

ARTICLE 7.—On the expiration of Missions, reports shall be promptly made to the Board, by Missionaries, stating definitely, the number of weeks' service, number of sermons preached, visits made, miles travelled, pages of tracts distributed, baptisms performed, Sabbath Schools visited, other meetings attended, Churches, Sabbath Schools, Temperance Societies and prayer meetings organized; moneys and other contributions, with the names of the donors; and such other facts connected with their labors likely to be of general interest.

ARTICLE 8.—No moneys shall be paid by the Treasurer, except on an order signed by the Chairman and Secretary.

ARTICLE 9.—The Chairman and Secretary shall sign no orders for moneys from the Treasury unless for accounts checked by the Auditors.

ARTICLE 10.—No accounts shall be audited until ordered by the Board.

ARTICLE 11.—The Board shall not accept and submit accounts to the Auditors, unless presenting full particulars of debits and credits, &c., as specified in Article 7.

ARTICLE 12.—The Secretary of this Board, with the consent of the Editor of the *Christian Messenger*, shall furnish, monthly, for publication in that paper, the following items, viz:—Letters received [during the month], appointments made, amount of funds in the Treasury, amounts due Missionaries, the names of Missionaries and their fields of labor, members of the Board present at last meeting, and such other particulars as may be ordered by the Board.

ARTICLE 13.—A copy of these Bye Laws shall be forwarded by the Secretary to each missionary on his appointment.
