## CONSTITUTION OF THE SOCIETY.

---

### I.

The Society shall be called the **DIOCESAN CHURCH SOCIETY OF NEW BRUNSWICK.**

### II.

No constitution, by-law, rule or regulation of the Society, or any abrogation, repeal, change, or alteration of the same, shall be of any force until it shall have been sanctioned and confirmed by the Bishop of, and administering the Diocese for the time being, by writing under his hand.

### III.

The payment at any one time of a sum not less than Ten Pounds, shall constitute a Life Member ; and the payment annually of any sum, however small, shall constitute the person paying the same a Member of the Society.

### IV.

The Society shall have a President, who shall be the Lord Bishop of the Diocese ; two or more Vice-Presidents, of whom the Archdeacon shall be the first ; one or more Treasurers ; one or more Secretaries ; two Auditors of Accounts ; and an Executive Committee of twenty four Lay Members of the Society, being Life Members of the Society, or Subscribers of, at least, One Pound to the funds of the Society ; who, with the exception of the President and Vice-Presidents, shall be annually elected at the Anniversary Meeting.

### V.

The Officers of the Society and the Clergy of the Diocese shall be *ex-officio* Members of the Committee : five to be a quorum, and three of the five Laymen.

### VI.

The Society shall embrace the following objects, and none other, viz :—

1. Missionary Visits to places where there is no settled Clergyman, and aid to new and poor Missions.

2. The establishment of Divinity Scholarships at King's College, Fredericton ; and assistance, where necessary, to those who may be under preparation for the Ministry, especially Sons of Clergymen.

3. Aid to Sunday and other Schools, in which Church principles are taught, and the training and encouraging of Schoolmasters and Catechists.

vi.

4. The supply of Books and Tracts, in strict conformity with the principles of the Established Church.

5. Aid to the building, and enlarging of Churches and Chapels.

6. Aid to the building of Parsonage Houses.

7. The creation of a fund towards the augmentation of the stipends of poor Clergymen—towards making a provision for those who may be incapacitated by age or infirmity—and for the widows and orphans of the Clergy—and towards the education of the children of poor Clergymen.

VII.

The Society will employ no Clergyman on Missionary services without the Bishop's licence and appointment, and will submit its choice of Divinity Scholarships to His Lordship's approbation.

VIII.

The Society will circulate no Books which are not in the Catalogue of the Society for Promoting Christian Knowledge, except such as the Bishop shall approve.

IX.

It shall be competent to any Member of the Society to limit his subscription to any one or more of the objects above recited, which he may be most anxious to promote.

X.

The Members of the Society in each Mission, or in each Parish of each Mission, at the discretion of the Missionary, shall constitute a Local Committee.

XI.

It shall be competent to each Committee to recommend any of the above recited objects to the special consideration of the General Committee, in the appropriation of the funds of the Society.

XII.

The Society shall hold its Anniversary Meeting at Fredericton and Saint John alternately; at the latter place on the Thursday after third Tuesday in January, and at the former place on the Thursday after the second Tuesday in February in each year.

XIII.

The Committee of each Parish or Mission shall hold an Annual Meeting; on some convenient day, previous to the Anniversary Meeting, when the recommendation to the General Committee of special objects shall be determined on.

vii.

**XIV.**

Each Local Committee shall be empowered to depute two Lay Members of the Society to be elected at the Annual Meeting of the Committee, to assist the Missionary in submitting the recommendations of the Committee to the consideration of the General Committee.

**XV.**

For this purpose the Missionaries and Lay Deputies shall meet in General Committee on the two days, or more if need be, previous to the Anniversary Meeting, to make the annual appropriation of the funds of the Society.

**XVI.**

The Executive Committee shall meet either at Fredericton or Saint John, on the first Wednesday in January, on the day after the Annual Meeting, on the first Wednesday in March, on the first Wednesday in June, and on the Wednesday after the first Tuesday in October.

**XVII.**

The Clergy are requested to preach annually two Sermons in their respective Churches, with a collection on each occasion for the General Purposes of the Society.

**XVIII.**

No article of the Constitution of this Society shall be rescinded, altered, or amended, except with the concurrence of two-thirds of the Members present at a General Meeting: and notice of any motion shall be given at the General Meeting previous to the one at which such motion is to be made.

## PRAYERS OF THE SOCIETY.

### BEFORE THEY COMMENCE BUSINESS.

PREVENT us, O Lord, in all our doings, with Thy most gracious favour; and further us with Thy continual help; that in all our works, begun, continued, and ended in Thee, we may glorify Thy holy name; and finally, by Thy mercy, obtain everlasting life, through Jesus Christ our Lord. *Amen.*

O GOD, from whom all holy desires, all good counsels, and all works of piety and charity do proceed, we beseech Thee to visit with Thy favour our Sovereign Lady Queen VICTORIA; and so rule her heart that she may in all things seek Thy honour and glory. Prosper with Thy blessing the designs of this Society. Comfort with Thy grace those benefactors who contribute to its support. Bless the ministry of thy servants, the Clergy; the endeavours of all who are engaged in spreading the knowledge of true religion in the dominions of our Sovereign, and the labours of those Missionaries who are promoting the same in this Province. And may Thy Holy Spirit direct all our consultations to the advancement of Thy Glory, and the good of Thy Church, through Jesus Christ our Lord. *Amen.*

O MERCIFUL GOD, who has made all men, and hatest nothing that thou hast made, nor wouldst the death of a sinner, but that he should be converted and live: Have mercy upon all Jews, Turks, Infidels, and Heretics, and take from them all ignorance, hardness of heart, and contempt of Thy Word; and so fetch them home, blessed Lord, to Thy flock, that they may be saved among the remnant of the true Israelites, and be made one fold under one Shepherd, Jesus Christ our Lord, who liveth and reigneth with Thee and the Holy Spirit, one God, world without end. *Amen.*

Our Father, which art in heaven, Hallowed be Thy name. Thy kingdom come. Thy will be done in earth as it is in heaven. Give us this day our daily bread. And forgive us our trespasses, as we forgive them that trespass against us. ## REPORT, &c.

THE period has arrived for another—and that the Fifteenth Anniversary Meeting of the Diocesan Church Society. It is well, at such a time, to look back, especially upon the year just closed, and in submission to the Sovereign Disposer of events, to augur from the past somewhat of encouragement for the time to come.

Much to make us sad and thoughtful has marked the course of the year that has gone by. Within that period, the Venerable Prelate, the Lord Bishop of Nova Scotia, under whose direction this Society was formed, has gone, deeply lamented, to his rest. By another dispensation of an All Wise Providence, an extensive Mission has been deprived of a beloved Pastor; a Widow and Orphans mourn over the loss of an earthly protector, and this Society is called to lament for one of the most zealous of its Members, who for a long time filled the office of Assistant Secretary. The remembrance of these events cannot fail to awaken, in the Members of this Society, feelings of sympathy and regret.

Turning, saddened and thoughtful from this subject, to view that Branch of the Church of Christ of which we are members, we find much to lead us, with the Apostle, “to thank God and take courage.” In the midst of those trials of faith and patience, through which the Church in England has of late been made to pass, evidence is not wanting that her Divine Master is drawing nearer. The vast and self-denying efforts to extend her ministrations at home and abroad, are tokens of His presence and blessing. What though in carrying on the work in this Country, difficulties must be encountered, and the result of our labours seem comparatively small? When we call to mind, that a few years ago this Diocese, and even the site of this flourishing City was a forest, surely the progress of this Society and

the interest taken in its prosperity should not lead us to despond. For several years it was thought that good success had attended it, when in addition to the aid afforded in building Churches, and the importation of Books, the expenses of two travelling Missionaries could be defrayed; now, let it be borne in mind, that besides these charges upon its funds,—besides aid yearly given to build Churches and Parsonage houses—besides the annual importation of Bibles, Prayer Books and religious publications for Sunday Libraries,—and the yearly addition to a fund for the assistance of Widows and Orphans of the Clergy,—this Society assists in keeping up Fourteen Missions in destitute places.

To maintain its present position, these holy objects, so undeniably worthy of support, must with patient perseverance be carried out after the mind of St. Paul, “who took care to provide things honest not only in the sight of God but also in the sight of men;” and to add yearly to its usefulness, the Members of the Church need only to consider and duly regard the privileges they enjoy, and the responsibilities, which according to the Gospel of Christ, these privileges impose.

From the following abstracts of the Reports of the Local Committees, it may be judged how far the Society can at present rely upon the support of its Members:—

ST. ANDREWS.—Rev. J. Alley, D. D., writes, that at a meeting of this Local Committee, in All Saints Church, on the evening of the 19th December, after Divine service, the following Resolutions were passed:—

1. That the wise regulations and the prudent management of the Church Society, call for the continued approbation and support of all the members of the Church of England in this Diocese.

2. That this Committee have heard with the deepest feelings of concern, of the death of our former venerable and highly respected Diocesan, the Lord Bishop of Nova Scotia, and most sincerely sympathize with the members of the Church in that Province, and with the late Bishop's afflicted family.

Contributions reported as follows:—General purposes, £16 12 6; 1st Sermon, £5 3 6; 2nd Sermon, £3 6 6—Total, £25 2 6.

CAMPO BELLO.—Rev. Dr. Alley since reports, that he has obtained contributions at this place, amounting to £2 5s.; and request on the part of that Committee a grant of Books and Tracts.

MAUGERVILLE AND BURTON.—Rev. Donald Bliss encloses the following Resolution, passed at a meeting of this Committee, held at Maugerville on the 1st January, 1851:—

“That the Committee view with the liveliest feelings of satisfaction the increased amount of subscriptions for the past year, it being an evident token that the Church in these Parishes still advances, notwithstanding the difficulties it has to contend with.”

Contributions from Burton, £14 10 6; 1st Sermon, £1 6 7; 2nd Sermon, 15s.—Total, general purposes, £16 13 1. Maugerville, Divinity Scholarship, £1; Widows and Orphans, £1 16 3; general purposes, £6 4s.; 1s Sermon, £1 15 10; 2nd do. 17s.—Total, £11 13 1.

**GREENWICH AND PETERSVILLE.**—Rev. J. Bartholomew writes, that the Local Committee in his Mission desires to express their unfeigned gratitude to the Society for the liberal aid in the support of their Minister, and especially for the grant to enlarge the Church at Petersville; the object of which, they are happy to say, has been realized by the erection of a small but neat spire and vestry, and an increase of Church accommodation. The grant of Books they have found very useful, and earnestly solicit an additional grant for their Lending Library. The Missionary deems it his duty to remark, for the information of the Society, which contributes so largely to the support of the Mission, that the attendance at the various Churches is steady and moderately large, particularly so at the various out-posts. Several new members have been added to the number of communicants during the year, and a growing attachment to our pure and Scriptural Church is distinctly perceived. As an evidence of this, the free will offerings of the people, notwithstanding the scarcity of money, are in general promptly paid; and on the part of many, indications are not wanting of their desire, while honored with membership in the "Church Militant here on earth," to be found in the "Church of the first born, whose names are written in Heaven." There are, he adds, three Sunday Schools in the Mission, where the doctrines of the Church are diligently, and it may be hoped, successfully taught. Contributions for general purposes, Greenwich, £7 13 8; Petersville, £6 4—Total, £14.

**HARVEY AND HOPEWELL.**—Rev. C. P. Bliss encloses a list of contributions from this Mission, amounting in all to £14 4 10, and trusts that each succeeding year may witness as great an increase as this over the last. The Missionary writes, that the severe weather in the autumn prevented the entire completion of the outside of the Church at Harvey, on which account he was unable to make use of the grant made last year. He solicits an additional grant, to be drawn for when the Church is finished. It is with great pleasure, he adds, that he is able to report the completion of a small Church in the poor district of New Ireland. He sends a list of his stations:—

Harvey,—every Sunday morning. New Ireland, 8 miles,—every fortnight.

Salmon River, 18 miles,—every fortnight. Creek, 14 miles,—every fortnight.

At the Cape, 14 miles, and the Hill, 6 miles, whenever he has an opportunity.

"I trust" he says, "the cause is gaining ground here. If I could confine my time and attention to one Parish, which would form three stations, the fruit would be greater. I pray for the time to come, when more labourers will be sent to this County."

The Missionary since reports the organization of a Local Committee in each of these Parishes. At Harvey, on the 10th January, when the following Resolutions were passed:—

1. That in the opinion of this Committee it is the bounden duty of all Christians to support by their alms some religious society; and that, in their opinion, there is none so worthy of support, or in which they can place greater confidence, than the Diocesan Church Society.

2. That the thanks of this Committee be given to the Society for the grant made to the Mission, for the aid afforded in the erection of the Church, and for the grant of Books; and that the Society be solicited to continue its bounty so far as its funds will allow.

In another Resolution the Committee express deep sympathy with their fellow Churchmen in the sister Province, in the loss of their excellent Bishop, who is affectionately remembered by several in that community.

A meeting was also held at Hopewell on the 9th inst., when after forming a Local Committee, it was resolved, "That it be the bounden duty of all members of the Church of England to afford the Society every support and encouragement;" and "that while the Committee thankfully acknowledge the exertions of their present Missionary, they regret that the wide field committed to his charge, prevents his performing Divine Service as frequently as they desire, and they trust the Society will speedily afford them further aid, the duties of this Missionary being too arduous for any one Clergyman." Contributions reported as follows:—Harvey, Schools, 2s 6d; general purposes, £8 5; Sermons, £1 3 4; Hopewell, Books and Tracts, 5s; general purposes, £4 19—Total, £14 4 10.

**KINGSCLEAR.**—Rev. J. Black reports contributions from this Mission as follows:—Widows and Orphans, £2; general purposes, £7 2 6; 1st Sermon, £1 8s.; 2nd do. £1 9s.—Total, £11 19 6.

**CHATHAM.**—Rev. S. Bacon has forwarded to the Treasurer, contributions for Missionary visits, £18; Widows and Orphans, 5s; 1st Sermon, £4 5s.; 2nd do. £2—Total, £24 10s.

Mr. Bacon writes, that at a Meeting of the Local Committee, Resolutions were passed expressive of an opinion, that the benefits derived from this Society cannot be overrated, and that the Committee view with unspeakable satisfaction its increased and increasing prosperity.

**MONCTON.**—Rev. W. N. Boyer writes, that he has remitted to the Treasurer £1 11 6, the amount of contributions and collections in his Missions. The collections after Sermons, he states, were small, owing to the bad state of the weather; and the contributions are below the usual amount, as endeavours are being made to erect a Church. The Missionary continues, that the frame of the Church is up, and other preparation made for proceeding with the work as soon as the weather will permit; the land will be legally secured to the

Church. He is happy also to state, that the ministrations of the Church are still well attended, not only on Sundays, but also on the Fasts and Festivals of the Church; and he has no doubt but in a short time he shall have a Church-going people in that place. There are no contributions from Salisbury, as efforts are being made for the erection of a small Chapel at that place.

**GAGTOWN.**—The Rev. N. A. Coster has forwarded the returns of this Local Committee, signed by W. H. DeVeber, Esquire, Treasurer, which are as follows:—Books and Tracts, 17s. 6d.; contributions, £5 16 10½; 1st Sermon, 4th Sunday after Trinity, £1 8 10½; 2nd do. 20th Sunday after Trinity, £2 2 5.—£9 8 2 general purposes—Total, £10 5 8.

**GRAND MANAN.**—Rev. G. T. Carey, through the Rev. J. Alley, D.D., has forwarded £2 10 for the general purposes of the Society, and requests a grant of Prayer Books, Catechisms and Tracts for use in his Mission. The sum of £1 was also forwarded to the Treasurer in June last.

**CARLETON.**—Rev. F. Coster forwards contributions as follows:—Collections, £12 9 8; 1st Sermon, £3 9 9; 2nd do. £2 13 4—£18 12 9 general purposes.

**FREDERICTON.**—The Venerable the Archdeacon reports that this Local Committee met at the Vestry of Christ Church on the 1st of January, when the following Resolutions were unanimously passed:—

1st. That although it might have been anticipated that there would have been a considerable falling off in the amount of contributions to the fund of the Society, on account of the late destructive fire, this Committee is happy to find the amount is scarcely inferior to that collected last year.

2nd. That it be a recommendation to the General Committee, to give authority and make provision for the regular payment of the expenses of Travelling Missionaries by the Executive Committee.

3rd. That it be recommended to the General Committee, to make a grant to the Book Depository in this place, for the importation of Books for sale, and the supply of grants to the Local Committees. Contributions reported:—£134 14 7; 1st Sermon, £18 13s.; 2d do. (W. & O. Fund) £14 0 4; St. Anne's Chapel, (W. & O.) £1 18 4—Total, £169 6 3.

**MARYLAND.**—The contributions from this small congregation exceed those of past year. It is a pleasing fact and worthy of remark, that the people, who have very little to give, of their own accord have increased their offerings, and many of them save the trouble of collecting, by bringing what they have to give to the Church. An addition to the Library, which is becoming very useful, is solicited. Contributions are as follows:—£8 0 1; 1st Sermon, 13s. 6d.; 2nd do. (W. & O.) 10s. 4d.—Total, £7 4 1.

**TRAVELLING MISSIONARY.**—The following extract is made from a Report of the Rev. W. Q. Ketchum to the Lord Bishop:—

Mr. Ketchum visited the County of Restigouche in June last. He held Divine service and preached at Dalhousie, Campbellton, and in a back Settlement, and also visited the members of the Church in those places and the neighbourhood, and distributed books and tracts among them. The services were well attended, and the Missionary everywhere received with great kindness. It is earnestly to be hoped that the wishes of the people will be complied with, and a settled Missionary be soon stationed in that most important section of the country. In the month of September, Mr. Ketchum visited the country lying on the east side of the River St. John, between Queensbury and the Tobique. Divine service was held at eleven different places; nine children were baptised; and large numbers of people attended, with apparent devotion, on each occasion. The regular visits of a travelling Missionary in that part of the country would be a great blessing. Truly the people there are for the most part "scattered abroad like sheep not having a shepherd." Mr. Ketchum travelled in all a distance of 1028 miles, for the expenses of which the sum of £10 was drawn by the Lord Bishop from the Fund for Travelling Missionaries.

**BATHURST.**—The Rev. Noah Diabrow reports contributions to the amount of £2 7s. and expresses regret that through the scarcity of money, the amount is less than that contributed last year.

**SACKVILLE AND DORCHESTER.**—The Rev. Thos. N. DeWolf forwards from this Mission, contributions, £15 4 5½; 1st Sermon, £1 14 10; 2nd Sermon, £2 4 8—Total for general purposes, £19 3 11½.

**SIMONDS.**—The Rev. J. W. Diabrow reports, that this Local Committee held their meeting at the Parish Church, on the 7th inst., and after expressing their warmest thanks for the aid rendered to this poor Mission by the Society, they solicit assistance in the erection of a Church at Black River, and a further grant to their Lending Library. With feelings of thankfulness the Committee report that the contributions from this Mission have not decreased; they are as follows:—Widows and Orphans Fund, 2s. 6d.; general purposes, £8 9 6; 1st Sermon, 8s. 10d.; 2nd Sermon, 10s.—Total, £9 11 7.



**UPHAM.**—Rev. W. H. DeVeber writes, that at the annual meeting of this Local Committee, on the 13th inst., Resolutions were passed thanking the Society for its donations to the Churches at South Stream and Londonderry, and soliciting further aid in behalf of the latter. The former Church will be ready for consecration so soon as a small debt upon it shall have been paid. The latter is a neat Norman structure, consisting of a tower, nave and chancel of pleasing proportions. It will hold about 150 people, and will, it is hoped, prove a blessing to the settlers in that comparatively poor district. With the Society's help, the Missionary hopes to finish this Church next summer. "Fully alive," he adds, "to the importance of this Society, as a handmaid of the Church, I have not ceased to impress upon the Parishioners the imperative necessity of liberally contributing to its support; and I have spared no exertions in collecting their contributions. In this work I have been much encouraged by the readiness with which they have responded to my calls, and seconded my exertions." The contributions, including the collections at Sermons, amounts to about £22.

**PRINCE WILLIAM AND DUMFRIES.**—The Rev. J. Elwell writes, that the state of the roads in Christmas week, prevented him from finishing the collections for the Society, and that since that time, important business has obliged him to go for a short time to the United States. He hopes to make the usual Report immediately after his return home.

**SAINT JOHN.**—R. Parker, Junior, Esq., as Secretary of this Committee, reports the following contributions to the Society:—Missionary visits, £2; Schools, £1; Books and Tracts, 10s; Parsonage Houses, £4; Widows and Orphans Fund, £20; general purposes, £206 19 8; 1st Sermon, £12 12 10; 2nd do. £5 8 9—Total, £252 11 3.

**ANDOVER AND GRAND FALLS.**—The Rev. S. J. Hanford on behalf of this Mission thanks the Society for the grant of Books and the grant to the Church at the Grand Falls. Although he has to regret that the Church is not yet completed, he hopes the work will go on next summer. He strongly solicits the Society to withdraw the restriction on a former grant, as this would hasten the completion of the building, which is of vast importance, as there is now no place of worship at the Grand Falls except a Roman Catholic Chapel, and none opened regularly on the Lord's Day. It is not surprising, the Missionary adds, that a careless observance of this sacred day should prevail, when the situation of the country and the occupations of the people are considered; and hence the great necessity of proceeding with this work, by which the lumbermen and other transient people, for whom the Grand Falls is much a place of resort, may be invited to meet for prayer and praise to the Almighty. On the British side of the Lines, the number of Protestants are few. There are some families living near the Saint Francis, seventy miles above the Grand Falls. A visit which the Missionary was enabled to pay this remote district during the past summer was very thankfully received, and God willing, he trusts soon to visit them again.

As the Missionary is now to reside at the Grand Falls, it will be out of his power to keep up the services at the Tobique and River des Chutes, and in still more distant stations, as hitherto. He earnestly commends this part of the Mission to the consideration of the Society, fervently hoping that if a Missionary be found, the Society will aid in furnishing the means of supplying the spiritual wants of that part of the country.

Illness and other unavoidable events have prevented the completion of the collections, which, it is hoped, will not fall short of the past year.

**PORTLAND.**—Rev. W. Harrison is happy in being able to Report, that the contributions in the western part of his Parish, exceed those of last year. The amount collected by himself is £30.

**DISTRICT OF SAINT PAUL'S CHURCH.**—The Rev. W. H. Shore has reported contributions to the amount of £11, making in all from the Parish of Portland £41.

**GLENELG, AND THE SETTLEMENTS ON THE SOUTH WEST BRANCH OF THE MIRAMICHI.**—The Rev. J. Hudson, Visiting Missionary, reports that the annual meeting of the Glenelg Committee was held on the 1st January last, after the celebration of Divine Service, and that the following Resolutions were passed thereat:—

1. That it is the bounden duty of the Members of the Church of England throughout this Province, "high and low, rich and poor, one with another," to assist cheerfully, according to the utmost of their influence and ability, in promoting the various objects of Christian charity now embraced by the Diocesan Church Society.

2. That the best thanks of this Committee be given to the Society, for its benevolent assistance towards building Saint Andrew's Church at Newcastle.

The Visiting Missionary, in transmitting the foregoing Resolutions, thinks it proper to add, that during the past year he has been steadily engaged in keeping within the Church's fold his little flocks at Glenelg, Newcastle, Nelson, Blackville, and the other Settlements of this extensive Mission; he is obliged, however, to express a doubt, whether he shall be able as a solitary Shepherd, to remain long in this isolated field. More pastoral assistance is much needed on this River, for which he shall be most thankful; and if soon granted, the Church would then be in a position to increase, and he trusts, by the blessing of God, that that increase would be given. Oh! that they who read these lines could but see and

feel his solitary position, for then he should be relieved, and then the "hungry sheep, who now look up, would be fed."

The Society will doubtless be glad to learn that the Church at Newcastle, which was assisted by its funds, has been duly consecrated to the public worship and praise of Almighty God, and that it has been generally filled with apparently as devout, and certainly as attentive a congregation as the writer has ever ministered unto. The Church has been built for the glory of God and the good of man. May it be the means of accomplishing this holy object!

The Missionary has also the satisfaction to mention, that several adults, (after due preparation,) have been lately baptised by him at Blackville, amongst whom was a venerable Son of Israel, aged "three score years and ten," whose "eyes had been opened," as he said, "to the necessity of baptism by reading the baptismal offices in the Prayer Book, and comparing the same with the Bible." On the following Sunday, this old man evinced his sincerity and honesty of heart by receiving the Holy Communion.

The contributions from this miserably poor district, are £18 16 4, of which a small portion has not yet been remitted to the Treasurer, owing to a late accident, from the effect of which the Missionary has not yet recovered.

**SHEDIAC.**—Rev. Dr. Jarvis reports contributions as follows:—Books and Tracts, 2s. 6d.; general purposes, £2 17 6; 1st Sermon, £1 17s.; 2d Sermon, £1 3 5; from Cocaigne, £2.—Total, £7 5s.

**ST. MARY'S.**—Rev. W. Jaffrey reports the usual amount of contributions, and trusts in a few days to forward a further sum, as the state of the roads have prevented him from calling on several of his former subscribers. The Missionary adds that there seems a growing interest in favour of the Church in this Mission; that 48 baptisms have been performed, and but one burial during the past year. Of the amount contributed, £5 10s. has been limited to the object of Schools. And as the operation of one of the Sunday Schools, numbering 65 children, has been suspended for want of a suitable building, he solicits on behalf of the subscribers, a small grant to aid in the erection of a school house.—Contributions for Schools, £5 10s.; general purposes, £4 18 4; 1st Sermon, 18s.; 2d do. 6s. 2d.; since remitted, £2 4s. 3d.—Total, £13 13 9.

**WESTFIELD.**—The Rev. C. Milner writes, that he has the pleasure to say, that a Committee has been formed in his Parish, and that R. F. Hazen, Esq., has undertaken the office of Delegate to the General Meeting. He hopes, as the advantages of the Society are better understood among his people, those who have the means may be more liberal in their contributions. A grant of Books for a Parochial Library would be most usefully applied.—Contributions, £7 12 10½; 1st Sermon, 9s. 2d.; general purposes, £9 14 10½.

**ST. GEORGE.**—Rev. J. M'Govern reports, that at a meeting of the Local Committee on the 13th of January, several Resolutions were passed expressive of gratitude to Almighty God for his continued blessing on the labours of the Society, and conveying thanks to the Lord Bishop and the General Committee for the grant of Books for the Lending Libraries; and soliciting a grant of £10 towards liquidating a debt incurred in adding a chancel and other improvements to St. Mark's Church. The amount of contributions is £14 18 2½ for general purposes. Mr. M'Govern feels pleasure in stating that the interest felt by the people of his Mission, and their attachment to the Society are steadily advancing; and he trusts, with the Divine blessing, as the Society's claims and objects become better known and understood, this good feeling will increase from year to year. He adds, that by the benevolent exertions of the Ladies of St. George, the Parish Church has been much improved and enlarged, a handsome and substantial fence erected around the Church-yard, a chancel and vestry added to the Church, the pulpit and desk removed to a more eligible situation, and the interior of the building has been painted. All which has met with the approbation and received the sanction of the Lord Bishop. A balance of £10 remains due for work on the Church, which Mr. M'Govern has been obliged to assume, and for which, with the concurrence of the Local Committee, he is constrained to ask a grant from the Society,—a reasonable request which, he feels confident, the Society will not refuse.

**SUSSEX & STUDHOLM.**—Rev. Thos. M'Ghee reports contributions, £6 3 6; 1st Sermon, £1 8 4; 2d do. 16s. 8d.—Total, general purposes, £8 8 6.

**RICHIBUCTO.**—Rev. J. Neales encloses the amount of contributions from this Mission, £30 18s.; 1st Sermon, £2 15s.; general purposes, £35 3s.

C. W. Weldon, Esq., as Secretary of the Local Committee, writes, that at a meeting of the same held at Richibucto, in Saint Mary's Church, on 28th Nov., 1850, the following resolution was unanimously passed:—

"Resolved, That this meeting desires to record its thankfulness to Almighty God for the increasing prosperity and usefulness of the Diocesan Church Society, looking upon it as one of the most efficient means which could have been devised for advancing the interests of the Church in this Province, and they do most earnestly call upon their fellow Churchmen in every Parish in the Province, to go on in the good work with increased zeal and liberality."

**SPRINGFIELD.**—Rev. R. D. Palmer forwards Resolutions passed by this Local Committee, expressive of thankfulness to the Society for its grants to the Mission, and on the part of the members of the Church in the Irish Settlement, for the grant to their Church, which they hope will be finished and consecrated in August next. To effect this, they again ask aid from the Society. The Missionary encloses a Letter from Mr. Grindon, a Schoolmaster in the Parish of Johnston, who is most earnest in his endeavour to establish a Sunday School, and asks for a grant of Books to assist him in that object. Contributions reported, £11 3 9; 1st Sermon, £1 11 10½; 2d do. £1 11 6½—Total, £14 7 2, for general purposes.

**LANCASTER.**—Rev. T. W. Robertson writes, that this Local Committee held their annual meeting on the 18th instant, and passed several Resolutions expressive of their entire satisfaction as to the management of the Society and the distribution of its funds, and pledging themselves to do all in their power towards its support. They thank the Society for the grant to the Missionary and the supply of Books and Tracts. The Committee solicit a grant from the Society to aid in enlarging the Parish Church. A Resolution was also passed expressive of sympathy with their fellow Churchmen in the Sister Province, in their loss by the death of their beloved Bishop. Contributions as follows:—Widows and Orphans, £5 3s.; general purposes, £5 17 5½; 1st Sermon, £1 5s.; 2d do. £1—Total, £13 5 5½.

**DOUGLAS.**—Rev. A. V. Stuart, in enclosing the returns from his Mission, writes, that though the subscription list does not evince as large an increase as he had hoped, yet under all the circumstances, it is perhaps as great as he ought to expect. He prays, that God may more and more open the eyes of his people to see the importance and blessing of giving of their worldly goods to this Society, which is doing so much good in this Province, and which ought to be supported by every member of the Church by his prayers and alms. The Books granted by the Society, Mr. Stuart adds, are divided in Libraries attached to his two Churches. They have a large circulation, are read with pleasure, and he fully believes with great profit.

A Resolution enclosed by H. P. Robinson, Esquire, the Secretary of the Local Committee, conveys thanks for the grant of Books, and solicits another grant this year. Contributions, £9 6 9; 2 Sermons, £2 17s.; Books sold, (1848) 5s.—General purposes, £12 8 9.

**NORTON.**—Rev. W. Scovil writes, that he is requested by the Local Committee in this Parish to thank the Parent Society for the few Books they were enabled to add to the Lending Library, and to beg to be remembered in the appropriations at the present anniversary meetings. They are happy to report that the contributions have very much increased, and exceed the collections of any previous year. They are as follows:—Widows and Orphans, £7 10s.; general purposes, £12 10s.; 1st Collection, £4 10s.; 2d do. £2 6s., 2d.—Total, £26 16 2.

**WOODSTOCK.**—Rev. S. D. Lee Street reports, that at a meeting of the Local Committee of this place, held at Saint Luke's Church on the 6th December, 1850, a Resolution was passed thanking the Society for the grant of Books to the three Lending Libraries in this Mission, and urging their great importance and the advantage of increasing them, as a means of dispensing true religious principles.

It was further resolved, "that whereas the time cannot be far distant when the support of the Church in this Province must chiefly, if not altogether, depend upon local exertions, it becomes a serious and important subject of consideration with Churchmen as to what means can best be adopted for providing for this contingency; therefore resolved, that this Committee would suggest to the Diocesan Church Society the propriety of setting apart a certain portion of the amount contributed from each Mission, towards creating a fund for the endowment of the Church in that Mission, and although by this, the annual expenditure would be contracted, a saving and would be created which would add to the means of the future prosperity and usefulness of the Society."

Another Resolution was passed expressing great thankfulness to the Giver of all good for the prosperity of this Society, and the blessing which has attended the labours of those engaged in promoting its objects, and urging the duty of all Churchmen to enroll themselves as members, and contribute to the same, according to the ability which God has given. Contributions for general purposes, £31 14 7; 1st Sermon, 4th August, £2; 2d do. 12th July, £1 15s.—Total, £35 9 7.

**ST. STEPHEN.**—Rev. Skeffington Thomson, L. L. D., writes, that this Local Committee held its meeting on the evening of St. Stephen's day, and passed several Resolutions expressive of the Committee's sense of the obligation of Christians to advance the cause of Christianity by their exertions, and their means; their full confidence in the Church Society, and an earnest desire, that all the members of the Church within this Mission should be contributors in aid of its objects.

Dr. Thomson writes, that owing to unavoidable circumstances the collections have not been fully completed.

**ST. PATRICK AND ST. DAVID.**—The Rev. J. Sedgfield Thomson reports, that the contributions from his Mission will exceed those of the past year; but owing to the state of the roads, and many of his people being absent from home, he has not quite finished the collection, but will forward the list very shortly.

**QUEENSBURY.**—Rev. H. W. Tippet encloses a list of contributions amounting to £5 15s. 11d.; collected at Sermon, June and October, £1 19 4½—Total, £7 15 3½.

**WATERBOROUGH.**—Rev. A. Wood reports contributions to the amount of £11 16 3; and the Committee solicit a grant for the formation of a Parochial Lending Library.

**HAMPTON.**—Rev. W. W. Walker reports contributions to the Widows and Orphans Fund, £2 10s.; general purposes, £17 12 9—Total, £20 2 9.

**WELDFORD.**—Rev. D. S. Wetmore reports £8 5s. as the amount of contributions for his Mission.

Thus we find, that comparing the above reports with the returns of the past year, there is a small increase in the gross amount of contributions.

In this the Society must find cause for gratitude and encouragement. More especially, when we find that in keeping up the present amount, the Society is this year indebted to increased contributions from the greater part of the country missions. Surely we are bound to thank God for "this work of labour and of love," which His Word declares, "he will not forget." But it is, after all, the secret advance of the Redeemer's Kingdom which ought chiefly to engage our attention, our hopes, our prayers. It is, that by this Society means are afforded of "preaching the Gospel to the poor," strengthening the weak, comforting the afflicted, "making ready a people prepared for the Lord, all for His sake, who has said, "I was an hungered and ye gave me meat, I was thirsty and ye gave me drink"; it is for this, we should be thankful, and be drawn on to renewed, to increased exertion. One thing we know, His Word sent forth, never is suffered to return void. How far this Society may conduce to such an end, the fullest reports cannot make known. All will be fully disclosed in that day when the work of every one who has aided these efforts, "shall be tried by fire of what sort it is."

January the 23d, 1851, being the day appointed for the Annual Meeting of the Diocesan Church Society of New Brunswick, the Clergy and Lay Deputies assembled in General Committee, on the 21st and 22d of January, in the Trinity Church Sunday School Room, Saint John, N. B.

The Right Reverend John, Lord Bishop of Fredericton, President of the Society, in the Chair.

January 21st, 1851.—The Prayers of the Society having been said by the Secretary, the Hon. the Master of the Rolls, R. F. Hazen, and W. Wright, Esquires, were nominated a Committee to report the names of the Lay Deputies, duly qualified to represent the Local Committees.

The certificates from two of the Local Committees were considered informal, as being certified by the Chairman in place of the Secretary, but on being referred to the meeting, were admitted.

The Secretary read Reports and Returns from the several Local Committees, of which the preceding is an abstract.

F. A. Wiggins, Esquire, one of the Auditors, presented the Auditors' Report upon the Accounts for the year ending 31st December, 1850; which he read.

EXTRACTS FROM THE MINUTES OF THE EXECUTIVE COMMITTEE.

*St. John, March 6, 1850.*

The Hon. the Chief Justice, Vice-President, in the Chair.

On motion of J. V. Thurgar, Esquire—Resolved, that S. L. Tilley and S. J. Scovil, Esquires, be added to the St. John Book Depository Committee.

That when any Book or Tract, not on the list of the Society for Promoting Christian Knowledge, shall have so received the allowance of the Bishop, it shall be the duty of the Depository Committee, by whom the same may have been obtained, immediately to transmit a list of such Books to the Secretary of the Society, to be laid before the Executive Committee at its next meeting ; stating the time when the allowance was given.

3. That such list shall be entered on the Minutes of the Executive Committee, with the date of the Bishop's allowance thereof.

4. That all grants whatsoever, made for Books or Tracts under the appropriation or specification of the Executive Committee, be supplied from the Books or Tracts now or hereafter to be in any Depository of the Society, in strict accordance with the foregoing regulations, and the rules of the Society.

5. That no part of the Funds of the Society, placed at the disposal of, or under the order or appropriation of the Executive Committee, or grants made out of the Funds of the Society, be expended in, or applied to the purchase or procurement of any other Books or Tracts than such as are in strict conformity with these regulations.

6. That the Secretary furnish a copy of those Regulations to the Depository Committees respectively.

On motion of the Rev. F. Coster—Resolved, that it be referred to the Loan Committee, to consider the propriety of investing an additional sum of £150, including £100 granted to the Widows and Orphans Fund.
