

Services of Grand Chaplain.

Bro. J. G. Elwood, G. W. P., S. of T. of C. W., having been announced, was introduced and received with all the honors and conducted to the P. G. W. P's chair.

The G.W.P. read his Report :---

To the Grand Division, Sons of Temperance, C. E.

Brothers. Under the merciful dispensation of our heavenly Benefactor I am permitted to meet you in Session once more, and to present you with this my Annual Report.

It is gratifying to be able to bear witness that since our last meeting the general cause of Temperance has made decided advancement. The great Convention held at Saratoga in August, composed of delegates from all parts of North America, representing almost every form of Temperance organization, is one of the hopeful indices of the times. Some of the brightest scholars and clearest thinkers of the Republic were there, and renewed their vows of devotion to our principles.

From Great Britain we learn that our friends are pressing forward, and that a large number of men of wealth, rank, and literary eminence have become closely identified with the good cause.

In Ganada the Temperance Act of 1864 has achieved many victories, and in spite of stremuous oppositon continues to force its way into new localities. In some places, I regret to say, that professed temperance men have failed to give it that support to which it is entitled, and which in many cases would have ensured success where it has met with defeat. Whether we are to attibute this derivition of duty to sheer indifference and disloyalty or to a candid and intelligent doubt as to the sound policy of the Act, the result is equally disastrous, and equally disgraceful to our cause. One sure test of the power and efficiency inherent in this Act is seen in the hostility with which it is everywhere confronted by the tavern-keepers. They know when their business is in danger and are consistent in their opposition. Let all temperance men be equally consistent, and avoid the stigma attached to too many of being found standing on the side of the enemy. I would recommend that this Grand Division express its continued faith in the wisdom and utility of "Dankin's Bill," and that we will aid in its adoption and enforcement whenever, and wherever practicable.

Our Order, as a whole, throughout Canada, maintains its wonted strength and vigor. In the West our brethren have commenced their campaign for 1866, with retrospective satisfaction, and agreeable articipations. I took the opportunity to visit their Grand Division at its late Session in Ottawa, and was greatly pleased and edified with their proceedings. The attendance was large and the several sittings were characterized with entire harmony, and with marked ability. One important measure was introduced and settled which is worthy the special attention of this Grand Division. They decided to abrogate their semi-annal Session, and to meet but once a year, this prerogative having been granted by the National Division at its convention held in New Haven last June. Whether it were wise in us to effect a like change is a question of grave importance, and I here present it to your notice that you may deliberate upon it and decide to the best of your judgment.

The state of our Order in Canada East is not so encouraging as I could The reports furnished by my Deputies indicate, in certain localities, desire. a tendency to retrogression. A spirit of apathy, which is almost as bad as the spirit of rum, has taken possession of some of our Divisions, and the non-attendance of a majority of the members disheartens and paralyses the faithful few who are always found at their post. Still there is no positive ground for despondency. On the contrary there is ample promise to stimulate us to perseverance. Within the last Quarter charters for three new Divisions have been issued, and only one charter has been surrendered. Besides, there is a fair prospect that additional charters will soon be in requisition. On the night of the 20th December, we planted our standard in the beautiful village of Lennoxville, a place which has hither to risisted all attempts at temperance organization, under any flag. Learning from our indefatigable Grand Scribe that a charter was called for, I proceeded from Montreal to Lennoxville, and there meeting with our esteemed Bro., the Rev. Mr. Duff, we together had the pleasure of instituting the Division. It is worthy of note that Bro. Duff took an active part in laying the foundation and preparing the material for this new outpost on our territory. His zeal upon this occasion is only one proof of his uniform love for the Order. May he long be spared to utter his protest against the curse of the age, and to illustrate by his own truly christian example what can be accomplished to abolish a vicious custom. If all public would soon become powerful seminaries to automa a violate custom. At an epition, would soon become powerful seminaries of total abstinence, and the liquid traffic would be broken down throughout Christendom in a single year. At our last Annual and Semi-Annual Sessions the motion to employ a lecturer advantaged and actual abstract the section to employ a lecturer was discussed and adopted. The design has not yet been carried out partly from insufficiency of funds, but chiefly from a difficulty experienced in obtaining a suitable person to undertake the work. A considerable sum has, I believe, been collected and pledged, and the Comittee have been endeavoring to secure the services of the Rev. Bro. Manning, a gentleman whose qualifications are well known. He has not yet consented to act, but it is thought he may be induced to do so ; and I now urge upon this body the imperative necessity of immediately raising the balance of supplies required to prosecute the labor for at least three months. An able lecturer would infase fresh vigor into the Order multiply our forces, and cheer us on to victory, Several Deputies in reply to the question, have you anything to propose for the good of the Order in your District? have written, "Send us a Lecturer." Let us, if possible, respond to the call at once, and in due time the seed thus scattered will produce an abundant harvest.

Allow me in connection with this subject, to impress upon Depnty G. W. P's. the responsibility of their position. Each ought to consider himself as an active aubsitute for the G. W. P. within his District, and andeaver to exercise a Missionary spirit, a self sacrifice, and liberality that will inspire those under his supervision with like virtues. Many perform their part nobly, but there are others, I fear, who are content to whistle for a fair wind, while resting upon their oars, the enemy, meantime, bombarding their forts.

I would also take the liberty to enjoin upon those elder brothers who absent themselves from the Division Rooms, on the plea sometimes urged, that they have served their time or some other equally weighty and constitutional apology, to return to their duty. Their presence is needed at the weekly meetings, to encourage younger members by their example, counsel and admonitions. What whould be thought of any military power whose oldest and most experienced officers should withdraw from the camps, and leave the management of a defensive and aggressive warfare to youthful aspirants and raw recruits? The answer and its application are too obvious to require further remark.

The salutary influence of Lady visitors is everywhere acknowledged. There is no indication of any desire to modify the relation which they now bear to the Order. Our policy of exempting them from the labor of certain offices in the Divi-jon Room is, I think, wisely shaped. I believe that our government, differing in this respect from an Order somewhat similar to our own, will bear the test of time and experience.

We are sometimes accused of a less liberal regard for the rights of the gentle sex than is exercised by the Order referred to. The charge is built on send. The moral strength of the fair sex has a sphere and mode of manifestation peculiar to itself. This sphere is not the public platform, and this mode is not the demonstrative and dominant boldness that becomes masculinity. We cannot, therefore, be farly accused of any lack of concession or gallantry towards the angelic sex. We think, on the contrary, that we are more worthy their esteem, insamuch as we exhibit a larger degree of scrupulosity in guarding the sacredness of that inestimable gem which has ever shone in the coronet of Woman's Character as her chiefest adornment, namely, her modesty. May the smiles of the Lady Visitors continue to be reflected on our banner till it waves over the ruins of the last rum-shop in the land.

no surrender." In great Britain and the Island Continent of Australia we are making rapid progress. In the former country the National Division held its Annual Seesion in Birmingham last June, and the number of subordinate Divisions then in existence were reported as 95, representing a membership of 3,667. The M. W. P. Bro. Beresford and M. W. S. concurred in reporting that from all parts of the United Kingdom inquiries were being unade relative to the Order, and new Divisions were being constantly organized. Thus, wherever the English language is spoken, our Order commends itself to the sturdy Aglo-Saxon intellect. Let us then value it for its achievements, and intrinsic beauty; and here in the commencement of a new year let us swear upon the altar of our Order renewed allegiance to its claims, and go hence to act our part with heroic resolve in the great social revolution of the age. Our labor will not be in valo, for there is a sublime truth in the lines,

" Earth casts off a slough of darkness, an eclopse of hell and sin. In each cycle of her being, as an adder casts her skin.

For my own.part, when it please the Divine Head to order my exit from the stage of life I should consider it the highest honor that could be conferred on my memory, to have engraven on the stone which shall mark the place of my repose, these simple words ;—" Here lies one who lived and died a faithful Son of Temperance". Such an Epitaph were more creditable to a departed soul than the conqueror's wreath, or the palatial tomb of a millionaire.

In closing this my final Report, I have only to add that in vacating this seat, to which I was elevated by your unanimous suffrage, I shall carry with me, even to the end of life, a grateful remembrance of your confidence and friendship. It has been to me a source of constant regret that unavoidable causes have withheld me from appropriating a larger share of time, and personal attention, to the good of the Order. But while I can lay no claim to efficiency in my administration, I retire with the conciousness of having neglected no duty wilfolly, but to have done all that lay in my power to serve the Order, and to uphold the dignity of the Grand Division.

To the G. W. P., Officers and Brothers of Grand Division of C. E.

We, your Committee of Good and Welfare, to whom was referred the report of the G. W. P., G. S., Lecture Committee, D. G. W. P. of Quebec on National Division Session, and other communications, beg to report as follows:

Ist. With reference to the Great Convention held at Saratoga last August, your Committee notice with pleasure the fact that "men of letters," wealth and influence there renowed and proclaimed their devotion to our principles, and regret that in the cities of Lower Canada, at least the great majority of such men have so far held aloof from the temperance cause, and guared the duties that devolve upon them, and we cannot hold them guiltess

of the pauperism and crime produced by the liquor traffic, which it is their duty to suppress.

2nd. With regard to "Dunkin's Bill," your Committee are of opinion that it fully meets in its spirit the wants of the community, but that such a bill from the fact of its newness and non-adoption throughout the whole land cannot be expected to produce the same effects and command the same respect as a law that is universal and has been handed down from generation to generation. We are glad that it has been adopted in so many localities, but regret that in some of these places it has been largely inoperative, owing to the lack of surport from temperance men and the want of a public prosecutor, all private informers not personnly interested, bring upon themselves much odium, and your Committee are of opinion that the appointment by the town, city, or county council of a public prosecutor, and the appointment of only one place in each locality where alcoholic liquors can be sold for specific purposes, and that it should not be sold either in five. gallons or any other quantity for any other purposes, would contribute largely to its usefulness; we would also recommend that this Grand Division communicate to Mr. Dunkin its sense upon these points.

3rd. With regard to a lecturer your Committee are of opinion that from the low state of other temperance organizations in Lower Canada, the present affords an opportunity for labor in our own Order, such as we have not had for years. The field being, to a great extent, at present unoccupied, we consider it absolutely necessary that a lecturer be at once put in the field, for three months at least, for the purpose of resuscitating old Divisions and establishing new ones, and if such were done, we are confident that our numbers could be doubled this year. And we recommend that the various deputies guarantee certain amounts to be paid to the lecturer or visit to them.

4th. With regard to the abolition of semi-annual meetings your Committee are not prepared to recommend such abolition, as our sessions have so far been pleasant and successful, and we prefer to await the working of the scheme in the Upper Province.

5th. With regard to the privilege of Lady visitors, we fully concar with the sentiments of the G. W, P., and we believe that the Lady visitors of our Divisions now occupy a really more exhalted and honorable position in governing our bearts, than in filling our offices to govern our proceedings.

6th. We are glad to notice the visit made by our G. W. P. to the G. D of Upper Canada, as such visit cannot fail of good results.
