An Act to amend section seven of the Act twenty-seventh and twenty-eighth Victoria, chapter thirty-nine.

HER MAJESTY, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:—

1. The Act passed in the Session held in the twenty-seventh and twenty-eighth years of Her Majesty's reign, chapter thirty-nine, is hereby amended, by adding the following sub-section to the seventh section of the said Act: Addition to section 7.

“3. The proceedings mentioned in the first and second sub-sections of this section may be adopted, even after judgment, as respects any creditor who, without having filed an opposition, shall have been collocated in conformity with the Registrar's certificate, and whose collocation shall not have been contested before the judgment; such proceedings, when adopted after judgment, shall not have the effect of suspending the payment of the sums adjudged by such judgment, but shall give the party collocated by the revised judgment the right to recover from the proper party, by execution and by all other legal means, the sums which shall have been adjudged to him by such revised judgment.” Proceedings mentioned in sub-section 1 and 2 may be adopted after judgment, in certain cases.
