## LADIES' HUXILIARY

# LONDON Y. M. C. A.

#### ARTICLE I.

The name of this Society shall be the Ladies' Auxiliary to the Young Men's Christian Association of London, Ontario: and its object shall be to aid said Association in the prosecution of its work.

#### ARTICLE II.

Sec. 1.—The active membership of the Association shall consist of ladies who are attendants of some Evangelical Church, and have been elected by a two-thirds vote of the members present at the regular meeting following that at which their names have been proposed.

Sec. 2.—Any lady of good moral character may become a member by a majority vote of the members present at the regular meeting follow.

Sec. 3—The membership f e shall be 70 cents per annum, payable on 1st October in each year.

#### ARTICLE III.

- Sec. 1.—The officers shall be a President, Vice-President, Secretary and Treasurer, chosen by ballot at the annual meeting, and to serve until their successors are elected.
- Sec. 2.—The President, or in her absence, the Vice-President, shall preside at the business meetings of the Association.
- Sec. 3.—The Secretary shall keep full minutes of all meetings of the Association, and shall conduct the correspondence. She shall notify all officers, members and committees of their election or appointment, and shall see that committees are organized and set to work as soon as possible after appointment. She shall receive and file their written reports. She shall oversee the work of the Association, and seek to enlist all the members in it.
- Sec. 4.—The Treasurer shall have charge of the funds of the Association, under the direction of the committee. She shall collect all dues, and keep a full account of all receipts and disbursements.
- Sec. 5.—An Executive Committee, consisting of one from each denomination represented in the

Association, shall be chosen at the same time, and in the same way as the officers, who shall have charge of the business of the Association.

Sec. 6.—If any vacancy occurs in the offices, it shall be filled by ballot at the next meeting of the Association.

#### ARTICLE IV.

- Sec. 1.—Within the two weeks next succeeding the annual meeting the President, after consultation with the Secretary, shall appoint the following committees. (1) A devotional committee, who shall have charge of the regular devotional meetings of the Association, appointing leaders, and suggesting topics for prayers and conference. (2) A committee to visit and provide for the sick and needy. (3) A committee to provide suitable entertainments, social and otherwise.
- Sec. 2.—Special committees for other purposes may be provided for, and their work defined by vote of the committee. They shall be appointed in the same way as the Standing committees.
- Sec. 3.—Unless otherwise ordered, all committees shall consist of three members each. They shall report to the committee when required and to the Association at each regular meeting.
- Sec. 4.—The President and Secretary shall be exoffic o members of all committees.

#### ARTICLE V.

Sec. 1.—The annual meeting shall be held on the 16th of October. A public anniversary shall be

held as near to the same time as convenient, at which the Secretary and Treasurer shall present full reports of the work of the Association, and of its receipts and expenditures during the year, such reports having first been submitted to the committee and approved by them

- Sec. 2.—Regular meetings of the Association shall be held on the third Tuesday of each month.
- Sec. 3.—Special meetings may be called by the President, or at the written request of three members.

#### ARTICLE VI.

Sec. 1.—Amendments to this Constitution shall require for their adoption notice at the previous regular meeting, and a two-thirds vote of the members present, except that this Article and Article II., Section 1 shall never be repealed.
