

An Act to amend the Act incorporating the Agricultural Loan Association of Canada.

(PRIVATE BILL.)

An Act to amend the Act twenty-third Victoria, chapter one hundred and thirty, incorporating the Agricultural Loan Association of Canada.

WHEREAS the Agricultural Loan Association of Canada, have by Preamble. their Petition prayed to have their Act of incorporation amended and further powers conferred upon them, and it is expedient to grant the prayer of the said Petition:-Therefore, Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacis as follows:-

1. The sixty-seventh section of the said Act, twenty-third Victoria, Section 67 amended. chapter one hundred and thirty, is hereby repealed and in lieu thereof the following shall be substituted:-

" From and after the passing of this Act the chief place of business business. of the Association shall be in the City of London in England; but the said Association shall from time to time, and at all times hereafter have power and authority, and they are hereby authorized to establish such and so many agencies or subordinate Boards of Directors in any portion 15 of this Province or in Great Britain and Ireland or in the United States of America, under such regulations for the management thereof, and to remove the same and to control or limit the powers thereof, from time to time, as to the Directors of the said Association shall seem meet."

2; So much of the said Act as may be inconsistent with or repug- Inconsistent 20 nant to the provisions of this Act, or as makes any provision in any repealed. matter provided for in this Act other than such as is hereby made, shall · be and the same is hereby repealed.

3. The Directors of the said Association for the time being, may Election of authorize and empower by letter of attorney duly executed by them rectors in 25 under their respective hands and seals, any person or persons in Eng. England. land to receive subscriptions for stock in the said undertaking, and to organize a meeting of stockholders to elect a Board of Directors for the management of the business of the said Association in the City of London in England, to whom all the provisions of the said Act of in-39 corporation shall apply; and the said London Board when chosen, shall power of be invested with all the powers mentioned in the said Act, and all the such Board. subsequent meetings for the election of succeeding Directors shall be held in London and not elsewhere.

4. One week's notice shall be given of the first meeting for the Notice. 30 election of Directors, by publication in the London Daily Times news-meeting. paper, after which the annual general meeetings shall be held in the City of London at the time and in the manner provided for in the said Act.

Imperial charter or Act of Incorporation.

5. The Board of Directors in London may apply for and obtain a Royal Charter of incorporation or an Act of incorporation by the Imperial Parliament, for the purposes and with all the powers and subject to the provisions set forth in the said above cited Act as amended by

6. Conveyances of real or personal estate situate in Canada or of property elsewhere out of England, may be made by one or more attorney or in Canada, by Attorneys of attorneys duly appointed by an instrument under the seal of the said the Company. Association, which shall be registered in the case of real estate in Canada, in the Registry office of the Riding or County where the property 10 is situated; and the attorney or attorneys so authorized shall be described in the deed or deeds of conveyance as the party or parties representing the said Association in Canada, and the execution thereof by such attorney or attorneys in their own names and under their own seals shall be deemed sufficient to pass to the party or parties named, any estate, 15 right, title, or claim which the said Association may have or hold in or to any real or personal estate whatsoever.

7. The expenses of obtaining this Act and also the expenses which Expenses of this Act, &c. may be incurred in obtaining subscriptions of stock and in organizing the said London Board, shall be a charge on the funds of the said 20 Association, to be paid by order of the Directors.

Public Act. 8. This Act shall be deemed a public Act.
