ANNUAL GENERAL MEETING
OF THE
INCORPORATED
Church Society of the Diocese of Quebec,

WAS HELD ON

WEDNESDAY, 2ND JULY, 1845,

IN THE

National School House, Quebec, at Two o'clock, P. M.

THE LORD BISHOP OF MONTREAL, President, in the Chair.

The numerous body of Clergy who had assembled at the Visitation in the morning, were present. The Meeting having been opened by prayer, and a few appropriate remarks by the Right Reverend the President, the Rev. W. DAWES, Secretary of the Society, read the Report for the past year. It was then

1st. Moved by the Rev. J. REID, seconded by the Hon. G. MOFFATT;

That the Report now read be adopted, and printed under the direction of the Central Board.

2nd. Moved by the Rev. M. WILLOUGHBY, seconded by the Rev. W. THOMPSON;

That this Meeting acknowledges with devout thankfulness to Almighty God the measure of success vouchsafed to the labours of the Society during the past year.

3rd. Moved by the Rev. M. TOWNSEND, seconded by the Rev. W. A. ADAMSON;

That in contemplation of the wants of this Diocese, present and prospective, this Meeting is anxious to impress upon all members of the Church, within its limits, the necessity of increased exertion in order to render the Society, under the Divine blessing, more extensively efficient.

4th. Moved by Ed. BOWEN, Esq. seconded by the Rev. J. JONES ;

That this Meeting desires to express its satisfaction at the continued prosperity of the Sister Societies of Nova Scotia, Toronto, and Newfoundland.

5th. Moved by the Rev. OFFICIAL MACKIE, seconded by J. BONNER, Esq. ;

That this Meeting tenders its heartfelt congratulations to the Churchmen of New Brunswick, on the establishment of a See at Fredericton.

6th. Moved by the Rev. C. BANCROFT, seconded by the Rev. JOSEPH SCOTT ;

That the following gentlemen be appointed Vice Presidents for the ensuing year :—*Vide page 3.*

7th. Moved by the Rev. R. R. BURRAGE, seconded by T. TRIGGE, Esq. ;

That the following gentlemen do form the Central Board :—*Vide page 4.*

Moved by the Rev. E. W. SEWELL, seconded by E. MONTIZAMBERT, Esq. ;

That the thanks of this Meeting be given to the Officers of the Society for the efficient discharge of their duties during the last year.

The Right Reverend the President having resigned the Chair to the Rev. Official Mackie, thanks to His Lordship for his conduct in the Chair were moved by the Hon. W. SHEPPARD, seconded by Major IRVINE, and unanimously carried. His Lordship having acknowledged the vote, closed the proceedings with the Apostolical Benediction.

GENERAL BY-LAWS
OF
THE CORPORATION
OF THE
CHURCH SOCIETY OF THE DIOCESE OF QUEBEC,

ADOPTED AT A GENERAL MEETING OF THE SOCIETY,

AT QUEBEC, ON THE 22ND DAY OF OCTOBER, 1845.

ARTICLE I.

The objects of the Society shall be comprehended in the following distinct departments of Christian exertion, viz :

First—Missionary labour, including the creation of a fund towards the augmentation of the stipends of poor Clergymen—towards making a provision for those who may be incapacitated by age or infirmity, and for the widows and orphans of the Clergy.

Second—Education, Day and Sunday Schools.

Third—Assistance, where it may be necessary, to those who may be under preparation for the ministry of the Gospel.

Fourth—Circulation of the Holy Scriptures, the Book of Common Prayer, and such other Books and Tracts as shall be approved by the Central Board, hereinafter to be provided for.

Fifth—Aid towards the erection of Churches, &c., Parsonage Houses, and the management of all matters relating to the endowment of the same.

ARTICLE II.

His Excellency the Governor General, if a member of the Church of England, shall be requested to become the Patron of the Society.

ARTICLE III.

The President of the Society shall be the Lord Bishop of the Diocese, or Bishop administering the Diocese—and the Vice Presidents shall consist of the Chairmen of the different District Associations, hereinafter provided for, and such other persons as shall be nominated at the General Annual Meetings of the Society.

ARTICLE IV.

The Treasurer or Joint Treasurers, the Secretary, Auditors and other necessary Officers of the Society, shall be appointed by the Central Board. The Secretary shall be allowed a salary and travelling expenses, under the direction of the Central Board, and may appoint an Assistant Secretary, subject to the approval of the Central Board, provided that such appointment shall entail no additional burden upon the Society. The appointments of Treasurer and Secretary shall not be for any specified period, but they may be removed at the pleasure of the Central Board.

ARTICLE V.

The Treasurer or Joint Treasurers shall collect all subscriptions, donations, rents, issues, and profits, payable to the Society, for which purpose a paid Collector, or Collectors, may be employed. Such monies shall be deposited in the Bank of Quebec, and Bank of Montreal, and an account shall be opened in such Banks, in the name of the Society.

No money shall be paid without the authority of a resolution of the Central Board, certified by the Secretary, and upon checks signed by the Secretary, and countersigned by the Treasurer, expressing the name of the person to whom, and the purpose for which, the money is to be paid.

The Treasurer or Treasurers shall also have the custody of all deeds, bonds, and other property of the Society, and shall submit his or their accounts at the stated periodical meetings of the Central Board.

ARTICLE VI.

The Secretary shall keep the minutes of all the proceedings of the Society, as well as of the Central Board, and shall have the custody of, and be accountable for, the safe keeping of the same, and he shall be subject to the direction and control of the Central Board in all his duties and proceedings.

ARTICLE VII.

The Society shall meet annually on the first Wednesday in July, alternately at Montreal and Quebec, whereof not less than fifteen days notice shall be given by the Secretary, in at least one of the leading Newspapers in Quebec and Montreal. A Special Meeting of the Society may be called at any time by the President, or in his absence from the Diocese, by two of the Vice Presidents, and four other members of the Society, by a written order to the Secretary, who shall notify the same in the manner hereinbefore provided in respect of the Annual Meetings. Such Special Meetings shall be held at such places as the President shall fix, if called by his order; or otherwise at the place where the next stated meeting of the Central Board is to be held.

ARTICLE VIII.

Persons subscribing 25s. per annum, or giving a contribution once for all of £12 10s. shall be capable of being elected Members of the Corporation, (in the latter case for life,) at any meeting of the Society or of the Central Board:

Contributors may limit and direct any portion, not exceeding one half of their contributions, to be applied to special objects within the designs and purposes of the Society.

Lists of the persons so subscribing or contributing, shall be furnished by the Treasurers of the District Associations, or by the Treasurer or Treasurers of the Society where there shall be no District Association, to the Secretary of the Society, to be laid before the next meeting of the Society or of the Central Board at which an election may take place.

ARTICLE IX.

Of the Central Board.

There shall be a Central Board for the management of the general business of the Society, consisting of the President, the Vice Presidents, and the other officers of the Society, and a Committee of not less than twelve Clergymen, and not less than twelve Laymen, who shall be chosen annually at the General Meeting of the Society, from among the Members of the Corporation.

The Board shall meet four times a year, alternately at Quebec and Montreal, on the Wednesday nearest to the 21st January, 15th May, and 10th October; and on the Friday next after the Annual Meeting. The first meeting thereof shall be held on the 23d day of October, in the present year, at Quebec. Special Meetings may be called by the President, or in his absence from the Diocese, by two of the Vice Presidents, and four Members of the Board; and not less than seven members present at any meeting shall form a quorum. When a sufficient number of members to form a quorum shall not assemble on the regular day of meeting, the members present shall have power to adjourn to another day, and so on *toties quoties*, until a quorum shall be found; and business shall and may then be proceeded in.

At all meetings of the Central Board the Chairman, in case of an equality of votes, shall have a double or casting vote.

The Central Board shall have authority to make such rules as may be necessary for the Government of its own affairs, provided that none of them be contrary to, or inconsistent with, the spirit of the Constitution or By-Laws of the Society.

ARTICLE X.

Of District Associations.

In connection and correspondence with the Central Board, there shall be formed District Associations (except in the cities of Quebec and Montreal, and the Banlieues thereof); to be composed of the Clergy, and all other Members of the Society resident within the bounds of such Districts,—a contribution of 5s. per annum, constituting membership of such District Associations. The District Associations (except as hereinbefore excepted) shall continue as heretofore settled by the Central Board of the Society, before its Incorporation, until otherwise hereafter determined by the Central Board. The senior Clergyman holding a Pastoral charge within such bounds shall be, *ex officio*, Chairman of such Association—they may have a Secretary and Treasurer, and shall meet at such places as they may themselves determine; at one of which meetings the officers shall be appointed and a report of the proceedings for the year read. The District Associations shall have authority to make rules for the government of their own affairs, provided such rules be not contrary to, or inconsistent with, the Constitution or By-Laws of the Society. They shall report annually to the Central Board, at least one month before the Annual General Meeting of the Society, (and at such other times as the Secretary, on behalf of the Board, shall require) a statement of their proceedings, and a detailed account of all the monies received and expended by them during the year.

It is nevertheless provided that the Chairman of the District Associations of Quebec and Montreal, heretofore existing, shall continue to be Vice Presidents of the Society during the current year until the Annual Meeting in July next.

ARTICLE XI.

Of the Sub-Committees of the Society.

For the more effectually carrying out the designs of this Society, the Clergymen and Church Wardens in every Parish and Missionary Station, and the Ministers and Wardens of every Chapelry within the Diocese, shall be a Sub-Committee of the Society, in correspondence with the District Association, within whose bounds such Parish or Missionary Station is situated, or in the Cities of Quebec and Montreal, with the Central Board, through the Secretary of the Society. This Committee shall meet as often, and at such periods, as they themselves shall decide to be most convenient, inviting the co-operation of all the Parishioners, in their deliberations and designs. They shall collect subscriptions and donations from the members of the Church, in such manner as they shall deem most effective, and endeavour, by every means in their power, to augment the resources of the Society. One sermon at least shall be preached during the year within the limits of such Parish, Station, or Chapelry, on such Sunday as the Bishop shall appoint, in favour of some one or more of the objects of the Society; and a collection shall then be taken up in aid thereof, the proceeds of which shall forthwith be remitted to the Treasurer or Treasurers of the Society; any Parish, Station, or Chapelry in which such sermon shall not have been preached, shall not be considered entitled to any grant or benefit from the Society, until a sermon shall have been so preached.

All other monies raised by such Sub-Committees, shall be remitted to the Treasurer of the District Association; or to the Treasurer or Treasurers of the Society, where such monies shall have been raised within the Cities and Banlieues of Quebec or Montreal.

ARTICLE XII.

One-half of all monies paid into the hands of the Treasurers of the District Associations, respectively, and not specially appropriated by the contributors, shall be transmitted to the Treasurer of the Society, to be at the disposal of the Central Board, and the remaining half of all such collections shall, when required, be expended within the Parish or District in which they have been made, for such objects only as are specified in the Constitution of the Society—the allotment to be made by the District Association. All monies remaining unappropriated at the General Annual Meeting of the District Association, shall be forthwith transmitted to the Treasurer or Treasurers of the Society to be at the disposal of the Central Board; it being understood that nothing contained in this Article shall interfere with any existing arrangement or agreement between any Clergyman and his flock.

ARTICLE XIII.

Of the Lay Committee of the Church Society.

This Committee shall consist of the twenty-five members appointed before the incorporation of the Society, and shall be governed by the Constitution, Rules and Regulations, adopted and in force before that period, until the same shall be altered by the Committee or by the Society at the General Meeting.

The proceedings of the Lay Committee shall be subject to the sanction of the Bishop of the Diocese. The clerical and other members of the Central Board, may attend at any of the General Meetings of the Committee, and may propose and discuss matters therein, but shall have no vote; and the Committee shall report their proceedings to the Central Board at their stated meetings. The objects of this Committee shall be:

First—The placing the Clergymen, now resident and doing duty in the Province, upon a just footing as regards the sufficiency and permanency of their incomes.

Secondly—The providing for the permanent and adequate support of an increased number of Clergymen, so that, with the least possible delay, the members of the Church in every portion of the Diocese, may have the means of access to a Church within a practicable distance.

Thirdly—The building in every place where it may be required a Church of stone or brick, upon a well considered plan, as to dimensions, external form, and internal arrangement, keeping in view the probability of its requiring enlargement.

Fourthly—The building, in a good situation, convenient to the Church, a comfortable Parsonage of brick or stone, upon a uniform plan, which should be carefully considered, with reference to size and internal arrangement, and should admit of additions being made, with the sanction of the Bishop.

Fifthly—The insuring such Churches or Parsonages against losses by fire.

Sixthly—The procuring an adequate and permanent support for all the Institutions, authorities, and functionaries, suitable and appertaining to the Establishment of the Church of England in this Diocese.

Seventhly—The investing all life subscriptions (unless so far as the application of these may be otherwise limited by the contributors) in a permanent and accumulating Fund, of which the interest only shall be applied to the general purposes of the Society.

Eighthly—The encouraging the formation of a local Endowment Fund, at every station or place having a Church or Clergyman, by special contributions, or by setting apart a portion of the Pew rents, to form an accumulating fund until the net income shall in each case amount to £50 per annum; for the more effectual promotion of which object the Society will engage, whenever such fund shall be formed and shall amount to £100, invested in Bank stock, or other public securities, to add thereto a corresponding amount of £100; provided always, that such investment, shall stand in the name of the President of the Society.

ARTICLE XIV.

All Meetings of the Society and of the Committees shall be opened and closed with the Prayers used by the two Societies in England, adapted to our situation, under the direction of the Bishop.

No alteration or amendment in the Constitution or By-Laws of the Society shall be made, unless such alteration or amendment shall first be communicated to the Secretary, to be submitted for examination and consideration to a Special Meeting of the Society, at least one month before a General Annual Meeting, and adopted at such General Annual Meeting. Provided that the rejection or adoption of any such alteration or amendment, by such Special Meeting, shall in no wise bind or restrain the General Annual Meeting, in considering and disposing of the same.

ARTICLE XV.

Whereas some members of the Church, who are not unmindful of the great Spiritual wants of their own neighborhood, still feel constrained, in pious gratitude for the blessings they enjoy, to allot something, however small, from the means with which a Gracious Providence has blessed them, towards the spread of the Glorious Gospel among the nations which still sit in darkness; the Society will gladly receive and forward to the Society for the Propagation of the Gospel, the Church Missionary Society, or the London Society for Promoting Christianity among the Jews, whatever sums may be given for the conversion and instruction of the Heathen or the Jews.

Prayer to be used at all the Meetings of the Society,

AND ITS SEVERAL ASSOCIATIONS.

Prevent us, O Lord, in all our doings, with thy most Gracious favour, and further us with thy continual help ; that in all our works, begun, continued, and ended in Thee, we may glorify Thy Holy Name, and finally, by Thy mercy, obtain everlasting life ; through Jesus Christ our Lord. *Amen.*

O merciful God, who hast made all men, and hatest nothing that Thou hast made, nor wouldest the death of a sinner, but rather that he should be converted and live ; Have mercy upon all Jews, Turks, Infidels, and Hereticks, and take from them all ignorance, hardness of heart, and contempt of Thy Word ; and so fetch them home, blessed Lord, to thy flock, that they may be saved among the remnant of the true Israelites, and be made one fold under one Shepherd, Jesus Christ our Lord : Prosper, O Lord, the labors of those Societies of the Church in the land of our Fathers, which Thou hast deigned to use in the promotion of this object, and which have nourished the Church, in the Colonies ; and bless in like manner with Thy Holy Spirit and Providential succour, the Society in whose cause we are now met, and the undertakings which we have now in hand. “ Prosper Thou the work of our hands upon us ; O, prosper thou our handy work,” for the sake, and through the merits of the same Thy Son Jesus Christ our Lord, who liveth and reigneth with Thee and the Holy Ghost, one God, world without end. *Amen.*

REPORT OF THE CENTRAL BOARD
OF THE
INCORPORATED CHURCH SOCIETY
OF THE
DIOCESE OF QUEBEC.

In laying before you the Third Annual Report of the proceedings of the Church Society, the Central Board would renew their expression of humble and sincere thanks to the Author of all Good, for the gracious tokens of His favour continued to the Society, and for the measure of success which has attended its operations.

The mission of our Society is grand and comprehensive. It is not only calculated to render aid, in the present exigencies of the Diocese, but to settle and consolidate the Church, and to provide for the time to come. Having been Incorporated by Provincial Statute, with the sanction of the Sovereign and the Executive Government at home, and numbering amongst its members the clergy and the great body of the laity of the Diocese, it cannot fail, if only adequately supported, of attaining, under the Divine blessing, the purposes of its establishment.

In a new country, such as this, in which, in God's Providence, we reside, it must be obvious to every reflective and observant mind, that all those institutions and regulations which are needful, under God, for the moral and religious well-being of the community, or, in other words, for the full and effective administration of the Church of Christ, are to be originated and established. Having, in the first instance, planted Ministers and erected Churches in the more populous sections of the country—which has been done to a degree that we may all rejoice at—we may now discern that there are four things of primary importance required for the present settlement and future well-being of the Church. They are objects of our Society, and to each and all of them should the earnest attention of Churchmen be directed.

First—A provision for the education of young men in the Province for the sacred Ministry.

Lennoxville

Secondly—The full establishment of the existing Churches and Ministers throughout the Diocese, by securing an adequate endowment for them, severally.

Thirdly—The engagement of a sufficient number of Travelling Missionaries, to visit every destitute settlement in the country, with a view both to supply the present spiritual wants of our people, and as pioneers of a settled Ministry; and to provide means for the erection of Churches and the establishment of resident Ministers, wherever the Lord shall open for us a door through their instrumentality.

Fourthly—The creation of an adequate fund for the relief of the Widows and Orphan Children of deceased labourers in this part of the Lord's vineyard.

With reference to the first, the recent foundation of Bishop's College, at Lennoxville, will offer many facilities for educating and training young men for the sacred Ministry. It cannot but be regarded as a propitious circumstance, that almost coeval with the full establishment of the Church Society, the new College should be coming into operation. We have here a chartered institution, immediately connected with the Church and partially endowed, that will, it is trusted, afford an education in every respect satisfactory for the pupils in general, and especially for those designed for the Ministry of the Church. It is reserved for the Society, and its individual members, to raise a fund for the endowment of a few exhibitions for divinity students. Many a pious and estimable youth, in whose heart there is a desire to be a "Labourer in the Lord's vineyard," might thus be encouraged to make known his desire, and to enter upon a preparatory course of study, under the prospective advantages that may thus be rendered him, who otherwise might have permitted the desire to languish in his breast, from the apparent hopelessness of attaining the end. With a sufficient number of divinity scholarships, or an adequate fund to assist in the maintenance of young men through their College course, may we not expect that, with the Divine blessing, the College, and the Society co-operating, will hereafter present a source of supply of faithful and efficient workmen, equal to the necessities of the Diocese.

That the second object named should engage the anxious attention of all who value their Church and would extend and perpetuate its blessings, cannot for a moment be questioned. It is *necessary* to endeavour to secure a sufficient endowment for the existing parishes and missions in the Diocese. Our deep obligations to the Society for the Propagation of the Gospel in Foreign Parts, which has so nobly commenced and continued in this country the "good work" which its title imports, must ever be acknowledged with thankfulness to God. But

the time has confessedly arrived when an earnest and continuous effort should be made to provide permanently for the Churches of the Diocese. In this work the Church Society, from its character and position, must take a leading part. Being now a Corporate body, it has the right of holding property and of managing it, with the sanction of the law, for the best interests of the Church. But if any effectual progress is to be made in this great work, the Society must not be merely a depository of funds and lands for this purpose, but must be itself an active agent and vigorous promoter of the undertaking. It has recognized this duty in its general By-Laws, and it is trusted that, by liberal contributions from its wealthier members, directed to this end, and from friends of our Church in England, it may be enabled to fulfil it. In every long settled parish or mission, in which a Church is erected and the necessary appurtenances are provided, it is strongly recommended that a commencement should at once be made towards the endowment of that Church, by placing annually a small sum at interest, taken from parochial collections or pew-rents, or derived from other sources, with a view to the production of an accumulating fund, which, in the course of years, may realize an ample provision for the clergyman.

Under the existing state of the Church in the Diocese, the third point mentioned is of pressing importance. Experience has testified to the suitability of Travelling Missionaries to the state of newly-formed and destitute settlements in this country. It is an excellent expedient where a resident ministry cannot early be established. It is computed that there should be four Travelling Missionaries, in order that the many sections of the Diocese, destitute of a settled ministry, might be visited with sufficient frequency and regularity. And upon the Church Society must devolve the maintenance of such Missionaries.

But however valuable this plan may be esteemed for supplying our destitute members and others in the wilderness with the ministrations of the Church, it is not to be regarded as a sufficient and final provision for such portions of the Diocese, but only as preparing the ground for the more regular and perfect cultivation of a resident spiritual husbandman. In this point of view, sending forth the Travelling Missionary may always be regarded as entailing further expenses upon the Society, if it would complete the work it has begun. For the Missionary, when enabled to visit periodically a back-woods settlement—if blessed and prospered in his work—will soon find it his privilege to promote the erection of a Church by the people, and thus prepare the way for placing a resident minister amongst them. To the Society he will look for aid in this good work, and should never have to look

in vain. It is then very important that a large Missionary fund should be created, whereby the Bishop might be enabled to send an adequate number of Travelling Missionaries into the wide field open before us, and the Missionary be assisted to carry onward to completion the "work of love," in which he has zealously engaged.

There is yet one other thing of primary importance which cannot fail to awaken the sympathies of every Christian heart, and engage the co-operation of all, viz : the making provision for the Widows and Orphans of the Clergy. The present state of the incomes of the great majority of our clergy, whilst it shews the necessity of such provision, at the same time evinces the difficulty of organizing any definite scheme,—such as will not draw, except in a very small degree, upon the inadequate resources of the Clergy themselves. Upon a sufficient fund being procured for this grateful object, must much depend that deeply concerns the spiritual interests of the Church, as well as the comfort and confidence of the clergy. A plan, combining subscriptions specially appropriated to this purpose and collections after sermons, through the Church Society, with a well-ordered and limited scheme of a Clergy Mutual Life Insurance Company, might be the most desirable method for the present of effecting this object.

With all this in view, surely the plan of our Society is comprehensive it is greatly concerned in the consolidation of the Church in the Diocese, as well as (to apply the language of an Apostle) "to lay up in store a good foundation for the time to come."

The Act of Incorporation and By-Laws.

The Society having become Incorporated, as has been intimated, a Special General Meeting was held in October last, for the purpose of framing a series of general By-Laws for its future government. It will be perceived, by a comparison of the By-Laws then enacted with the original Constitution, that but few alterations have been made. The old model, accordant with which the Act of Incorporation was itself framed, has been in all its more important features closely followed. In this we have materially differed from the sister Society of Toronto, which has formed itself upon the model of the Society for the Promotion of the Gospel in Foreign Parts. We believe it will be found that the existing rules are well adapted to our peculiar position and circumstances. The chief alterations made were directed toward promoting the greater efficiency of the general Society, as represented by its executive, the Central Board, enabling it to accomplish, in some measure, the great purposes before mentioned, by securing to it as a large an income as was deemed compatible with the interests of the District and Parochial

Associations, and their due attention to and provision for local necessities.

With reference to the amount received by the Treasurers it should be remarked, that several remittances have yet to be made from the District and Parochial Branches, and that there are some annual subscriptions to the Society, for the year ending on the 1st July, not yet paid.

Of the balance named it should be observed, that the sum of £100 has been appropriated, in accordance with the last section of the 13th Art. of the general By-Laws, toward the creation of an endowment fund for Nicolet Church, the people having raised and invested a corresponding sum for the same purpose; and the sum of £50 is to be paid to Trinity Church, Christievill; laying a net balance in favour of the Society of £454 5s. 6½d.—By this account will be seen, that during the past year the sum of £300 has been invested. The investment comprises subscriptions of life members, and is designed to be the nucleus of a fund for the general purposes of the Society, the interest only of which is to be expended annually. The amount is invested in twelve shares of Quebec Bank Stock. The grants referred to, under the head of expenditure, were made by the Central Board at its several meetings, and are fourteen in number, amounting to £192 10s., inclusive of three payments made on grants of the late Montreal (proper) District Association, and assumed by the Central Board on the dissolution of that body. We have satisfaction in saying that these grants, chiefly made to assist in the erection of Churches and Parsonage-houses, were acknowledged with much thankfulness, and will prove, it is trusted, encouraging to the several places assisted.

Travelling Missionaries.

The sum of £250 per annum has been appropriated to enable the Lord Bishop to have two Travelling Missionaries constantly employed. The Rev. C. Rollit, appointed in May, 1844, to the Quebec District, has been unremittingly engaged in the interesting and arduous duties of his office. During the winter months he has been travelling on an extensive mission, on the south shore of the St. Lawrence; and his journals, which have been punctually rendered, exhibit an interesting detail of his labours, and of the success with which he has been blessed. His Lordship has recently appointed the Rev. E. G. Sutton to be the second Travelling Missionary, and has directed him to proceed to destitute parts of the Eastern Townships. His labours will be divided between that section of the country and the numerous destitute settlements in the Ottawa District. It would be very desirable if the Society could, at an early day, enable the Bishop to send another labourer into this extensive field, that the one might confine himself to the Ottawa District, and the other to the Eastern Townships. May the Lord hasten the time! And permit the remark, that as we earnestly desire a full blessing may attend the labours of our Missionaries, let them not be without the comfort and benefit of our prayers.

The Clergy Reserves.

The Statute of the Imperial Parliament, 3 and 4 Vict., ch. 78, provides for the sale of those lands, and the distribution of the proceeds. It is considered most desirable for the interests of the Church—with a hope of rendering this property available for its partial endowment—that the lands, rather than the proceeds of their sales, should be granted to us, and left to our control and management.—This is the judgment of the Church in the United Province. The great and overwhelming expenses charged hitherto upon the sales of the lands, render it essential that the existing method of disposal should not continue, or there is a prospect that the Church will receive little or nothing from them. Under these circumstances, the Society petitioned the Provincial Legislature, during its last Session, that it would recommend to Her Majesty to cause measures to be adopted for vesting in the Incorporated Society a portion of the Reserves, corresponding with the income assigned to the Church of England by the Imperial Statute; to be managed by the Society in all time to come for the benefit of the Church. Similar petitions were forwarded from nearly all the parishes and missions in the Diocese; and petitions, with the like prayer, were presented very numerously from the Diocese of Toronto. The Committee of the Legislative Assembly, to whom the petitions were refer-

red, reported most favourably, recognizing the principle, and recommending to the House the adoption of the prayer. The Session closed, without any action being taken on this Report.—But it is earnestly hoped that another Session will not pass, without the recommendation of the Committee being conveyed to Her Majesty's Government at home. The important interests of the Church are much involved in this matter. Its future endowment, so far as these lands are concerned, will be much affected by the issue.

The Sources of Income to the Society are the same as when last reported. The sons of his Lordship the Bishop have again laudably exerted themselves in England on behalf of the Society, and have reported subscriptions obtained by them to the amount of £25 1s-6d Sterling; of which, £8 10s are annual subscriptions.

The City of Quebec has added considerably to its list of subscribers during the past year. It exhibits an account of—

The small amount mentioned under the head of "Parochial Association," will, it is believed, be greatly enlarged before another year shall expire, (unless indeed the desolating calamity which has, in God's Providence, befallen this city, should prevent it,) because of the means recently adopted, to collect subscriptions to the Society's funds from all in the parish enabled to bestow any thing.

In February last, the Parochial Association, as provided in the 11th Art. of the general By-Laws, was formally organized. It is designated the Parochial Visiting Association of the Diocesan Church Society; the usual Parochial Association of the Church Society being interwoven with what is ordinarily called a "District Visiting Society."

The parish has been subdivided into small districts, and to each, district Visitors have been appointed, whose office it is to solicit from all who do not themselves need assistance, contributions to the Society: from the rich, according to their means; and from the poor, their weekly penny. By this means, it is believed that all the members of the Church in the parish will be enrolled as contributors to this Christian Society, and that its funds will be thereby much augmented.

The City of Montreal, during the past year, has been disturbed in its operations on behalf of the Society, by the dissolution of the Montreal (proper) District Association, of which the city was the centre, consequent upon the adoption by the Society of the new general By-Laws. Since that time, efforts have been made by a few gentlemen in the city, connected with different congregations, to obtain collections for the Society; and to T. B. Anderson, Esq., and Ogilvie Moffatt, Esq., on the part of Christ Church, and to Dr. Holmes and — M'Kay, Esq., on behalf of Trinity Church, the acknowledgments of the Society are due for the larger amount of the annual subscriptions which we are enabled to announce. As yet, no systematic plan of proceeding appears to have been adopted by the Parish Church or the Chapels, and to this must be chiefly ascribed the very small sum which has been this year contributed to the Society in that wealthy city. But ere another year shall elapse, Montreal will doubtless take its proper position, and will stand foremost amongst the benefactors to the Society.

At Terrebonne, it is proposed to erect a Church. A valuable site has been granted by the Seigneur, and the people are commencing to lay materials on the ground.

In the parish of Chamby, a parsonage is in the course of erection, for which the inhabitants have contributed, the sum of £200. £40 has been collected elsewhere for the same purpose.

A subscription, intended to be annual, has been made for clothing and educating poor children ; and many improvements have been made in the Church, by means of contributions from the parishioners.

In Lacole, it has been found necessary to erect a gallery in the new Church, because of insufficiency of accommodation for the people, for which purpose the sum of £15 has been subscribed in the mission.

At Clarenceville, the sum of £30 has been raised, during the year, for newly fencing the church-yard, and £10 for repairing St. Thomas' Church. The subscriptions for the Society, in this parish, are small ; but it should be remarked that the sum of £268 13s 8d has been collected, within a short time, toward the erection of a Church at Henryville. This work is progressing but slowly, for want of more assistance. The District Association Committee has granted £10.

At Hemmingford, where the foundation of a Church had been laid four years ago, and the walls partially raised, the work has been resumed this summer, and, by the encouraging aid afforded by the Society, the District Association, and other friends of the Church, it is trusted that this much-needed edifice will at length be brought to completion: This work is almost wholly dependent on foreign aid, the people being able to do but very little.

The Church at Russeltown is also advancing. The Central Board, and the Richelieu District Association Committee, have each assisted with grants in this work.

In the mission of Brome, the sum of £30 9s has been subscribed during the past year toward the completion of the parsonage-house.

It is proposed to erect a Church at Sutton, twelve miles from the residence of the Rev. Jos. Scott, at Brom'e. within his mission, towards which the sum of £200 has been subscribed.

In Granby, the sum of £40 5s has been contributed for the purpose of finishing the Church recently erected in this village; and at Milton, in the same mission, the sum of £1 15s toward the completion of their Church.

At Phillipsburgh, the new Church is advancing, and it is expected will be soon ready for divine service. The Rector has made several collections in different Churches in this and in the Diocese of Toronto, and the building committee have raised a further sum of £62 10s among themselves, for the purpose of hastening this needful work to its completion.

At Waterloo, in Shefford, the Church has been standing nearly three years incomplete. The Church in the west of the township is undergoing extensive repairs, which are needed to preserve its existence. The sum of £75, it is computed, will be necessary to accomplish those repairs. The people are poor, and the contributions to the mission are chiefly in lumber, produce, and labour. The Rev. A. Balfour, the Missionary, asks from the Central Board the whole amount obtained for the Society in his mission for the last year, with an additional grant from the funds of the Society, to assist in this work.

At Abbottsford, a new front fence has been put up the past year, and the church has been painted within, at a cost of £20 to the people.

At Rougement Mountain, a new Church has been commenced. The Clergyman writes, "Great and praiseworthy exertions have been made by the people; but unless they can be assisted by some foreign aid, it is feared its completion must be long delayed. This small Protestant settlement, surrounded entirely by a Romish population, is worthy of every encouragement. It has adhered to the ministrations of the Church through evil report and good report." The amount subscribed in the neighbourhood, in materials and labour, is estimated at £70.

The Missionary at Grenville writes, "Contributed for Church purposes in that part of the mission of Grenville which is within the limits of this Diocese, during the last two years, of which no report had heretofore been made, £31 10s. The Missionary at this place begs to be permitted to state, to save himself from the imputation of negligence, that a considerable portion of his charge is in the Diocese of Toronto, from which he has been enabled to report to the Church Society in that Diocese, contributions for Church purposes to the amount of £400 during the last year."

This statement exhibits a gratifying increase on this year compared with those which have preceded it. On comparing the amount received by the Treasurers of the Society, it will be seen that there is an increase of £110 1s 6d; and upwards of £500 more has been reported as contributed for Church purposes generally than we had to announce the previous year.

It should be remarked, with reference to the sum above mentioned, raised for local Church purposes, as distinct from the amount contributed to the Society, that it has been necessary to preserve this distinction because of the 8th general By-Law of the Society. It is therein provided, that "Contributors may limit and direct any portion, not exceeding one-half, of their contributions, to be applied to special objects within the designs and purposes of the Society." But as that sum has been *wholly* applied by the contributors, though for Church purposes, which the Society contemplates, it could not be regarded strictly as subscribed to the Society, and therefore it is named separately.

On a review of the whole of the proceedings for the past year, though the amount contributed cannot be deemed equal to the ability of the Diocese, or corresponding with its great necessities, yet must it be considered satisfactory and encouraging. The alterations in the working of the Society, consequent upon the adoption of certain new rules under the Act of Incorporation, will, in some measure, account for the little that has been announced from some parishes and missions. In many places, we see a steady maintenance of their original receipts; and in others, an increased amount contributed.

The position of the Society is at present favourable, to seek the accomplishment of those objects essential to the stability and growth of the Church in the Diocese, referred to in the introductory remarks. By its incorporation, it will be greatly facilitated in the management of permanent stock-funds; and the creation of such funds is favoured by existing regulations of the Society. May they be steadily kept in view by all! and, according to our several abilities and opportunities, may all labour cheerfully and zealously in this righteous cause, following the godly admonitions of our revered and beloved Diocesan, to-day delivered to the Clergy in his Triennial Charge, respecting this Society, which owes so much to him: and co-operating in unity of spirit, in the bond of Christian love and peace, we cannot fail, under the smile of a gracious Providence, to behold hereafter realized the great mission of our Society, and thus advance the kingdom of God on earth.

Forms of Bequests and Debises by Will.

I. *A Bequest of a sum of Money, or of Shares of Stock, or Public Debentures for the general Purposes of the Society.*

I give and bequeath to the "Church Society of the Diocese of Quebec," incorporated by a Statute of the Province of Canada, passed in the seventh year of the Reign of Her Majesty, QUEEN VICTORIA, the sum of _____ pounds, Currency, (or _____ Shares of Stock in the _____ Bank of _____, standing in my name in the books of the said Bank, or, (if debentures, describe them briefly,) upon trust, to be by the said Church Society applied to and for the uses and purposes of the said Society, as specified in the said Act of Incorporation, and none other.

II. *A Bequest of a sum of Money, or Shares of Stock, or Debentures for one or more of the specific purposes of the Society.*

(Same as the foregoing, only instead of the words in italics, say) for and towards the encouragement and support of Missionaries and Clergymen of the United Church of England and Ireland, within the said Diocese of Quebec,—the creating a fund towards the augmentation of the stipends of poor Clergymen of the said United Church within the said Diocese,—and making provision for those who may be incapacitated by age or infirmity, and for the widows and orphans of the Clergy of the said Church in the said Diocese.

Or,

For and towards the encouragement of education and the support of Day Schools and Sunday Schools in the said Diocese of Quebec, in conformity with the principles of the United Church of England and Ireland.

Or,

For and towards a Fund for assisting persons preparing for the Ministry of the Gospel in the United Church of England and Ireland, within the said Diocese of Quebec.

Or,

For and towards a Fund for circulating, in the said Diocese of Quebec, the Holy Scriptures, the Book of Common Prayer of the United Church of England and Ireland, and the Books and Tracts approved by the said Church Society, for circulation within the said Diocese of Quebec.

Or,

As an aid towards the erection, endowment and maintenance of Churches, according to the Establishment of the United Church of England and Ireland

within the Diocese of Quebec,—the erection and maintenance of Parsonage Houses,—the setting apart of Burial Grounds and Church-yards,—and the Endowment and support of Parsonages and Rectories, according to the said Establishment within the said Diocese.

III. *A Devise of Real Estate for the general purposes of the Society.*

I give and devise unto the "Church Society of the Diocese of Quebec," incorporated by a Statute of the Province of Canada, passed in the seventh year of the Reign of Her Majesty, QUEEN VICTORIA, all and singular, &c. (Describe the Real Estate clearly.) To have and to hold the said, &c. unto the said Church Society of the Diocese of Quebec, and their successors, for ever; upon trust to hold and apply the same, and the rents, issues and profits thereof, *to and for the uses and purposes of the said Church Society*, as specified in the said Act of Incorporation, and none other, and under the provisions of the aforesaid Act of Incorporation of the said Church Society.

IV. *A Devise of Real Estate for any one or more of the specific purposes of the Society.*

Same as No. 3—only instead of the words in italics, insert the specific purpose, as in No. 2.

V. *A Devise to the Society of a Site for a Church, &c.*

Same as No. 3, down to the words "for ever"—then go on as follows:—to the uses and upon the trusts following, that is to say: Upon trust to hold the same for ever hereafter, as and for the place and Site of a Church and Church-yard, and Burial Ground, for the sole use and benefit of members of the United Church of England and Ireland, residing in places adjacent to the said site and premises within the said Diocese of Quebec, being in full communion with the same, according to the doctrines and discipline of the said United Church of England and Ireland, and for no other purpose, and under the provisions of the aforesaid Act of Incorporation of the said Church Society.
