FOR THE YEAR ENDING 31ST DECEMBER, 1890.

Your Committee are pleased to report that the past year has been one of continued prosperity, the ordinary collections exceeding those of last year by \$272.94, while the special collection falls below last year by \$23.30. The following are the figures as taken from the Treasurer's report : Envelope collections, \$5592.54; loose collections, \$1049.44; mortgage debt collections, \$466.05; leaving a balance on hand of \$358.83, after paying off \$1000 on mortgage debt and \$1358.13 for church improvements. The number of subscribers by envelope are 468, giving the sum of \$114.10 per Sabbath, an increase over last year of 10 subscribers and \$3.33 per Sabbath. The arrears by envelope are \$197.95.

Your Committee, acting upon instructions received at the last congregational meeting, proceeded early in the year to make the necessary alterations and repairs to the church property, for which the above mentioned sum has been paid.

Your Committee express the hope, that the work of the Managers in this respect has met with the approval of the congregation and that the repairs are such as will preserve and beautify the church property.

Your Committee would recommend only one collection be taken up this year for the reduction of the mortgage debt, and that one on the second Sabbath in October.

\* Owing to the difficulty experienced in furnishing sufficient pew accomodation to those applying for sittings, your Committee would recommend that the allocating capacity of the following pews be increased by one sitting, viz. : all the pews down-stairs, excepting those on the east end of the church, and numbers 1, 2, 6, 12, 19, 25, 88, 89, 93, 99, 106 and 112, and all in the gallery excepting numbers 130, 131, 148 to 157, 165, 166, 183 to 192.

Your Committee would also recommend, that all sittings, whose occupants are in arrears for three months, shall be declared vacant at the discretion of the Managers.

Your Committee would further recommend, that all votes for officers and the expenditure of money at all congregational meetings be taken by ballot.

In the month of June, the resignation of Mr. John Scott was received and accepted, and Mr. John Wright was elected to serve the unexpired term. The Managers have also received and accepted the resignation of Mr. M. Brennen, and it will be necessary for the congregation to elect another to serve for one year. The Managers who retire by rotation this year are Messrs, J. A. Moffat, W. H. McLaren and James Dixon.

In conclusion, your Committee recognize with thankfulness the manifest signs of spiritual and temporal prosperity and express the hope that such prosperity may continue, and that as pastor and people our efforts may be successful in advancing the Kingdom of Christ in our midst.

All of which is respectfully submitted.

For some five or six years back it has been our pleasure to record a steadily growing membership and average attendance. It is with a good deal of regret, therefore, that we have to show a slight falling behind in these matters during the year that has just closed. But there are several good reasons for this decline, chiefly as follows, viz.:—1st, it will be remembered that quite a few Sundays during 1890, particularly in the fall of the year, were damp, wet days, when it would have been unwise for a good many of our scholars to have ventured out. 2nd, we found that rather more than the average number of scholars were out of town during the summer vacation. 3rd, when

19

teachers leave our school without providing substitutes, the classes thus left have sometimes to wait for probably from two to three months before suitable teachers can be procured. This of course cannot do otherwise than retard the progress of the school and keep down the average attendance, for scholars cannot be expected to come Sunday after Sunday without a regular teacher of their own.

With these reasons carefully considered, therefore, the foregoing figures should be a source of congratulation.

Our collections for 1890 compare favorably with those of recent years. We have raised altogether for general expenses 377.40, and for missions 120.75, or an average of exactly 9.58 per Sunday. Besides this, some of the smaller classes have contributed through mission boxes 220.63, this amount has been handed over to the Women's Auxiliary to the Foreign Missionary Society. Also the young men of Mr. Madill's class have raised 50.00, which they intend to reserve to help sustain a student for the mission school in the north end of the city. should one be appointed.

The system of presenting Prize Banners at the end of each quarter to the classes having the best average attendance, and Prize Cards to pupils bringing new scholars to the school have still been carrried out; but we fear the scholars do not take the same interest in them as when first adopted; and we shall soon have to devise some other means if the attendance is to be thereby affected.

The "Northern Messenger" still remains the favorite Sunday School paper, and its issue is regularly supplied to the pupils. The "Sunday School Times" and "Westminister Teacher" are used largely by the teachers and members of the Bible Classes as helps for the study of the lessons. This shows that those subscribing wish to get the very best comments on the International Lessons available for the money.

So far as we can learn, only two deaths have occured in

our ranks since the first of the year, viz.: Miss Isabella Donald, of Mr. Halcrow's class, in February; and Willie Graham, of Miss Bella Mitchell's class, in November. We would acknowledge God's hand in these removals from our midst and return thanks to Him for his tender care of such a large school.

The teacher's meeting for the study of the lessons, formerly held at the close of the weekly prayer meeting, has been discontinued owing to the very poor patronage paid to it. As a substitute for this, Dr. Fraser has kindly offered to take up the International Sunday School Lessons as subjects in the prayer meeting. This will be of great assistance to our teachers and we hope as many as possibly can will avail themselves of it.

Our Librarian, Mr. McKenna, reports that out of 952 books in the library, as per catalogue, 150 have been handed over to the mission school; 108 have not as yet been returned by scholars since the library was closed in December, and 25 have been laid aside for repairs. The library has been well patronized by teachers and scholars alike, in fact, so much so, that it has been found inadequate to meet the demands of the school, and we have therefore concluded to purchase 250 new books at once, when we expect to have a stock worthy of the size of our school.

On summing up the work for the year 1890, we notice two strong difficulties which the management of our schools has had to contend with, viz.: the difficulty experienced in procuring suitable teachers, who can make it a point to attend regularly; and the general lack of respect for the discipline of our school. In all love and frankness, be it said, that these are both the outcome of the slack manner in which our parents perform their duty towards their children. Is it possible, we ask, that out of a congregation of 960 of a membership, so many parents really care so little for the spiritual welfare of their children, that they cannot make it convenient to come every Sabbath afternoon for one hour, to expound God's holy word to these starving souls I surely there are many who are

qualified for this glorious work who take no share whatever in it. Let such beware! When God calls for reapers, woe to the man or woman that would dare stand idly by and refuse to respond. Perhaps some of the parents will wonder how the lack of regard for discipline in the Sunday School can possibly interest them. Of such, we would ask how it is that scholars repeatedly come to school late, without their bibles, catechisms or lesson schemes, with little or no knowledge of the lesson of the day, without the slightest attempt at a preparation of the verses to be memorized, and with little or no regard for the sacredness of God's house, or for the feelings of teachers and fellow-pupils. We venture to say, that not one out of every five scholars of our common-day schools go thus about the educating of their minds in worldly knowledge, and is it possible that the spiritual welfare of the soul demands so much less preparation? Surely, if our parents performed their duty before God to their children, such things would not be complained of. We are aware that there is now-a-days among our Christian parents, what would appear a feeling of such complacent trust and confidence in the abilities of our Sunday School Teachers, that they need give themselves no concern whatever as to the spiritual progress of their children. We have invariably noticed, however, that if one of our teachers should find fault because of indifference to the lesson on the part of the scholars, these very parents are the ones who will first raise the cry against such a teacher. We would ask these people what right they have to expect us, as Sunday School Teachers, to provide in one hour enough spiritual advice to insure a child against the besetting sins of a whole week; or what right our teachers have to take upon themselves any such responsibility. We fear our Christian parents of to-day, to a large extent at least, overlook the weight of responsibility that rests upon them in their dealings toward their children.

We do confidently trust that these plain words spoken in love for the sake of the dear children left to our charge will stir up our people to take a greater interest in this work, and to

remember in their supplications the faithful, toiling teachers, who labor Sunday after Sunday without, sometimes, as much as a single word of encouragement from the parents of the very children they are striving to educate spiritually.

In conclusion, we desire to thank God for his mercy and loving kindness towards our school during the past, and to pray for a still greater outpouring of His Holy Spirit during the ensuing year than we have yet experienced in our history as a Sabbath School.

#### Knox Church Mission Sabbath School.

#### To the Members and Adherents of Knox Cnurch.

The teachers and officers of the Mission Sabbath School have pleasure in presenting the following brief report for the past year.

As intimated in our last report, the hour for meeting was changed at the beginning of the year from 9 o'clock in the morning to 3 o'clock in the afternoon. This reduced the attendance considerably, as a number of our pupils also attended other schools in the afternoon.

There are at present on the roll, officers 5, teachers 21, pupils 167—total 194. The average attendance for the year has been 129.

During the latter part of the year the teachers thought it advisable to obtain a library for the children and appropriated a small amount of money at their disposal for this purpose, which together with donations from the Church Sabbath School has placed us in possession of a Library of useful books, which we believe are read with a great deal of interest by the children.

The Treasurer's Statement is appended to this report, showing receipts from the ordinary Sunday collections of \$105.63, and an expenditure of \$113.33, leaving a balance on hand of \$18.78.

In conclusion, we would express our gratitude to our Master for all His mercies to us during the year, and pray that He may continue to prosper us as a school even more than in the past.

# Young People's Society of Christian Endeavor.

In presenting their Second Annual Report, the Young People's Society of Christian Endeavor do so with sincere thankfulness to God for the many blessings bestowed upon them during the past year.

Commencing the year with a membership of 37 active and 37 associate members, our roll now numbers 60 active and 11 associate. The Society would probably have shown a much larger increase were it not for the fact that a large number of our most active members have left the city, but as these are no doubt actively engaged in other fields of labor, our loss is gain to some other society.

During the year 51 prayer meetings have been held, 23 of which were led by young men and 28 by young women, and as these meetings have required extensive preparation by all those who have taken part, it will easily be seen that the good done is simply incalculable. We firmly believe that God has been present with us, and that we have been stimulated to put forth greater efforts for the good of one another and the glory of His name.

To increase the sociability of our membership, as wellas to enlist others in this good work, we have held three socials during the year, on the evenings of March 14th, October 7th and December 2nd, each of which were well attended.

A special feature of the Society's work is the visitation of strangers and the sick of the congregation, and a large amount of this has been done with very gratifying results.

## CONSTITUTION

# KNOX CHURCH, HAMILTON,

P

1st.—The Church, <sup>b</sup>Manse, Burying Ground, and any other Houses or Real Estate, now belonging to or which may hereafter become the property of the Congregation, shall be held in trust by three members of the said Congregation in full Communion, in accordance with a Deed of Trust bearing date the Sixth Day of September, in the year of our Lord One Thousand Eight Hundred and Fiftysia.

2nd,—The members in Full Communion with the Congregation shall have the sole power of choosing a Minister, or Pastor and Elders of said Congregation.

3rd—The election of a Minister or Pastor shall take place at a meeting of the Members of the Congregation, which shall have been called from the Pulpit of the Church by the officiating Minister on each of the two Sabbaths preceding each meeting. The majority of Members present shall determine the election.

4th.—The method of the election of the Elders shall be determined from time to time by the Session, as occasion may require; but the election shall be by the Members of the Congregation, and notice of meeting for such election shall be given as provided in Clause Third.

5th.—The constitutional duty of the Session to superintend the Spiritual affairs and watch over all the interests of the Congregation is recognized and reserved to them.

6th—Nine Managers shall be elected to take charge of the secular affairs of the Congregation, three of whom shall retire annually in rotation, but shall be eligible for re-election. In case of vacancy occuring by resignation or otherwise, the Managers themselves shall fill the vacancy at their earliest convenience ; and a Manager absenting himself from three successive regular meetings without leave shall case to be a Manager.

7th.—The Managers shall elect their own Chairman, Treasurer and Secretary, hold regular meetings as often as their business may require and may give notice of their meetings, either from the Pulpit on Sabbaths or by the Secretary to each Manager, when demanded by any three of them. Five Managers shall constitute a quorum. When the Managers shrll themselves deem it necessary, or when requested to do so by seven or more Members of the Congregation in Full Standing, they shall with concurrence of the Session call a special meeting of the Congregation, stating the object in the notice thereof; and no business shall be entertained at any Special Meeting excepting what is mentioned in the notice thereof. Schould any Manager cases to be a Member of the Congregation he shall cease to be a Manager. The Treasurer shall open an account with some regular Chartered Bank in the city, and deposit in his own name, as Treasurer of the Managing Committee, monies from time to time as may be convenient.

8th.—The use of the Church property for public and general purposes not connected with the Congregation shall be under the control of the Managers, with the concurrence of the Minister. 9th.—The whole revenues of the Congregation, from all sources, shall be received and disbursed by the Managers in payment of Stipend, Salaries and other expenses, including such as may be required for preserving the property and providing for the dispensation of Divine Ordinances; but no repairs, improvements or alterations exceeding the sum of One Hundred Dollars shall be gone into without the consent of the Congregation. The "Poor Fund," however shall be distributed by the Session, and contributions for Missionary and Benevolent purposes shall be distributed by the Association appointed for these special purposes.

toth —The Members of the Congregation shall choose their Organist and Precentor and fix their salaries, and in the discharge of their duties they shall be under the control of the Session.

11th.—The Managers shall have power to engage or dismiss, and regulate salary of any one who may act as Church Officer or Door Keeper; and appoint or pay such person or persons as may be required to keep the Church clean and comfortable.

12th.—The Managers shall be accountable to the Congregation for their acts, and shall at each annual meeting in January, submit a full printed, audited, articulate Statement of the Income and Expenditure of the preceding year—copies of which shall be distributed in the pews on the Sabbath before the Annual Meeting; and said Managers shall be regulated as to the proportions of revenue to be applied to any particular purpose by the instructions they may receive from the Congregation at any Special or Annual Meeting.

13th.—A Committee consisting of the Chairman, Secretary and Treasurer of the Managing Committee, two members of Session, the Secretary of the Sabbath School, and Secretaries of all the organizations in connection with the Congregation shall annually arrange for the printing—in pamphlet form—of the reports of all the different organizations in connection with the Congregation, together with the list of office-bearers, members and adherents, with their residences ; said pamphlet to be distributed to the Congregation as early as possible after the annual business meeting and not later than March 1st. The Chairman of the Managers shall be Chairman of the said Committee.

14th.—The Managers or Trustees shall have no power to contract debt on property without the consent of the Congregation.

15th.—At each annual meeting the congregation shall elect three Trustees and two Auditors to serve for one year.

16th. The foregoing rules shall be in force until altered or amended; and no motion to alter or amend said rules shall be put, unless due notice of such motion has been given at the annual meeting of the Congregation; and when notice of motion shall have been made, a special meeting of the congregation shall be called to consider the same—not sooner than two weeks, nor later than two months after said annual meeting.

17th.—In the foregoing rules, no one shall be held to be a member of the Congregation who is not in Full Communion with the same, and whose name does not appear on the Communion Roll of the said Congregation, and no others than members in Full Communion shall be allowed to vote at any Congregational meeting.
