

An Act to amend the Act respecting the Judges of Provincial Courts.

HER Majesty, by and with the advice and consent of the Senate and House of Commons of Canada, enacts as follows:—

1. The section substituted by section 2 of chapter 52 of the R.S.C., c. 138, 5 statutes of 1898, for section 4 of the *Act respecting the Judges of the Provincial Courts*, chapter 188 of the Revised Statutes, Salaries of is amended by striking out the word "fourteen" in the Quebec judges seventh line and substituting therefor the word "seventeen."

2. Section 10 of the said chapter 188 of the Revised Sta- New s. 10. 10 tutes is repealed and the following is substituted therefor:—

"10. The salaries of the judges of the Supreme Court of Salaries of the North-West Territories shall be as follows:—
The Chief Justice of the said court.....\$5,000 per annum;
Four puisné judges of the said court, each.. 4,000 per annum."

15 3. Section 10B, added to the said Act by section 4 of chapter New s. 10B. 52 of the statutes of 1898, is repealed and the following is Salaries of substituted therefor:—
Yukon

"10B. The salaries of the judges of the Territorial Court of Territory.
the Yukon Territory shall be as follows:—

20 Two judges of the said court, each.....\$4,000 per annum."
