

An Act to alter and amend the Act 22 Vict., cap. 80, relating to the London and Port Stanley Railway Company.

WHEREAS by an Act passed in the twenty-second year of Her Preamble, Majesty's reign, chapter eighty, intituled "An Act to vest cer-" tain portions of Bulhurst Street, in the City of London, in the London 22 V. c. 80. "and Port Stanley Railway Company, and to facilitate the said Com 5 " pany in the disposal of certain real estate," power is granted to the said Company, amongst other things, to sell and dispose of all lots and parcels of lands lying and being in the City of London and Town of Saint Thomas, and not then used or occupied by the said Company for the purposes of the said Railway, or any other purposes of the 10 said Company, and doubts have arisen as to whether the said Company have power under the said Act to sell the said lands and to convey the same free and discharged from all incumbrances, and it is expedient to remove the said doubts; Therefore Her Majesty, &c., enacts as follows:
