It is no news that the brethren do not much favor the priests; but a somewhat queer illustration of this antipathy is afforded by the fact, in which it is said some of the Dublin priests described their creed at the goal. Two or three of them, who are known to be Roman Catholics, simply registered themselves as "Christians"—as the saying is, "Christianus amicus."

The Fenian Trial at Dublin.
[From the Times, Oct. 5.]
The examination of the Fenian conspirators has ended in the conviction of five persons on a charge of high treason—a decision against which not even their own counsel could venture to protest. The evidence produced, and the manner in which it was presented, was of a most extraordinary character. It is to be observed that the whole scheme of Fenianism, as it is now known, was established by a certain newspaper, not only was the Irish People the organ, advocate, and promoter of the movement, but the principal office, agents and directors of the hatched enterprise. O'Donoghue was the registered proprietor, O'Connell was the editor, and O'Connell was the contributor.
