

Held at Pickering, Ontario, from the 17th of the Sixth

Month to the 21st of the same, inclusive, 1887.

SIXTH DAY-the 17th of Sixth Month.

entering into correspondence with Ohio Yearly Meeting report: Some of our number have attended that meeting and after careful and deliberate consideration were united in recommending that a correspondence be opened with that meeting.

Pickering, the 17th of Sixth Month, 1887.

This meeting recognizes Ohio as a co-ordinate yearly meeting of the Society of Friends, and we accord to them all the rights and privileges that membership in the society confers.

11th. The Committee on Correspondence were directed to prepare an epistle to Ohio Yearly Meeting and present to a future sitting. Joseph Henderson, Allen M. Dorland and William Rorke, were added to said Committee.

12th. Resumed, the examination of the state of Society, and read the remaining queries and answers the eto. A summary whereof is as follows :

SUMMARY ANSWERS.

Ist. Friends are careful to attend all our meetings for religious worship and discipline, though neglected by a number, more especially in the middle of the week. The hour is nearly observed. No unbecoming behaviour to remark except some instances of sleeping.

2nd. With a little exception from one n eeting, Friends are preserved in love one towards another. When differences arise care is taken to end them. Tale-bearing and detraction are discouraged, and mostly avoided.

3rd. Friends endeavor to train up their children and those of other Friends under their care, in the principles of the christian religion as professed by us; but more care is desirable in regard to the plainness and simplicity of dress, language, and deportment which it enjoins, and also in the examples set in these particulars. We believe they do endeavor to guard their children and all others under their care against corrupt conversation and the reading of pernicious books.

4th. Most Friends are diligent in reading the Holy Scriptures in their families collectively.

5th. Friends avoid the use of all intoxicating drinks, excepting for purposes strictly medicinal; and are clear of frequenting taverns, and of attending places of diversion as far as appears.

6th. The circumstances of the poor, and of those who appear to require assistance, are inspected and relief afforded Their children, and all others under our care, are in a way to be properly educated to fit them for the ordinary duties of life.

7th. Friends are clear of complying with military requisitions, and of paying any fine, or tax instead

8th. As far as appears, Friends are just in their deal ing-, and punctual in fulfilling their engagemen s, and are careful to conduct their business as becomes our religious profession. When any give occasion for fear on these accounts, they are seasonably labored with for their preservation and recovery.

9th. Care is taken in most cases seasonably, to deal with offenders we trust, in the spirit of meekness and agreeably to our discipline.

13th. Meetings for Divine Worship to be held tomorrow at 10 a. m., and 3 p. m.

Thou hast the words of eternal life" was, and remains to be, the reply of the trusting disciple, to the enquiry, "Will ye also go away?" The Apostle Paul, in confirming the souls of the disciples, and exhorting them to continue in the faith, said : " And that we must, through much tribulation, enter into the Kingdom of God." The Apostle Peter bears testimony "That the trial of your faith being much more precious than of gold that perisheth, though it be tried with fire, might be found unto praise and honor and glory at the appearing of Jesus Christ" The trials which the Lord's devoted servants have to endure, are neither new nor strange. May we endure all the crosses that come upon us that through the mercy of God we may be permitted to wear the crown. Let nothing separate us from the love of Christ; and may we manifest our allegiance to the Lord, by diligently assembling ourselves together to render worship and true honor to His worthy name.

We have witnessed the cementing influence of the love of God at this time, and our desires are that we all may faithfully guard against every inlet to suspicious or improper interpretations of the motives or actions one of another, and to see to it that when we do open our lips it be of right things.

Prevention and care are both necessary to the health of the body. The training of the children in right principles is a powerful antidote to wrong things. The principles of the christian religion as professed by us, are the true principles of the Bible As they are lived in, and maintained, lead to proper practical results, out of a conformity to the world, and operate as a guard to the love of it. But if parents and guardians do not manifest such results by their example, they fail to exercise an influence. for good. The abundance of corrupt literature of the present day are as evil agencies acting upon the minds of the young and others. Many of the publications have such a mixture of the evil with the useful, that it requires a diligent, and discriminate care in providing proper reading for our families. May nothing take the place of a diligent and prayerful reading of the Holy Scriptures

in our families and in private, with times devoted to waiting on the Lord. The care may be more difficult with children in their majority, who reside under the parental roof. Correct examples in these particulars are the most effectual. The duty of rendering proper honor to parents on the part of children, does not lessen with increasing years, but a filial deference to them we believe will be rewarded with the Divine blessing. We are encouraged by the evidence given by a goodly number of the rising generation among us, that they are seeking to know, and endeavoring to serve the God of their Fathers; may all these be encouraged to persevere in the right

The evils of intemperance continue to be such as to claim our prayerful attention. The proper remedies are the object of careful thought and action. May all Friends persevere in a consistent course, and not be diverted from the plain path of duty by political excitement or other hindering things.

The places and facilities for questionable amusement, seem to be on the increase, and the alluring facinations to take part in them are strong. We desire that all Friends, younger and older, may be guarded against mixing in them to the loss of their Spiritual strength or

Our dealings with our fellowmen serve as opportunities to let our light shine. It is by our actions in these particulars that our characters are chiefly estimated. And when our moral acts are the result of religious life the influence is the more effectual.

Let not the church abate in its care over delinquent members, but "be watchful and strengthen the things which remain that are ready to die," that our works may be found more perfect before God.

We have at this time experienced the help of the Lord in transacting the affairs of the Church in His fear and in harmony. May all our subordinate Meetings, and members individually, so look to the Lord in the obedience of faith as to witness the same Divine preserva-

We rejoice to believe that there are Marys amongst our younger sisters, who have heard with more or less distinctness, and hearkened more or less to the call.






