ROSEBUD.

JULY CAKE.—One pound of sugar one and one-half cups of flour, one heaping teaspoonful of butter, one heaping teaspoonful of milk, two eggs, one half-teaspoonful of soda, and one teaspoonful of cream of tartar. Stir the butter to a cream, beat sugar and eggs together until a thick cream, add the milk, and beat until stiff (stiffed twice with the baking powder) and milk by degrees. Bake in four layers.

SOFT MOLASSES COOKIES.—Two cups molasses, half cup cold water, two heaping teaspoonfuls of butter, one heaping teaspoonful of milk, two eggs, one half-teaspoonful of soda, and one teaspoonful of cream of tartar. Stir the butter to a cream, beat sugar and eggs together until a thick cream, add the milk, and beat until stiff (stiffed twice with the baking powder) and milk by degrees. Bake in four layers.

SCOTCH STOUT CAKE.—Beat the white of an egg to a stiff froth, and add one pound of sugar to a cream, mix and add a grated lemon; stir in a mix of flour, and bake immediately. It requires two persons to make it.

FRUIT BREAD.—One pound of flour, six ounces butter, one ounce sugar, one teaspoonful oil, one quarter pound of currants, half a teaspoonful baking powder. Put the butter in the flour, then add currants, sugar and baking powder. After mixing well, stir in half milk, make into thick paste half an inch thick; dust with sugar and cut with a tumbler. Bake for twenty or thirty minutes.

CANADIAN TOAST.—Beat very light one or two eggs, separate to the quantity of toast required, and stir into one or two cups of new milk, add a little salt. Dip some nicely sliced bread into this milk till each slice is quite soaked, but not to break the slice. Lay each slice on a well-buttered gridle delicately browned, then spread with butter and serve hot.
