

MINUTES OF SYNOD.

SPECIAL MEETING.

SAINT JOHN PRESBYTERIAN CHURCH, Wednesday, 22d October, 7 o'clock, P. M. o

The Moderator having summoned a Special Meeting of the Synod of the Presbyterian Church of New Brunswick, by circular, a copy of which is as follows:

WOODSTOCK, 15th September, 1862.

REV. AND DDEAR SIR-At the request of Synod, I hereby call a pro re pata Circular. meeting of the Church on Wednesday, the 22d day of October next, at the hour of 7 o'clock, P. M., to receive the Report of the Committee on Education ; and also of Committee on Grants, and to take such action as may be deemed Yours truly, JAMES SALMON, Mod. Synod of Presby. Church. most expedient.

The following Ministers and Elders attended :- Rev. James Salmon (Moderator), J. Turnbull, William Elder, William Alves, J. Gray, C. G. Glass, W. McKay, A. Sterling, G. Brown, and J. Bennet, with J. G. Stevens, Elder.

The meeting having been constituted by the Moderator, Moderator's by reading, singing, and prayer, it was moved and agreed conduct apthat the conduct of the Moderator, in calling the meeting, proved. be approved.

The Committee on Education having been permitted to Report of Edu. retire, to draw up a formal report, returned after a brief cation Comabsence, with the following statement:

> Saint John Presbyterian Church. October 22, 1862.

The which day, Education Committee met. Present: Revs. J. Bennet, W. Elder, James Salmon, Wm. Alves, and J. G. Stevens, Esq. Wm. Alves, Convener.

The sub-committee appointed at last meeting of Committee, report as follows :

1. That they have had the Trust Deed executed by all the parties thereto, so that the site and buildings of Woodstock College are now vested in the Synod, as an incorporated body.

2. They have enquired into what is necessary to be done to the building to preserve it, and make it fit for educational purposes; and they submit tenders to the Committee for the information of the Synod.

3. As the money needed for the above purpose can only at present be raised by mortgage-and the power of mortgage belongs to the Synod-the sub-committee advise a special meeting of Synod.

4

4. The sub-committee suggested several matters connected with the internal management of the Institution, scale of fees, &c.; but they wish the Education Committee or Synod to take up and dispose of the matter.

5. A teacher, in addition to Mr. Glass, is now engaged in the Institution; and his relation to it, and to the Synod, ought to be defined.

6. There are claims against the Institution, particulars of which are submitted in part, and the whole should be enquired into.

First.—The Education Committee receive the report of the sub-committee, copied above, and submit the same to the Synod.

Second.-The Committee report that a grant of \$250 was obtained from Government, up to June last, and applied to the purposes of the Institution.

Report received and laid on table.

The preceding report having been read in Synod, it was moved and agreed that the report be received, and laid on the table for consideration.

The relation of the teachers of the Woodstock Institution to the Synod, was first taken up, when it was moved and agreed-

That the Synod, considering the relations to it of the teachers now in Woodstock College, finds that the Rev. C. G. Glass, A. M., and Alexander Murray, Esq., A. M., are the present teachers; that in the event of the teachers, or either of them, desiring to terminate their connection with the Institution; or in the event of the Synod, or its Committeee, desiring such termination of the relation between it and such teachers, or any of them, such relation may be terminated by six months' notice, in writing, on either side-the Convener of the Education Committee to give or receive such notice, as the case may be; provided always, that the Synod and its Committee shall be understood to be possessed of the power of peremptory dismissal of teachers without any notice, should any offence of a Synod: moral character on the part of the teachers, or any of them, seem to demand such peremptory dismissal without notice. The following propositions were made during the sederunt:

1. It is proposed that the Committee do mortgage the buildings, site, &c., and raise, if possible, £600.

2. That part of this sum be appropriated to the payment of outstanding claims, to be arranged by the Committee, and the balance to be expended on the buildings.

3. The deed of motgage shall be rexecuted by Clerk of Synod, who shall affix the Corporate Seal.

4. The Synod shall endeavour to raise the sum of $\pounds 500$, to meet balance of liabilities, and to repay the sum taken from amount of mortgage to meet claims of creditors.

5. The Committee shall have charge of tenders and contracts, and shall see to their proper fulfilment.

The consideration of these propositions was proceeded with, up to a late hour; when it was moved and agreed to adjourn till Thursday morning, at 10 o'clock.

SAINT JOHN PRESBYTERIAN CHURCH,) Thursday, October 23, 1863.

At which place and time the Synod met, according to adjournment. Present: Mr. Salmon (Moderator), Mr. Gray, Nr. Glass, Mr. Elder, Mr. Alves, Mr. McKay, Mr. Donald, and Mr. Bennet. 1. 1.12

The meeting having been opened with prayer, the Minutes were read, and approved; when consideration of the proposals made at latter part of previous meeting was resumed.

The Synod, with a view to ascertain the probable total sum required to be raised, as provided in the resolutions above embodied, entered into a consideration of the pe-pequniary cuniary claims of Mr. Glass, arising prior to his being ap-claims of Mr. pointed one of the teachers of the Institution, and it was Glass. proposed with this view-that Mr. Glass, as a full and final settlement, receive the following allowances, over and above all sums which he has received and accounted for to the e of a Synod:

1. The sums proposed to be allowed for expenses by the Committee.

of the 2. The goods obtained by Mr. Glass for bazaar, and remade puted to be of the value of £100-members of Synod to

co-operate in promoting sale of goods at bazaar, and procuring additional fancy articles.

3. Mr. Glass further to receive the sum of £100 in money. These resolutions to be embodied in an agreement to be signed by Mr. Glass, and executed by Committee of Synod, provided the Synod feels, in going into all the accounts, that it seems warranted in adopting the resolutions in substance.

In further consideration of the resolutions, it was agreed that the proposed mortgage for the sum of £600, be negotiated, if possible; and that at least one half of this sum shall be expended on the building—the remainder to go towards payment of the claims on the Institution. Agreed also, that no mortgage for less than £400 be negotiated by the Committee; agreed also, that Mr. Elder and Mr. Salmon be a small committee, in the event of failing of the General Committee, to execute a mortgage, to take steps to raise such sums as may be necessary to make the building water tight, and effect insurance on it.

The other propositions above embedded, were all agreed to, including the resolution that members of 'Synod endeavour to raise the sum of $\pounds 500$ —not only from the old subscription list, but from additional subscribers; such sum being required in addition to the sum proposed to be raised by mortgage, to meet all the liabilities, and to put the building in proper order; provided, however, and it is understood that in the event of the Synod's Committee failing to raise by mortgage and subscription the sum of $\pounds 500$, the proposed arrangement as to claims of Mr. Glass, be neither binding on him nor on the Synod.

The Synod entered into the consideration of the internal arrangements, and agreed as follows:

1. The fees of the pupils shall be equally divided between the teachers; and also the Government grant, subject to deductions for insurance, and interest on mortgage, if executed.

2. The Synod remit all other matters in regard to internal arrangement of the Institution to the Committee; and also all other matters in connection with the interests of the building and the Institution, and instruct the Committee to enter into an agreement, in writing, with Mr. Glass and Mr. Murray, in accordance with the present demands of the Synod.

3. That the Committee enter into an official correspondence with the Colonial Committee of the Irish Presbyterian Church, with a view to obtain a further grant from that Church for missionary operations and ministerial aid in New Brunswick.

The business for which Synod was called, having been concluded, the meeting was closed by the Moderator, with the benediction.

PRESBYTERY OF YORK REPORT.

The Presbytery of York begs leave to report to the York Presby-Synod, that the principal circumstances connected with its tery Report. proceedings during the past year, are as follow:

Mr. Robert Moodie, who arrived from Scotland last autumn, and who was appointed by the Synod to labour at Glassville, applied to the Presbytery to be taken on trial for license. The usual subjects were prescribed, and all of which were delivered in the usual manner, to the entire satisfaction of the Presbytery; after which, he was licensed to preach the Gospel, at Woodstock, on the 25th day of March. The Presbytery then appointed Mr. Moodie to visit the congregations of Harvey and Salmon River. But it was found advisable to ordain Mr. Moodie before proceeding to said congregations, as he would then be in a position to administer the ordinance of baptism to the children of the scattered adherents of the Church; which ordination took place at Woodstock on the 2d day of April.

2. The various districts of missionary labour lying within the bounds of the Presbytery of York, have received occasional supplies from each of the ministers, as they best could.

3. Prayer meetings, Bible classes, and Sabbath schools have been attended to in the various congregations.

4. The Presbytery made the appointments for the various Committees.

ALEXANDER SMITH, Py. Clerk.

Certain irregularities relative to the license of a student without leave of Synod, appearing in the report of the Presbytery of York, it was moved and agreed, that it is necessary that in future the leave of the Synod be obtained according to the laws of the Church, previous to taking students on trial for license. Report was then adopted.

PRESBYTERY OF MIRAMICHI REPORT.

The Presbytery of Miramichi have to report that they Miramichi have held five meetings during the past year; that the Presbytery Reregular preaching of the Gospel, and the dispensing of the port. ordinances, have been duly attended to; that the instructions of Synod respecting the congregation at River Charlo and Jacquet River have been carried out; that the congregation at Bass River have completed their Manse, which is now occupied by their minister; and that appointments have been made of members to serve on the committees of the Church.

missionary be procured as soon as possible for Glassville and Florenceville; that steps be taken to supply Shediac and adjacent stations, with other stations over the Province, with missionary labour; that £100 sterling was received last year from the Irish Church, for which, the thanks of the Synod are due; that it is expected the same sum will be granted for this year; and that, with the sums received for the present year in the Province, the whole income may probably be estimated at £170 or £180; that they have at present only two missionaries on the fund, and that should the stations contribute in the way expected, in raising additional means of support to the missionaries, s above recommended, another missionary may be mainained; and that the Home Mission Committee should be authorized to look out for and engage another suitable abourer.

The Committee also express their sympathy with Mr. Junlop under his bereavement, and they would unite in arnest prayer, that his afflictions may be sanctified.

After much consideration, it was moved and agreed to Home Mission dopt the Home Mission Committee report generally; but Report that Synod instruct Committee :

1. That special attention be paid to Glassville, and that he amount required of the settlers there for some years, he rated in proportion to their means.

2. That the people of Nerepis, &c., be visited by Home lission Committee, and urged to raise their subscriptions, as to give Mr. Brown the additional salary required for is support.

8. Moved and agreed to relative to Shediac and adjacent ettlements, that it be referred back to the Home Mission committee to deal with them, with permission either to ontinue Mr. Dunlop in his present position at Shediac, or ot, as the whole matter, when duly investigated by them, any seem to warrant.

The following instructions and credentials were agreed upon by the Committee:

"The Synod, learning that the General Assembly of the Instructions United States intend holding its next annual meeting in and creden-Boston, deputes the Rev. Neil McKay, Rev. Wm. Elder, ties. and Rev. Wm. Alves, to convey to that reverend body the expression of esteem and affection, and to explain our position and prospects.

"The Synod, considering the many favours which this Church has received from the Free Church of Scotland and the Presbyterian Church in Ireland, through their respective Colonial Missions; and considering also the resent condition of the congregations and missionary labours under the care of the Synod, and their need of continued and additional pecuniary aid from parent of mis Churches, resolves to depute the Rev. James Bennet, Convener of the Home Mission Committee, to visit parent

Churches in Great Britain and Ireland, personally, to convey the expression of our deep gratitude for the measure of fostering care already extended to us; to be the bearer of filial and affectionate greetings; to explain our position, difficulties, and prospects; to crave a continuance and increase of the pecuniary aid now received, specially as regards the Irish Presbyterian Church, and to endeavour to enlist the sympathy of the United Presbyterian Church in Scotland, and of the Presbyterian Church in England, on behalf of the extension of evangelical teaching in the destitute localities of the Province, and the better support of ministers settled as pastors in thinly inhabited districts, which are very much of the nature of missionary centres. Mr. Bennet is also instructed to press upon the parent Churches already referred to, and also upon wealthy and public spirited individuals, the claims of such localities as Glassville and Shediac, to aid in erecting a place of worship, without which congregations cannot be organized, and which, in present circumstances, cannot possibly be accomplished by local means alone.

"The Synod further instructs their deputy to attend the General Assembly of the Presbyterian Church in Ireland, to bear our filial greetings, and convey the information above referred to, to that reverend body. The Synod instructs their Moderator and Clerk, to furnish Mr. Bennet with the necessary extracts from the Minutes, in relation to his commission."

APPENDIX.

Extracts from Mr. Moodie's Report.

About the 1st October last, I returned to New Brunswick ; and, according to the decision of the Synod, that I should labour in the settlements of Glassville and Greenfield, in Carleton County, I proceeded thither without delay. Since that time, until the end of March, my labours have, for the most part, been confined to Glassville, a new settlement composed chiefly of Scotch Presbyterian families. At present, there are about seventy families; of whom, about fifteen are connected with other Churches; but all are desirous to unite in maintaining a Presbyterian minister among them. During the past winter, a subscription list was opened, with the view of learning what could be done in the settlement towards maintaining a minister; and about fifty dollars were subscribed. This sum is not large, but I fear it is even more than the people could pay, as two or three years must pass before they can be sustained by their farms; and at present, all their means are needed for their own maintainance, while a large number have to labour outside the settlement at various occupations, as opportunities occur, to procure means of present subsistence. My impression was, that the subscription above mentioned, showed their willingness more than their ability to support a minister; and it is much to be hoped that the Church will be able to send and support a minister or missionary for a few years, until the people are more able to support one themselves. The district is a most important one for missionary operations for this Church, as a large increase of Presbyterian settlers is still looked for; so that Glassville, while it may be expected to contain in itself a large Presbyterian congregation in a few years, if tended by the Church, will also be a centre of missionary operations in the surrounding country, where there are a good number of Presbyterians scattered in such a way, that hitherto they have been unable to unite and secure the services of Presbyterian ministers. The attendance at our meetings has hitherto been very satisfactory, considering the distance which many have to come, the very imperfect state of the roads, and the frequently inclement weather. It has been, on an average, each Sabbath, about fifty. As yet, the settlement has no place of worship, and the meetings have been held in the different houses. The people have been engaged in raising a building for a school, which, when completed, may answer temporarily for public worship. would strongly urge the case of the settlement upon the Churches, and commend to their sympathy and aid in erecting a suitable and commodious place of worship. In the adjoining settlement of Johnsville, made by Roman Catholics, even later in date than Glassville, they are building a Church, and securing aid from outside of their own district; and it is to be hoped that the care of Established Presbyterian Churches will not be less than that of Roman Catholics for their weaker brethren. On proceeding to Greenfield, I found that there were very few families remaining firm to Presbyterian principles-not more than eight or ten; and that after long waiting for the services of a Presbyterian minister, they had joined in supporting a minister of the Congregationalist body, who appeared among them. I preached to them, and learned that they are still attached to Presbyterianism; and when their present engagements with the Congregationalist minister terminate, would do what they can for one of their own body. Taking, in connection with the Glassville settlement, Greenfield would form an interesting field of labour, and should be occupied, if possible, by the Church. Here the Presbyterians are chiefly of Irish birth or descent. About the beginning of April, the York Presbytery directed me to undertake a

I found, that in the former congregation, the minister has a very large district under his care; that there is another Presbyterian Church in connection with the secession body in it, and that the old party feelings between the two bodies are still smouldering. I need not enter into account at length of this congregation, as its history and affairs are well known to the members of the Home Mission Committee; but I may be allowed to say, that it seemed unadvisable to me that a minister or missionary should be sent, if the effect should be to perpetuate the division between the two parties, and that means should be adopted to promote a union among them as speedily as possible.

In Salmon River, I found an exceedingly interesting field of labour, and the people very anxious to secure a minister, and the more especially, as the Methodist Church, which has had very few members or adherents hitherto in that district, have begun their labours there recently, and have begun the erection of one or more places of worship, and are preaching at the various stations previously held by the pastor of the Presbyterian congregation.

Extracts from Mr. Dunlop's Report.

I have generally preached three times, and sometimes but twice, on the Sabbath. In Shediac, the first half of the year, the congregations have numbered from one to two hundred; but, for the last six months, from fifty to one hundred. Besides Shediac, I have preached in Point du Chene, Cocagne, Scotch Settlement, and Dorchester Road, where the congregations have numbered from forty to sixty. I have also preached at Bateman's Mill, and extended my labours to Salisbury, Hillsboro'. Hopewell Hill, Hopewell Corner, and a place called the Lake, in Albert County. In these places the congregations ranged from about eighty to one hundred and fifty. There are scattered through Albert County probably six hundred Presbyterians. In Salisbury and Hopewell, they are most anxious for the occasional visit of a minister, and appear willing to contribute to the funds of your Society, should such a supply be sent them. I also intended to have visited Memramcook, between Shediac and Dorchester, and Irish Town, beyond the Scotch Settlement, but was prevented in consequence of a fall, in which my shoulder and collar bone were much injured. In the season, I have had a Sabbath school, which would do very well, could I always attend to it myself, but not otherwise. The Hall, where I did preach, I have been obliged to give up, and for the present, have no place where I can preach, unless it. be my own house.

Extracts from Mr. Brown's Report.

The Communion has been twice dispensed at Nerepis. On the last occasion, forty seven communicated—three being newly admitted, whose character and Scriptural knowledge justified entire confidence in their fitness to enjoy this privilege. The services have been continued there with regularity throughout the year, the state of the weather but slightly affecting the usual attendance.

The liveliest interest is taken in Church matters by all. At our suggestion, the young men of the congregation added six new open back seats; the young women provided fittings for the pulpit, Communion table linen, and window blinds. The older members provided a full Communion service. I consider our cause has a fine footing at Westfield, with the ready sympathies of the entire neighbourhood.

Golden Grove has had monthly services during the year. While the attendance has been fair, little interest can be awakened among the people to have their Church decently seated; and less has been done than last year for the support of ordinances. There exists a long-cherished jealousy among the people, arising out of some money matters in connection with the crection of the Church, which prevents all united effort for any one good object.

Lepreaux has shared, as heretofore, our labours, with the other districts; and though there are but few Presbyterians here, still there is a heartiness among the few, which is encouraging. On the 7th December last, the Lord's Supper was dispensed, for the first time, when nine communicated, five being already members of the Presbyterian Church, and four admitted for the first time. I am satisfied of the wisdom of the Presbytery's recommendation to have the Sacraments dispensed at stations where there are members of the Presbyterian Church, and others, who in regular attendance manifest a desire for Christian privileges, and whose character and Christian conduct justify their admission. Many have said, that the high privileges have been to them a source of enlargement and comfort; and at each place I can see an improvement, as regards the sacred obligation of the Sabbath, and religion generally.

Lancaster has been regularly supplied with monthly services-attendance good. A continued interest is kept up, although Mr. Bird, who was the chief support, has left for Saint John. The people expressed a desire that we should continue to come, as usual. We intend doing so.

Prince of Wales.—An application from several heads of families attached to the Presbyterian cause there, was made for preaching. They have a nice school room, fitted up as a Church, which was opened by Mr. Baird. We have supplied this place with preaching every month since August last year. The attendance is good, and expenses are paid with cheerfulness.


