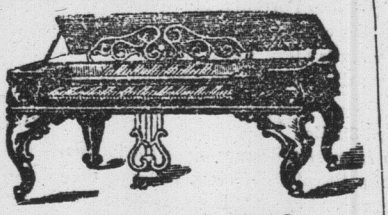

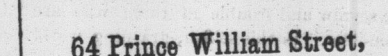

## FROM Yesterday's Edition!

## School Meetings.

We give below the names of the School Trustees elected yesterday, so far as heard from, and their various districts.

St. John County: No. 1—St. Catherine's, Dr. John Waddell, E. D. Jewett, and Wm. Kane, and A. H. Demill Auditor. To be assessed for general purposes \$1,500, for library \$100.

No. 2—Fairville—Trustees, Joseph Murphy, Dr. McFarlane, John Mealy. Assessment \$2,000.

No. 3—Manawagonish—Trustees, Oscar D. Wetmore, James Quinton and John Lord, and Thomas C. Olive Auditor. Assessment \$300 for current expenses, as they have a good school room already.

No. 6—Maquah—Trustees, C. F. Clinch, J. E. Knight and John Dunn. Assessment for all purposes \$1,400.

St. John County: No. 1—Marsh Road—Trustees, Edward G. Swill, T. J. Crookshank, Gilbert Ross, Auditor, Geo. G. Gillett, \$4,000 to be borrowed.

No. 8—Little River—Trustees, Thomas Curry, James Davidson and Thomas Lee, and James L. Dunn Auditor. \$600 to be assessed for teachers.

King's County: No. 4. Penobscot—Trustees, Robert Pugsley, Wm. Stone and Gideon McLeod; Auditor, George Morton. An assessment ordered.

Norton Station: Trustees elected. An assessment of \$2,000 for teachers' support and erection of a suitable building was ordered.

Central Norton: Trustees elected. An assessment ordered of \$4,000.

Parish of Hampton: Trustees elected. Trustees elected and an assessment of \$4,000 ordered.

Hampton Village: Trustees elected. An assessment of \$900 was ordered.

Rothney: Stephen S. Hall, M. F. Manks, R. Ellis, Trustees, and D. J. Perkins, Auditor. Assessment of \$800 was ordered, with \$500 additional to pay the interest and \$2,000 to be borrowed.

Westmorland County: Salisbury—Trustees, W. F. S. Stores, A. L. Wright and James Bentley, and E. N. Kay Auditor. Assessment of \$130 for general school purposes ordered.

York County: Canterbury—Trustees, Dr. H. A. Robert Robinson, M. P. P., and D. H. Budge; Auditor, A. Bennett. A teacher is engaged at \$600.

Westmorland County: Salisbury—Trustees, W. F. S. Stores, A. L. Wright and James Bentley, and E. N. Kay Auditor. Assessment of \$130 for general school purposes ordered.

No. 10—St. John's—Trustees, Thomas P. and Wm. Morris, and John Ford. For general school purposes \$2,000 was voted. A loan of \$3,500 for buildings for three graded schools was authorized.

## Business Partnership.

It will be noticed that Messrs. Stewart and Son have dissolved partnership, and that the former partnership between Messrs. William Logan and Alexander Stewart has been revived. The old firm of Logan and Stewart was very successful in the manufacture of Soap and Candles, and achieved both large gains and an excellent reputation. We have no doubt that like results will follow the new partnership. The business will be conducted in the New Factory in Germain St., recently erected by Messrs. Stewart, which, however, will be largely extended. It is proposed to add some sixty feet to the building, increase the number of pans, and otherwise prepare for engaging on an extensive scale in the manufacture of Soap and Candles. The firm has been so long identified with the manufacture of the Cold Water Soap, invented by Mr. Stewart, will be energetically pushed, and as this is probably the best article in its line ever introduced in the market, and is secured by Patent throughout the Dominion, it is highly probable that Messrs. Logan and Stewart will find ample work on their hands under the new order of things.

Mr. Stewart, Junior, it is said, intends to visit England with a view of thoroughly informing himself on the manufacture of Fancy Soaps, Toilet Soaps, &c., so that we may expect to find this branch added to the work of the Germain St. Factory after a time.

## Shipping Notes.

The schr. "Rough Diamond," Patterson, Master, which stranded on Hampton Beach 4th inst., as previously reported, was sold at auction on Saturday last to J. W. Pitcher of Boston, for \$412.50. Mr. Pitcher is now making arrangements to get her off if possible.

Amongst the list of international code of signals, allotted by the Registrar General of Steamers, at London, during the week ending 10th ult, we find two St. John vessels, viz bark "Sarnia" W. R. D. G. and bark "Edina" W. R. D. G.

The schr. "Vincent White" is at Liverpool, N. S., having been obliged to put in there leaky, with loss of sails and mainmast. She was on a passage from Halifax to Yarmouth, coal laden.

## New Vessels in the Harbor.

The following new vessels are lying in our harbor almost ready for sea:—

The ship *Salvator*, 1,400 tons, built by Nevins & Fraser, and owned by Messrs. Navis, Burpee and others. She has on board a cargo of deals and birch for Liverpool, and is expected to sail in the course of a week. She is commanded by Capt. Seely.

The bark *Mary Stewart*, 408 tons, commanded by Capt. Pannery, built at Black River, by Mr. John McLeod, and owned by John McLeod, Luke Stewart, Captain Penney and others, has on board a cargo of shooks for Canada. She will be ready for sea in a few days.

The new bark "St. Andrew," registered about 730 tons, built at Tyne-mouth Creek by Mr. Robert Lovitt, and owned by Messrs. Hall and Fairweather, Luke Stewart, Magee Bros., Messrs. Gilson, Hutchart, Charles Torrill and the Captain, Mr. Malcolm McLean, came into port on Wednesday. Her length of keel is 152 feet, breadth of beam 33 feet 8 inches, depth of hold 10 feet 9 inches. She is built of iron, and is classed in the French Lloyd's A. 3. 3. 8 years. Her construction reflects great credit on Mr. Kennedy, the foreman of the yard, to whom is due the extra fine finish which gives her due to her appearance. Her owners intend her for the general trading business. She is chartered to load deals for Swansea.

## The Fisk Murder.

Some of the New York newspapers are not satisfied with the delay that occurred in the Crown's Jury finding a verdict in the case of Fisk's murder. Although the jury, in the hands of James Fisk, Jr., who had a long experience as a juror, had been empaneled for three hours—a jury, too, composed of leading citizens. The following is their verdict:—

The jury find upon the testimony subscribed at this inquest that the deceased John Fisk, Jr., came to his death at the Grand Central Hotel in the City of New York on the 25th of January, 1872, at the hands of John Mackay, a witness who was wounded or mangled by him in a deliberate manner at the said James Fisk, Jr., at the Grand Central Hotel, about 4 o'clock, p. m., on Saturday, 25th of January, 1872.

The World points out that the jurors do not find that the act was "feloniously committed; it is dissatisfied with the wording of the verdict, as well as the extraordinary deliberation that attended its preparation.

It is a satisfaction to know that there is in New York at least one juror whose name does not go into contact with the personal of "the Mansfield woman." The New York correspondent of the Boston Post writes:—

What is by courtesy styled *embossment*, might without exaggeration be denominated a glancing of the eye, while her ripe and noble mouth has already a hard set to its lines which is cruel to see.

What Mrs. Mansfield has when years have expanded her already broad figure, flattered her sensuous face and wiped out the brightness which now may pass for intellect, it is apparent in the woman as she now appears.

The diamonds that she wears in a profusion which indicate the luxury of the woman are real, and will retain their glitter; but she herself is pearly only, coarse-grained and ready to fall into worthlessness. Not a woman to die for, indeed; and if Stokes's pocket-book, on which he staked his trust should fail him, he must be a fool indeed to carry within the prison walls the intimation which brought him to the gaol.
