BILL.

An Act to amend and extend the Act to incorporate "*The Montreal and Province Line Junction Railway Company.*"

WHEREAS, by reason of the advanced Preamble,
period of the season at which the Act
passed in the Session held in the tenth and
eleventh years of Her Majesty's Reign, inti-
tuled, "*An Act to incorporate The Montreal* 10 and 11 Vict.
and Province Line Junction Railway Com- c. 121, cited.
pany" received the sanction of Her Most
Gracious Majesty, it was impossible for the
said Company to complete and deposit the
10 map or plan; and book of reference of the
said intended Railway, within the time re-
quired in and by the said Act, and it is ne-
cessary to extend the same; Be it therefore
enacted, &c.

15 And it is hereby enacted, by the authority
of the same, That the period limited in and
by the said Act for the deposit of the said map
or plan, and book of reference, is hereby ex-
tended to the thirty-first day of December,
20 in the year of Our Lord one thousand eight
hundred and fifty. Period for de-
positing plan,
&c. of Rail-
way, extended
to 31st Decr.
1850.

II. And whereas, the Capital of forty Capital stock
of Company
increased to
£75,000 cy.
thousand pounds currency, which the said
Company were, by the said Act, authorized to
25 raise, has been found insufficient for the pur-
poses of the said Act, and it is expedient
to authorize the said Company to increase
their said Capital Stock, be it enacted,
That it shall be lawful for the said Com-
30 pany to raise among themselves, or by the
admission of new subscribers, or in both these
ways, a further sum of thirty-five thousand
pounds, currency, for the purposes of the
said Act; and every subscriber towards rais-

ng such further sum of money, shall be a proprietor in the said undertaking, to an extent proportionate to the sum he shall pay towards the same; and it shall be lawful for the said Company to divide the said further 5 sum of money to be so raised, into such number of shares as the said Company shall think fit, and the said last mentioned shares shall be issued on the same terms and conditions, and subject to the same rules 10 and regulations as are provided in and by the said Act with respect to the Capital Stock authorized to be raised under the said Act.

pany to bor-

III. Provided always, and be it enacted, 15 That nothing in this Act contained, shall be construed to affect any right granted to the said Company in and by the said first mentioned Act, to raise or borrow any sum 20 or sums of money in the manner, on the conditions, and under the restrictions in the said last mentioned Act provided.

Public Act.

IV. And be it enacted, That this Act shall be a Public Act, and shall be judicially taken notice of as such by all Judges, Jus- 25 tices of the Peace and others, without being specially pleaded.
