4. The Sheriff shall, immediately upon receipt of his copies, cause one of them to be posted up in a conspicuous place in the Court House; the Clerk of the Peace, upon receipt of his copies, shall cause one of them to be placed in a conspicuous place in his office; every Public or Separate School Head Master or Mistress shall in like manner put up one on the Door of the School House; and every Post Master shall post up one of his copies in his Post Office.—
