Twelfth Annual Communication.

The Most Worshipful Grand Lodge of Ancient, Free and Accepted Masons of British Columbia, commenced its Twelfth Annual Communication in the temporary Hall of Union Lodge, No. 9, in the City of New Westminister, Province of British Columbia, Dominion of Canada, on the 23rd day of June, A. D. 1883, A. L. 5883, at 10 a. m.

The Grand Lodge was then opened in ample form by the M. W. Grand Master of Masons in British Columbia, Henry Brown, Esq., and solemn prayer by V. W. Bro. Rev. Robert Hall Smith, Grand Chaplain.

The Grand Master next announced the following

The Grand Lodge was therupon called from labor to refreshment for half an hour to allow the above named committee time to examine Proxies and make their report. The Grand Lodge being called to labor again, V.C.W., Bro. Edgar Crow Baker, from the Committee on Credentials, submitted the following:

REPORT OF COMMITTEE ON CREDENTIALS:

To W.M., Mr. G. Grayson Loper, of Burwash County:

Your Committee on Credentials beg leave to report, as follows:

That Victoria-Columbia Lodge, No. 1, is represented by the Worshipful Master; Bro. John Teague, as proxy for Senior Warden; and the Junior Warden.

That Vancouver-Quidra Lodge, No. 2, is represented by Bro. E. C. Neufelder, as proxy for Worshipful Master; Bro. Robert Bennett, as proxy for Senior Warden; and the Junior Warden.

That Ashlar Lodge, No. 3, is represented by the Worshipful Master; and Bro. William Howay, as proxy for Senior Warden.

That Cariboo Lodge, No. 4, is represented by Bro. J. C. Hughes, as proxy for Senior Warden; and Bro. John Murray as proxy for Junior Warden.

That Mount Hermon Lodge, No. 7, is represented by the Worshipful Master.

That Union Lodge, No. 9, is fully represented by the Worshipful Master; the Senior Warden; and the Junior Warden.

As further representation is anticipated during the day from Ashlar, Cariboo and Mount Hermon, your committee respectfully ask for further time to complete their report on arrival of the Brethren expected.

On motion of Bro. E. C. Neufelder, seconded by Bro. Easson, the Report of the Committee on Credentials was received, and further time granted.

The Most Worshipful Grand Master informed Grand Lodge that the matter of holding Divine Service in the Skating Rink was distasteful to many of the Brethren, and suggested that other arrangements be made. Bro. Hughes and Bro. Howay explained how such an arrangement for Divine Service had originated, and the former stated that the Pastor and Trustees of the Methodist Church had since expressed a willingness to place their sacred edifice at the disposal of the Brethren, and further that the offertory on the occasion might be added to the Masonic Fund of Benevolence.

On motion by Bro. Beaven, seconded by Bro. Trounce, the offer of the Pastor and Trustees of the Methodist Church was accepted, and Bro. Hughes, Bro. Haslam and the V. W. Grand Chaplain were authorized to make the necessary arrangement in regard to Grand Lodge attending Divine Service.

On motion by Bro. Baker, seconded by Bro. Kelly, a vote of thanks was tendered to the Pastor and Trustees of the Methodist Church, but declining to accept the offertory as not being in keeping with Masonic custom.

On motion, duly seconded and carried, The Proceedings of the Eleventh Annual Communication were confirmed and accepted as presented in the printed pamphlet form already distributed amongst the members of the Fraternity of this and foreign jurisdictions.

The Most Worshipful the Grand Master then delivered the following address:—

ADDRESS OF GRAND MASTER:

RIGHT WORSHIPFUL, VERY WORSHIPFUL, AND WORSHIPFUL BRETHREN:—

On this the Twelfth Annual Communication of our Grand Lodge, permit me to extend to you all a hearty and fraternal welcome, and to invite you to join with me in giving thanks to the Supreme Grand

Ruler of the Universe for his goodness and mercy in having protected us through the past Masonic year, and to implore his assistance and guidance in our deliberations during the present session, and may we perform the duties for which we are called together with fervency and zeal and may justice be the guide of all our actions.

FRATERNAL DEAD.

As we look back to the experiences of the past year, it is but natural that we should first recur to the vacancies which Death has made in our ranks, and though through the mercy of Divine Providence our death-roll is short, numbering only eight or nine in this jurisdiction, the names of those to whose merits we have paid the last sad tribute of respect will long remain green in our memory, notably those of Brother Laing, Victoria-Columbia Lodge, No. 1, and Brother Oasterhout, of Vancouver-Quadra Lodge, No. 2, old and respected brethren amongst us, who, though well striken in years, always set a bright example to their younger brethren, being very enthusiastic Masons, and ever attentive to the duties of their Lodge; also that of Bro. Sidney Thomas Franklyn, a member of Victoria-Columbia Lodge, No. 1, who finished his earthly labor on the 29th of April, dying nobly at the post of duty in the effort to save the lives of his fellow creatures on the occasion of the burning of the steamer "Grappler". We have also to lament the loss of two Past Grand Officers of this jurisdiction, viz., Bro. E. Brown, Past Grand Warden, and Bro. P. J. Hall, Past Grand Tyler. I should therefore recommend that suitable memorial pages be inserted in our printed proceedings, and also that the Very Worshipful Grand Secretary be instructed to procure a suitable printing block for that purpose, as hitherto our memorial pages have presented rather a mean and poor appearance.

VISITATIONS.

Brethren, this I consider one of the most pleasant duties of a Grand Master, and which I have fulfilled to the best of my ability, and though not having reached Cariboo Lodge, No. 4, or Mount Bernon Lodge, No. 7, have visited all the others.

My first official visit being to Ashlar Lodge, No. 3, Nanaimo, on Saturday, 30th of September, 1882, accompanied by a great many Brethren, including nearly all the Officers of Grand Lodge. We were met at Nanaimo by the Right Worshipful Deputy Grand Master, Brother M. Bate, and several prominent members of Ashlar Lodge. I am pleased to inform you that this Lodge is in a prosperous and healthy condition. Our Very Worshipful Grand Secretary found their books carefully kept. The work in the Third Degree was ably exemplified by the Officers of the Lodge, after which the Brethren

entertained us with their accustomed liberality. On the following morning we attended Divine Service at St. Paul's Church, where we listened to a very impressive sermon, and were afterwards escorted by our Brethren of Ashlar Lodge to the steamer, where after hearty hand shaking and mutual exchange of good wishes, we once more, under the care of our worthy Bro. Captain G. Rudlin, resumed our journey, arriving safely at home at about 7 p. m., well pleased with our visit.

On the 7th of December, I paid an official visit to Victoria-Columbia Lodge, No. 1, and am happy to say this Lodge is prosperous, their books and affairs generally were found in a very satisfactory condition.

On the 20th of the same month I had the pleasure of visiting Vancouver-Quadra Lodge, No. 2, accompanied by several members of Grand Lodge, where we witnessed the Election of Officers for the ensuing Masonic year. The records and accounts were reported as being very correctly kept, and their work is among the best done in the Province.

The annual Re-union on the 15th of January, 1883, was a grand success and will long be remembered as one of the most pleasing Masonic gatherings ever held in our jurisdiction.

On the 20th of March, 1883, accompanied by a large number of Brethren from Victoria, I had the pleasure of visiting Union Lodge, No. 9, New Westminster, where we met with a most cordial and fraternal welcome. The affairs of this Lodge are improving and show signs of great zeal on the part of many of the members. The Fellow-Craft Degree was ably conferred on a Brother of this Lodge by the Worshipful Master; assisted by Bro. Past Master Hughes, after which we were invited to a banquet such as I have seldom seen equalled and never surpassed by any Lodge in the Province.

INSTALLATIONS.

On the 27th of December, 1882, I had the pleasure of installing the Worshipful Master and Officers of Vancouver-Quadra Lodge, No. 2, assisted by Past Grand Master E. Harrison, and Past Master A. R. Milne. The retiring Worshipful Master was the recipient of a handsome Past Master's Jewel, presented by the Brethren as a slight token of their appreciation of his services to his Lodge. After the ceremony we were invited to refreshment, and sat down to one of those pleasant entertainments for which No. 2. Lodge is so justly noted.

On the 4th of January, 1883, I installed the Worshipful Master and Officers of Victoria-Columbia Lodge, No. 1, ably assisted as on previous occasions by R. W. Past Grand Master Eli Harrison. On the completion of the ceremony Brother Teague was presented with a very nice Past Master's Jewel, and also with an elegant diamond

bracelet for Mrs. Teague. This was a very happy thought on the part of the Brethren, and I am informed their gift was highly appreciated by the recipient. Brother Teague filled the Master's Chair of his Lodge for three years, and still takes an active interest in the affairs of Masonry. After the Lodge was closed we passed a very pleasant and social hour with our Brethren of Victoria-Columbia Lodge, No. 1.

APPOINTMENTS AND COMMISSIONS.

On the 24th of January, 1883, I appointed Worshipful Brother R. B. McMicking, Acting Grand Secretary. This appointment was rendered necessary on account of the departure of our W.:W.: Grand Secretary to Ottawa on Parliamentary duty.

On the 14th of April, I caused commissions to be issued to W.: Brother W. Howay, W.: Grand Marshal, and to W.: Brother B. Springer, W.: Grand Sword Bearer, to act as my Special Deputies in visiting Mount Hermon Lodge, No. 7, and report on the condition of Masonry in its jurisdiction. Also to R.:W.: Brother J. Nutt, Past Grand Warden, and W.: Brother H. McDermott, W.: Grand Standard Bearer, to visit Cariboo Lodge, No. 4, and report on the general condition of the Craft in its jurisdiction. The reports of these Brethren will no doubt be laid before you.

COMMITTEES.

The year 1882 will long be remembered in the annals of our Province with pleasure, on account of the visit of His Excellency the Governor-General of Canada, Marquis of Lorne, accompanied by Her Royal Highness the Princess Louise, a daughter of our beloved Queen, and as you are well aware the loyalty of the Craft is proverbial, the occasion was not one to be neglected, being the first visit of a member of the Royal Family of England to our shores, I therefore at the request of several members of Grand Lodge, on the 2nd of October, 1882, appointed a committee to draft an address of welcome to our illustrious visitors, and to report to the Board of General Purposes at its next regular meeting, full particulars of which will doubtless be laid before you in the report of the Board.

On the 19th of October, agreeable to resolution passed at last session of Grand Lodge, I appointed a special committee to collect all edicts and resolutions having the force and effect of law, revise the Grand Lodge Register and Constitution, and perform other duties as specified in said resolution. I am informed the Committee have not completed their labors, but will doubtless have a report to lay before you during the present session.

DISPENSATIONS

have been granted during the past year for the following purposes:-

On the 7th of July, 1882, to Cariboo Lodge, No. 4, to bury with Masonic honors their late Brother P. Castignetto.

On October 2nd, to Victoria-Columbia Lodge, No. 1, to bury with Masonic honors their late Brother Robert Laing.

On March 3rd, 1883, to Vancouver-Quadra Lodge, No. 2, to bury with Masonic honors their late Brother P. Oasterhout.

On December 2nd, 1882, to Ashlar Lodge, No. 3.

On January 13th, 1883, to Vancouver-Quadra Lodge, No. 2.

On January 13th, 1883, to Victoria-Columbia Lodge, No. 1, and

On February 3rd, 1883, to Mount Hermon Lodge, No. 7, to wear Masonic Regalia in public on the occasion of balls and social gatherings.

On February 8th, 1883, to Victoria-Columbia Lodge, No. 1, to confer the Second and Third Degrees at the same communication, and on 18th June, to Cariboo Lodge to hold the Election of Officers out of time, they having failed to give proper notice.

SISTER GRAND LODGES.

I am happy to inform you that our relations with Sister Grand Lodges are in the same peaceful and harmonious condition as when we last met.

I have taken much pleasure in and derived considerable information from the perusal of the various Grand Lodge Proceedings received, and can assure you that we receive very favorable notice in the majority of the reports. And here, Brethren, I should like to extend the fraternal sympathy of this Grand Lodge to our Brethren in some of the neighboring States, viz., Ohio, Indiana, Kentucky and Illinois, where storms and floods have been unprecedented in the loss of property and many valuable lives, and to assure them it is with deep regret we read of their misfortunes.

RECOGNITION.

The recognition of this Grand Lodge by the Most Worshipful Grand Lodge of Scotland has so far progressed that the Grand Committee have recommended the matter for consideration in their Grand Lodge, and have also recommended the exchange of Representatives, and named Brother Edward Savage, Provincial Grand Master, Aberdeen City Province, to be our Representative near their Grand Lodge. I have therefore caused a commission to be issued to Bro. Savage as our Grand Representative near the Grand Lodge of Scotland; also to Brother H. W. Hutchins as our Grand Representative near the Grand

Lodge of Vermont, and Brother T. Dickson as our Representative near the Grand Lodge of Idaho. I have also recommended the appointment of the following Brethren as Representatives near this Grand Lodge, as under :—

DECISIONS.

There have been only two questions referred to me during the past Masonic year, and which I have answered, as follows :—

1. Are amendments to notices of motion printed on Grand Lodge summonses admissible in Grand Lodge? Yes; this ruling was confirmed at the time by vote in Grand Lodge.
2. Are amendments passed in Grand Lodge to become law without awaiting confirmation at next session of Grand Lodge? This question I also answered in the affirmative.

APPEALS.

There has been only one case of appeal to me as Grand Master during my term of office, namely, that of Ashlar Lodge, No. 3, calling attention to the fact that Victoria-Columbia Lodge, No. 1, had made a certain candidate a Mason, who they claimed belonged to the jurisdiction of Ashlar Lodge, and asking that all fees for Initiation, Passing and Raising be handed over to them. On receipt of their communication I requested the Very Worshipful Grand Secretary to write to them asking if they had tried to settle the disputed question with Victoria-Columbia Lodge, if not, recommending them to do so, and calling attention to clause 6, page 89 of the Constitution. This suggestion was acted upon, but without success, as I was again addressed on the subject on the 28th of May, and then referred the matter to the Committee on Grievances for full investigation and to report to the Board of General Purposes.

ALTERATION TO BY-LAWS.

On the 14th of April I sanctioned certain alterations to the By-laws of Vancouver-Quadra Lodge, No. 2, they being in accordance with our Constitution. Also on May 28th the By-Laws of Cariboo Lodge, No. 4, were amended so as to change the date of their annual communication and election of officers from December to St. John's Day in June, which was also assented to.

CONDITION OF LODGES.

From personal inspection and the reports of Brethren who have acted as my Deputies in visiting, I believe the Lodges are in better condition than they were one year ago. There is an increase in the membership though not large, and I trust Brethren, that with the general prosperity which is now being felt throughout the Province, we as Masons may prosper, and that our beloved Order may gradually, and it slowly, surely extend its branches.

CASCADE LODGE.

In regard to the charter of this Lodge, which was surrendered, I must inform you there has been no application for its re-issue, which was provided for at last session of Grand Lodge. I should therefore recommend that the time be extended for another year so as to enable the Brethren to whom the charter was granted to take it up again without further expense, if they should find themselves in a position to do so.

CHARITY.

I am proud to say every application for relief made during the past year to the Fund of Benevolence has been cheerfully entertained and the desired relief granted, and while on this subject let me remind you Brethren, that the giving of pecuniary assistance is not the only form of charity which we are called upon to exercise, but that there are various and manifold ways of practising that most inestimable virtue, such as visiting a sick Brother, lending a helping hand to one who has fallen and is anxious to rise up again, throwing the mantle of Masonic charity over the faults of an erring Brother, for should one err ninety and nine times we should ever be ready to forgive and assist him back into the paths of rectitude. Brethren, we all profess this virtue, let us try to practise it.

CONCLUSION.

Before closing my address I should like on behalf of the Grand Lodge to thank Brothers G. Rudlin, J. Spratt, R. P. Rithet and J. Irving for their kindness and liberality in conveying members of Grand Lodge and visiting Brethren to Nanaimo and New Westminster at reduced rates, and for all courtesies extended to the fraternity. I am also anxious to express my gratitude to the members of the Board of General Purposes and the Brethren for their assistance and co-operation with me during the past year, especially to the Right Worshipful Brother Eli Harrison, Past Grand Master, who has often rendered me valuable assistance; and now, Brethren that I am about to surrender into your hands the authority with which you invested me one year ago, trusting the interests of the Craft have not suffered during my term of office, and that my actions will at all times meet with your approval, let me assure you that I shall return to the ranks a willing worker in the cause of Masonry, ever ready to perform any duty which may fall to my lot to the best of my ability. Once more, Brethren, let me thank you for the high honors which you have conferred upon me.

M.:W.: SIR AND BROTHER:—So rapidly does time pass that it only appears to me a few weeks since we were last in session, and yet I am more than reminded that another year has rolled away from the fact of having before me the usual six sheets of "Annual Returns" from my Brother Secretaries in the various portions of the Province where Freemasonry has long held, and still holds, its own. Considering how widely separated our "little Masonic homes" are from one another, how many disadvantages we labor under as regards expeditious communication by sea and by land within our own Province, and how widely severed from such portions of the world where the Masonic banner is spread to the breeze of more prosperous communities, and has the benefit of bringing together the masses at short notice, it is a matter of some little satisfaction to notice that we still manage to maintain our numerical strength.

It will be observed from the returns which I shall shortly read to you that we have only 293 members on our roll as compared with 295 last year—an apparent decrease of two—and yet in reality our strength is really greater than it has been for the last two years, as it will possibly be remembered that in last year's returns were included some 15 members on the roll of Cascade Lodge, No. 10, and which Lodge I regret to say surrendered its charter, not for any reprehensible reason, but simply from the fact that those ardent Masons who so nobly entered into the laudable cause were unable to effectuate its working in keeping with original anticipations and consequently by ill luck and various adverse circumstances were reluctantly compelled to accept the only alternative. I do regret, however, to state that out of those 15 only 2 have affiliated with other Lodges, and consequently, although 11 have been added to our members in the past year 13 have dropped out or rather failed to come in with us—if it were not for this we might have had reason to congratulate ourselves upon the onward march of Masonry; as it is we must content ourselves by recording that "Brotherly Love" has been extended, "Relief" afforded to those in need, and "Truth" that Masonry is in a state of "in statu quo."

I shall not weary you, Brethren, with a lengthy report upon the annual work and efficiency of the Subordinate Lodges of this jurisdiction, but follow the course pursued last year and leave it in the more able hands of the M.:W.: Grand and R.:W.: Deputy Grand Masters, though I may be excused for taking this opportunity of stating that although ready and willing to participate in all reasonable extent in matters affecting the Craft in this Province I was only able to pay a fraternal visit to Ashlar Lodge, No. 8, at Nanaimo, being

prevented by sickness in December and January, (which nearly resulted in my being entitled to a small corner in the obituary sheet of this session's proceedings) from attending at my usual station with the Grand Master at the installation of officers in the two Victoria Lodges.

From 20th January until the 6th of the present month I was absent from the Province on other business connected with its interests, and which I trust will, when added to the former, sufficiently exonerate me from what might appear to some to be apathy or indifference in matters Masonic, "and palliate in some degree any offence, real or imaginary, at the presentation by me of such a short statistical report, and allow me to proceed with facts and figures.

Making the total contributions from all the Lodges in this Province, for Grand Lodge and Benevolent purposes, to be \$708.25, shewing an increase (although slight) as compared with last year of some \$31.50, which sums have been promptly handed to V. W. Bro. M. W. Waitt as Grand Treasurer, in keeping with clause 2, page 76, of the Revised Constitution, and to this worthy Brother I must refer you for a verification of the figures just quoted, and also for a statement of the sums expended, respectively, for Benevolent Fund and Grand Lodge, and the actual amount remaining at the credit of each.

The Proceedings of Sister Grand Lodges have been received with usual regularity, generally three copies of each. One of each set has been handed to the Grand Master, one to the Chairman of the Committee on Foreign Correspondence, and the third placed on my file

as Grand Secretary. In cases where only one has been received the same has been added to my file for the benefit of such members of Grand Lodge as may desire to read or refer to them on any occasion.

As previously expressed it would be well if the Committee on Foreign Correspondence could glean sufficient time in their leisure hours to make brief mention of the valuable matter contained in them and thus generally disseminate our true sense of gratitude by embodying such an "epitome of review" in our Proceedings as would shew our Brethren who so kindly think of us in all parts of the world that we are not unmindful of their continuous courtesy, and that however unable we may be to sufficiently reciprocate these favors, we do at least read them and regard them as valuable additions to our library. Should the Committee referred to not favor us this year with a report upon this subject I trust the Grand Representatives will be incited to fill the gap by sending us their reviews of the Proceedings sent from their respective jurisdictions.

With R. V. W., Edgar Crow Baker, as Grand Secretary and Secretary of the Board, to act with said Committees, as has been customary, since the formation of Grand Lodge.

4. There have been no appeals to the Board from a Subordinate Lodge as to expulsion or suspension of members during the past year, nor have there been any other appeals except the difference between Ashlar Lodge, No. 3, and Victoria-Columbia, No. 1, hereinafter more fully reported upon.

5. The Board has much pleasure in reporting that at last the official recognition of this Grand Lodge by the Grand Lodge of Scotland has been secured, and an exchange of Grand Representatives effected on the 14th June, 1883.

6. The report of the Trustees of the Masonic Building in Victoria will be made in ample season for embodyment in the printed proceedings of this session. No unforeseen expenditure has as yet been made and the dividend will probably be, as heretofore, 5 per cent.

7. The differences in regard to "Election of Officers" last year in Cariboo Lodge, No. 4, have been amicably settled, and a change made in their By-laws, providing for elections in June instead of December in each year.

8. At the first meeting of the Board it was considered advisable to hold regular monthly meetings on the last Monday in

each month in order to afford an opportunity for all members to be present, but more particularly for the accommodation and convenience of those members who are non-residents of the City of Victoria, of which all members were duly apprized by letter enclosing list of Committees, etc., and with the exception of 26th March and 30th April, (when quorums could not be formed) such stated meetings have been held accordingly.

9. During the visit of His Excellency the Governor-General and H. R. H. the Princess Louise in October last, a Committee of your Board was appointed to draft a suitable address to them on behalf of the Masonic Fraternity of this Province, which was ably carried into effect by R. W. Bro. Eli Harrison, Senr., (Past Grand Master), R. W. Bro. Thos. Trounce, (Grand Senior Warden), and V. W. Henry F. Heisterman, (Past Grand Secretary), and engrossed by Bro. Dennis Harris, (S. W. Vancouver-Quadra, No. 2), but as will be seen by a letter dated 23rd October, 1882, from the Governor-General's Secretary, Col. F. deWinton, R. A., their Excellencies were reluctantly compelled to decline the formal acceptance of the Address on the plea of having had to decline all similar addresses save those of the Lieutenant Governor and the Mayor of the Capital.

10. The Committees appointed to report upon matters in connection with the Grand Lodges (real or imaginary) of Morocco and Arizona, as also matter referred to a Committee for a report re. Grand Lodge of Utah will probably do so this session.

11. Circular communications have been received from the Grand Orient of France and Grand Lodge of Peru on matter not affecting this jurisdiction in any essential, and can be read if the brethren deem it expedient.

12. A report, dated 18th June, 1883, from the Committee appointed by this Board to enquire into and report upon certain differences of opinion as to the initiation of a candidate, between Ashlar Lodge, No. 3, and Victoria-Columbia Lodge, No. 1, has been received and adopted by the Board. For further information see report on file.

Bro. Easson requested that all correspondence between Victoria-Columbia Lodge, No. 1, and Ashlar Lodge, No. 3, on the subject of the initiation of Rev. Bro. Gilbert, be read for the information of Grand Lodge.

Brothers Trounce and Waitt suggested that only the report of the Committee on Grievances in regard to said matter, be read.

The M.W. Grand Master ruled that the request of Bro. Easson be complied with, and ordered Grand Secretary to read all correspondence asked for, which having been done a discussion ensued. Bros. Baker, Teague and Waitt explained the matter for the information of the Brethren.

The M.W. Grand Master then explained his views on the subject under discussion, and stated that he fully agreed with the report of the Committee on Grievances, to whom the matter had been referred. Neufelder stated that he had a copy of certain questions which had been referred to the Grand Master for his decision by Vancouver-Quadra Lodge, and suggested that as they had reference to the matter under discussion it would be well to have them read. The letter of the 21st June, from Vancouver-Quadra Lodge, No. 2, was then handed to the M.W. Grand Master, who ordered the same to be read for the information of Grand Lodge.

LETTER FROM VANCOUVER-QUADRA LODGE, No. 2.

MASONIC TEMPLE, Victoria, B. C., 21st June, 1883.

E. C. BAKER, Esq., Grand Secretary.

V. V. W.: DEAR SIR AND BROTHER:—At the last regular meeting of this Lodge, held last evening, I was instructed to lay the following resolution before the M. V. W.: Grand Master for his consideration:

" As there are various opinions expressed in regard to the literal interpretation of certain sections and clauses of the Constitution— we would respectfully request that the following questions be submitted to the M. V. W.: Grand Master for his unqualified decision:

" PROPOSING MEMBERS—SEC. 2, PAGE 90.—1st. Does the clause " *Except in cases of Royal Naval and Military men* literally, or by implication, mean to embrace persons engaged in the Merchant Marine service, or any service except that directly under the Royal Naval authorities?

" 2d. Does the Royal Navy only apply to persons in Her Majesty's service, or does it apply to persons who may be serving in the navy of any foreign State, or to persons belonging to other nations and serving in the Navy or Merchant Marine? Does it apply, say to a person serving on board a Canadian light-ship, whose term and pay is from month to month?

" 3d. Under the same clause requiring residence of one year, can he be claimed as under the jurisdiction if he has not so resided continuously for one year? Say he has been two years in this Province, of that time he has resided six months in Victoria, eight months in Nanaimo, nine months in New Westminster, and one month in Burrard Inlet, which of these Lodges can claim jurisdiction? he having resided last at Burrard Inlet and seeks admission by initiation at that place.

" 4th. Not having resided the required time, is it not compulsory on him by this clause to produce a certificate of character from the nearest Lodge to the place of his nearest residence?

" 5th. Is there any section or clause in the Constitution of British Columbia whereby Vancouver-Lodge, No. 2, would be fully justified in conferring the degrees of Masonry on a merchant seaman who has only resided in the jurisdiction one month or less, and not having any certificate of character from the Lodge nearest his previous residence?"

The M.W.: Grand Master stated that as the letter contained questions of great importance it would be inadvisable to render a hasty decision, and he would therefore defer the matter for consideration after the business of the present session was completed.

Bro. Baker suggested an expression of opinion from the representatives of the mainland Lodges in regard to this matter. Bro. Hughes declined to express an opinion, not having been present all the time the same was under consideration. Bro. Kelly expressed his views in regard to the difficulty, and it was his opinion that Victoria-Columbia Lodge, No. 1, had acted rightly and in conformity with the Constitution. Bro. Howay dissented from the opinion of Bro. Kelly, and considered that both of the Lodges had acted wrongfully and not in accordance with the true intent and meaning of the provisions of the Constitution, as laid down for the government of private Lodges.

Bro. Baker moved, seconded by Bro. Kelly, That after a careful consideration of the matter in dispute between Victoria-Columbia Lodge, No. 1, and Ashlar Lodge, No. 3, this Grand Lodge is of opinion that the same has had all due consideration at the hands of Grand Lodge, and that whether Victoria-Columbia Lodge, No. 1, acted in keeping with the Constitution or not—and this point does not arise—Ashlar Lodge, No. 3, has no just ground of complaint against Victoria-Columbia Lodge, No. 1. Carried.

Moved by Bro. Millar, and seconded by Bro. Trounce, That the report of the Board of General Purposes be considered clause by clause.

Moved in amendment by Bro. Waitt, and seconded by Bro. Howay, That it be adopted as a whole.

The amendment was put and carried; original motion lost.

2nd. That the Grand Lodge of Utah at its organization acted wisely in avoiding any question of religion and strictly adhering to the ancient landmarks Masonry having made every provision to avoid such questions by the proper use of the ballot.

3rd. That Masonry recognizes the right of every Craftsmen to be a member of any church, creed, or religious denomination he pleases. We trust this will be strictly maintained by the Brethren in Utah, and in every jurisdiction in the Universe for all may be admitted to see the light who believe in God and strictly obey the moral law. No man's polities or religion should interfere with his Masonic rights and privileges, this, we contend is one of the corner stones of our Temple, which has enabled it to stand for so many generations.

Let us take our sacred Masonic Traeing Board in the first Book of Kings, xix, chapter from the 14th to the 18th verses, there the Prophet Elijah complains that he only of the faithful is left and they seek to take away his life, but God who knows the hearts of all men informs the Prophet that there are seven thousand in Israel who have not bowed the knee. As the Representative of the Grand Lodge of South Carolina, near this Grand Lodge, I beg to submit the following:—

The 106th Annual Communication was held on the 12th of December, 1882. The M.W.C. Grand Master in his address congratulates the Brethren on the universal peace and Brotherly love which prevails. Dispensations have been issued for four new Lodges. It is proposed to hold bi-annual instead of annual communications and to devote the money saved by this means to the reduction of the debt owing by Grand Lodge and which it is expected by this plan can be reduced about \$3,000 every second year.

There are 171 chartered Lodges with a membership of 7,500. The Grand Master and Grand Secretary were both re-elected.

GEORGIA.

The Bi-annual Communication of this Grand Lodge was held in Masonic Temple, in the City of Macon, on the 31st October, 1882, and was opened in ample form on the third degree by M.W.C. Bro. Josiah J. Wright, Grand Master; all the elective Grand Officers were present with the exception of the Junior Grand Warden and the Grand Chaplain; seven past elective Grand Officers and eighteen Grand Representatives were also present—among the latter I do not observe the name of Bro. Calvin Fay. There were also present fifteen Past Masters and the Representatives of some 300 Subordinate Lodges, such representation being only the W.M. or his proxy in the person of a Past Master. There are some eighteen interesting decisions of the Grand Master, notably the 18th, in which it is decided "to be exceedingly improper and un-Masonic in a Subordinate Lodge while called from labor to refreshment to have, or suffer to be had among such refreshments, any kind of intoxicating drinks." I also notice under the heading Grand Lodges in communication with the Grand Lodge of Georgia that British Columbia figures as "British America!"

Solomon's Lodge, No. 1, on the roll of this Grand Lodge is claimed as the oldest Lodge in the United States.

M.W.C. Josiah J. Wright re-elected Grand Master. R.W.C. J. Emmett Blackshear re-elected Grand Secretary.

An Occasional meeting of Grand Lodge was held at the Masonic Temple, Savannah, on the 3rd November, 1882, for the purpose of constituting, consecrating and dedicating "Lantinen Lodge, No. 48," on the roll of that Grand Lodge.

NEW-SOUTH WALES.

The only proceedings of this Grand Lodge (since last reviewed) received by me are those from June, 1880, to June, 1881, although I receive in addition "The Freemason" regularly, and therefore cannot but conclude that those of 1882 have miscarried through the post.

The prosperity of this Grand Lodge is steadily advancing and the steps taken by this Colony in the matter of independence has been followed by Victoria.

There are 27 Lodges on the roll—an increase of seven during the year—there are nine Grand Lodges having extended fraternal recognition, and doubtless at the present moment that number has been doubled. The Board of Benevolence consists of the Masters of the Sydney Lodges, and the proxy Masters of the country Lodges, together with Grand Treasurer and Grand Secretary.

REPORT OF COMMITTEE ON GRAND MASTER'S ADDRESS:

To the M.:W.: Grand Lodge of British Columbia :

Your Committee to whom was referred the Annual Address of the M.:W.: Grand Master report that we have carefully perused that valuable paper with satisfaction and pleasure, and are pleased with the Masonic principles it contains, and appreciate the care, interest and zeal exhibited in the discharge of the duties pertaining to the office of Grand Master.

We feel that nothing can be added to the sentiments expressed on Masonic charity and commend that they be exemplified by each member of the Craft, for they are the peculiar characteristics of Free Masons. We hope the suggestion for an appropriate memorial plate will be carried out for your Committee are often humiliated when comparing our memorial page with those of other jurisdictions.

Referring to the silent dead we can but echo the sentiments of our M.:W.: Grand Master and mourn their loss whose example and precept were worthy of emulation, trusting that they are labouring in that Supreme Lodge where there is no occasion for level or plumb-line, trowel or gavel, compasses or square.

We consider the visitations of M.:W.: Grand Lodge of vital importance for the good of the Craft, and commend the time, trouble and expense of the M.:W.: Grand Lodge in witnessing the workings of the Craft. We observe with pleasure that arrangements were made for visitations by representation to Lodges at too great a distance for personal visitation of M.:W.: Grand Master and are satisfied that the working of the Craft is harmonious.

We most heartily endorse the loyal tribute paid to the Vice-Regal party the Princess Louise and the Marquis of Lorne, and can but commend the homage paid the representatives of the Royal family.

We note with pleasure the remarks concerning our relations with Sister Grand Lodges ; the assurance of peace and harmony existing ; and that we have representatives of this Grand Lodge near the Grand

Lodges of Scotland, Vermont, Idaho and Illinois, and echo the expressions of sympathy to the Brethren of Sister jurisdictions who suffered by the elements.

We commend for your consideration the decisions and recommend that they be sustained, and congratulate the Craft on having a presiding officer endowed with wisdom and integrity to support the laws of the M.:W.: Grand Lodge, and to deal with grievances so firmly and kindly as to leave the Craft in a harmonious and peaceful condition.

We note with pride the prosperity of the Craft and hope with the M.:W.: Grand Master that with the prosperity of the country Masonry may increase its numbers in this Province and exceed in excellence and zeal the labors of any previous period.

We trust the Committee appointed to collect all edicts and resolutions having the force of law and to revise the Constitution will at an early date complete their labors, and suggest that when compiled their report be printed in a proper manner or not accepted.

"For we are members one of another."—Eph. iv., 25.

Dear Brethren, two years ago I addressed you upon the general
principles of the Craft; last year I endeavored to explain its high
ideal; now I shall attempt to illustrate its spirit.

It has been said that man is more political than any bee or ant.
In every community there is a constant gravitation of sentiment, af-
fection and interest towards a common centre. This original impulse
of our nature finds its explanation in the truth, "It is not good for
man to be alone." As the tiny rivulets starting in the hills form the
creeks, and these swell into rivers, and those branch into seas, so we
have the marriage relation, and out of it springs the family, then the
community, and finally the state. In this way God has fitted our
nature to the conditions of its development. We owe our happiness
in a large measure to the presence of others. Man left to himself is like

a tree standing alone in an open field, battered by the storm, seethed by the lightning's flash, knotted and gnarled, the mere wreck of what it might have been in its native forest. Solitary confinement is said to be the most cruel punishment that can be inflicted. Persons sentenced for life to Siberian exile have been known to commit crimes and thus risk a greater punishment, in order that they might be brought back to their native land, and even in a court room be permitted to look upon the faces of their friends again. We boast of our originality, but whence have come our ideas? They have been dug from the mines of truth by the mental toilers of every age. We justly glory in our civilization, its science, its art, its mechanism, its refinement. It is the product of the workers of all time. The political privileges we hold so dear have sprung from the struggle of ages; and our religious liberties have flowed to us on streams of human blood. What have we that we have not received through the mediation of others? Men thoughtlessly speak of themselves as being independent! It is a vain boast. We are members one of another, bound together as the organs of the body by indissoluble ties.

What then are the duties growing out of this common relationship? The feeling that men, whatever their nation — or color, rank, creed or circumstances are men, and as such — call to our sympathy and respect. "God hath made one blood" so that deeper than race, rank, belief or condition, lies the common brotherhood. In a manufactory there is the capitalist whose money supports it, the manager who directs its business, the foreman who superintends its work, and the employee whose industry creates its productions; now these are all necessary to its efficiency. So in society, every man whether he sits on the throne or in the senate, stands in the pulpit or the market, works in the shop or field, bears a part greater or less it may be towards the common good. We enter into the labors of the race. The feet cannot say to the hands we have no need of you; and however far we may be advanced in excellence, the only real bond of union, the meanest may yet stand by our side, for "she hath done what she could" is the true standard of all merit. On one occasion it was said to the great teacher, "Thy mother and thy brethren stand without desiring to speak to thee." He answered, "Who are my brethren?" "He that doeth the will of my Father in heaven the same is my mother, my sister and brother." When, therefore, nations, churches and distinctions have melted into one common wreck, and even the marriage tie it dissolved, this bond shall abide. Then we join in the sentiment of the old Roman whose words filled the forum with applause, "I am a man, and nothing that concerns man can be a matter of indifference with me."

A common sympathy should rule. What is fellow feeling; it is

better felt than expressed. That mysterious power by which we enter a man's heart, feel his sorrows, reciprocate his joys, and share his burdens. Whence does it arise? A sense of the struggle in which those we care for are involved. You are standing on the banks of the Ningam river. A man is pulling for the shore; suddenly the boat is swamped and its occupant is tossed about in the angry surf. He strikes boldly for life. Now he is lost in the foam, then he appears again. How would you regard him? Would you not reach out great arms of sympathy? O think of the multitudes struggling in the currents of this world's evil; now breasting bravely the wave, then sinking despairingly beneath it. Have they no claim upon our consideration? There is a great power in sympathy. Some one says there is a great power in a child's laugh. Men will work the better for having others by. How the tedium of a journey is relieved by companionship. Let us then learn to rejoice with them that do rejoice, and weep with them that weep.

Forbearance is also due to others. The disposition to linger in our judgments. In case of apparent wrong, instead of forthwith giving judgment, passing sentence, and proceeding to the execution of it; it is to linger. Men are not alike in moral endowment; therefore we that are strong ought to bear the infirmities of the weak. How hard it is for a man of robust health and strength to put up with the puny efforts of a mere weakling. It is not easy for one possessed of keen intelligence to bear with the stupidity of a dullard. For the same reason it is often a hard task for a person having a well balanced moral nature to endure the fruitless faults and sins of those less happily constituted. Besides, we are not out of the reach of danger. "Brethren, if one be overtaken in a fault ye that are spiritual restore such a one in the spirit of meekness considering lest ye also be tempted." Have we resisted the keen edge of the sword which has pierced him? Have we stood in the battle where he has fallen? then it is time enough for us to boast. Our own failures, moreover, should soften the tongue of censure. The inquiry, "He that is without sin amongst you let him cast the first stone," should arrest the harsh judgment, and hush the slanderous word. We must take care when we seize the five hundred pence debtor by the throat that there is not in Heaven's chamber ten thousand talents against us.

Forgiveness is also a duty we owe to each other. We are taught caution in life. A burnt child dreads the fire. The loss of human confidence is a part of the dread penalty of persistent sin in this life. But there is required a disposition to meet an offender more than half way in order to effect a reconciliation. Our responsibility is the result of a power far-reaching in its results. It was a deep insight that dictated the words, "Whosoever ye shall bind on earth

shall be bound in heaven." This is no exclusive right enjoyed by a privileged class. Forgiveness withheld but rivets the chains of sin. We have seen a father's indifference, a sister's scorn, and a brother's contempt, seal up the repentant spirit and bind it down to vice. Forgiveness on the other hand breaks every chain, and the emancipated soul breathes the very freedom of heaven. See the lad that, in the street, has broken the commands of home. With downcast eyes and faltering step he returns. He tells out the tale of his guilt in the mother's ear. She clasps him to her heart and kisses away the tears. What a change love makes; the light of gladness is again in the eye, the smile of peace is upon the face, and the ring of truth on the lips.

" And blessings on the falling out,
 That all the more endears,
 When we fall out with those we love,
 And kiss again with tears."

And need we be reminded that co-operation is binding upon us as members one of another. The eye has a lofty place in the body; but it has to guide the hand in its humble task and the foot in its lowly path. The thing itself is easy of comprehension. Two men are at work in the forest, a log lies in the way, one puts his shoulder to it and exerts his strength in vain his companion joins him in the effort and it is forced aside with ease. Herein lies the philosophy of united effort in business, government and religion. White water is diffused in vapor through the atmosphere it is powerless, when it is condensed in the shower it becomes one of the mightiest agents in nature. The electric fluid, latent in matter, is harmless, but when precipitated from the cloud it shatters the oak and splits the rock in fragments. Great ideas inspiring individual minds are only elements of power; it is when organized that they form public opinion and become living forces, working the common good. Yet how many climb on the fence and watch indifferently the movements shaping around them. Idle drones in the social beehive enjoy the shelter and sip the honey created by the busy throng around them. Like a great boy who sits by the hearth on a winter's evening, he absorbs to the full the cheerful heat, and luxuriates in the abounding enjoyment; but he will not provide a stick for the fire, his sisters may do that.

We have now to consider the end of this associated life. Surely mutual helpfulness. In Philosophic Greece during one period of its history, it was permitted to allow weakly or deformed infants to expire, and to put out of the way the hopelessly sick and infirm as being elements of weakness in the state. Our Holy Law teaches differently. In the words of an Apostle, "when I am weak then am I strong." How helpless is the child in the cradle; yet the father's power of brain.

the mother's wealth of love, the brother's might of muscle, and the sister's feminine gentleness, are all employed for it. "Bear ye one another's burdens," is our divine rule. If a man has given to him great physical strength it is not that he may lord it over others; but that he may shield if need be a weaker one. If you have that rare dower, superior wisdom, it is not that you may entrap the unwary and make them your tools; but that you may hold high the torch of truth for their safe guidance. Or if wealth has flowed into your coffers, it is not that you may by monopoly tax industry at will, but that you may wisely aid it.

Our power of helping, it is true, is very limited. Let us then be careful how we injure. A story is told of a Cossack travelling in Northern Russia; his family were with him in the sledge; the rapid reindeer sped them over the wintry wastes; night overtook them and the wind whistled through the scattered pines; but above its moaning they heard the cry of the dreadful wolf; soon the forms of the infuriated animals were seen through the drifting snow; in a moment they were rushing upon the affrighted travellers; the father took the youngest child and threw it out; we spare you the sickening details * * * the man saved his life by the destruction of his family. How do we regard such conduct? Its atrociousness appalls us. What then shall be said of those who would build up their reputation upon the ruins of a neighbor's good name; of those who amass wealth at the expense of the sinews and blood, the loves and hopes of their fellow men; or of those who gain momentary gratification through the lifelong throes of murdered virtue.

Lastly, this state of interdependence should be viewed as a preparation for fellowship hereafter. Earth's greatest teacher has said: "In my Father's house are many mansions." Were the gates ajar so that we might catch a glimpse of the life within what a scene would greet our gaze. Here we are clannish. The Frenchman hates the German; the Irish plots against the English; the Yankee suspects the Briton; mountain chains limit our sympathies, rivers determine our antagonism, and imaginary lines sunder us. There nations, kindreds, peoples and tongues dwell together in happiest fellowship. Here caste rules us, Patrician cannot mix with Plebian, the one cries with sneering contempt, "common people!" the other mutters "privileged classes!"; there the prince and the peasant, the capitalist and the hodsman, the merchant and the menial meet in fellowship; here sectarian feelings alienate, the Jew and the Gentile still stand apart, the Catholic and the Protestant are but resting on their arms; the Episcopalian gives over the Dissenters to unenvied mercies; the Calvinist hedges himself in with the five points, and the Baptist dwells in castellated isolation surrounded by

a moat whose waters no draw-bridge ever spans; there Heaven's charity has fused those diverse masses into a divine kinship, and beheld low beautiful the unity in which they dwell!

Here sin especially divides. Once sink below the common standard of morality and the Church gathers up its holy skirts and inquires, doth not your master know she is a sinner, and the world with a hypocritical leer passes by on the other side; there we find those who washed their robes and made them white through forgiving love; they were sinners but the kiss of Divine love has made them worthy of fellowship with the just.

Such is the spirit of Masonry. It was born in the heart of God. Like the Pentecostal fire it fuses Parthians and Medes, dwellers in Mesopotamia, Crete and Arabians, Jews and Gentiles into unity. O that it might burn more fiercely until the antagonisms of race, the hatreds of creed, and the rivalries of business shall disappear, and the pure gold of brotherly love remain.

On returning to the Lodge, it was moved by R. W. Bro. Past Grand Master Henry Brown, and seconded by R. W. Bro. Deputy Grand Master Thomas Tromee, That a vote of thanks be tendered to V. W. Bro. Grand Chaplain for the eloquent and instructive address delivered to-day, and that he be requested to furnish a copy of the same for the purpose of being printed in the proceedings of this Session.

Moved by Bro. Neufelder and seconded by Bro. Beaven, and carried, That a vote of thanks be tendered to the Pastor, Trustees and Choir of the Methodist Church for their kindness and courtesy extended to Grand Lodge.

The M. W. Grand Master appointed the following:- Bro. Hughes, Neufelder and Beaven a committee to prepare a suitable written acknowledgment to the Pastor, Trustees and Choir of the Methodist Church.

The labors of this communication being finished, the M. W. Grand Master then closed the Grand Lodge in ample form, being so declared by the Junior Grand Warden and so proclaimed by the Grand Director of Ceremonies in the East, West, and South after solemn prayer by the V. W. Grand Chaplain.
