of cross-examination designed to make this point clear was rudely interrupted by Mr. Boyd's refusal to tell how much he makes from his office in the Knights of the Macabees. He would only say that he had no other occupation yielding an income, and the court respected his contention, that he is under oath to the Supreme Commissioner of the Knights of the Macabees not to divulge any facts connected with his office.

Whether the office of Deputy Supreme Commander yields sufficient to keep the body and soul of Samuel John Martin together must therefore remain one of the hidden mysteries of the Stratton investigation. The assumption is that the income is sufficient, for Mr. Martin looks as if he enjoyed three square meals a day, and there is a healthy independence.

It must be said, tho, that Samuel John Martin told a strange tale. Briefly, it is that when he arrived in Toronto to attend the exhibition last September, he was assigned, as a matter of accommodation, to partnership with R. Gamey in a room at the Walker House. They had never met before, but they slumbered closed heavy eyelids, Mr. Gamey of Gore Bay, Ont., confided in Mr. Martin of Kempsville, Ont., his intention of supporting the Ross government because of its good work in behalf of Manitoulin.

Where the Gamey came in, on the morning of September 5 the two were joined by Arthur Bowen, also of Kempsville, Mr. Gamey making no objection to a second room mate. To Mr. Martin and Mr. Bowen Mr. Gamey is said to have repeated the confession that he had formerly made to Mr. Martin alone. Mr. Martin said he was struck with the similarity of the admissions of Mr. Gamey last September to the famous Globe interview.



The shipping situation at Montreal occasioned by the striking longshoremen, is causing some trepidation among local shipping men. The canal opens to-morrow, and if the strike is not settled before then, it may seriously affect the amount of freight carried up the lakes. Some fear is expressed that the present trouble may permanently and injuriously affect Montreal as a shipping port. Any blow of this kind, falling on Montreal, it is thought, would be felt all along Lake Ontario. Quebec is said to have suffered commercially from a similar cause, and fears are entertained for Montreal.

Dredge is late.
The government dredge, which had its two anchors broken, was towed with the schooner Straubenberg, is lying at the foot of Church street. The repairs are being effected with commendable expedition, and it is expected that it will resume its work to-morrow. The breaking of the anchors will entail an expenditure of about \$700. An anchor is an oak stick about twenty-five or thirty feet in length, and sixteen or eighteen inches in diameter. The crew of these is quite costly. The crew of the dredge is, therefore, idle while the repairs are in progress.

Water 17 inches higher.
The dredge had not been working on the eastern gap, owing to the high water this year, there are fourteen feet of water over the sandbar, which has formed at that point. The water, according to Harbormaster Postlethwaite's records, is 17 inches higher this year than last. This fact is unaccountable, as the snow and rainfall during the past season has not been above the average. A peculiar phenomenon in connection with the lakes of the different lakes, and one which gives an idea of their tremendous extent, is that they vary in height independently of each other. The water is lower on the Upper Lakes, it is higher here.

TIMBER GAP SULLIVAN GOT CONSUMPTION

Concession Shannon Applied for Was 11-4 Square Miles in Rutherford Township.

WHERE MR. DAVIS LOST TRACK OF IT

Lifeless Day in the Legislature—New Bills Forecast Important Legislation.

With the Horse Show and the Gaiety inquiry in full swing downtown, interest in the law-makers of the province doing business in Queen's Park has subsided almost to the vanishing point. Half the chairs were vacant yesterday afternoon, and the gallery attendance was the smallest of the session. The members lounged, in a doleful sort of way in their chairs, and there was not a stir beyond the usual formal business during the half-hour the House was in session.

Sullivan's Timber Deal.
The Shannon-Sullivan timber concession was brought up by Mr. Whitney, the inquiry being set down for the following terms: Was any timber license granted by the Crown Lands Department since Jan. 1, 1902, to one Shannon, and was any such license afterwards transferred to any person, and, if so, to whom? If such license was granted, what locality was covered by it, and what was the extent of it? What was paid for it by Shannon? What was paid for it by the present holder? Was the transaction a bona fide one on the part of Shannon, or did he represent another person or persons? The Commissioner of Crown Lands replied as follows:

The concession was issued May 1, 1902, to Patrick Shannon. This license was transferred by Patrick Shannon to the Traders' Bank on July 29, 1902, and was again transferred by the Traders' Bank to the Molsons Bank, April 8, 1903. The license covered the north-west quarter and the northeast quarter, Sec. 24, Township of Rutherford, and also reserved lands north of above sections, covering an area of 40.80 claims. Total area of whole territory, 1.4 square miles. Shannon paid a bonus \$250, and \$125 per thousand feet B.M. to be paid as the timber was cut. The department does not know what was paid for it by the present holder. The transaction was a bona fide one on the part of Shannon, so far as the department knew or now knows.

No Aid to Cold Storage Houses.
In reply to Mr. Barr, the Premier said no municipal aid had been paid under the act respecting provincial aid towards the establishment of cold storage buildings.

Mr. Whitney Misreported.
Before the orders of the day were called, Mr. Whitney arose to correct a misstatement in the Globe regarding his attitude on the budget debate. The Globe so far offended on the point of Mr. Whitney's speech, that he did not propose that the debate should go any further, in view of the fact that the House had already been in session the greater part of two months. What he did say was that, should the motion for the speaker to leave the chair, to go into supply, he would reserve the right to discuss anything contained in the budget.

Resolution of Condolence.
At a special meeting of the Board of Directors of the North American Life Assurance Company, held in the city yesterday afternoon, it was unanimously resolved to express their sincere sympathy to the family of the late William McCall, L.L.B., F.I.A., who died on the 27th inst. The resolution was adopted and sent to Miss McCall, Goldman, A.I.A., who has been secretary of the company since it commenced business, by unanimous vote, elected to the position of managing director, formerly held by the late William McCall, R. Taylor, Esq., who has been acting secretary for some time, was appointed in place of Mr. Goldman, elected a director of the company.

McDougal Case Disposed.
Alfred McDougal did not appear before Judge Winchester yesterday. His counsel presented affidavits from Dr. John Ferguson and Dr. E. J. Wilson, stating that the accused was confined to his bed, and physically unable to be present at the trial. The Crown prosecutor suggested that physicians appointed by the court should examine the invalid, and there was an adjournment granted for two weeks. Mr. McDougal is suffering from nervous prostration and heart failure, and is represented to be gravely weak.

Appointed in Sarnia Tunnel.
Suffocated into unconsciousness, seven workmen were carried from the Sarnia tunnel on Tuesday afternoon. Two of them are seriously affected. The other five are expected to recover. A slight wind, which blew the gas back into the centre of the tunnel, was responsible for the mishap. Section men from Port Huron and the eastern end were sent for to complete the work on the tracks in the tunnel.

HORSE SHOW OPEN
