Frank Langan, of Montreal, agent, has been appointed curator *ad hoc* to the substitution created by the last will of the late James McCready, for the purpose of taking such proceedings before the Courts of Justice of the Province of Quebec and elsewhere and also before the Governor and the Legislature of the Province of Quebec, to set aside the deed of sale, intitled dissolution of partnership between executor late James McCready and Charles F Smith, to compel the said executor and Jeremiah Fogarty in his quality of curator to the said substitution to make a faithful inventory of all the assets of the estate of said late James McCready and to apply to the Governor and to the Legislature of the Province of Quebec to repeal the Statute passed and sanctioned on the 30th of December 1890, chap. 101, 54th Vict, intitled an act concerning the estate of the late James McCready to compel the said executors and the said Jeremiah Fogarty, to render an account of their administration of the affairs of the said late James McCready and also to take proceedings to remove the said executors and the said curator to the said substitution if the same should be deemed advisable.
