Collapse of a Spinning Factory With Terrible Results.

More Christians Massacred by Tarks Labor Troubles in Scotland-Reducing Australian Salaries.

CUT DOWN HIS SALARY. London, Oct. 10 .- The bill reducing the salary of the Governor of South Australia from £5,000 to £4,000 has passed both Houses of Parliament.

THE CZAROWITZ DYING. A special from Berlin says: Prof. Leyden has received a dispatch to the effect that the Czarowitz is growing rapidly worse. His condition is reported to be alarming.

THE AFRICAN BOOM. London, Oct. 10.-The Earl of Dunmore has purchased a farm near Johannesburg, South Africa, for £35,000, and proposes building a large house and taking up his residence there. Lord Henry Paule is an other British nobleman who has succumbed to the attractions of South Africa.

RUMORS FROM ROME. London, Oct. 10 .- It is stated at Rome that the Pope is strongly opposed to the proposed visit of the King of Portugal to Rome, and tried to dissuade the King from visiting the Italian capital. In Vatican circles it is said that the Pope will refuse to receive King Carlos, who is expected to ar-

rive Oct. 17. CHOLERA IN HAWAII. London, Oct. 10.-A letter from Honolulu, dated Oct. 2, says the record of deaths from cholera to date is 87 cases. Sixty-three died, including only two white people. Eighty-two victims were Hawaiians. The natives persistently refuse to report cases until the victims were dead or dying. They declare that the cholera was brought by the whites to exterminate them. On Sept. 23 the whole town received a thorough cleaning.

But two new cases have been re-ported since that date. It is believed the trouble is now over. There is much distress among the Hawaiians. About 20,000 rations are given them weekly.

LABOR TROUBLES. London, Oct. 10.-The Amalgamated Society of England has notified the Belfast shipbuilders and engineers that conceded a strike will be commenced on Thursday. The employes state that there is no chance of bringing about a compromise in the matters in The Clyde shipbuilders, who dispute. are working under an understanding with those of Belfast, will, it is announced, suspend 25 per cent. of their men every week after the strike begins, and before the end of the month it is estimated that 5,000 men will be in idleness. A long and severe struggle between the members of the Amalgamated Society of Engineers and the shipbuilders and engineers is anticipated.

THE TURKO-ARMENIAN TROUBLE London, Oct. 10 .- A dispatch from Constantinople says that massacres of Christians have occurred at Rodosto, in Roumelia, at Silivri, 40 miles west of Constantinople, and at Simid, in Asia Minor, 56 miles southeast of Con-

The Turks who took part in the rioting were armed. The few troops in the place made no attempt to stop the massacre, and it is even stated that they took part in the slaughter and pillage. The Sultan is much disturbed at the presence of the fleet at Lemnos, and has sent several messages to the British embassy describing the measures that have been taken to preserve order and praying that the ships be with-

drawn. It is now announced that the Porte has accepted the scheme with the modifiscations the powers declared were admissable. Nothing certain, however, is known. The dispatch adds that it is learned from a Turkish source that the six powers in their recent joint note demanded, besides the adoption of provisions for the public safety, the immunity of Armenians from further arrest and violence, and that a com-



"But we are not in a position to judge whether a wheelman is out on pleasure or duty," commented Mrs. J. W. Jones. "This motion would make it appear that all wheelmen who ride on the Lord's Day are breaking the Sabbath. In passing it we may only call down upon ourselves the ridicule of the public."

Mrs. Thornley said that a great amount of Sabbath riding for pleasure existed, and that the county hotels did a big Sunday business catering to wheeling parties. But when necessary, the wheel, as a means of locomotion on the Lord's Day was, in her opinion, preferable to the use of the horse. In amendment, she moved that the resolution be referred back and altered so as to commend the use of bicycles on the Sabbath where necessity demands their use, in place of carriages, and at the same time discountenance Sunday riding for pleasure.

conscience does not twinge I will not consider it binding. (Laughter.) One delegate wanted to know if a woman who sold tobacco could be a member of the W. C. T. U. The question was referred to Mrs. Thornley, who answered: "A woman can be a member who pays 50 cents and signs the pledge."

Mrs. Jones-I suppose she could also be a members if she wears a wing and an ospray? (Laughter.)

The convention viewed with pleasure the increasing tendency on the part of temperance people to refuse to follow leaders who were unwilling to avow their position on that great moral reform. It expressed pleasure at the growing disuse of tobacco among Christians. The Ward Hotel catastrophe was referred to, and while the convention expressed itself as grateful at the county hour of closing being made 10:30 it referred to certain "unenforced restrictions," as instanced by

Annual Fair of the Dorchester Agricultural Society.

Successful in Point of Attendance and Exhibits.

The Attendance Was Large-Speeding in the Ring-No es.

Annual fall fair, No. 40, of the Dorchester Agricultural Society, was held on the society's grounds at Dorchester Station yesterday, and like the 39 which preceded it, the show was a success. In every respect—attendance, entries, and quality of exhibits-it exceeded any previous year. The increased attendance is easily accounted for. "The "Donnybrook" (as the fair is generally called), has always proved a great attraction. It draws people not only from the township of Dorchester, north and south, but from Nissouri and London townships to the north, Westminster on the west, Oxford on the east, and Elgin county on the south. From the city a large number always go in rigs, but more generally they go on the trains. Yesterday about 200 went down from London. The noon express carried a large number; the afternoon accommodation carried quite a few, while the morning trains carried smaller delegations. And while London did more than its share in making the Donnybrook a success, the district surrounding Dorchester Station did nobly. From about 10 o'clock in the morning the crowd began to pour in and every concession and sideroad leading to the village was heavily traveled. The farmers brought their wives, the sons brought their sweethearts, and the younger children came in groups, until the attendance at the grounds must have reached 3,000. The fair was not actually begun un-

til after dinner. The morning was mostly occupied in getting the exhibits into shape and preparing for the visitors. The weather was not altogether desirable for a country fair, however. It was very dismal, with a cold wind blowing, and this condition of affairs was only altered now and again by the sun endeavoring to shine through heavy clouds. The change was good while it lasted, but it did not last ong. It was officially announced that the fair would be opened by Sir John Carling, and that Joseph Marshall and Wm. Shore, the representatives of East Middlesex in the Dominion and Ontario Houses respectively, would be present. Sir John was there, so was Mr. J. Marshall, but through some unavoidable cause, no opening ceremonies were indulged in. The arrangement of the exhibits in the grounds was the same as last

year. The sheep and swine were in wagons and pens along the north side; The cattle were kept in kraals a little to the east, while the horses were tethered to trees near the cattle kraals The poultry and roots were located on the west side. THE EXHIBITS. The exhibit of fancy work was not up to the average, neither were any of the departments shown in the frame

There was room for all disouilding. plays and to spare. Entries in every other line were above the average. Every class of sheep was well represented, while in swine, Tamworths were very numerous. Horses were up to the mark, and while thoroughbred cattle were none too plentiful grade cattle were exceptionally numerous. SIGNS OF THE TIMES. A few days ago, the high tax organs of Ontario were strongly denouncing the Government of New Brunswick, and pointing out the danger of again returning Premier Blair to power. The New Brunswick Premier, they asserted, is as ardent an advocate of a change of Government at Ottawa as is Sir Oliver Mowat, and Mr. Blair must be defeated at all hazards. It would never do to have a Government

tablished in New Brunswick on the eve of a Dominion general election. And so Mr. Geo. Foster, Mr. Temple, Mr. Weldon and other high tax M.P.s posted off to New Brunswick constituencies to defeat the Liberal Premier and his Government.

The nominations for the New Brunswick Legislature took place yesterday. There are 46 seats in the House, and before the close of nomination day the New Brunswick Liberal leader had a majority of the constituencies

Not in Canadian history has there been a greater collapse of an Opposition.

Twenty of the seats went to Premier Blair's supporters by acclamation yesterday, and only five to his opponents. The Premier and all his colleagues were re-elected unopposed. In Northumberland the Government are sure of two seats. In Gloucester and Victoria all the candidates are Government, while in Kent only two Conservatives are in the field. The indications are that of the 46 seats in the new House, Premier Blair, opposed though he is by the men in power at Ottawa, will have a following of from 30 to 40-probably 35.

This result is a significant rebuke to the clamorers for a defeat of Premter Blair and his associates because they believe that it would be of great benefit to the people of Canada to have a change of men and policy at Ottawa.

Following so quickly after the reduction of 1,400 in the Conservative majerity in Westmoreland, N. B., in the recent Dominion bye-election the triumph of the Liberal Premier of New Brunswick clearly shows that nothing can save that Province to the makeshift, misfit Cabinet at Ottawa when it summons sufficient courage to

decree a general election. In Nova Scotia, where Hon. Mr. Mc-Isaac carried Antigonish, the seat held by the late Sir John Thompson, the portents for a victory for trade freedom are equally marked. And, of course, Prince Edward Island will be

In Quebec the opponents of high taxation will triumph, also, if recent byeelection victories mean anything, while in Ontario we know that the people but await an opportunity to make themselves heard in favor of a change.

Winnipeg went Liberal as soon as it found an opportunity; so will five out of every six of the Northwestern and Pacific Province constituencies when the voting takes place.

The country needs a change.

Following out the policy of building up its shops at central points where the greatest possible efficiency can be obtained with the most economy, the Grand Trunk Railway Company will enlarge and improve its shops at Battle Creek, Mich. Much work hitherto done for the Chicago anod Grand Trunk Railway at Port Huron will be taken to Battle Creek. The rolling stock will be increased, the locomotives improved, and the main lines and tributaries kept in the very best of condition for traffic. Battle Creek will be the center of the G. T. R. system for Michigan, that London is for the network of G. T. R. lines in the fertile and populous western half of Ontario.

INJUSTICE TO THE VOLUNTEERS.

The Dominion Government this year, for the first time, reduced the drill pay of the city corps of mintia from twelve days to eight days on the plea that it had no money in the treasury for this purpose.

This is the declaration after \$38,000,-000 a year has been spent by these men.

The colonels of the leading city corps were first assured that the money would be forthcoming, but they have since been told that the money cannot be granted. They accordingly proceeded to Ottawa in a body yesterday to represent to the Minister of Militia that the force would be greatly injured if the men were thus deprived of the pay to which they are entitled, and which they expected to receive as

It may be that under this pressure, and after much worry and expenditure of time and money, the colonels will compel the Government to pay the men their due. At present the fact stands out in bold relief that while millions of dollars have been squandered on useless voters' lists, on Curran bridges, on harbor jobs, and on other frauds, the very first attempt to make up for these rascalities is directed against the men who, at much self-sacrifice, give their services as the defensive force of the Dominion,

A Great Speech.

Hon. Wilfrid Laurier Opens His Ontario Tour.

Over Four Thousand People Listen to a Masterly Address.

The Leader Adheres to His Position on the Manitoba School Question.

If Sir M. Bowell Appoints a Commission be Will Support Him.

Morrisburg, Oct. 8 .- (Special.)-Hon. Wilfrid Laurier's Ontario tour was most successfully inaugurated at this place to-day. The sky was overcast with leaden-lined clouds and a chill and penetrating wind swept down the St. Lawrence, but in spite of these discomforts the demonstration was of a character which must have been particularly gratifying and encouraging to the Liberal leader. A crowd of 4,000 people or more, composing the sterling men of Dundas, with their wives and daughters, representing all shades of political opinion, assembled at the agricultural grounds and listened with profound interest to the arguments advanced in support of sound political principles. Mr. Laurier never looked or spoke better in his life. The feature of his speech was the plain and frank statement he made in regard to the all-absorbing Manitoba school question. Interest was added to the occasion by the presence of Sir Richard Cartwright, that doughty old political war-horse, who is a host in himself. He was given a very cordial wel-

Mr. Laurier, who was accompanied by Mr. Alex. Smith, Secretary of the Ontario Liberal Association, from Montreal, was received at the railway station by the citizens, headed by Reeve Meikle, who presented him with an address of welcome on behalf of the municipality. A procession was formed, headed by the Chesterville band, and it marched through the town to the residence of Mr. Adam Johnston, whose guest the Liberal leader was.

whose guest the Liberal leader was.

Mr. Laurier was compelled to wait for
the subsidence of the enthusiasm
which effervesced in spite of the frigid
atmosphere. In alluding to the compliment paid him in the address, he said that he was disposed to accept it without any reticence whatever. It had spoken of his ability, integrity and devotion to his public career. He had no hesitation in accepting just one-third of this-the reference to his integrity. To say that a man was honest was not saying so much after all. Honest men he saw in hundreds about him. But still those who had united in the address had been good enough to refer to him as an honest man. Perhaps it was because they knew that he had been for twenty years in the corrupt atmosphere of the Government at Ottawa, and perhaps they thought that when a man had been for twenty years in the corrupt and mephitic atmosphere of Ottawa he might be looked upon as a phenomenon and complimented on be-

ing an honest man yet. (Applause.) was no Mr. Laurier said that u such thing as a Conservative Govern-But there was a Government that styled itself Conservative, but he would not call it a Conservative Government. Sir Mackenzie Bowell recently went to the Northwest, apparently with the intention, as he said, of entering into negotiations with Mr. Greenway on the Manitoba school question. It was Manitoba school question. known that he interviewed Mr. Greenway, and, if they were to credit the papers, they exchanged compliments on the good crops with which God has favored us this year. Sir Mackenzie Bowell came back to Ottawa, summoned his colleagues from their pleasure and held a meeting of the Council. People were on the tiptoe of expectation, for they supposed that at last they would have a solution of the aggravating question. They waited for the decision of the Privy Council and what was it? They had fixed the day for thanksgiving. (Applause and laugh-Continuing, Mr. Laurier said :-

I am not here to solve this question, because it is not in my province to solve it, but I understand that the Ministerial press of this country and of this Pro-vince has been very anxious to know what was the policy of Mr. Laurier with regard to it. I would not be worthy of the position I occupy and of the trust that has been placed in me by my colleagues of the House of Commons if I were afraid to speak on this question. I intend to do so, though I am sure I shall not satisfy the Ministerial press. I do not hope that, but I intend to satisfy, as far as I can, every sensible man, I hasten to plunge at once into the ques-tion, because it is the most difficult we have to deal with at the present time, and because it is to be faced with courage by every man that has in his own conscience the duty of doing well by the country in which we live. I have been accused by the Conservative press having expressed no opinion upon this question. I have expressed an opinion more than once upon it, but I have not yet expressed the opinion which the Ministerial press would like me to express. (Laughter.) I am not responsible for that question, but I do not want to shirk it; I want to give you my views; but remember that war has to be waged in a certain way. When the Duke of Wellington was in Portugal, as those of you will remember who have read that part of the history of England, he withdrew at one time within the lines of Torres Vedras, and there for months he remained, watching the vements of the enemy. The French at that time were commanded by Marshal Massena, and Massena said:-"I want that man to come down from his lines; let him come down into the plain and I will thrash him, but I cannot assail him within the lines." Gentlemen, I am within the lines of Torres Vedras. I will get out of them when it suits me and not before. (Applause and laughter.) There is a way of discussing that question. Time and again I have laid lown my views before the Government, and I do not hesitate to tell you what my views are. First of all, whether here or elsewhere, I speak the same language. I speak here as I have spoken everywhere else. I have the same language whether I speak in one language or the other, in one Province or the other. I would not be worthy of the position I occupy if I did not, as far as I could, educate the Liberal party to the views which I think are the sound views upon that question, which is a most

important one. There is a question to

iar constitution, as you know. Section 93 of the British North America act provides that whenever a minority in any Province where a system of Separate Schools has been established is not satisfied, and thinks itself aggrieved by the legislation of that Province, that minority has an appeal to the Federal Executive. As you know, it has been decided by the Judicial Committee of the Privy Council that in this matter the minority has a grievance, and has the right of appeal.

What are we to do here? that is the question. The minority has the right to appeal. This is conceded and granted. I say this, and I submit it to your common sense and to your knowledge. If the minority has an appeal you must not conclude, as some men conclude, that this appeal is to be denied in every case, any more than you can conclude that the appeal is to be granted in every case, but if the minority has an appeal, it is the duty of the Government to investigate the subject and to ascertain what the facts are, in order to see whether or not a case has been made out for Federal interference. This is how I look at the But this is not the way the Government has proceeded. I ask you, now, would it not have been more fair, more just, more equitable, more statesmanlike, at once to investigate the subject, and to bring the parties together to hear them, to have the facts brought out so as to see whether a case had been made out for interference or not. That is the position I have taken in the Province of Quebec. That is the position I take in the Province of Ontario. I have never wavered from that posi-Two years ago, when the matter came before the House for the first time, I said, "This is not a question of law, it is simply a question of fact. Investigate the facts and see whether or not a case has been made out." This is the position I still maintain, and I venture to say that the question cannot be settled until there has been such an investigation, to see what are the rights and pretensions of the case. But what are you to investigate? There are many things to investigate. You will have to see what is the position of affairs, what is the relative strength of the population, how the groups of population are constituted, and how far the pretensions of the minority can be met without encroaching upon the rights of the majority.

(Applause.) Do you not believe that there is more to be gained by appealing to the heart and soul of men rather than by trying to compel them to do a thing? If you have a difference with one of your neighbors, and if he comes to you and says, "You must do this," in a moment you will say, "No, I will not do it." Your manhood will rise against But if you go and appeal to your neighbor and say, "We have a difference, and we must settle it," he will "I will meet you half way." But the Government of Canada instead of appealing to Mr. Greenway in this way have threatened to coerce Mr. Greenway, and the people of Manitoba have declared, "No, we will stand no coercion." This is not the way to settle the question. I have stated to the Government again and again the first thing they must do is to investigate this question. I stand upon this ground to-day, as I have done in all the Provinces in which I have discussed this question, and to-morrow you will hear the Conservative press say, "Mr. Laurier has spoken upon this question again, and he has said nothing." (Laughter.) I am prepared for that. I cannot hope to satisfy them. I do not expect to satisfy them. But while I cannot satisfy them. I hope, at all events, I can satisfy the honest peocle, the thinking people, of Canada that this is the only way in which you can give justice upon that question. If there is any other method whereby the Government can give justice upon that question, why, let us have it by all means, and for my part I shall be be settled. There is an appeal of the minority in Manitoba to the Governor in Council which has to be heard and deready to give it a fair hearing and con-sideration: but so long as they con-

tinue to do as they have been doing up to the present time I will not permit them to attack me as they have been them to attack me as they have been doing in their press, and to say that I do not discharge my duty upon this question. I discharge my duty as an Opposition leader, but I am not bound to frame a policy for the Government. It is not to me that the petitions of the minerative have been addressed. I have minority have been addressed. I have not been charged by the constitution with the duty of looking into this case; the only thing that I can do is to point out the means by which the end can be attained, and if there is any better means than this let the Government adopt such means, and they will be

welcome to it. But it does not, it will not, do for the Government to be acting as they have been acting upon this question, for their organs to say in the Province of Ontario, "There shall be no interference," and for their organs in the Province of Quebec to say, "There shall be interference." It must be the same thing, whether in Quebec or elsewhere. For my part, I pride myself that, whether in Quebec or in the Province of Ontario, on these questions as on all other questions I have held the language which I do here to-day. You have heard in the Ministerial press that in the Province of Quebec I have a different language to that I speak in the Province of Ontario. I am quite willing to stand here responsible for my acts. Let a speech of mine be quoted that has been delivered anywhere, and let it be quoted entirely, and I will be responsible for it. But when a speech of mine that has occupied one hour in delivery is condensed into six lines I refuse to be bound by such a report as that. The last time I spoke on this question was at Ste. Anne de la Parade, and I will give you the words, because they were reported verbatim, not in any paper supporting me, but in L'Evenement; and this is what I said: "While the Government has done nothing, all the party organs throughout all the Provinces have demanded what was my policy. It does not belong to me to settle this question, but I shall not wait until the responsibility is put upon my shoulders to outline what I believe to be the true way. Two years ago, when the question first came before the House, I said to the Government, which desired to consult the courts to ascertain whether it had the power to intervene: 'You have the power to intervene; it is written in the constitution. The only question is a question of facts. Make an investigation; it is the first thing to be done.' But they said, 'Why an investigation? Are the facts not clear?" I simply replied : 'These facts are clear to you and to all those who believe in a system of Separate Schools, but remember that there are those who do not think as we do on this question, and that they are in the majority.' I know that when I say that the first thing to be done in this question is to have an investigation, I do not percarries weight in this Province by his haps express an idea that will be very popular in this Province, but I hold to the same language in all Provinces. Remember that there are differences of opinion and profound differences on this question, and that to solve it we must enlarge our horizon and place ourselves on a basis that all Canadians, without distinction of race or creed,

This is a question which should not be approached from any standpoint of creed or race, but I appeal to all my countrymen, whatever may be their race or creed, to place themselves beyond these narrow distinctions, to stand up as Canadians, to do justice to whever justice may be due. Gentlewhoever justice may be due. Gentle-men, that is the policy which I advocate to you at present, and I say again I would be beneath contempt if I feared to approach this question as every other question has to be approached from the standpoint from which I do approach it, that is to say, from the standpoint of a Canadian, placing the Canadian nationality before all other nationalities and placing our common country before any other considerations that may animate us, We are here a population of different races and creeds. We can never be a people unless we are able to stand up in any corner of this Canada of ours and repeat upon that corner what has to be said everywhere else. the ground upon which I arraign the policy of the Government. The New Officers Installed and the Court Closed.

Ottawa the Next Place of Meeting-Off cers Complimented-Warm Debates.

WEDNESDAY AFTERNOON. Court opened at 2 p.m., the high chief ranger presiding.

The discussion on the report of the finance committee was resumed.

In resuming the report, Inspector Morgan presented the high chief ranger with a rose on behalf of the youth and beauty of London, the compliment being gracefully acknowledged.

Minutes were read and adopted as amended on motion of Bro. Preston. An attack on clause 5 of the report of the finance committee was commenced as soon as the report was read, the past high chief ranger defending the official procedure of the High court as to the free distribution of

MANITOBA ARCHDEACON SPEAKS. He Criticizes Principal Grant and States

His Own Views. Winnipeg, Oct. 10 .- In opening the annual session of the Episcopalian Archdeaconry of Winnipeg today Ven. Archdeacon Fortin spoke very strongly on the school question, criticising Principal Gran't attitude very freely. Principal Grant had said that the schools of Manitoba were Protestant schools. He (Archdeacon Fortin) den-ied this, and said, on the contrary, that our schools were public schools. and undenominational. The speaker said it was impossible to introduce distinctive religious teaching into our schools, and it would be a glaring injustice if Roman Catholics were allowed to teach their own tenets in the schools at public expense. He concluded his address by urging all to support the Local Government in the school policy, so far as that could be done by clergy without a too active interference in political doings.



The Sultan Refuses to Give the Powers Satisfaction,

And Britain Will Not Withdraw Her Fleet.

The Ambassadors in Session - Turkey Cannot Pay for Fire-Arms.

Constantinople, Oct. 10.-Late today it became known that the Turkish Government had finally presented to the envoys of the six powers a reply to their collective note on the subject of the recent disturbances here. This reply, however, is not satisfactory to the six ambassadors. The Porte, in the answer, enumerated the measures taken to preserve order, and declared that the Musselmen were not the aggressors in the recent rioting, but that, on the contrary, the Armenians killed inoffensive Musselmen. The Turkish Government added that as soon as the Armenian refugees leave the churches, in which they have sought refuge, the normal aspect of the city will be restored. It demies ordering that no food be supplied to the refugees in the churches and urges the ambassadors to assist in the work of restoring or-der, claiming that the Armenian agitators are intriguing to cause fresh trouble. The Turkish note concludes with the assertion that the Government is unable to open an inquiry into the recent rioting with the view of

discovering the guilty parties. In view of the unsatisfactory nature of the Porte's reply the six ambassadors met today to consider the matter. It is expected, however, that the dragomans of the different embassies will assist the Turkish officials in clearing

The Sultan continues to be greatly disturbed by the presence of the British fleet off the island of Lemnos, and has sent again to the ambassador of Great Britain, Sir Phillip Currie, to ask for the withdrawal of the British warships from the vicinity of the entrance of the Dardanelles. Sir Phillip Currie, it is understood, persists in refusing to recommend his Government to withdraw the British squad-

Advices received here from Trebizond. Armenia, confirm the report that a massacre of Armenians has occurred there. It is further reported that a general panic prevails in that city. The number of killed is not known.

A consignment of 5,000 Manser rifles, ordered by the Turkish Government, arrived here several days ago, but they still remain on the lighters to which they were transferred, as the bill of the manufacturers has not been paid, and the agents of the latter decline to give up the rifles until the money is forthcoming.

LONDON PRESBYTERY.

Rev. Mr. Graeb, Port Dalhousie, Called to Thamesford.

Rev. W. A. Cook, Dorchester, Will Prob ably Go to Thorold-Committee on Young People's Societies

The London Presbytery met in the lecture hall of the First Presbyterian Church at 19:30 a.m. today. The conduct of the moderator in calling a special meeting was, on motion, sus-





DISASTER ON LAKE HURON.

Loss of the Steamer Africa With Twelve Persons on Board.

A Quick and Wonderful The Vessel Suddenly Sunk-All Hands Probably Drowned - A Barge

Wrecked.

Stoke's Bay, Ont., Oct. 10.—The steamer Africa, of Owen Sound, and barge Severn, of Toronto, were bound up Lake Huron on Monday evening from Owen Sound, loaded with coal. When twenty miles south by west from Cove Island Light the Africa let go the Severn's tow line. Both boats were making bad weather. When last seen by the Severn the Africa was rolling heavily, and a few minutes later disappeared. The crew of the Severn think the Africa went down with all on board, consisting of twelve and addressed them in a fatherly discourse, of a crew. The Severn then ran be-fore the gale with bare poles until Loyal Island was reached. Her canvas being all gone, she could do nothing more than go on the beach, five miles

from North Loyal Island. The Africa let go the Severn at 7 o'clock p.m. on Monday, the 7th, and the Severn went on the beach at 10 p.m. She is a total loss, the crew being saved by some fishermen after being in the rigging twenty hours, and are now at Stoke's Bay.

Capt. H. P. Larsen, Toronto; Mate Wm. Anderson, Owen Sound; Chief Engineer Hay, Toronto; Second Engineer Ed. Forest, Toronto; William Mann, first wheelman, Toronto; John King, second wheelman, Oakville; Miss Lee, cook, Toronto; two firemen and two deck hands, names unknown, are the missing crew.

The Africa was last seen southwest from Cove Island, a distance of about twenty miles. The Africa's life-boat and life-preservers were picked up on Loyal Island late on Monday night. Southampton, Ont., Oct. 10.—The fishing tug John Logie arrived here last night from Pike Bay, reports having passed through a quantity of wreckage, apparently part of a cabin painted white. This is thought to belong to the steamer Africa, reported lost off Cove Island.

Collection of Public Revenue by the Simplest and Fairest Method.

Letter From a Prominent London Labor Man.

It is not often that I trouble you for a space in your valuable paper, but crave a little at this time to explain to my fellow-workers in this beautiful land of ours something of single tax and sociability. Single tax is a procedure of gathering or collecting the same from land values, according to the concentration or location of the people and their interests or prospects, whereby the location is valued more or less in the situation, as some places may be several multiples in value to others in city, town or village; and center to circumference, or, to be plain, from business center to the outskirts of each municipality, and the ethics of economy could be shown by such an administration and such a government missionaries—Messrs. Dunlop, McKenzie, wonderfully lessen the expenses of collecting them by the qualified mode appreciate it, because he would feel more sociable at the rate of taxation and be temporised with the idea that he's not being trespassed upon by Government dupes or otherwise, and 'twould give him a more contented mind and make him feel happier in his surroundings, and approach his fellowcreature with better confidence in a social degree in whatever station of life he may be. He would not be worned about his taxes being higher than they should be, and on the basis of moral independence would feel himself a man and not a slave, and alive to the best of freedom, and look after those pleasures that exalt and not de-

> Single tax is not alone a factor to cause happiness in a man's soul, but the love of God and his brother man, by doing justly, loving mercy and walking humbly with God. Moral suasion or reasoning, with due emphasis in daily life, gives us clear concep-tions of what is right and wrong in the multitude of business, and exhilarates our aspirations with a right tone of confidence in doing our dutiful obligations, fits us for better social intercourse with our neighbors, and enables us to ply the ethics of economy with best results. We are not what is termed isolated as a communnity, the same as Anarchists are. We have the whole wide world of Chistianity, which loves social and convivial meetings, in our favor, because we observe, or should, the principles it The most ignorant can be educated on such an instructive basis and become a Christian soldier, befitting the constitution of a national community. Then the realization of true manhood will burst out in its refulgence amidst the world's glorious anticipations. Another phase of the matter is those who study the ethics of economy for themselves and not for the general good, because they think there is a monopoly of money in it and don't consider the oppression on their fellow-creatures by their action-by such unjust scrutinizing causing a fel-low-man to be a slave to his cogitations, which in time bring on dull, apprehensive thoughts, as though the man was sold for a mess of pottage, and as though it were his fate. There is a fatality in it. When a man is alive to do what is just in his own interests, so the only source of keeping down such undue influence is to combat them in their first inception and keep in line with a true idea of economics and true social ideas, which is the only salvation of the labor problem. We have places of meeting to acquire the knowledge that should daily interest us, by re-ceiving instruction as to the right or ways and means apart from those who would enslave us. By being united we place suitable and proper men in muni-cipal and legislative positions, so that laws can be enacted amenable to our social condition. Then we would be able to cast away the evils that militate against our present and future
