

### CONSTITUTION.

This Congregation shall be known by the name of the First Presbyterian Church, London.

The Board of Managers shall be chosen by ballot by the Congregation from among the members of the Church in full communion, at the annual meeting of the Congregation, or at a meeting duly called for that purpose.

The Board of Managers shall consist of nine members, one third of whom shall retire annually by rotation; and their places, as also the places of any who may die or vacate their office during the year, shall be filled at the annual meeting of the Congregation. The retiring Managers may be re-elected.

If any Manager be cut off from Church privileges by process of discipline, or leave the Congregation, he shall forthwith cease to act as Manager, and another shall, as soon as convenient, be appointed in his place.

The duties of the Managers shall be to attend to the temporal and financial affairs of the Congregation. More particularly it shall be their duty to obtain from the people contributions for the sustentation of the ministry; to take care of the property of the Congregation; to provide for the payment of the Minister's and other salaries; and generally to administer all matters committed to their charge, as the Congregation may from time to time direct.

Meetings of the Board shall be held on the last Wednesday of each month for the transaction of business; but a meeting may be held at any time on the call of the Chairman, by notice from the pulpit, or addressed personally to the members of the Board.

Five members present shall constitute a quorum. Every meeting should be opened and closed with prayer.

The Treasurer shall be appointed at the annual meeting of the Congregation from the members of the Board of Managers. His duties shall be to keep the accounts of the Congregation and to receive and disburse all moneys, subject to the direction and control of the Board of Managers.

The Chairman and Secretary shall be appointed by the Board of Managers at the first meeting of the Board held after the annual meeting of the Congregation.

The Chairman's duties shall be to preside at the meetings of the Board of Managers, and to sign all accounts which have passed the Board. In his absence any member may be chosen to act as Chairman pro tem. The Chairman has only a casting vote.

The Secretary's duties shall be to keep a correct record of the proceedings of the Board of Managers, and to act as Clerk of the Congregation at congregational meetings.

All cases not herein provided for shall be governed by the Rules and Forms of Procedure laid down by the Church Courts of the Presbyterian Church in Canada.

In reviewing the work of the Congregation for the past year, the Session see great cause for gratitude to God for the good accomplished in the Congregation, and, while noting some drawbacks in the work, look forward to more successful labor and greater results in the year that lies before us.

During the first six months of the year the Congregation was without a regular Pastor, the Session during that time being presided over by Rev. Alex. Henderson, of Appin.

During the vacancy the Sacrament of the Lord's Supper was dispensed twice—in January by Rev. Dr. Laing, of Dundas, and in April by Rev. John Somerville, Owen Sound.

At a meeting held May 23rd the Congregation decided unanimously to extend a call to our present Pastor, Rev. W. J. Clark, then a graduate of Knox College. The call was sustained by the Presbytery and accepted by Mr. Clark, who was formally ordained and inducted into the pastoral charge of the Congregation on July 2nd.

We feel grateful to God that as a Congregation we were so led in our choice of a Pastor, and our prayer to God is that he may be long spared to work with us in the Master's service, and that great spiritual blessing may be the result.

In the month of November, the need of a larger Session being very much felt, an addition of eight new members was made. Mr. John Crombie having resigned his position as Elder, our number now stands at eleven.

The Congregation has been divided into a corresponding number of districts, and each Elder has a special oversight of the district assigned to him. Two Lady Visitors have also been appointed in each of these districts. A list of districts, with names of Elders and Visitors for each, will be found on the fifth page of the printed reports.

In October a Young People's Society of Christian Endeavor was formed. The meetings have been well attended and helpful to the young people. Still, a number of our young people have shown no interest in the Society, and the Session would affectionately remind them of the privileges which membership affords.

The Session decided, previous to the last Communion, that in future unfermented wine should be used in the Sacrament of the Lord's Supper.

The Organist of the Church having resigned, the Session have appointed Mr. W. C. Barron to the position.

The affairs of the Congregation generally afford great satisfaction to the Session. The various departments of the Church's work are well to the front. The Sabbath School, W. F. M. S., and Mission Band, have all held meetings regularly, and, as their reports evidence, are growing in interest and power.

The Sabbath Services, both morning and evening, have been well attended. The Prayer Meeting, too, has greatly increased in numbers and general interest. There is, however, a proportion of the Congregation who as yet show no interest in the Prayer Meeting, and the Session would urge on these the privilege and blessing to be gained by regular attendance at this service.

Only one department of the Church's work has not kept pace with the other improvements. The Mission contributions of the Congregation do not stand where they ought, and it is desirable that a greater conscientiousness should be manifested in the giving to this all-important branch of the Church's work.

## Report of the Board of Managers

## FIRST PRESBYTERIAN CHURCH, LONDON

For the Year 1890.

With gratitude to the Great Giver of all good your Board of Managers beg to present their Annual Report.

The Congregation is to be congratulated on the very excellent showing made during the past year. Our numbers are increasing in such a ratio, that while in previous years we have had a considerable number of sittings unoccupied, we now find a difficulty in providing accommodation for new comers; however, our pew stewards have been able, so far, to provide for all applicants, having been aided by those already occupying pews kindly making room where they could at all possibly do so.

From the Treasurer's statement for each quarter already placed in your hands, you will see a correspondingly gratifying increase in the amount of the weekly offerings. In 1889 it was \$2,385 37, while in 1890 the amount was \$3,125.15, showing an increase of \$739 78.

Taking it by quarters it is as follows:

At the present rate of increase we see no reason why our weekly offerings should not in 1891 amount to at least \$4,000, and if so we trust the balance of \$1,200 now due on note will then be paid, and the way cleared to increase our seating accommodation.

The total debt is now four thousand dollars; two thousand

eight hundred being the amount of the mortgage and twelve hundred the balance on the note.

While not thinking it wise to expend much at present on the Church building, your Board report having made several alterations which were necessary for health, comfort and convenience. The outside windows have been removed totally, the stained glass fixed properly in place and new ventilators adjusted nearer the ceiling, not only in the side windows but in the large ones in front of the Church.

The seating in the Choir has been altered to suit the Choir members who were rather cramped for room, and at the desire of the Session the pulpit has been moved back and a platform erected in front. This was a much needed improvement, the benefit being apparent at the last celebration of the Lord's Supper.

The Session having reported the appointment of Mr. W. C. Barron as organist at a salary of four hundred dollars per annum, in place of Mr. W. M. Clarke, resigned, we recommend that the amount to be paid be endorsed by the congregation.

We would recommend that the same ushers be reappointed with the addition of Mr. Irwin and Mr. Robert Lind.

We would recommend that the Janitor's salary be two hundred and sixty dollars per annum, and that the organ blower be paid two dollars per month.

We would recommend that the sum of fifty dollars, as usual, be voted to the Sabbath School.

The Treasurer's books have been duly audited and found correct, and have been certified to by the Auditors.

The thanks of the Congregation are due to the Choir for their faithful services, and to the young gentlemen who have so faithfully and efficiently acted as ushers.

## Sunday School Report, 1890.

In submitting this our annual report, and reviewing the work of the Sabbath School for the year, we have many causes of thanksgiving to God for the measure of success that has attended our efforts. Among other things our numbers have been largely increased, and there is evidence of an awakened interest among both teachers and scholars in the work of the School, as shown by their regular attendance. Last year our books showed a considerable deficit. This, we are glad to be able to state, has been wiped out, and a handsome balance carried forward to '91.

There are just the same number of classes in the School this year as last, viz., seventeen—the two Bible classes, seven boys' and seven girls' classes, and the infant class. Thirty-five of the scholars are communicants, and it is worthy of note that sixteen, at least, of these united themselves with the Church during the year.

The names of four new teachers and officers were added during the year, and the number struck off was four; while of scholars the very large number of fifty-three was added, and the number taken off the roll seventeen, leaving a net gain of thirty-six. Of those removed, two were enrolled as teachers—one, a member of the Bible Class. James Cousins was removed by death, greatly regretted by us all, and the balance have mostly left the city.

The regular Sabbath collections for Missions amounted to \$241.92, showing an increase over the previous year of \$14.61, and have been distributed as follows:

On three Sabbaths during the year, instead of holding the usual sessions in the school room, the teachers and scholars, also a good number of the Congregation, met together in the body of the Church, when special sermons were preached by the following gentlemen: Rev. Mr. Beattie, Rev. Dr. Moment, and our own Pastor, Rev. W. J. Clark. The collections on these several occasions, amounting to \$49.23, were devoted to the following schemes: Sabbath School fund, \$9.91; Missions, \$13.82; fund for replenishing the Library, \$25.50.

A large number of new hymn books have been recently purchased, so that now there is one for each scholar. The teachers have been supplied with the "Westminster Teacher" and the "Sunday School Times" for the current year; the older scholars with the "Westminster Quarterly," and the younger children receive the "Leaflets" and "Sunbeams." We cannot too strongly urge upon the parents the necessity of seeing that their children are regular in attendance, and have their lessons properly prepared, thereby greatly assisting the teachers.

The thanks of the school are due, and we take this opportunity to express the same, to the Congregation for their substantial grant to assist us in meeting the expenses of carrying on the School, and for their liberality on all occasions. In conclusion, we trust that God's blessing may still be upon this portion of the Church's work, and that each member may strive to follow more and more closely in the footsteps of Him who said, "Suffer the little children to come unto Me, and forbid them not, for of such is the Kingdom of God."

## Report of the Missionary Society.

The General Missionary Society in connection with this Congregation begs to report that the amount collected during the year 1890 for the various schemes of the Church, was \$303.70 as against \$284.90 collected during 1889, showing an increase of \$18.80, which is so far satisfactory, especially in view of the fact that during the first six months of the year, the Congregation was without a settled pastor. The effect of this will appear when we look at the amounts collected during the four quarters, which were as follows:

It will thus be seen that the rate of progress during the last six months has been rapid, and would justify us in expecting a much greater improvement during the current year, even if no other means were used, beyond those now in operation. It will be remembered that the Congregat on at its Annual Meeting two years ago, decided to do away with the system of sending round collectors and adopted the envelope system entirely, thus abolishing all personal intercourse on the subject of Missions, and leaving the matter perfectly voluntary. This is no doubt the ideal method, but it is doubtful if we have reached that stage when such a method can be safely adopted without other assistance.

The Committee believes that the time has arrived when the duty of the members in this respect should be brought prominently before them. In other directions the Congregation is waking up to its reponsibilities and privileges, and the different organizations are being pushed with vigor and success in their respective spheres. The ladies have their Missionary Society; the children have their Mission Band, and the Sabbath School has its Missionary Society, but in the Congregation as a whole we have no organization beyond the regular appearance of the envelope. We would recommend, therefore, that such steps be taken as will bring before the members of the Congregation the claims of the various schemes of the Church, so that there may be a more intelligent interest taken in the subject, and that giving for these purposes may be made more a matter of conscience.

This could be accomplished by the appointment of a small committee by the Session, whose duty it would be to see that information on these subjects should be presented periodically to the Congregation, either at meetings called for that purpose, or occasionally at prayer meeting, or by any other means they may deem advisable, and thus endeavor to stimulate the enthusiasm of the Congregation on this important subject.

FIRST CHURCH AUXILIARY.

In presenting the fourth annual report of the Women's Foreign Missionary Society, we do so feeling that the year that s past has not been altogether fruitless. Our membership has been added to, and, although not in any very large numbers, still we feel thankful that a few have been induced to help us to work in the great cause which we have so much at heart, and for which workers are so much needed. If many of those who have not joined us could only re lize what a blessed and happy work it is, we are sure they would be constrained to join and help forward the work. We trust that the year that is to come will add many more to our number.

If members would make a point of attending the monthly meetings regularly, it would be much more encouraging. We are, however, thankful to say that the last three or four meetings have been the largest we have had. May they continue to increase still more is our earnest wish and hope. We only need to take part in the work to have our interest in all missions, whether home or foreign, stimulated and increased.

While acknowledging that the monthly meetings are not always as interesting as they might be, we feel sure that if each member would try and do something towards making them more so, we would have nothing to complain of and they would be both pleasant and profitable.

We grieve to have to record the loss of one of our number during the past year, Mrs. Currie, who died last January.

During the year ten meetings have been held, the August

meeting having been omitted on account of so many of the members having been from home. The largest attendance at any meeting was twenty two and the smallest eight.

In April a Union meeting of all the city auxiliaries was held in Knox Church, London South, to receive the report from the different delegates who had attended the Annual Meeting in Hamilton; and a most interesting meeting it was, although the attendance was not so large as it should have been.

At the meeting in June, it was decided to ask the Congregation for a collection, as was done the previous year, for the purpose of purchasing goods to be sent to the Northwest (Birtle Industrial School). One was accordingly taken up on the fourth Sabbath of June, amounting to \$14.65, which was small as compared with the previous one, but fortunately the supplies sent last year had been so liberal that comparatively little was required. The article most needed seemed to be boots, and quite a liberal supply was sent along with cotton, flannel and other warm clothing. Those supplies must prove very acceptable to the Indians, and save them from much of the destitution and suffering they experienced in former years. May the Holy Spirit open their hearts to receive the truth as it is in Jesus, which alone can give them true happiness and comfort.

The work undertaken by us in behalf of the Northwest tends to deepen our interest in that part of the field; and the fact that the Indians are dependent upon us for comforts and instruction, enables us to realize that "it is more blessed to give than to receive."

On the 23rd of October the Annual Thanksgiving meeting was held in the Lecture room and was a most interesting one, there being a good attendance notwithstanding the unfavorable state of the weather. There was a good programme

and the offering amounted to \$31.35, which we thought was very good considering the size of the meeting.

The Rev. Mr. Clark kindly gave a very interesting lecture under the auspices of the Auxiliary, the subject being a "Sketch of the life and work of J. G. Paton." There was a large attendance and a very liberal collection in aid of the funds of the Society.

The total amount collected during the year was \$124.37, and also goods to the value of \$80.

On reviewing the work of the year just closed, we feel that there is much cause for thankfulnesss and encouragement, but we desire more and more to extend our sympathy and help to those who are living in darkness and the shadow of death, that they may be brought into the glorious light and liberty of the Sun of Righteousness.

First Presbyterian Church, London, for 1890.

In presenting the report for 1890 the officers of the Society will briefly state, for the information of those not aware of our aims and objects, that about five years ago the ladies of the Congregation met and organized for the purpose of aiding, not alone financially, but for promoting socialbility in the Congregation, visiting the sick and infirm, relieving those in need, and also assisting as much as possible in any other branch of general Church work. During the first year or so of our existence sewing meetings were held, and articles, some useful and ornamental, and some otherwise, were made up and sold, the proceeds being added to our funds.

This, however, not being altogether satisfactory, it was decided to discontinue the sales of work and the holding of bazaars, and it was resolved to raise money by a direct appeal to each lady in the Congregation to contribute a certain amount each month by envelopes placed on the ordinary collection plates. We are happy to say that this system has been very successful.

At the time the Church authorities purchased the land on which the building stands, the Society undertook to pay off the amount of the purchase money \$1,852, and to this object we contributed the sum of \$740; but last year the Board of Managers being called upon to raise the sum of \$2,000, the retiring allowance to our late esteemed pastor, they made a special appeal to us to divert our funds and aid them in paying off this amount, as the debt on the land had been consolidated with the general debt in one mortgage, which it was not thought desirable to increase. After due consideration we consented to do so, and have already paid \$547 for this purpose.

We beg to report having cleaned, papered and re-furnished the vestry.

We have also visited the sick, the aged and infirm of our Church family, and relieved those in distress.

In order to be in line with the other organizations of our Church, we decided, beginning with this year, to hold our Annual meeting in January, instead of in March as in former years; it will be therefore understood that our financial statement annexed is not for a complete year.

Our membership has not increased since last year, although we have five more contributors; in all we have 45 names on our roll. We thank those who, while not actively engaged in our work, have so materially helped financially; and we earnestly urge those ladies who are not members to join us Our fee is only nominal, 25 cents, and except in cases of emergency, our meetings are held once a month only.

# Report of the Victoria Mission Band

FOR 1890.

The end of the year 1890 brought our Band to the close of the fourth year of its existence, and although, in giving our report for the year, there are some things to cause regret, there are others for which we are very thankful.

Last year we had forty-three members; this year the number is fifty-four. This shows an increase of eleven; but there are still many in the Sunday School whom we would be glad to welcome to our Mission Band. Two of our members are also members of the Central Society.

During the year eleven regular meetings and one special Praise Meeting were held, at which the average attendance was twenty-one. When we remember that last year our attendance only averaged fourteen, we think the increase very encouraging. The meetings were well attended, with two exceptions, at one of which, in January, when so many people were ill, there were only eight present, and at the other twelve. Had it not been for the small attendance at these our average would have been much larger. The day on which our Praise Meeting—the first we have had—was held, there was a steady pour of rain, but twenty-five members, the greater number of them children from school, braved the storm, and we had a most enjoyable and impressive meeting, and the collection amounted to \$13.

A pleasing feature of our meetings this year is the increased interest shown in the work of Missions.

One part of our opening exercises is the repetition of a Scripture quotation, and it was a rare occurrence for any member to come without an appropriate verse.

Besides our regular meetings we had one open meeting, at which we were cheered to see a large gathering of friends.

A number of meetings were also held to prepare for the open meeting, and also many sewing meetings, to make useful and pretty things to send to the Northwest. The girls dressed a number of dolls, eighteen at least, giving their own names to the ones dressed by each. Pretty sewing aprons were also made as prizes in the school, with many other articles of use and beauty. Some of the boys helped as well in this work, making balls, scrap books, etc. The Band received a very kind and appreciative letter from Miss McLaren, of the Birtle School, to which the goods were sent.

This year we sent a whole bale, valued at \$71, to the Northwest. Last year we were only able to send goods to the value of \$40.

With the exception of the money received at our open meeting, all our funds this year have been obtained from fees, mite boxes, and collections, so that we feel that we are now getting into the real sprit of giving to the Lord willingly.

We are able to send to the General Fund \$50.26.

All the moneys collected, with the value of goods sent to the Northwest, amount to \$134.51.

On the whole we feel that in the year that is now passed our Band has made some real progress, but we are far from satisfied with what we have already attained, and hope that every member will put forth new energy to endeavor to make the year 1891 far surpass that of 1890.

Believing, as we do, that the more interest we take in Mission work the more the Church at home will prosper, let us strive to do all we can to hasten the time when the kingdoms of this world shall become the kingdoms of our Lord and of His Christ.

One of our chief aims is to encourage one another to greater

freedom in public prayer and speech. The blessed influences which come from a properly-conducted Prayer Meeting are also ours in our weekly meetings. The decided Christian young people who attend these meetings seek never to forget that while they are the means of strengthening Christian faith and love in our own souls, we are endeavoring to attract to our gatherings those who have not publicly confessed Christ, that we may influence them to a more open stand for righteousness. This, the great work of the Church, we hope to help forward among the young people.

Our numerical position is fairly satisfactory. There is enrolled thirty-five active members and twelve associate members.

We are about to make an attempt to do some practical work in connection with the Sunday School. We think the attendance might be increased there by an effort. Particularly would the young men of Dr. Hodge's Bible Class like to see their numbers added to. There are many members of the Congregation who could aid us in this by using their influence upon the young men of their family or acquaintance.

In conclusion, we wish to say that we look forward hopefully to the future year's work. It is God's work, and we pray for and anticipate His blessing upon it We desire that the spirit of our Society's motto, "For Christ and the Church," may touch all our Christian endeavor, and we look to our Church for their commendation and encouragement.
